Not less than eight (8) years experience in general administration, five of which should be at a senior level in his government of sub-regional, regional or international organizations. An advanced degree will be of distinct advantage.

2. Category and level.—PROFESSIONAL CATEGORY (P-5).

- (e) transit trade and transit facilities;
- (f) clearing and payments arrangements;
- (g) standardization and quality control (the director of trade, monetary and customs division will co-ordinate with the director of agriculture and industry division

in effectively implementing this protocol as well as that on simplification and harmonization of trade documents and procedures);

- (h) the unique situation of the B.L.S. state, provisions concerning the eastern and southern African trade and development bank. In this case the director will provide necessary assistance to P.T.A. member states for the establishment of the bank;
- (i) act as secretary at all meetings of the technical committees defined in annexes I to V and X to XII;
- (j) undertake day-to-day administration of the trade, monetary and customs division;
- (k) undertake any other duties that may be assigned to him by the secretary-general.

Qualifications and experience.—A degree in economics with specialization in international economics. Should have at least minimum of eight years experience, six of which should be at a senior position, in his government or sub-regional, regional or international organization in the field of international trade and finance including familiarity with trade negotiations, implementation of trade liberalization proceeds between African countries and/or financial and monetary matters. An advanced degree in international economics will be of distinct advantage.

THE Kenya Building, Construction, Civil Engineering and Allied Trades Workers' Union shall hereinafter be referred to as the claimants and Narshi Laxman and Bros Limited, shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi, on 9th June, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" duly signed by the parties on 2nd September, 1982, was received by the court on 10th December, together with the statutory certificate signed by the Labour Commissioner.

The parties appeared before the court on 7th January, 1983, when the respondents were represented by the Federation of Kenya Employers and the hearing was fixed for 5th April. On 17th March, the Federation of Kenya Employers withdrew from the dispute and they forwarded the claimants' memorandum to the respondents. The court arranged for another mentioned on 22nd March, on which date there was no appearance by the respondents and the court ordered that they should submit their memo on or before 22nd April, and the court fixed the dispute for hearing on 9th June. The respondents were duly notified of these arrangements.

On 9th June, the respondents again failed to appear for the hearing. Under these circumstances the court decided to make an *ex parte* award against the respondents.

The court recalled the findings and recommendation of the Ministry of Labour in which it was found that there had been no redundancies and that these employees had suffered wrongful termination.

In the case of Mr. Yoga who had served the respondents for eleven years, the ministry recommended four months' salary by way of compensation for the wrongful dismissal. The court awards that the respondents should pay him five months' salary by way of compensation.

In the case of Messrs. Maunga and Ochuka, the ministry recommended three months' salary as compensation for the wrongful dismissal. The court confirms this recommendation and awards accordingly.

In all the three cases the respondents should also pay them the terminal benefits in addition to the compensation except pay in lieu of notice which is part of the compensation.

THE INDUSTRIAL COURT

CAUSE No. 13 OF 1983

Parties:

Railways and Harbours Union (Kenya)
and

Kenya Railways Corporation

Issue in dispute:

Dismissal of T. H. Otieno.

THE Railways and Harbours Union (Kenya) shall hereinafter be referred to as the claimants and Kenya Railways Corporation shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 7th June, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 9th July, 1982, duly signed by the parties was received by the court on 4th February, 1983, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Mr. Otieno started working for the East African Railways on 23rd July, 1956, as a trainee division three. By 1973, he was an executive assistant in grade RB executive one. With effect from June, 1974, he was stationed at Nakuru and posted under the then district personnel officer where he worked until March 1977. On 1st April, 1977, he was transferred to the district mechanical/engineer's office in his capacity as the chief clerk.

In the aforesaid position of chief clerk he used to operate the imprest account. On 28th November, 1977, a surprise check was made and it was found that there was a shortage of KSh. 13,269.75. A complete statement of reconciliation together with the amount of shortage was shown to him on 1st December, 1977, and he asked to be given up to Saturday, 3rd December to make good the shortage. His request was granted but it was not until 4th December at around noon that he advised the auditors in the presence of the district mechanical engineer that he had managed to raise the cash shortage.

He was relieved of the imprest duties and on 8th December, 1977, he was interdicted. On 17th December, 1977, he was required by the chief mechanical engineer to give an explanation for the aforesaid misconduct, i.e. the misappropriation of KSh. 13,269.75 within 72 hours in terms of staff regulation G. 6. This is the crux of the matter in this dispute as this regulation applies in cases not justifying dismissal. Surprisingly when the case was referred to the management appointments committee "A" it was decided that the offence committed by Mr. Otieno was serious and merited dismissal from the respondents' services with loss of all privileges and on 10th April, 1978 he was dismissed and the decision was conveyed to him. The letter of dismissal read as follows:

"The management appointments committee 'A' at its meeting held on 7th April, 1978, considered your reply to the letter of explanation issued to you on 17th December, 1977, for misappropriation of KSh. 13,269.75 being part of the imprest account, found the same unacceptable and ordered that you be dismissed. In the circumstances you have been dismissed from the services of the Kenya Railways with the loss of all privileges with effect from 1st December, 1977. Please arrange to return all Railways property in your possession and vacate the Railways quarter currently occupied by you."

The claimants have strongly pleaded that the respondents had charged Mr. Otieno under regulation G. 6 which does not lead to dismissal instead of G. 5 where dismissal is mandatory. They argued that the respondents had made him believe that if he repaid the shortage then that would be the end of the matter.

The respondents, however, maintained that their action was justified even though they had used the wrong regulation because they expect their staff to remain honest and loyal but Mr. Otieno unfortunately had abused the trust placed on him by mismanaging imprest funds which were in his custody. They pointed out that the punishment of misappropriation of funds was known to him which was dismissal. The respondents maintained that in any case the managing director had the powers to vary the regulations.

This dispute was investigated by the Ministry of Labour whose findings and recommendations were:

"Mr. Otieno did not deny misappropriating the alleged funds. The corporation, however, made him believe that on repaying the money it would be the end of the matter. A recommendation was made that he be removed from Nakuru.

The corporation agreed they had charged him under the wrong staff rule, i.e. G. 6 which stipulates that the severest punishment for minor offences is a severe reprimand as opposed to G. 5 under which it is mandatory to dismiss the employee. But looking at the years of service rendered and the fact that the money was paid I find summary dismissal too harsh.

In view of the above it is recommended that his dismissal be reduced to normal termination which allows him to collect his terminal benefits."

The court notes that if Mr. Otieno had retired from the respondents' service in the normal manner he would have been entitled to a reduced pension of KSh. 922.80 per month and commuted pension of KSh. 46,140.95. If Mr. Otieno's services had been terminated on the grounds of public interest his pension would have been reduced by a fraction of about 10 per cent giving him KSh. 830.55 per month and commuted pension of KSh. 41,526.85.

The court has carefully considered this matter and finds that the respondents have overlooked the provisions of staff regulation G. 6 (g) which reads as follows:

"Notwithstanding the provisions of this regulation if at any stage during proceedings taken under it prior to final submission to the commission, the head of department is of the opinion that the offence, if proved, would justify dismissal or that proceedings for the termination of the employee's service on grounds of public interest would be more appropriate, such proceedings will be discontinued and the procedure in regulations G. 5 or G. 12 followed."

It is quite clear that the idea behind this regulation is that the employee should be left in no doubt as to what is at stake regarding his employment with the respondents, i.e. he is facing dismissal. In other words an employee should be given every opportunity of defending himself with that grim prospect before him that he faces dismissal. In this case Mr. Otieno was not charged under G. 5 and instead he was charged under G. 6 (a) which led him to believe quite rightly that he would face a punishment less than dismissal. The court has carefully considered all aspects of this dispute and cannot accept the respondents' submission that the managing director has the authority to vary the regulations on the spot when he feels like it and therefore he is deemed to have varied them in this case with the result that although he was charged under G. 6 the respondents were within their rights to apply G. 5 and to dismiss him under that regulation. This argument is absurd. There are proper ways of varying regulations and there is no evidence of that having been done in the present case. The claimants submitted that the proposed amendments to the regulations had to be placed before the joint industrial council.

The court is satisfied that the respondents were wrong in proceeding to dismiss Mr. Otieno under G. 5 when he had been charged under G. 6 without discontinuing the proceedings under G. 6 and starting afresh under G. 5.

Having made the above observations the court notes that Mr. Otieno did misappropriate the money involved and that when it was found out he refunded it. The court further finds that the respondents made an obvious error in dismissing him after charging him under a section which did not justify dismissal. The court further accepts that it is a technicality and that the respondents could quite easily have rectified it and started the proceeding afresh and Mr. Otieno in all probability would have again met the same fate of being dismissed albeit after a few months.

The fact, however, remains that as the matter stands Mr. Otieno has suffered a wrongful dismissal. The court, however, is not prepared to make an award which would give Mr. Otieno a pension of about KSh. 830.55 per month with a commuted pension of KSh. 41,526.85 or a slightly higher pension of KSh. 922.80 and a commuted pension of KSh. 46,140.95 just because the respondents have made a technical error. To do so would be completely wrong and uncalled for and the court does not propose to give Mr. Otieno any of these benefits.

The court has come to the conclusion that Mr. Otieno will be duly compensated for the wrongful dismissal that he has

suffered because of a technical error if he is awarded compensation of four months' salary at the rate he was earning at the time of his dismissal and the court so awards. The court would like to emphasize that apart from this four months' salary Mr. Otieno is not entitled to any other benefit from the respondents.
