- (iv) to notify that trade union and the organization in writing and within one month, of payment;
- (v) to make written returns to the Registrar of Trade Unions within one month of making all payments to that trade union and to the organization.

- (d) A charge of shillings forty (KSh. 40) for each occasion on which the supply is disconnected at the request of a consumer and meter read.
- (e) A charge of shillings forty (KSh. 40) if the supply is re-connected at the request of the consumer.

111 A deposit of shillings two hundred (KSh. 200) or an appropriate multiples or fraction of this sum should the company depart from the present policy of billing consumers monthly, shall be required from every consumer prior to connection. The deposit shall be retained by the company for the period during which the consumer is supplied with water as a security for the payment by him of charges relating to such supply.

PROFICIENCY EXAMINATION FOR CLERICAL OFFICERS, 1983

IT IS notified for general information that this year's Proficiency Examination for Clerical Officers will be held on 14th and 15th December, 1983, in accordance with the provisions of Personnel Circular No. 10 of 5th December, 1973.

2. SCHEME OF THE EXAMINATION

The examination will consist of the following eleven (11) subjects, seven (7) of which will be attempted by all candidates and the remaining four (4) will be optional subjects from which each candidate will be required to choose only one relating to his/her normal official duties, making a total of eight (8) subjects to be taken by each candidate:

Paper I.—General Paper.

(This Paper will consist of four separate papers):

(a) English Language.

(b) Organization and Functions of Government.

(c) Current Affairs.

(d) Elementary Economics.

Paper II.-Civil Service Regulations.

Paper III.-Clerical Procedures.

Part 1.—(Compulsory for all candidates).

(a) Office Practice.

(b) Business Calculations.

Part II.—(Optional—any one subject related to officer's duties):

(a) Accounts or

(b) Stores or

(c) Personnel or

(d) General Office Services.

3. ELIGIBILITY TO ENTER

The requirements for clerical officers (civil servants only) to qualify for sitting for the proficiency examination are as

- (i) That those appointed directly in Job Group D are required to complete at least four (4) years' service in the grade before entering for the examination.
- (ii) Those clerical officers who were appointed at a starting salary of K£471 per annum and above by virtue of their educational qualification examination after completing two (2) years' service.
- (iii) Junior clerical officers who have been promoted to Job Group D are required to complete at least two (2) years in this grade before they qualify.
- (iv) Storemen Grade III qualify for the examination in the same manner as junior clerical officers.

4. CONDITIONS FOR OBTAINING A PASS

Every candidate will be required to enter for and pass in all the three main papers at one and the same sitting. No partial passes will be allowed.

5. Examinaton Registration Fees

Every candidate entering this examination will be required to pay a registration fee of KSh. 50 only, for the whole examination. The registration fee, which will be non-refundable will be payable to the Secretary, Public Service Commission of Kenya, P.O. Box 30095, Nairobi, in either crossed Kenya money order, postal order or cash. Personal cheques will not be accepted.

6. ENTRY FORMS

The candidates must complete and submit the examination entry forms in triplicate, as set out at the "Appendix" to this circular letter, copies of which should be reproduced and cyclostyled by each ministry/department as required and the completed entry forms, duly certified correct by the candidate's chief/senior personnel officer/P.F. and E.O. and accompanied by the correct registration fees, to the Secretary, Public Service Commission of Kenya, Nairobi, so as to reach him on or before Monday, 26th September, 1983. Late entries, incomplete/wrongly com-pleted entries or uncertified and forms not accompanied by the correct registration fees, will automatically be rejected.

It is, therefore, the responsibility of the certifying officer to check and certify himself/herself that the information given is correct in every respect and that the person intending to register for the examination is what he/she claims to be. Officers who sit and pass the examination while they are not eligible to sit will automatically be disqualified. All entry forms from officers serving in the provinces must be submitted to the Public Service Commission of Kenya, through the ministry headquarters for certification. Forms sent direct to the Commission from provinces will not be accepted.

7. Examination Centres

The examination will be held in all the provinces at Mombasa, Nyeri, Embu. Nairobi, Nakuru, Kakamega, Kisumu and Garissa. The actual venues at each provincial centre will be notified to the candidates soon after registration.

8. General Conduct of the Examination

Candidates will not be allowed to consult any books, files, notes, etc., during the examination progress. Any infringement of this rule will result in immediate disqualification from the whole examination, and may also lead to disciplinary action being taken against the offenders. Examination question papers and stationery will be supplied to the candidates by this office, through the provincial education officers who will be in charge of the examination centres. Provincial education officers will be responsible for the appointment of invigilators and supervisors, the arrangement of the examination venues and return to this office of the candidates' answer scripts. The decision of the Public Service Commission of Kenya, in all matters related to the examination, will be final.

ORDER

IN EXERCISE of the powers conferred by section 8 of the Rabies Act, the Director of Veterinary Services orders that the following provisions shall have effect and be complied with in the area specified in the schedule hereto, which is an area in which rabies has broken out:

- 1. For a period of three months from the coming into operation of this order, or for such longer period as the Director of Veterinary Services shall by notice declare, all dogs shall at all times be secured on leads except when in enclosed premises, a dwelling-house, or a building and shall be kept in enclosed premises, a dwelling-house, or a building between the hours of 7 p.m. and 6 a.m.
- 2. After the expiration of three months or such longer period as aforesaid, all dogs shall be secured on leads at all times when on or near a public road and shall be kept in enclosed premises, a dwelling-house, or a building between the hours of 7 p.m. and 6 a.m.
- 3. (1) Any dog that is suspected of having been bitten by or been in contact with a rabid animal may, if not destroyed, with the approval of a veterinary officer be secured in a place of isolation as hereinafter provided and kept under observation for a period of at least six months and shall be examined at least once a month by a veterinary officer during such period.
- (2) A dog is deemed to have been in contact with an animal if it has been in the same building, kennel, field or other place as the animal.
- 4. For the purposes of paragraph 3, the dog shall be secured in a suitable place of detention in the immediate neighbourhood of the place where the dog is normally kept or in such other place as may be approved by the Director of Veterinary Services.
- 5. The place of detention shall comprise a kennel or other enclosure with sufficient adjoining space to provide for the full liberty of the dog in the open air, the whole being so enclosed as to prevent the escape of the dog therefrom or its contact with any other dog:

Provided that in the absence of such facilities the dog may, as a temporary expedient, be detained in such manner as may be approved by a veterinary officer or inspector.

- 6. A veterinary officer, or any person authorized by him in writing, may destroy any dog not controlled in accordance with the provisions of paragraphs 3, 4 and 5.
- 7. The carcass of an animal that has died from rabies or that has been destroyed on account of rabies shall be burned or buried by the owner or the person in charge of such animal.
- 8. No person shall move any dog or cause any dog to be moved out of or into the area specified in the schedule without the prior written permission of a veterinary officer.

THE INDUSTRIAL COURT

Cause No. 16 or 1983

Parties:

Tailors and Textiles Workers' Union

and

Rift Valley Textiles Limited

Issue in dispute:

Wrongful dismissals of Sylvester Chebii and Tom Nyanaro.

The Tailors and Textiles Workers' Union shall hereinafter be referred to as the claimants and Rift Valley Textiles Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 31st May, 17th June and 28th July, 1983, and in addition to relying on their written and verbal submissions called the following witnesses to give evidence on oath:

Claimants:

S. Chebii, T. Nyanaro.

M. H. K. arap Langat.

Respondents.-G. Openshaw.

AWARD

- 3. The Notification of Dispute Form "A" dated 15th November, 1982, duly signed by the parties was received by the court on 4th February, 1983, together with the statutory certificate signed by the Minister for Labour and the Labour Commissioner.
- S. Chebii who was the claimants' assistant shopsteward at the respondents' undertaking and their branch chairman for Eldoret had his services terminated at the end of May, 1981, when he was a quality controller earning KSh. 749 per month. He had started working for the respondents in January, 1977.

Tom Nyanaro joined the respondents in October, 1976, and was confirmed in the position of chief clerk with effect from 1st October, 1979. His services were terminated on 23rd June, 1981.

The dispute was investigated by the Ministry of Labour whose finding was that the respondents had no conclusive evidence of the offences allegedly committed by these two persons and their dismissals were therefore wrongful. It recommended that they should be paid four and three months' salary by way of compensation in addition to the terminal benefits that had already been offered by the respondents to them. Mr. Chebii was offered KSh. 1,086.50 which included thirty days' pay in lieu of notice and Mr. Nyanaro was offered KSh. 2,588.80 which again included thirty days' pay as wages in lieu of notice. Both of them received these amounts and they have also signed certificates dated 29th June and 5th August, 1981, certifying that they had received these sums being the payment of their final accounts and they have no further claims against the company. The court will refer to these certificates of discharge in due course.

On or about the material time when their services were terminated, the personnel manager at the respondents' undertaking, Mr. Wachira, was facing a criminal charge relating to corruption and was convicted and fined. The court was told that the state had appealed against this sentence with a view to enhancing it. On the dates on which it is alleged that Mr. Chebii failed to clock in and clock out, i.e. 4th to 9th and lith May, 1981, Mr. Wachira's case was going on in the criminal court. Mr. Chebii claimed that he attended the court as he was interested in Mr. Wachira's case because of his trade union positions. He said that he used to attend the court in sympathy with the personnel manager but the courd doubts if it was sympathy. More likely it was the other way round!

The court has to determine if Mr. Chebii was guilty of unauthorized absences on these dates. The court finds it interesting that the respondents' deputy chief executive, G. Openshaw, who in October, 1980, was the assistant general manager, had issued Mr. Chebii with an open letter which clearly showed that Mr. Chebii and the other shopsteward will be free to carry out union work for most of the time! This letter is worded as follows:

"Please note that the above two employees will be required to carry out union/shopsteward work for most of the time. They can be kept in establishment of their respective departments and will continue to be shown in the shuttle sheet. In order that the duties which they are supposed to carry out in the department are covered their places may be permanently filled by other workers."

While giving evidence, Mr. Openshaw stated that notwithstanding this letter, it was not his intention that this letter shall change the regular procedures. This meant that the shopstewards had to obtain permission to leave the premises.

Apart from this, the court was also shown a muster roll in which Mr. Chebii appears to have been absent from 4th to 9th May, 1981, but it is quite obvious that first he had been entered as being present on these dates and then the "p"'s have been erased and dashes have been marked on top. Mr. Chebii claimed that his clocking-in eard had mysteriously disappeared and therefore he could not punch it on the dates in question. The card was produced in court by the respondents and it shows that on the material dates Mr. Chebii had clocked in at 7 a.m. and clocked out at 3 p.m. These entries, however, are handwritten and there seems to be no argument that they were made by the timekeeper. The respondents stated that the timekeeper l'ad been suspended for making these fictitious entries but had not been sacked and is still in employment. This is very surprising. All this leads the court to believe that Mr. Chebii did report for work on the days in question after which he went to the court to listen to Mr. Wachira's case.

Regarding the disappearance of the card as claimed by Mr. Chebii, the court believes him when he stated that it had disappeared.

The respondents asked their administrative manager, Maj. Lang'at, to investigate Mr. Chebii's case vide a memo from the finishing manager to the personnel labour manager dated 1981, and did not clock in on 111th May.

Mr. Chebii did not clock in and out on 4th to 9th May, 1981, and did not clock-in on 11th May.

Consequently he was absent without permission since Mr. Homan was not approached.

Maj. Lang'at inquired into this allegation and also whether or not Mr. Chebii preached tribalism or groups workers along tribal lines in the mill and whether or not Mr. Chebii's memo of 18th May, 1981, to Mr. Homan was insubordinate.

Maj. Lang'at carried out a comprehensive investigation and prepared a six-page report and recommended that Mr. Chebii's suspension should be lifted and he should be warned about being absent without leave for probable periods between 4th and 11th May, 1981. Maj. Lang'at noted that it was never proved that he was absent continuously between 4th and 11th May and further found that he should be acquitted on all other counts as they were never proved. He further made the following three observations:

"In order to restore good faith in the handling of disputes, I recommend that the appeals from Mr. Wachira should be heard by John Clements, the mill manager, alternatively there should be no appeals as alluded to the mill manager in our recent meeting with you. This would be a great relief to me

Mr. Homan, and indeed all managers, should investigate cases thoroughly and fairly if feelings of bias and unfairness are going to be reduced to a bare minimum.

Mr. Homan, and indeed all managers, should not write about other managers in a derogatory or detracting manner. This creates friction and division in management which is not desirable or necessary concerning the interests of the company."

The claimants called Maj. Lang'at to give evidence and he confirmed his investigations and findings in court. It is obvious that there is or was a serious rift in the top management at the resopndents' undertaking at the material time but even allowing for a certain amount of latitude for this rift the evidence that was produced during the hearing convinced the court that Maj. Lang'at's findings are reasonably accurate as to what took place re Mr. Chebii's absences on the alleged dates and other accusations against him. All the evidence taken together leaves the court in no doubt that Mr. Chebii did not deserve termination and the court must therefore find that he has suffered a wrongful dismissal.

Now coming to the case of Mr. Nyanaro, the court can find no real reason why the respondents suddenly lost confidence in him (their chief clerk in the personnel department). No warning letter was produced which had been issued to him and the court is left with no alternative but to give due weight to what Mr. Nyanaro stated that he had surrendered certain documents to the police when they had come to his office and asked for those documents which were used in the case against Mr. Wachira. He stated on oath that the police had search warrant and he had no alternative but to give them the documents. He informed the mill manager that the police were there and that the security officer also knew about it. He said that the security officer told him to give the documents to the police after which he listed the documents and

the police signed for them. He said in court that when he received a letter from the respondents addressed to him he thought it was an increment but on opening it he found it was a letter of dismissal.

In Mr. Nyanaro's case, also the court is satisfied that he suffered a termination because of Mr. Wachira's case but under the circumstances as narrated by Mr. Nyanaro and which were not rebutted by any evidence called by the respondents, the court is satisfied that he has also suffered a wrongful dismissal.

The court has already expressed its views on the certificates of discharge which the employers obtain from their employees on termination and here again the court accepts Mr. Chebii's and Mr. Nyanaro's explanation that they accepted this money because they were on the point of starvation and secondly, that they knew that their dispute with the respondents was being processed by the ministry and they never intended to give those claims up.

The court notes Mr. Chebii is still unemployed but Mr. Nyanaro has found a job in Kisumu. The court awards that Mr. Chebii should be reinstated to his position at the time of his dismissal with effect from the first of the month following the court award, he should in addition be paid six months' salary by way of compensation. His services should be deemed to have continued without a break. The court would like to advise the respondents that it would be in their own interest to review the open letter that they had given to Mr. Chebii and they should make him do some productive work for them in addition to his duties as a shopsteward.

The court awards that the respondents should pay Mr. Nyanaro three months' salary by way of compensation for the wrongful dismissal that he has suffered in addition to what he has already been paid.

Award

- 3. The Notification of Dispute Form "A" dated 13th Ootober, 1981, duly signed by the parties was received by the court on 22nd July, 1982, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.
- J. Otieno worked for the respondents who are a member of the Distributive and Allied Trade Association, from 1st April, 1974, until 12th July, 1980, when he was arrested by the police and was prosecuted on a criminal charge. On 30th September, 1980, he was discharged by the Nakuru resident magistrate, as the senior state counsel entered a nolle prosequi in the case. On 1st October, he reported to the respondents' branch manager at Nakuru and told him that he had been acquitted. The manager told him that he had been dismissed on 31st July, 1980.

The incident that led to his predicament as stated above started when Mr. Otieno was working in the respondets' Kisumu

office which had recently been opened as a general office messenger. Prior to that while in Nakuru, he had been promoted to the position of junior sales clerk grade I and was earning KSh. 864 per month with effect from 1st January, 1978.

As a result of information gathered through a stock check at the Nakuru office, the respondents discovered that a number of items were missing from the stores and they launched investigations. On 12th July, 1980, the respondents' personnel manager, J. H. Ochola W'oigo, reported at Kisumu Police Station from where a police constable accompanied him to their Kisumu office. There they questioned Mr. Otieno and A. Owino, their two employees. The police constable told both of them that he wanted to search their houses. They proceeded to Mr. Owino's house and started the search and while the search was going on Mr. Otieno started running away. The police constable chased him and caught him after a two-hundred yards sprint. From there the police constable decided to immediately go and search Mr. Otieno's house from where he Mr. Otieno himself produced a bag containing various spares belonging to the respondents which he claimed he had been given by two employees in stores at Nakuru. A total of fifty-one items valued at KSh. 15,000 were found in his possession.

The court is satisfied from the lists produced during the hearing of the items missing during the physical stock check at Nakuru and the items found in Mr. Otieno's house at Kisumu were the respondents' property and were shown among the missing items during the stock check.

The sequence of events as stated above was confirmed on oath by Mr. Woigo, the respondents' personnel manager who also stated that Mr. Otieno pleaded with him to dismiss him there and then rather than report the matter to the police.

Mr. Otieno while giving evidence denied all this but the court does not believe him and finds that the respondents' witnesses, Mr. W'oigo, and Mr. Kiuna, who at the time was their manager at Nakuru and is now one of the directors, told the truth.

On the evidence that was produced before the court which was so clear, it is obvious that Mr. Otieno was a dishonest employee. It is true that the state counsel entered a nolle prosequi in the criminal action but then section 17 (f) of the Employment Act, is relevant because he was absent from 12th to 23rd July, 1980, when he was in police custody and after that he did not report back for duty until 1st October.

The court feels that if the Ministry of Labour had not recommended an exgratia payment of three months' pay in addition to other terminal benefits this dispute would not have come to the Industrial Court. The court cannot support the investigator's findings and recommendation in this dispute.

The court is satisfied that Mr. Otieno acted dishonestly while in employment and deserved summary dismissal which the respondents justifiably handed out to him at the end of July, 1980. They should pay him up to and including 29th July, 1980, less the days he did not work.
