THE Kenya Chemical Workers' Union shall hereinafter be referred to as the claimants and Pan Plastics Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 31st August, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 3rd February, 1983, duly signed by the parties was received by the court on 24th May together with the statutory certificate signed by the Labour Commissioner.

The collective agreement which the parties are revising expired at the end of February, 1982. The claimants had forwarded their proposals for revising it to the respondents on 10th November, 1981. The parties met under the chairmanship of an F.K.E. representative for the first time in January 1982. It is apparent that the claimants' junior officers at these meetings did not realize the seriousness of either keeping appointments or while discussing the subject matter. This prompted the respondents to bitterly complain about their conduct.

The claimants reported a trade dispute to the Minister for Labour on 23rd March, 1982, and on 3rd June that year the parties were advised that a conciliator had been appointed. As if there was not enough delay already the first conciliation meeting was held on 28th October, 1982. By this time the new guidelines had been announced effective from 1st August, 1982. If the negotiations had been concluded prior to August the workers' entitlement would have been under the old Guidelines giving not more than half of the increase in the cost of living. Under the new guidelines they are entitled to an average of three-quarters of the increase in the cost of living and the way has been opened for the parties to deconsolidate housing where it was consolidated prior to 1st August, 1982.

In these circumstances the court is confronted with a situation where the claimants are pressing for an award on the issues in dispute to be strictly based on the workers' entitlement under the August 1982, guidelines both on wages and house aflowance. The respondents on the other hand have pleaded that although they have in a spirit of give and take agreed to deconsolidate the existing consolidated wage they are entitled to benefit from the guidelines in operation prior to August 1982. They further submitted that there were presently more than a hundred companies involved in plastic manufacturing activities which had intensified competition within this industry. The recent devaluation had increased the cost of their raw material by 30 per cent.

One main point which the respondents made in this dispute was that as a result of a loan of four million shillings which they had obtained they had installed new machinery and moulds to increase their manufacturing capacity between 1980 and 1982 as a result of which they had increased employment from 57 employees at the end of 1979 to 101 at the end of 1982. Currently they have 103 workers.

The court has carefully considered the parties' submissions and also the report from the Division of Manpower Planning and Development of Ministry of Labour who compiled it at the request of the court and has decided to make the following award.

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and Grain Milling Group shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 7th July and 8th August, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 2nd June, 1982, duly signed by the parties was received by the court on 17th August together with the statutory certificate signed by the Labour Commissioner.

The parties have had a relationship for the purposes of collective bargaining dating back many years. The member companies in the respondents' group have changed since the original recognition agreement was signed but the parties have not deemed it fit to have a new recognition agreement. Currently the four companies that comprise the respondents are Unga Limited, Unga Feeds Limited, Unga Maize Millers Limited and Practor and Allan Limited. The parties have also had successive collective agreements and the current one was signed on 1st October, 1982, for a period of two years with effect from 1st August, 1982.

The three issues in dispute are omitted from this agreement but the parties agreed that they be referred to the Industrial Court for a decision.

The claimants' demand on the three items was first raised in 1980 but at that time they did not pursue these items. They, however, repeated their demands before the 1982 agreement was concluded. The matter therefore is now before the court.

The issue of junior management terms and conditions of service was settled by the parties at their own level leaving only the matter of shift allowance, meal allowance and long service increases before the court.

The claimants have based their demands on the fact that other similar industries engaged in food production are giving shift allowance to their employees and also reward their long service employees by giving them suitable long service increases and also that these companies provide free meals to their night shift employees or give them appropriate meal allowances.

At some stage the respondents undertook to carry out a feasibility study regarding the issue of meal allowance with a view to establishing the possibility of setting up canteens. The matter, however, died there. The Division of Manpower Planning and Development reveals that at the Eldoret plant there is no vacant room which can be used as a canteen but the nearest hotel is about two hundred metres from the plant where employees may buy meals if they so wished. At Nakuru again there is no canteen facility and the management stated that meals, tea, coffee are discouraged especially at the mill. At the Nairobi plant in the industrial area, there is a staff canteen which has a capacity of fifty diners at one sitting where the meals are somewhat subsidized.

The court has studied the parties' argument on this issue and has considered it from the various aspects but has come to the conclusion that the claimants have failed to satisfy it on the desirability of burdening the respondents with this item whose cost would be quite high and prohibitive especially at this time when the economy is going through a difficult stage. The court has therefore decided to reject this demand made by the claimants.

On the issue of shift allowance and long service increases, the court finds that the claimants have established a case for the introduction of these two items. The court is sympathetic with the claimants that workers on night shift are greatly inconvenienced in various respects like irregular meals and sleeping times, and that it upsets their family and social life considerably; they are deprived of the time they would spent with their children. For all this the workers are entitled to get an additional compensation for this inconvenience which they suffer.

The court has considered the respondents' argument that night shift work is a normal feature of their operations and that it applies to workers who cover the entire circle of twenty-four hours. The system itself is a continuous operation and is rotational in that no particular employee is assigned to the shift permanently. Notwithstanding that the working period of the employees employed on night shift is shorter than all those working on the normal shift, the court has come to the conclusion that the workers are entitled to be paid a shift allowance. Shift allowance is a normal feature in the collective agreements covering industries which operate twenty-four hours.

Long service increases

On this item also the claimants have impressed the court with their argument and especially the fact that the K.C.C. have such a scheme in their collective agreement. This certainly is an incentive for continued employment of workers in one place. The fact that the respondents rewarded their long service employees by giving them promotions or awarding them merit increases and alloting them some shares is a matter which is entirely in the hands of the management which they may or may not give. The court is not satisfied with the respondents' argument that the senior employees benefit more in various ways in counting the claimants' demand. The court is aware that the respondents have relied on the principle of equal pay for equal work but after about twenty years of collective bargaining between the parties the court is of the view that the respondents should introduce long service increases for their employees.

The court accordingly awards that the respondents' employees should be given a shift allowance and long service increases but the court does not intend to make an award on these items in this dispute during the life of the current collective agreement. The court would at this stage like to open the door for negotiations between the parties on these two items which should be dealt with when the current collective agreement is being revised. The claimants will be at liberty to make their demands on these items along with other items in the collective agreement and the respondents will be free to make their counter offers. In the event of there being a dispute the parties will of course be at liberty to come back to the court on all the items on which they are deadlocked for arbitration.
