They should also be capable of handling junior staff, taking mature decisions on the technical aspects of the work, have leadership ability and zest for taking responsibilities. They should in addition possess wide experience in the design and detailing of various drainage and sewerage disposal schemes and have a thorough knowledge of survey and levelling techniques.

Civil servant applicants who have served at the grade of draughtsmen I for at least three (3) years will also be considered provided they satisfy experience requirements.

Senior Draughtsman (Civil/Structural) (Two Posts) (No. 136/83)

Applicants should have higher diploma in structural and civil engineering or equivalent approved qualifications. They should have a minimum of ten (10) years of relevant experience of which two (2) years should have been spent on site supervision of large structural schemes. They should also be capable of handling junior staff, taking mature decisions on the technical aspects of the work, have leadership ability and zest for taking

responsibilities. They should in addition possess wide experience in the design, detailing of R. C. steel and timber structures, and have a thorough knowledge of current building regulations and codes of practice.

Civil servant applicants who have served at the grade of draughtsmen I at least three (3) years will also be considered for the post provided they satisfy experience requirements.

Quantity Surveyor Assistant I (Seven Posts) (No. 137/83)

Applicants must be in possession of the ordinary diploma in building and civil engineering or the construction technicians certificate Part II from Kenya Polytechnic or other institutions and must have a further four (4) years experience.

Duties involve supervision of building contracts or maintenance works and candidates must be able to understand and interpret architectural and engineering drawings, specifications and bills of quantities, prepare cost estimates and understand contractual and supervisory procedures.

Senior Inspector Building (Seven Posts) (Architectural Department) (No. 140/83)

Salary scale.—K£1,494 to 2,010 p.a. PENSIONABLE or AGREEMENT.

Applicants must be in possession of the ordinary diploma in building and civil engineering or the construction technicians certificate Part II from Kenya Polytechnic or other institutions and have a further four (4) years experience.

Duties involve supervision of building contracts or maintenance works and candidates must be able to understand and interpret architectural and engineering drawings, specifications and bills of quantities, prepare cost estimates and understand contractual and supervisory procedures.

Draughtsman II (Civil/Structural) (Four Posts) (Structural Department) (No. 141/83)

Salary scale.—K£1,494 to 2,010 p.a. PENSIONABLE or AGREEMENT.

Applicants should have a minimum of East African Certificate of Education or its equivalent. They should possess the ordinary diploma in building or civil engineering from Kenya Polytechnic or recognized equivalents. They must have

worked for at least two (2) years after their diploma in a reputable engineers office and should be able to translate engineer's design specification into working drawings.

Civil servant applicants who have served at the grade of draughtsmen III for a minimum of four (4) years will also be considered. Applicants must be neat accurate draughtsmen and must be familiar with detailing of R. C. steel or timber structures. The applicants will also be required to have relevant site experience.

Draughtsman II (Drainage) (Five Posts) (Structural Department)
(No. 142/83)

Salary scale.—K£1,494 to 2,010 p.a. PENSIONABLE or AGREEMENT.

Applicants should have a minimum of East African Certificate of Education or its equivalent. They should also possess the ordinary diploma in building or civil engineering from Kenya Polytechnic or a recognized equivalent. They must have worked in a reputable structural/civil engineers office dealing with preparation of schemes from the drainage, roads, and paved areas and allied civil engineering structures for at least two (2) years after their diploma.

Civil servant applicants who may not possess the academic requirements but who have served at the level of draughtsman III for a minimum of four (4) years will also be considered.

Applicants must be neat and accurate draughtsmen and should be able to carry out elementary surveying and levelling in relation to the preparation of such schemes.

Inspector Gardens (Two Posts) (Architectural Department)
(No. 143/83)

Salary scale.—K£1,128 to 1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants must be in possession of Kenya Certificate of Education Division III or above or its equivalent and must have worked as a groundsman/gardener I or at equivalent level for a minimum period of three (3) years.

Duties.—The work for the successful candidates involves maintenance of gardens for government such as gardens within housing estates, office buildings, public buildings, etc.

Vacancy in the Ministry of Transport and Communications:

Fire Officer I (One Post) (Aerodromes Department) (No. 144/83)

Salary scale.—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving fire officer grade II with sound knowledge in both technical and administrative matters of aerodrome fire service organization with at least ten (10) years of fire fighting experience, four of which must have been spent as an officer in charge of a major fire station.

They must be capable of carrying out training at station level and conduct fire prevention surveys affecting airport buildings and operational areas. The candidate should be capable of compiling comprehensive reports after aircraft and or fire incidents and knowledge of stores accounting procedure would be an added advantage.

Vacancies in the Ministry of Water Development:

Senior Inspector (Electrical) (Four Posts) (Water Engineering Department) (No. 145/83)

Salary scale.—K£1,494 to 2,010 p.a. PENSIONABLE or AGREEMENT.

Applicants should have attained a good general education preferably school certificate of education. They must have approved electrical training preferably City and Guilds Electrical Technician Certificate final grade or its equivalent and must have had at least two (2) years post training experience as inspector (electrical) dealing with installations, operations and maintenance of low, medium and high voltage electrical machinery.

They should be conversant with water supply electrical works including borehole submersible pumps, motors/control gear, and diesel generators. They must be familiar with the current official electrical regulations and must be in possession of a class "A" electrical licence.

Alternatively candidates must hold a grade I wireman trade test certificate and preferably should have served an apprenticeship in an electrical trade followed by at least three (3) years in a supervisory position at a level equivalent to an inspector (electrical) in the civil service. They should be familiar with water supply electrical services including submersible pumpsets,

motor/control gear and diesel generators, etc. They must be in possession of class "A" electrical licence and be conversant with the current official electrical regulation.

Vacancy in the Ministry of Information and Broadcasting:

Director of Broadcasting (One Post) (VOK) (No. 146/83)

Salary scale.—K£4,584 to 5,514 p.a. PENSIONABLE or AGREEMENT.

Applicants should have a degree in production; or preferably a degree in social sciences from a recognized university. They should have proven capability in administration and management coupled with a thorough knowledge of broadcasting, and have experience in broadcasting services for a period of not less than ten (10) years.

Applicants in possession of a degree in social sciences should in addition have at least a diploma in production from a recognized institution.

Duties and responsibilities.—The director is responsible to the permanent secretary to whom he is administratively and operationally answerable for the efficient running of the Voice of Kenya Radio and Television stations. He also carries responsibility for the planning, co-ordinating, control and development of radio and television services including accountability for their effectiveness; advises the permanent secretary on broadcasting matters; ensures harmonization of overall government policy and objectives into programmes production, including localization of programmes; initiates programme policy; liaises with counterparts in other organizations in matters relating to his schedule; as well as overall responsibility for the proper use of the resources under his charge including training and development of the staff in the department.

Vacancy in the Ministry of Labour:

Assistant Director (One Post) (N.S.S.F.) (No. 147/83)

Salary scale.—K£3,408 to 4,428 p.a. PENSIONABLE or AGREEMENT.

Applicants should preferably be civil servants who have demonstrated outstanding ability in field management particularly in personnel and establishment matters with particular emphasis on pensions work. They must have served on Job Group "L" for at least three (3) years. University graduates in possession of a degree in sociology or economics and wide administrative experience will have an added advantage.

Applicants are expected to be familiar with National Social Security Fund Act.

Duties include assisting the director in supervision, control, and organization of a large staff, co-ordination of field inspectorate services and initiation of training programmes.

Vacancy in the Ministry of Constitutional Affairs:

Salary scale.—K£1,128 to 1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers, preferably of East African Certificate of Education standard or its equivalent with a minimum of six years satisfactory clerical functions. They must be serving senior clerical officers who have passed proficiency examination for clerical officers. They must have thorough knowledge of government regulations and procedures and must be able to control staff and conduct correspondence independently.

Principal Economist (Two Posts) (Planning Division)

In addition they should have demonstrated administrative capability in handling senior staff and acceptable degree of competence to give professional leadership.

They should have had past professional experience which must bear specific reference to complex economic matters including general economic planning duties in economic planning and development identification, preparation, implementation and evaluation of development projects and programmes.

The successful candidates will be charged with formulation of economic policies with regard to specialized or specific areas of economic development activity. They will also be

involved in initiation, implementation and appraisal of national, urban/rural developments strategies or projects or advising thereon. They will be acting as the heads and co-ordinators of the work and activity of major planning unit in a ministry.

Vacancies in the Office of the Vice-President and Ministry of Home Affairs:

Senior Superintendent of Prisons (Technical) (One Post)
(No. 150/83)

Salary scale.—K£2,154 to 2,928 p.a. PENSIONABLE or AGREEMENT.

Applicants should possess at least the East African Certificate of Education or its equivalent and City and Guilds in one of the following:

Carpentry and joinery, cabinet making, tailoring upholstery and cushion making, blacksmith and welding, painting and decorating and soap manufacturing technology. Grade I certificate of final proficiency certificate in any of the trades mentioned above plus at least ten (10) years practical industrial or technical teaching experience in running a large industrial set-up at a grade not below Job Group "J" and must have a thorough knowledge of the following:

- (a) Administration and supervision of industrial production of various trades.
- (b) Government regulations and procedure related to stores, staff and financial control.
- (c) Ability to organize, co-ordinate and supervise activities in the industry, planning and advising on extension services and marketing the products produced within prison industries in the institution.
- (d) Ability in managerial and technical aspects to estimate, costs of industrial items with working method for estimating the qualities of materials required for each particular item. Programming monthly progress return of expenditure and progress of each order within the industry.

The successful candidate will be required to undergo three (3) months training at the Kenya Prisons Staff Training College. He/she will be directly responsible to Senior Assistant Commissioner of Prisons (industries) for the running of large industries in one of the provinces in Kenya Prisons Service, safe keeping of assets, its financial control, production, purchase of industrial raw materials and sale of products, control of all technical staff and planning and drawing up work programme for training of prisoners within prisons industrial section.

Inspector (Mechanical) (Two Posts) (Prisons) (No. 151/83)

Salary scale.—K£1,128 to 1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants must be in possession of Kenya Government Grade I Trade Test Certificate for motor vehicle mechanics or have passed either East African Examination Council for motor vehicle technicians course Part I and II or must have served as motor vehicle mechanic grade I for at least two (2) years. They must be fully conversant with the repair and overhaul of motor vehicles petrol and diesel engines and have knowledge of stationary power plants and be capable of running a small workshop without supervision. They should be capable of inspection and simple technical report writing and able to conduct correspondence—knowledge of stores, accounts and stock control will be of added advantage. Candidates should preferably be in possession of valid driving licences covering heavy commercial vehicles.

The successful candidates will be expected to serve in any province in Kenya where the ministry has workshops.

Entomological Field Laboratory Technologist (One Post)

Salary scale.—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants must be entomological field laboratory technologist or entomological field officers for at least six (6) years, three of which must be in Grade II Job Group "H". They must be well acquainted with the epidemiology and control of prevalent vector-borne diseases in this country. They should also have had experience of vector-borne diseases unit and should be able to plan and identify diseases problems in an area.

The successful candidate will be required to take charge of a large district or provincial division of vector-borne diseases unit or work under a scientific officer in a large field operational research programme.

Kenya Engineering Workers' Union
and

Datini Merchantile Limited

Issues in dispute:

Violation and failure to implement the wages general increase clause of 13 per cent with effect from 1st January to 31st December, 1980, as stipulated in the parties collective agreement.

Implementing the second year increment of 12 per cent on wrong figures after having violated the first year increment as it appears above.

THE Kenya Engineering Workers' Union shall hereinafter be referred to as the claimants and Datini Merchantile Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi, on 27th July, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 31st January, 1983, duly signed by the parties was received by the court on 11th May together with the statutory certificate signed by the Labour Commissioner.

The parties entered into a collective agreement on 2nd December, 1980, effective from 1st January, 1980, for a period of two years from that date. Under the clause covering wages minimum consolidated monthly wages are specified for the

various groups. Then in sub-clause (b) there is a provision for general wage increase reading as follows:

"Employees in the service of the company as at the effective date of the agreement shall be granted increments as follows:

With effect from 1st January to 31st December, 1980: 13 per cent.

With effect from 1st January to 31st December, 1981: 12 per cent".

The dispute before the court now on the interpretation of the above wages clause which the parties themselves negotiated and worded. The claimants' contention is that the respondents implemented the agreement wrongly as a result of which about eleven employees did not get the general wage increases of 13 per cent effective from 1st January, 1980.

The claimants also complained that because these workers did not get their first year 13 per cent wage increase the second year wage increase of 12 per cent was based on lower figures.

The respondents stated that employees earning below the established minimum were to be brought to the new minimum of KSh. 460 or given 13 per cent wage increase whichever was more favourable but they could not have both benefits.

The court has carefully studied the parties' submissions and notes that at the end of December, 1979, the employees involved in this dispute were earning KSh. 375. The respondents increased them on 1st January, 1980, and brought them up to KSh. 460. If they had given them 13 per cent wage increase then these employees would have gone up to KSh. 427.75 only. So these employees received an increase of KSh. 85 or 22.7 per cent as opposed to 13 per cent. This point is not disputed by the claimants but they maintained that these workers in June, 1980, were entitled to a wage of KSh. 456 by law and according to them the workers got only a KSh. 4 increase; obviously the claimants are not taking into account the fact that the respondents gave their employees a wage increase of KSh. 85 with effect from 1st January, 1980.

The court would like to point out that the parties' collective agreement has not clarified this point and it seems to be silent on it. One other point that will help come to the correct interpretation of this clause is the fact that employees in the respondents' service as at the effective date, i.e. 1st January, 1980, were to receive the 13 per cent wage increase on their 31st December, 1979, wages. The compensation to which they are entitled under the guidelines at that time would have given them a 16 per cent increase for a two-year period therefore if the claimants' interpretation is accepted then they would receive far more than the permissible limit under the guidelines. From KSh. 375 they were brought up to KSh. 460 giving them a wage increase of KSh. 85 or 22.7 per cent. If on top of that they were given another 13 per cent that would give them 35.7 per cent for the first year and another 12 per cent for the second year making in all a 47 per cent increase as against their entitlement of 16 per cent.

The court notes that the then general secretary who is the signatory to the agreement to this dispute did not query the implementation of the agreement. He appears to have accepted the implementation as carried out by the respondents.

The court also notes that the parties have signed another collective agreement which is effective from 1st January, 1982, for a period of two years under which the basic minimums have been again revised and further wage increases given.

The court has very carefully considered the submissions made by the parties and finds that in the absence of a clearly worded statement showing that the workers would be entitled where they are below the new basic minimums to have their salaries brought up to the new minimums and then granted additional general wage increases, the respondents' interpretation is correct. In the circumstances of this dispute the employees in employment were to benefit from either an increase in the basic minimum or if they were above that to the 13 per cent wage increase whichever was more favourable but not both. The claimants' demand is accordingly rejected. The court would like to add that the claimants were not quite right in stating that the workers had received only a KSh. 4 wage increase to bring them up to the new minimum. On 1st January, 1980, they brought up from KSh. 375 to KSh. 460.
