CAUSE NO. 32 OF 1983

Parties:

Kenya Engineering Workers' Union
and
Ndume Limited

Issues in dispute:

- Minimum wages.
- General wages increments.
- Effective date.

THE Kenya Engineering Workers' Union shall hereinafter be referred to as the claimants and Ndume Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 29th August, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 19th June, 1982, duly signed by the parties was received by the court on 24th May, 1983, together with the statutory certificate signed by the Labour Commissioner.

The parties' collective agreement which was being revised and gave rise to this dispute was for a period of two years from 1st May, 1979. So it expired on 30th April, 1981. The parties are agreed on the duration period of the agreement to be again two years but the effective date of the new agreement is in dispute. It is again a matter of great regret that the parties have asked the court to make award which in fact would be already expired and would mean that the parties would start negotiations for the next two years' collective agreement on its announcement. This is despite the fact that the parties held their first meeting on 15th July, 1981, and followed up with two meetings on 18th August and 21st September, 1981. At that stage they were unable to agree on nine items and on 2nd October, 1981, the claimants reported a trade dispute to the Minister for Labour. The conciliator's arranged meetings did not materialize but the parties with the F.K.E.'s help tried to settle the matter at their own level with the result that a few other items were also settled. Then there was a further delay when the claimants' general secretary wrote saying that he had agreed to settle the remaining issues with the respondents' managing director which statement the latter repudiated. The matter is now before the

court on the remaining items the parties having signed a deadlock agreement on 25th October, 1982.

The respondents are engaged in the manufacture of maize and flour *posho* mills and are based in Gilgil area out of eighty employees working for them, seventy-six are unionizable. The respondents pleaded that they had suffered a loss of £18,841 for the year 1982.

The D.M.P.D. report reveals that under the wage guidelines the workers are entitled to a wage increase of 9.25 per cent per year. As against this the claimants' demand for the two-year period is above the guidelines by 11.5 per cent and the respondents' offer for the same period is above the guidelines by 3.5 per cent.

The parties are also deadlocked on the issue of minimum wages.

At a meeting held on 7th October, 1982, the parties discussed and agreed on the following minimum excluding house allowance:

They, however, were not able to agree on a general wage increase.

At the same meeting the claimants had proposed an increase of 15 per cent for the first year and 10 per cent for the second year provided that the employees should first be brought up to the new minimums and then given the first year 15 per cent increase. The respondents did not accept this.

After careful consideration of all the submissions the court awards that the effective date should be 1st May, 1981, and that the award should be deemed to have been in force for two years from that date so that the parties will be at liberty to commence negotiations for revising it as soon as the award is announced.

The court awards that the minimum wages that the parties themselves agreed at a meeting of 7th October, 1982, should be effective from 1st May, 1981, and they should continue in force if they are not amended by the statutory order that came into force in August, 1982.

On the general wage increase the court awards that for the first year the workers should get a 15 per cent increase on their wages which they were earning on 30th April, 1981, and if some workers benefit by an increase due to the award on minimum wages the total increase for such employees should not be in excess of 15 per cent.

For the second year the court awards a wage increase of 12 per cent to all the employees on their wages which they were earning as at 30th April, 1982, and if any workers received further increases as a result of the statutory order with effect from 1st August, 1982, then those workers should get an additional $7\frac{1}{2}$ per cent wage increase over and above the statutory order.

2. The parties were heard in Nairobi on 21st February, 20th and 25th May, 20th and 22nd June and 11th August, 1983, and in addition to relying on their written and verbal submissions called the following witnesses:

S. Abuga.

Respondents:

N. H. Salyani.
M. E. Jin.

AWARD

3. The Notification of Dispute Form "A" dated 2nd March, 1982, duly signed by both parties was received by the court on 2nd November together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The Respondents manage Joint Aviation Fuelling Services at Jomo Kenyatta Airport (hereinafter referred to as the airport) for Agip, Mobil Oil, Total and themselves. The grievant worked for them as a clerk at the airport. At the material time three other persons working there were M. E. Jin, aviation superintendent, S. Abuga, acting shift supervisor and P. Abinya, shift supervisor.

The Kenya Pipeline Co. Ltd. supply the aviation fuel at the apron through underground connections and when any airline buys fuel at the airport from any of the member companies of the Joint Aviation Services a flight receipt in respect of fuelling of the aircraft is prepared with eight copies in all. These copies are distributed as follows:

- Two handed to flight engineer of the aircraft concerned.
- Two copies go to Kenya Pipeline Co. Ltd.
- One goes to customer's ground engineer and/or ground airline representative.
- Two to the oil company.
- One remains in depot office file.

It was the duty of Mr. Odhiambo as he was the clerk to distribute the flight receipts to various sections when he came on duty in the morning with the exception of the two copies to be handed to flight engineer of the aircraft concerned which was done by the shift supervisor.

Lufthansa had a contract with Air Total for their aviation supplies at the airport. On 18th September, 1980, Lufthansa flight No. LH541 was refuelling on Air Total's account at the airport and a flight receipt No. 2302 was completed for fuel supply by the acting supervisor on duty, S. Abuga. This flight receipt shows that 128,030 litres were refuelled between 0043 hrs. and 0104 hrs. midnight. That another transaction also took place immediately after this, i.e. that 13,030 litres were defuelled from the same plane commencing at 0105 hrs. and completed at 0125 hrs. For this defuelling transaction flight receipt No. 2303 was prepared. On this receipt 13,030 litres are cancelled and 9,819 is written at two places and in between these two entries under imperial gallons 2,160 is written. The entry of 13,030 has been altered to 9,819 at another place also on this receipt.

These receipts and the timings on them clearly show that the defueller KHD 456 must have been ready and already parked near the aircraft when refuelling started. Otherwise defuelling could not have commenced one minute after refuelling. The court was told and has no reason to doubt it, that the defueller is a very old model vehicle which is usually parked at the depot and when it is needed it is specifically sent for and it takes some time before it comes to the aircraft. Mr. Abuga while giving evidence admitted that he had altered receipt 2303 as he had written 13,030 by mistake. He said 9,819 litres were defuelled.

The Court would now like to move to flight receipt No. 2311 which has been altered to 2,302. The alteration is quite clear and visible to the naked eyes and this altered receipt has the same entries relating to 128,030 litres refuelling with some alterations to some of the figures. Receipt 2311 as a matter of fact was issued in the name of Swissair for refuelling 37,680 litres. The court would like to add that Swissair have made no complaint at all regarding any of their transactions. So somebody used their receipt 2311 by altering it to read 2,302 to make it appear the Lufthansa receipt which was issued on 18th September at midnight and for which another proper receipt 2302 had also been issued.

In October, Lufthansa station manager reported to Air Total that there had been something fishy in this transaction and he came and saw their depot and distribution manager, N. H. Salyani who told the court that the station manager had brought the original flight receipt No. 2311 which had been altered to 2302 and shown it to him that he had made a photocopy from that. He had also brought the copy of receipt 2302 which he claimed had been altered after the Lufthansa flight had left Nairobi. He demanded and was given a credit note for 13,030 defuelled litres with the result that Air Total claim that they lost 3,211 litres (the difference between 13,030 and 9,818 litres). It is most regrettable that the original altered document, i.e. 2,311 to 2,302 was not produced during the hearing which the court was told Lufthansa had but it could not be traced now as it had probably been destroyed. The court was shown only a photocopy. The claimants' advocate naturally very strongly objected to the production of this document and insisted that the original should have been produced. The court is of the view that the original would have been of great assistance in the case but surprisingly Lufthansa did not bother to keep the original knowing fully well that they had taken up this matter with Air Total and might come useful in some proceedings arising out of this transaction. To make matters worse for the respondents the handwriting expert who had carried out certain examinations of the following documents: a photocopy of Air Total flight receipt No. 2302 dated 18th September, 1980, a photocopy of Air Total flight receipt No. 2311 and five handwritten sheets, is also no longer in Kenya now and the respondents were not able to trace him. So there again in court is reluctant to look into his report which forms a part of the appendices to the respondents' submission as it would not be fair to the claimants to accept it in a situation where they would be deprived of cross examining the expert.

There is, however, evidence of the respondents' witnesses who say that at a meeting held soon after the Lufthansa had reported their suspicions the grievant after some arguments admitted that he had altered flight receipt No. 2311 to read 2302. He is alleged to have admitted signing it on behalf of S. Abuga and also admitted altering receipt No. 2303. Present at this meeting were Mr. Ndungu, the respondents' personnel manager, Mr. Rapp, their operational manager, Mr. Jin the superintendent and Mr. Salyani of Air Total. It is also alleged that at this meeting Mr. Abuga denied having altered receipt No. 2311 or 2302 or having signed them. It was alleged that he was very nervous and started crying. However the grievant the very next day repudiated his so called confession at this meeting and denied ever having admitted to have altered any of these documents and Mr. Abuga came to give evidence on behalf of the claimants during the hearing. He admitted that on flight receipt

No. 2303 he had made all the alterations and changed the figures from 13,030 litres to 9,819 litres and that he had also signed that receipt. The respondents claimed that at the said meeting Mr. Abuga had denied having altered this document but in view of his testimony on oath the court has no alternative but to accept what he says.

From the aforesaid critical analysis of the parties' submissions of the evidence tendered in support thereof, both through the witnesses and the documentary, it is quite obvious that without the active participation of Mr. Abuga who was on duty during the night Lufthansa refuelled at the airport and who prepared both the refuelling and the defuelling receipts and who had the defueller ready at the apron in the middle of the night in anticipation that it would be needed, this conspiracy could not have been hatched and succeeded. As it is, Mr. Abuga was promoted to full supervisor in March 1981. The management stated that they felt that he had been used in this conspiracy and was not the real culprit.

In the absence of the original flight receipt No. 2311 which had been altered to read 2302 and the handwriting expert the court finds it very difficult to come to the conclusion that Mr. Odhiambo had altered the flight receipt one of which Mr. Abuga on oath said that he, Mr. Abuga, had altered and initialled. The management, however, claimed that Mr. Abuga originally had denied having done that.

The court is also at a loss to understand how 3,211 litres which the respondents claim were defuelled from Lufthansa flight LH 541 were stolen. The excess fuel which the court was told cannot be used in the aircraft again but becomes kerosene had to be removed from a point between the airport and the depot. No evidence was produced to show what happened. Air Total produced no documents to show that they had in fact lost that much aviation fuel although they were quick to give Lufthansa the appropriate credit for these.

The court has no doubt that something sinister was afoot and the persons involved may or may not have spirited away 3,211 litres of defuelled aviation fuel and sold it as kerosene in the city. But in view of the vital missing links the court finds it very difficult to come to a conclusion one way or the other. The court has decided to give Mr. Odhiambo the benefit of doubt but considering all aspects of this dispute the court finds that as far as the respondents are concerned Mr. Odhiambo because of his alleged part in this fraud would be an undesirable employee the court is not inclined to award his reinstatement. Since he is merely getting the benefit of doubt the court does not intend to award a heavy compensation either. After careful consideration of all the submissions the court awards that the respondents should pay Mr. Odhiambo three months' salary by way of compensation. This compensation includes his pay in lieu of notice and should be given to him in addition to his other lawful dues like days worked and accrued leave.

The period for lodging notice of opposition may be extended by the registrar as he thinks fit and upon such terms as he may direct. Any request for such extension should be made to the registrar so as to reach him before the expiry of the period allowed.

Formal opposition should not be lodged until after reasonable notice has been given by letter to the applicant for registration so as to afford him an opportunity of withdrawing his application before the expense of preparing the notice of opposition is incurred. 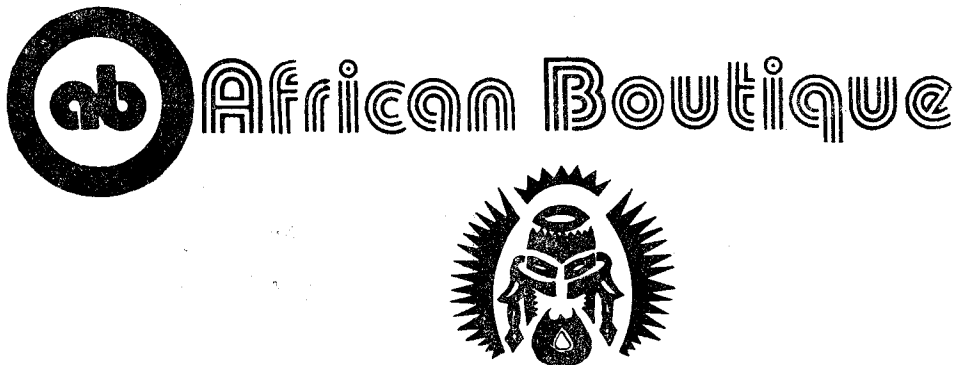

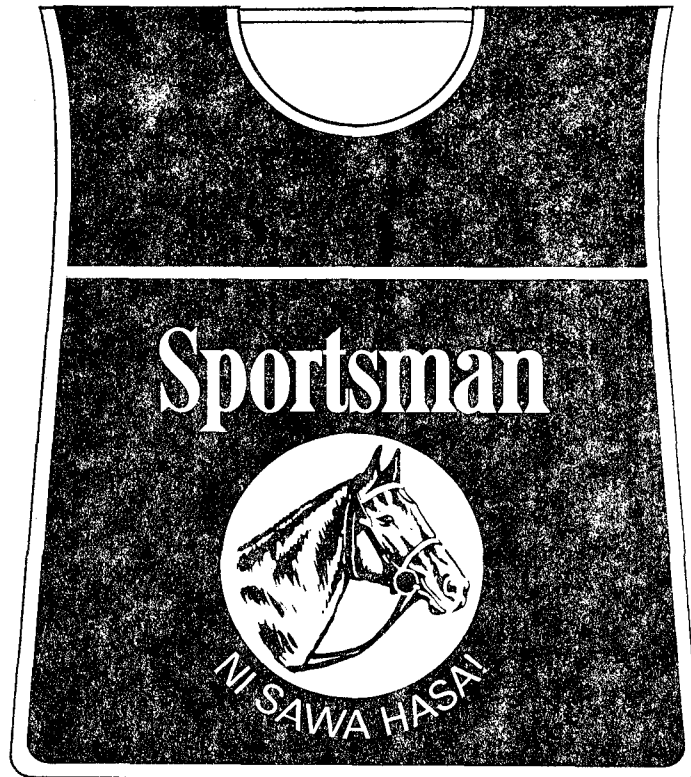
