THE WILDLIFE (CONSERVATION AND MANAGEMENT) ACT

CESSATION OF PART OF A NATIONAL RESERVE

IN ACCORDANCE with section 7 (2) (a) of the Wildlife (Conservation and Management) Act, the Minister for Tourism and Wildlife, gives sixty (60) days' notice, with effect from the date of publication of this notice, of his intention to declare that the area of land specified in the schedule shall cease to be a part of Marsabit National Reserve.

VACANCY OFFERED BY COMMONWEALTH

AGRICULTURAL BUREAUX, U.K.

APPLICATIONS should be made to the Permanent Secretary/Director of Personnel Management, P.O. Box 30050, Nairobi, so as to reach him not later than 8th November, 1983. Civil servants should submit their applications through official channels.

Post title.—DIRECTOR-GENERAL of the Commonwealth Agricultural Bureaux.

The Commonwealth Agricultural Bureaux (C.A.B.) is a corporate body supported and controlled by Commonwealth governments, through the executive council. Overall management of C.A.B.'s information, identification and biological control services is discharged by the director-general who is responsible to the executive council.

The director-general.—The director-general is responsible to the executive council for the overall management of C.A.B.'s activities. Three directors have immediate responsibility for the information, scientific and administration functions each reporting to the director-general.

Qualifications.—Ideally it would be desirable for the director-general to have—

- a broad background and record of achievement in agriculture or a related science and a demonstrated interest in information transfer;
- a proven record of leadership and management;
- knowledge and experience of international commercial activities relating to the field of information or publishing;
- an appreciation of the needs of developing countries;
- ability to promote C.A.B.'s services internationally at the highest level; and
- experience in supervising the preparation and negotiation of proposals for development assistance from funding agencies, a background in agricultural science would be essential in this connection.

Terms of appointment.—An appointment may be made on a "permanent" basis up to the retiring age of 60 and service could be extended on a year to year basis with the agreement of the executive council, up to the age of 65. Alternatively, secondment or a term appointment for about five years would be considered and may be extended with the agreement of the executive council.

Salary.—The position of director-general is one of the more important Commonwealth appointments. The salary would be in the order of £25,000 to £30,000 per annum, but this would be negotiable.

Taxation.—Under the agreement with U.K., C.A.B. is authorized to recover tax from staff for its own purposes. U.K. tax law is applied in order to determine the level of tax to be recovered from each employee.

Medical fitness.—The appointment would be subject to the provision of a medical certificate of fitness.

Termination.—Thirteen weeks' notice of termination would be given and required.

Annual leave.—Annual leave would be twenty-five (25) days initially, rising to thirty (30) days after 10 years' service.

Superannuation.—The director-general would be eligible to join the C.A.B. superannuation scheme. Alternatively, for a secondment or a term appointment, a contribution could be made up to an equivalent amount to maintain benefits in an existing scheme.

Travel allowances.—Appropriate travel and baggage allowances would be payable to cover the cost of moving.

Car.—A car would be available for the use of the director-general.

Note.—The post will become vacant in May, 1985, on the retirement of N. G. Jones, D.F.C., B.Sc., but a successor will be appointed in 1984, and the appointment may be taken up earlier than May, 1985, by arrangement.
