Applicants must be civil servants who are in possession of a good Kenya Certificate of Education or its equivalent and who have served in the grade of executive officer I, Job Group "J" for a minimum period of two (2) years. THE INDUSTRIAL COURT

(CAUSE NO. 35 OF 1983)

Parties:

Kenya Engineering Workers' Union
and
Narcol Aluminium Rolling Mills Limited

Issues in dispute:

Basic minimum wages.
General wage increase.
Leave travelling allowance.
Retirement benefits.
House allowance.
Effective date and duration.
Casual workers.

THE Kenya Engineering Workers' Union shall hereinafter be referred to as the claimants and Narcol Aluminium Rolling Mills Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi, on the 1st September, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 25th February, 1983, duly signed by the parties was received by the court on 24th May, together with the statutory certificate signed by the Labour Commissioner.

The parties signed a recognition agreement on 9th June, 1981, and the claimants forwarded their proposals for the first ever collective agreement between them on 23rd July, 1981. This was despite an assurance given by them to the respondents that a recognition did not mean an automatic rise in wages. They did not even wait for two weeks before submitting their proposals for what the respondents considered were demands for a big wage increase. Under these circumstances the court is not surprised that the matter dragged on for almost a year and it was not until 22nd July, 1982, that conciliation was concluded and the parties recorded a deadlock on the various issues. It must be said to the credit of the parties that they made yet another attempt in early, 1983, to resolve the outstanding issues which were twelve at that time and managed to settle another five leaving the seven in dispute before the court.

It is not disputed that the respondents are a relatively new organization as they commenced business in September, 1981. They vigorously pleaded that they were undergoing serious hardships which any infant industry has to undergo. Their main business is to manufacture aluminium circles and sheets and they depend solely on imported raw materials for their operations. The supply of raw materials was very erratic.

The claimants while maintaining that the respondents paid their employees in accordance with the legal rates demanded the basic wage rates to go up from the lowest at KSh. 480

to KSh. 550 and at the highest from KSh. 1,085 to KSh. 1,300 per month and they also included a rate for the supervisor at KSh. 2,000 per month.

In addition to this the claimants demanded that all the unionisable employees should get an 80 per cent wage increase. They maintained that the respondents' parent company Narshidas & Co., who are members of the Major Engineering & Allied Industries Employers' Association, paid their workers twice as much as proposed by the respondents.

The respondents pleaded that they could not afford to pay higher basic wages than their offer which was KSh. 510 per month at the lowest and KSh. 1,100 at the highest. They submitted that the supervisors were not subject to union negotiations.

On the general wage increase they made a nil offer. The court has carefully considered the parties' submissions and the D.M.P.D. report in making its award. The report reveals that if the period January, 1981, to 31st December, 1982, is considered relevant then the compensation under the guidelines would be about 35.5 per cent, but if the period was calculated from 1st June, 1981, to 30th June, 1983, then the compensation would be about 34.5 per cent, for the middle income and 25.4 per cent, for the lower income.

The court awards that for the first year of the collective agreement the basic wage rates as proposed by the respondents' should be the rates in force. For the second year period the court awards that the rates as demanded by the claimants should be in force.

On the general increase the court awards a 15 per cent wage increase for the first year provided that where employees benefit from an adjustment in the basic wage rate they should not get less than 15 per cent. Such workers, however, will not benefit from double increases. For the second year, however, the court awards another increase of 15 per cent, and rules that if any worker is earning less than the new basic minimum wage then he should first be brought up to the new minimum and then granted the 15 per cent wage increase.

House allowance.—The court awards a house allowance of 15 per cent of the workers' wages to be paid to them in addition to the wages.

Leave travelling allowance.—The court awards a leave travelling allowance of KSh. 125 for the first year and KSh. 150 for the second year.

Retirement benefits.—Withdrawn by the claimants.

Casual workers.—The court awards that if any employees work for the respondents on a casual basis for a continuous period of three months from the date of the court award then such workers should be converted to permanent employment.

Effective date and duration:

Since this is the first collective agreement between the parties the court awards that the effective date should be 1st December, 1981, and that it should remain in force for a period of two years from that date. The court would like to point out that the claimants forwarded their proposals to the respondents on 23rd July, 1981.

On the question of wage rates for the supervisors the court has decided to defer this matter in view of the very contradictory submissions made by the parties concerning their status. Moreover, the supervisors appear to have lost their jobs and the matter is being investigated by the Ministry of Labour. In these circumstances the court feels that it should neither reject the claimants' demand nor accept the respondents' submission and hopes that when the next collective agreement is being revised the parties will be able to approach this issue realistically.

Finally for ease of reference the court awards the following wage rates effective from 1st December, 1981, and 1982.

Issue in dispute:

Terminal benefits for Justus Muita.

THE Kenya Engineering Workers' Union shall hereinafter be referred to as the claimants and Stainless Steel Products Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 12th September, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 22nd April, 1982, duly signed by the parties was received by the court on 3rd June, 1983, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

In this dispute there are really two firms which are involved, namely Thika Cloth Mills Limited (previously known as Nath Brothers Limited) and the respondents. Mr. Muita started his employment with Nath Brothers Limited on 5th July, 1965, and was taken over by Thika Cloth Mills Limited.

It is not disputed that Thika Cloth Mills Limited and the respondents are sister companies as they have common directors. In law, however, they are two separate business entities. Furthermore, their industries are different, they deal with two different trade unions and have in operation two different collective agreements.

With this background the claimant was verbally told to go on transfer to the respondents by the management of Thika Cloth Mills Limited. Although the date of transfer is in dispute the fact remains that Thika Cloth Mills Limited confirmed in writing this transfer in the following words addressed to the claimant on 21st December, 1974:

"We confirm your transfer from Thika Cloth Mills Limited to Stainless Steel Products Limited, with effect from 30th April, 1973".

The court is astounded at this because if the two companies are really different then how could one company transfer its employee to another company, i.e. the respondents? The court

is satisfied that this was an internal arrangement between the two companies and the claimant was really transferred, otherwise, both Thika Cloth Mills Limited and the respondents with all the professionals in their employment would certainly have taken steps to ensure that the claimant received all his dues from Thika Cloth Mills Limited and taken up employment afresh with the respondents. This was not done and he was merely transferred. Now during the hearing the respondents are relying on the legal technicalities but the court must point out that the workers are not really aware of these nice legal distinctions and therefore as far as the claimant is concerned he genuinely understood and accepted that he was being transferred to work for the respondents.

This point having been disposed of the court would now like to deal with the claim. The claimant claims that he was forced to resign under pressure by the respondents which he did on 5th October, 1977. The respondents, however, denied that there was any pressure on him to resign. In the collective agreement at the material time between the parties there is a clause on redundancy being No. 12 where it is stated under paragraphs (e) and (f) as follows:

"e. A severance pay of fifteen (15) days wages for every completed year of service will be paid.

f. Paragraph (e) above will also apply to any employee who resigns from service after serving for a continuous period of five (5) years."

The claimant put forward a claim of KSh. 13,934 made up as follows:

The respondents are strongly resisting this demand on the grounds that he was a non-unionizable employee and that he had not worked for them for twelve (12) years as they refused to give him credit for his previous years of service with Thika Cloth Mills Limited and maintained that offer on 3rd January, 1978, of paying him some gratuity stands withdrawn. The court notes that in this offer the respondents told him that although he was a member of management and not subject to the collective agreement but because he had worked for a sister company for some time the respondents had decided to exceptionally pay him for the period he had worked for them only.

The court having ruled that as far as the claimant was concerned he was transferred from one company to another; the court finds that it is only logical that he should carry with him the years of service which he had rendered to Thika Cloth Mills Limited to the respondents. It was up to Thika Cloth Mills Limited to terminate his employment with them and up to the respondents to take him as a new employee if that is what they had intended to do. Instead they failed to do so and confirmed that they transferred him from one company to another. If Thika Cloth Mills Limited had wanted to declare the claimant redundant at that time then they would have been required to pay him severance pay on redundancy, probably they wanted to avoid paying him that hence the transfer and now the respondents and their sister company, i.e. Thika Cloth Mills Limited want to get out from recognizing his previous years of service with Thika Cloth Mills Limited. The court cannot and will not allow such manoeuvres by employers to deprive their workers of their legitimate dues to succeed notwithstanding the legal technicalities and niceties.

In the absence of a clear letter of appointment telling the claimant that he was a member of the management and not subject to the collective agreement, the court must overrule the respondents on their submissions that he is not entitled to any benefits in the union-negotiated collective agreement. In any case the question of who is management and who is not management is the subject of hot debate in the country just now and has not been finalized one way or the other. The court has very carefully considered all the submissions and finds that the respondents are liable to pay the claimant gratuity not only for the years of service he rendered to them but also the years of service he rendered to Thika Cloth Mills Limited and previous to that Nath Brothers Limited which he is deemed to have brought with him to the respondents as he was transferred and not taken on as a new employee. The court accordingly awards that the respondents should pay the claimant KSh. 13,934 as specified above. It is up to the respondents and Thika

Cloth Mills Limited to apportion between them what share each has to pay towards this claim. As far as the claimant is concerned the respondents should pay him this amount forthwith.

2. The parties were heard in Nairobi on 7th September, 1983, and in addition to relying on their written and verbal submissions called the following witnesses:

AWARD

3. The Notification of Dispute Form "A" dated 27th August, 1980, duly signed by the parties was received by the court, on 21st June, 1982, together with the statutory certificate signed by the Minister for Labour and the Labour Commissioner. The hearing of this dispute was adjourned four times at the claimants request or because of default on their part.

The grievant worked for the respondents from 2nd October, 1978, up to 15th December, 1979. It is not disputed that his services were terminated verbally. It is further not disputed that no warning letter was issued to him during this period of employment with them.

The respondents maintained that they had decided to terminate his services because of various shortcomings and careless performance of duty on his part like overspeeding in the town, driving carelessly causing an accident at Ruaraka, where he damaged somebody's house, slow working to obtain overtime, not using enough discretion when on job and bringing unnecessary arguments, stopping and leaving vehicle in the middle of the road while purchasing his personal items, driving a vehicle at night without spare wheel and without lights for which he was fined KSh. 100 and so on.

During the hearing the grievant admitted that he had damaged somebody's house at Ruaraka, but stated that he paid for the damage and he also admitted having been fined KSh. 100 for overspeeding and on another occasion for driving without lights although there was nothing wrong with the lights.

The claimants have rested their case on the warning system clause in the collective agreement and vigorously submitted that the respondents should have utilized this clause in full before deciding to terminate Karanja's services. They also criticised the Ministry of Labour investigator for not having interviewed the grievant during investigation and asked the court to reinstate him back to his job as a warning to employers who do not follow the provisions of the collective agreements seriously.

The ministry found that Mr. Karanja was not an efficient employee considering the amount of damage that he caused the respondents within such a short period of his employment. On the other hand the respondents did not give a charge to improve himself by not issuing him warning letters. The investigator further found that Mr. Karanja did not deny the respondents' allegations and the ministry recommended that he should be paid only the terminal benefits as a way of settling this dispute as his termination was justified.

The court has no reason to doubt that Mr. Karanja was an inefficient employee but fails to understand why the respondents did not resort to clause 16 on warning system in the collective agreement. The court would like to emphasize that the warning system has been introduced in the collective agreements for the specific purpose of trying to improve the work performance of those employees whose output falls below the employers

expectations. The idea is to give the worker every chance to improve himself before he gets the extreme penalty of being dismissed. The respondents obviously failed in this regard and instead relied on the termination of employment clause in the collective agreement. The court has already covered this point in various previous awards and does not intend to go into it again. Suffice it to say that where an employee does not deserve summary dismissal then an employer is well advised to resort to exhausting the provisions of the warning system which the respondents failed to do in the present case. To make matters worse they handed him a verbal termination. The employers should realize that it is in their own interest that such steps are taken in writing even if technically they are not required to give a written notice because it can be difficult for them to prove such verbal notices.

The court has carefully considered all aspects of this dispute and bearing in mind the ministry's findings and recommendation has come to the conclusion that this particular employee was indeed inefficient but then the respondents are also at fault in not giving him warnings as required under the collective agreement. In these circumstances the court finds that although the respondents are at fault the grievant does not deserve a heavy compensation as he worked for them for only one year and that also very inefficiently. The court awards that in addition to the one month's notice pay, wages for days worked, overtime, any leave due and leave travelling allowance the respondents should pay him another two month's wages only by way of compensation for the wrongful dismissal that he has suffered in that the employer did not give him the required written warnings. The court would like to add that the grievant is getting this award only because the employer technically defaulted. Had the respondents strictly observed the warning system it is most unlikely that the grievant would have received any compensation from the court.

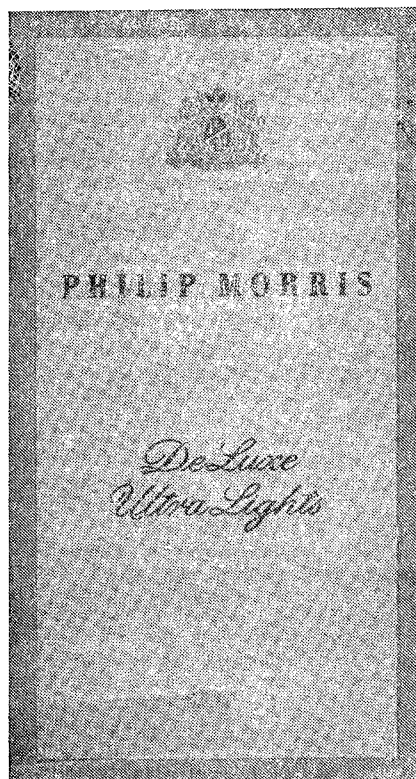

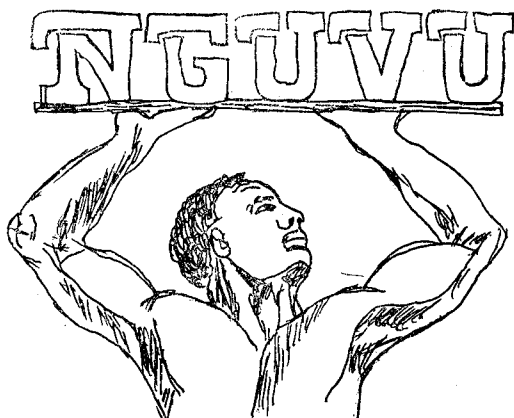
