Category and level.—Professional category (P-4).

Organizational location.—Interpretation division, bureau of conferences, languages and documents.

Duties and responsibilities.—Under the supervision of the chief of the interpretation division, the incumbent is responsible for—

1. interpreting, by both consecutive and simultaneous methods, at meetings of all types to which he or she is assigned, into French or English, and into Russian, and from these three working languages;

2. managing, co-ordinating and supervising, as head of team, teams of freelance interpreters at meetings both at headquarters and in the field;

3. training of interpreters and preparing of technical glossaries and documents for meetings;

4. assisting as required, in the office of the chief of interpretation division, in various administrative tasks, such as prospection and recruitment of freelance interpreters, compilation of statistics, etc.

## Qualifications and experience required:

1. University degree or equivalent qualifications and experience; wide general culture.

2. Excellent knowledge of English, French and Russian; knowledge of other languages useful.

3. At least five years' experience of conference interpretation, preferably in the UN system; proven ability as interpreter.

4. Qualities of leadership and good team spirit essential.

5. Readiness to accept responsibility and to travel.

2. Supervision of the science in the contemporary world section of the division of scientific research and higher education.

3. Keeping abreast of the most significant developments relating to the interaction between science, society and technology through conferences, publications and personal contacts.

4. Planning, arranging and supervising, in collaboration with the office of public information, multi-media treatment of Unesco's activities in the natural and engineering sciences.

5. Performing any other related duties as may be assigned.

## Qualifications and experience required:

1. University degree(s) in science or engineering, coupled with wide scientific and technical knowledge and experience in editing, publishing or audio-visual production dealing with science and public affairs.

2. Excellent knowledge of English and French, with capacity to draft and edit easily in one of these languages; knowledge of a third language is desirable.

3. Ability to conduct sensible interviews with influential personalities and to enlist these in the endeavours of Unesco's major programme dealing with science, technology and society.

Salary and allowances.—Initial appointment will be at P-5 grade with a net salary equivalent to US\$33,318 (US\$30,776 if without dependants) per annum, payable mainly in French francs, plus the prescribed annual allowances, e.g. post adjustment, at present US\$13,040 for staff members with dependants, US\$12,048 for staff members without dependants, family allowances of US\$700 for each dependent child (if there is no dependent spouse, this indemnity is not payable in respect of the first dependent child). Category and level.—Professional category (P-5).

Organizational location.—Africa section, division of operational programmes science sector.

Duties and responsibilities.—Under the authority of the director of the division and the supervision of the chief of the section, the incumbent will—

1. prepare, in close liaison with the chief of the section, scientific and technical projects financed under U.N.D.P. resources, funds-in-trust arrangements and other extra-budgetary sources, involving both research and training activities in science and technology and their application to development; this will be done in collaboration with the different divisions responsible for the regular programme of the science sector, the regional office of science and technology for Africa as well as Unesco representatives in the region;

2. collaborate with specialists from the regular programme divisions of the science sector who are familiar with the substance of these projects, especially in the preparation of job descriptions, the selection of experts and equipment, the examination of reports and evaluation missions;

3. ensure effective supervision and efficient implementation of operational projects and to this end undertake regular reviews of projects and assessment of project staff under his responsibility in close consultation with the chief of the section;

4. participate in Unesco task-force meetings and exploratory and evaluation missions with a view to elaborating interdisciplinary projects in countries of the region to be financed from extra-budgetary sources;

5. participate in the preparation of the sector's contribution to country programmes and prepare whatever comments are necessary in this regard in respect of countries or organizations of the region as may be entrusted to him;

6. participate actively in the preparation of country files containing information on the state of research and training in science and technology in each country of the region as may be entrusted to him;

7. assume responsibility for the conduct and supervision of the activities of the section as may be required from time to time;

8. carry out any other related duties as may be assigned to him.

*Qualifications and experience required:*

1. Ph.D. or equivalent in a branch of sciences or technology.

2. Experience in the negotiation, organization and implementation as well as management of operational projects in the field under bilateral or multilateral financing (applied studies, research centres, higher educational establishments), and good knowledge of the administration of international programmes.

3. Experience in preparing overall programmes, technical memoranda, final reports, etc., concerning matters related to the incumbent's specialty.

4. Working experience in Africa as well as proven administrative ability at a high level in government or scientific and technological institutions.

5. Very good knowledge of French, and a good working knowledge of English.

*Category and level.*—Professional category (P-5).

*Duty station.*—Regional unit for the social and human sciences, Regional Centre for Higher Education in Latin America and the Caribbean (CRESALC), Caracas, Venezuela.

*Duties and responsibilities.*—Under the direct authority of the director of CRESALC, and under the supervision of the assistant director-general for the social and human sciences, the incumbent will be responsible, within Unesco's plan for decentralizing its activities concerning the social and human sciences, for keeping in continuous touch with philosophers and specialists in the social and human sciences, their associations and their representative bodies in the region; he will assist member states that wish to build installations for the social and human sciences in their universities and research institutes and to develop their training capacity, their documentation services and exchanges and co-operation in the relevant fields; lastly he will apply himself to improving regional co-operation and to advising on means of promoting, at the regional and national level, studies relating to philosophy or to the social and human sciences. He will be specifically required—

1. to take the necessary measures, in close consultation with the various divisions and specialists concerned at headquarters, to provide the planning, co-ordination and implementation of Unesco's programme concerning the social and human sciences in Latin America and Caribbean; in particular, to encourage and promote effective participation in that programme by all the member states concerned, by their national commissions and other competent institutions, and by the competent regional organizations and associations, whether governmental or non-governmental (such as FLACSO, CLACSO, CSUCA, CARICOM, SELA or the Caribbean institute for higher education);

2. to maintain close working relations with other organizations of the United Nations system, particularly the resident representatives of the United Nations Development Programme, the competent regional commission of the United Nations and the United Nations agencies;

3. to serve as adviser for the social and human sciences to the director of CRESALC, especially in the following areas: Programmes relating to social and human sciences policy, social and human science studies concerning the environment, and teaching programmes centred on integrated rural development;

4. to participate in devising and formulating Unesco's draft programmes and budget in all matters concerned with the development of the social and human sciences and philosophical studies in the region;

5. to perform such other functions, in his specialized field or in related fields, as may be assigned to him by the assistant director-general for the social and human sciences.

*Qualifications and experience required:*

1. Specialization in a branch of the social and human sciences, preferably economics, political sciences, sociology, social anthropology or psycho-sociology, and a general knowledge of other disciplines, particularly philosophy; he should be familiar with social and economic planning, problems of development and of the environment, population questions, youth problems, the defence of human rights and of peace, rural and urban development and similar matters.

2. A good knowledge of the cultures and societies of the Latin American and Caribbean region and some experience of several countries, if possible in different sub-regions of the continent; and of other parts of the world would be an additional advantage.

3. An experienced organizer and manager, capable of running extensive research and training programmes comprising projects and exchanges of documentation, the candidate should know from experience the life, management and development of universities; practical knowledge of a national or an international administration would be a considerable additional asset.

4. Discretion and tact, ability to negotiate and to work in a team, initiative and drive.

5. A very good knowledge of Spanish and of English or French and ability to write clearly and concisely in two of these three languages; good practical knowledge of the third language. Knowledge of Portuguese would be an additional advantage.

*Duration of appointment.*—Two years, in the first instance, renewable.

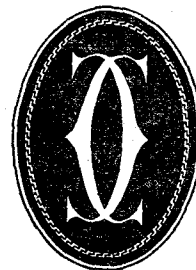

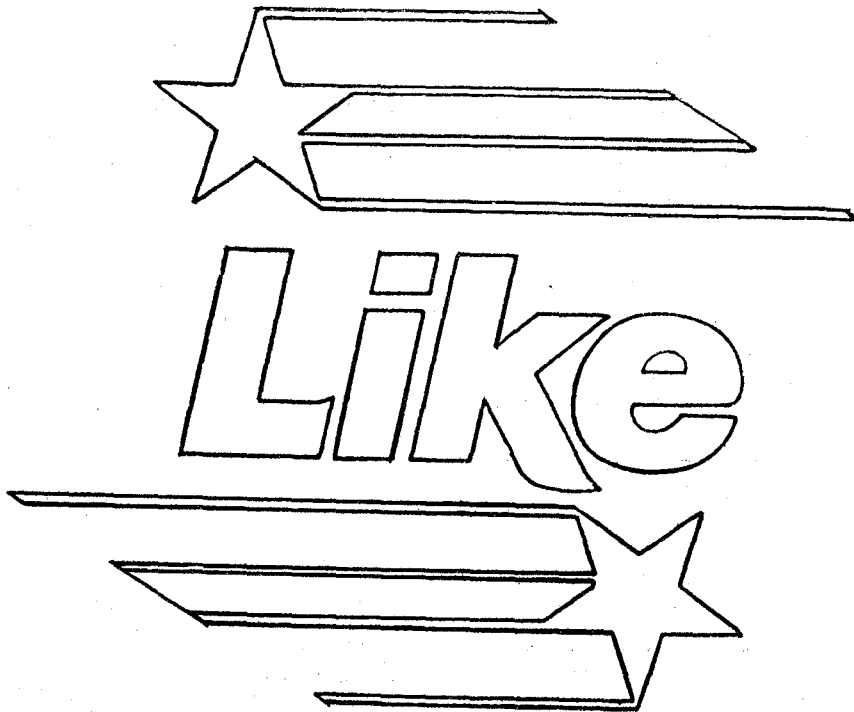
