THE CENTRAL BANK OF KENYA ACT
(Cap. 491)

REGULATION OF INTEREST RATES OF SPECIFIED BANKS AND SPECIFIED FINANCIAL INSTITUTIONS

IN EXERCISE of the powers conferred by section 39 of the Central Bank of Kenya Act, the Central Bank of Kenya has determined the following to be the maximum and minimum rates of interest which specified banks and specified financial institutions may pay on deposits and charge for loans or advances:

1. The maximum rate of interest which specified banks may charge for loans or advances shall be 15 per cent per annum calculated on a reducing balance method, with monthly rests.
2. The maximum rate of interest which specified financial institutions may charge for loans or advances shall be 20 per cent per annum calculated on a reducing balance method, with monthly rests.
3. The rates of interest mentioned in paragraphs 1 and 2, above, shall include service charges, commitment fees, negotiation fees, application fees, documentary fees, appraisal fees, front-end fees and all other sundry charges or fees imposed or charged on a loan or an advance by a specified bank or a specified financial institution.
4. The minimum interest rates which specified banks or specified financial institutions may pay on deposits shall be 12½ per cent per annum.
5. This notice shall be deemed to have come into force on 1st November, 1983, and shall apply on any deposit, loan or advance outstanding on the books of any specified bank or specified financial institution on or after that date.

Salary scale.—K£2,154 to 2,928 p.a. PENSIONABLE or AGREEMENT.

Applicants must be Kenya citizens with a minimum of 2nd class bachelor of science degree in forestry from a recognized university, with a minimum of three (3) years working experience in silvicultural research, and post-graduate training at least at the MSc. level.

The successful candidate will be expected to direct and implement silvicultural research, collect research data for publication and management information and advise field officers on appropriate forestry practices.

Wood Engineer (One Post) (No. 200/83)

Applicants should be Kenya citizens with a bachelor of science degree mechanical or structural engineering from a recognized university, and must have an aptitude for carrying out research and promotion of wood technology.

The work consists of establishing engineering properties of various Kenyan grown timbers from results of laboratory tests and developing information on working stress for application in timber engineering designs. The successful candidate should be able to carry out his work in co-operation with colleagues in related disciplines with minimal professional supervision. He will be expected to provide on-the-job training of technicians and technologists.
