THE INDUSTRIAL COURT CAUSE NO. 68 OF 1983

Parties :

Kenya Union of Commercial Food and Allied Workers and

Gailey & Roberts Ltd.

Issues in dispute:

Wages and salaries. House allowance.

Working hours for watchmen.

Annual leave.

Leave travelling allowance.

Sick leave.

Retirement benefits (gratuity). Trade test.

Protective clothing.

Tools loan and allowance.

Medical expenses reimbursement.

Transport from place of work to residential homes.

THE Kenya Union of Commercial Food & Allied Workers shall hereinafter be referred to as the claimants and Gailey & Roberts Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 10th November, 1983, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 14th March, 1983, duly signed by the parties was received by the court on 18th July together with the statutory certificate signed by the Labour Commissioner.

The parties' collective agreement which is being revised was effective from 1st September, 1980, for a period of two years from that date. It was based on an Industrial Court award in cause No. 33/81.

The respondents asked the claimants to submit proposals for revising it on 10th May, 1982, thereafter the parties held negotiation meetings in September after which conciliation proceedings commenced and although at some stage deadlock was recorded and the Notification of Dispute Form "A" was in the process of being completed, the Ministry of Labour made another attempt to solve the dispute. As a result of these efforts the dispute was referred to the court on the aforesaid twelve items. However, before the commencement of the hearing the claimants informed the court that they had withdrawn the following four items:

Working hours for watchmen.

Sick leave.

Trade test.

Transport from place of work to residential homes.

The parties' submissions were forwarded to the Division of Manpower Planning and Development for an analysis vis-d-vis the guidelines and its report was available to the court and the parties during the hearing.

The claimants have based their case mainly on the guidelines but have argued that since 95 per cent of the respondents' employees are in the middle income bracket in terms of guideline 4 (a) they should be considered "the lower paid groups" and therefore should be entitled to full compensation for cost of living instead of three-fourths as allowed by the guidelines. The claimants submitted that the cost of living for the middle income carners had gone up by 45 per cent and for the upper income 34 per cent. They demanded the following wage increases spread over a period of two years:

They argued that the respondents were a profit-making organization and there was no question of their not being able to meet the claimants' demand and alleged that 84 management staff received salary which was equivalent to the total salary of the 484 unionizable employees.

The respondents pleaded that all the areas of their operations had been badly affected by the country's severe economic recession compounded by critical shortages of foreign exchange earnings resulting in import restriction and lack of ready cash due to poor export commodity prices in the world market. The respondents' three major areas of business are:

Sale of imported capital machinery and equipment.

Provision of imported spare parts for the machinery sold. Provision of back-up maintenance and repair service to customers.

They referred the court to the marked decline in the building and construction industry and vigorously pleaded with the court to take into account that their sales of capital equipment has seriously continued to decline and machinery imported as long ago as four years had remained without a buyer. This had created liquidation problems which had no solution in sight. The accumulative effect of all this was that their business capacity and staff are becoming increasingly and in some cases grossly underutilized.

The court has taken into consideration the vigorous submission made by both the parties and the very comprehensive report prepared by the Division of Manpower Planning and Development before making the following award: *Wages*

As against the claimants' demand which have already been set out hereinabove the respondents proposed the following increases:

The court can see no reason why the respondents should not give their employees their full entitlement under the guidelines. The court awards that the respondents should give the following wage and salary increases:

The claimants' demand on house allowance is as follows: KSh.

The respondents have offered to increase the existing house allowance in accordance with guideline 4 (b) (i) as follows:

The claimants have relied on Guideline 5 which requires the court to decide the basic minimum standard of the workers and argued that the existing house allowance from KSh. 94 to KSh. 259 was below the basic minimum house rent costs.

The court notes that prior to the collective agreement which is being revised the workers used to earn a consolidated wage and it was only with effect from 1st September, 1980, that the workers received a separate house allowance. This was in addition to the housing element in the consolidated salaries and it was worked out on a basis of 10 per cent of the workers' salaries. The court cannot freely use Guideline 5 to increase labour costs to a point where it can seriously affect the financial viability of an employer. After careful consideration of all the submissions the court awards that the current house allowance should go up by the following amounts:

Annual leave.—The court awards that the current entitlement of twenty-two working days should be increased to twenty-four working days leave in any twelve months.

Leave travelling allowance.--The court awards that all employees who joined the respondents after 1st August, 1964, should get a leave travelling allowance of KSh. 525 and those who joined it before 1964 should get a leave travelling allowance of KSh. 825.

Retirement benefits.—After careful consideration of the parties' submissions the court while bearing in mind the current provisions has decided not to vary it. At present the employee on retirement is entitled to:

"N.S.S.F. dues-his own contributions to the company's provident fund.

Company's contributions to the provident fund or the equivalent of sixteen days' pay for every completed year of service whichever is greater."

Protective clothing.—The claimants' demand under this item is for the provision of boots for the employees in the service workshop as part of the protective clothing. They stated that workers in this workshop were open to danger of heavy objects dropping on their feet and they also run the risk of stepping on oil and grease. They demanded that the respondents should pay for boots for these employees when they were on duty.

The respondents dubbed the claimants' demand speculative and argued that protective clothing was a matter regulated by statutory provisions contained in the Factories Act.

The court notes from the D.M.P.D. report that the nature of the work in the workshop dictates that the respondents' employees should have protective clothing including safety boots: further that the respondents provided boots in 1982 at a cost of KSh. 250 per pair. Over three-quarter of employees never opted to buy them because they were too expensive. In fact most of the workers wear ordinary shoes which could easily be pierced through by sharp objects in the workshop.

The court cannot take highly remarks made by the D.M.P.D. and has decided that the factory inspectorate should give their attention to this matter as protective clothing is a matter regulated by statutory provisions contained in the Factories Act. The court therefore makes no award on this issue for the time being.

Tools loan and allowance.—At present the following tool allowances are paid per month to workers using their own tools. These allowances have been in existence for the last fifteen years:

The claimants demand these allowances to go up to KSh. 50, 70 and 160, respectively. They also demand that the respondents should give loans to the employees in order to buy tools. The respondents argued that the recognition agreement precluded this item from being negotiated in the collective agreement and that was at their own discretion.

The court finds that this is a negotiable item and awards that the existing tools allowance should be increased to the following figures:

Medical expenses reimbursement.—The claimants are demanding that the respondents should meet not only the cost of medical expenses of their employees but that they should also extend this benefit to their families and reimburse expenses incurred by the employee and his family. The respondents pointed out that they run a fully equipped dispensary in Nairobi which is manned by a fully qualified medical assistant. They also retained a fully qualified doctor who is always available to deal with serious cases of illness and also visits the dispensary once a week. In serious cases the employees are referred by the company doctor to government hospitals. They asked the court to reject this demand.

The court has carefuly examined this particular demand and feels that the parties should seriously consider the claimants' demand for extending the medical benefits to the workers' families progressively in stages during the next revision of the collective agreement. This will no doubt depend on the circumstances prevailing at that time. In the meantime this demand stands rejected.

- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-Kenya Gazette

"D.14.(1) Communications for the Kenya Gazette should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.
