VACANCY OFFERED BY AFRICAN REGIONAL CENTRE FOR TECHNOLOGY

APPLICATIONS are invited from suitably qualified candidates for the post of deputy executive director.

Title of post.—DEPUTY EXECUTIVE DIRECTOR.

Duty station.—Headquarters of the centre, Dakar, Senegal.

Qualifications.—A candidate for the post of deputy executive director must:

- (a) Be a national of a member state of the Organization of African Unity.
- (b) Possess a post-graduate university degree in engineering, applied science or related discipline.
- (c) Have a minimum of eight years' post-qualification experience including senior positions of responsibility in the development of technology and its application to socio-economic development.
- (d) Possess considerable experience in the administration and management of a technological organization.
- (e) Have experience in institution building in the field of technology.

Duties and responsibilities.—The deputy executive director assists the executive director of the centre in the organization, direction and administration of the secretariat. He assists the executive director also in the co-ordination and supervision of programmes and projects, and acts on behalf of the executive director in his absence. In addition to the foregoing, the duties of the executive director which the deputy executive director may be called upon to assist the former in discharging, include—

- (a) service and assistance to the organs of the centre in the performance of their functions;
- (b) the functioning of the centre and its continuous examination where appropriate;
- (c) periodic preparation of the centre's draft work programme and corresponding budget for the consideration of the executive board;
- (d) preparation of periodic reports on the activities of the centre including financial statements on income and expenditure;
- (e) execution of the work programme of the centre and its co-ordination with that of such other institutions interested in the objectives of the centre as the executive board may determine;
- (f) perform such work, studies and activities relating to the objectives of the centre as may be assigned to the centre by the council or the executive board.

Salary.—In the range of US\$23,996 to 25,844 per annum (tax free).

Other benefits.—Dependency allowance, housing allowance, educational allowance, post adjustment.

Term of office.—Three years initially with possibility of extension.

1. Title.—PROGRAMME SPECIALIST.

Post No.—ED-520.

Category and level.—Professional category (P-5).

Organizational location.—Science education section, division of science, technical and vocational education, education sector.

Under the supervision of the director of the division, the incumbent will be responsible for the planning and execution of Unesco's programme in the field of physics education:

(1) Promote activities aiming at the international exchange of ideas and information on the improvement of physics education, through a programme involving such things as surveys, publications, meetings, etc.; at continuing innovation in physics education, through activities directed towards the development of relevant content, new methods and materials including low-cost instructional materials for physics education and related teacher training; and at the development of out-of-school and non-formal activities in physics education.

(2) Assist member states, at their request, in the formulation and execution of projects for the improvement of physics education.

(3) In connection with items 1 through 2 above, foster the development of close working relationships with institutions and organizations—national, regional and international—that are active in the improvement of physics education.

(4) Provide to other units within Unesco advice in connection with the physics education components of their projects, including the selection, briefing and supervision of field experts in physics education.

(5) Undertake such other duties as assigned by the director.

Qualifications and experience required:

- (a) Advanced university degrees (normally at Ph.D. level or its equivalent) in physics education or physics and a diploma in education.
- (b) International reputation as judged by publications, consultancies, international meetings attended, etc.
- (c) Wide experience in physics education including development of instructional materials and teacher training.
- (d) Familiarity with the special conditions and problems of physics education in developing countries.
- (e) Experience in the organization and conduct of meetings, preparation of reports, etc.
- (f) Excellent knowledge of French or English and working knowledge of the other; familiarity with other working languages of Unesco would be an asset.

Salary and allowances.—Initial appointment will be at P-5 grade with a net salary equivalent to US\$33,318 (US\$30,776 if without dependants) per annum, payable mainly in French francs, plus the prescribed annual allowances, e.g. post adjustments, at present US\$11,881 for staff members with dependants, US\$10,977 for staff members without dependants, family allowances of US\$700 for each dependent child (if there is no dependent spouse, this indemnity is not payable in respect of the first dependent child). These emoluments are normally all direct taxation. Income tax on such remuneration, if levied, is reimbursed in accordance with staff regulations and rules.

2. Title.—PROGRAMME SPECIALIST.

Post No.—SS-913.

Category and level.—Professional category (P-4).

Organizational location.—Population division, sector of social sciences and their applications.

Duties and responsibilities.—Under the direct supervision of the director of the population division, the programme specialist will assist in the planning, implementation and evaluation of operational population information and communication projects, at global, regional and national levels. The programme specialist will in particular—

- (a) provide technical and administrative backstopping to operational projects at national, regional, and global levels;

- (b) liaise with social sciences and communication centres/institutions with a view to their involvement in population and development policies and programmes;

- (c) prepare manuals guide/books, handbooks on various aspects of population communication and specifically for training purposes;

- (d) assist in the conception and realization of training and motivational media materials in support of population/development programmes;

- (e) undertake such other related tasks as may be assigned from time to time.

Qualifications and experience required:

- (a) Postgraduate degree, preferably Ph.D. or doctorate in sociology of communication.

- (b) Good knowledge of population policies and programmes in developing countries.

- (c) Proven organizational and managerial ability in developing and implementing operational population/development communication projects.

- (d) Excellent knowledge of English and French with ability to draft in both languages. Knowledge of Arabic an asset.

Salary and allowances.—Initial appointment will be at P-4 grade with a net salary equivalent to US\$27,612 (US\$25,672 if without dependants) per annum, payable mainly in French francs, plus the prescribed annual allowances, e.g. post adjustment, at present US\$9,958 for staff members with dependants, US\$9,251 for staff members without dependants, family allowances of US\$700 for each dependent child (if there is no dependent spouse, this indemnity is not payable in respect of the first dependent child). Category and level.—Professional category (P-3).

Organizational location.—Planning and administrative unit bureau of conferences, languages and documents.

Duties and responsibilities.—Under the authority of the chief of the planning and administrative unit, the chief of operations control is responsible for—

- (1) the general supervision of production planning in accordance with the timetables drawn up, any priorities fixed and the production capacity of the bureau;

- (2) seeking all opportunities for improvements in the organization of control, particularly those offered by computerization, making recommendations in this connection and putting into effect the ideas decided on;

- (3) checking the validity of all requests for work to be done in the light of the rules in force (PADs, quotas, timetables) and checking that everything needed for COL's work (references, etc.) exists;

- (4) maintaining permanent liaison with the various sectors and offices so as to advise them and inform them about the conditions applying to work which is in COL's hands and the progress of such work;

- (5) the regular and correct registration of the bureau's work, the charging of it to the various sectors and the preparation of the corresponding statistics;

- (6) assisting the chief, COL/P, in examining the work plans of the programme sectors and the administrative bureaux, in order to determine COL's expected workload for the following year;

- (7) replacing the chief of the unit, when the chief is absent, in the regard to all matters relating to planning, workload and liaison with the sectors and the bureaux;

- (8) carrying out any other tasks which might be assigned to him as part of his duties.

Qualifications and experience required:

- (a) University degree or equivalent experience.

- (b) International administrative experience, preferably acquired in an organization of the United Nations system.

- (c) Knowledge and experience of computers and their use in management.

- (d) Perfect command of one of the working languages and a good knowledge of the other. Some knowledge of Spanish, Russian or Arabic an asset.

Duty station.—Unesco regional office for education in Africa (Breda), Dakar, Senegal.

Duties and responsibilities.—Under the authority of the director of the regional office, and under the direct supervision of the chief architect, the incumbent will carry out the following duties—

- (1) undertake studies relating to design, construction, furnishing and maintenance norms for educational buildings;
- (2) contribute to the design and implementation of pilot projects relating to development of educational buildings and furniture using local resources;
- (3) assist and participate in advisory missions to member states of the region;
- (4) participate in regional, subregional and national training courses in educational planning, administration and facilities;
- (5) participate in the practical training of national educational buildings specialists;
- (6) assist in the briefing and backstopping of international experts working in the region;
- (7) participate in the identification, preparation and appraisal of educational building projects involving international

assistance and in the briefing of experts and consultants as well as their technical backstopping;

(8) assemble and disseminate information relating to educational facilities;

(9) prepare reports, studies and bibliographical annotations on educational buildings for publication by the regional office;

(10) carry out any other functions and duties that may from time to time be assigned to him by the director of the regional office.

Qualifications and experience required:

- (a) University degree in architecture with a wide experience in school design.
- (b) Professional experience in architectural research and development work.
- (c) Familiarity with techniques of educational planning and administration in developing countries.
- (d) Work experience in developing countries will be an asset.
- (e) Excellent knowledge of either French or English with a working knowledge of the other. Knowledge of Portuguese will be an asset.

Duration of appointment.—Two years, renewable.

Salary and allowances.—Initial appointment will be at P-4 grade with a net annual salary equivalent to US\$27,612 per annum (US\$25,672 if without dependants), plus the prescribed allowances e.g. post adjustment, at present US\$6,801 for staff members with dependants, US\$6,318 for staff members without dependants, assignment allowance, at present the local equivalent of US\$3,000 for staff members with dependants, US\$2,400 for staff members without dependants, family allowances of US\$700 for each dependent child (if there is no dependent spouse, this indemnity is not payable in respect of the first dependent child) at least 30 per cent payable in the currency of the duty station, the balance being paid in one other currency. These emoluments are normally exempt from all direct taxation. Income tax on such remuneration, if levied, is reimbursed in accordance with staff regulations and rules. Travel is provided for the staff member and his family (spouse and recognized dependants). In addition, Unesco contributes towards the cost of installation at the duty station and to the education of dependent children. On separation from Unesco, a repatriation grant is paid.

NEW LARI TRADING CENTRE, KIAMBU DISTRICT

Plots for (A) Shops, Offices and Flats, (B) Residential

(C) Inoffensive Light Industry

THE Commissioner of Lands invites applications for the alienation of plots in the above-mentioned area as described in the schedule hereto. A plan of the plots may be seen in the public map office, lands office, Nairobi, or obtained therefrom on payment of KSh. 10.

Applications should be submitted to the Commissioner of Lands, Nairobi, through the District Commissioner, Kiambu, P.O. Box 32, Kiambu, stating the plot required in order of preference. Applications must be on the prescribed forms which are available from Lands Department, P.O. Box 30089, Nairobi, or the office of the District Commissioner, P.O. Box 32, Kiambu.

Applications should be submitted so as to reach the District Commissioner, Kiambu, not later than 12 noon on 12th March, 1984.

Applicants must enclose with their application a banker's cheque, money order, postal order or cash for KSh. 1,000 made payable to the Commissioner of Lands as deposit for the plot. Personal cheques are not accepted.

The deposit will be dealt with as follows:

- (a) Credited to a successful applicant.
- (b) Refunded to an unsuccessful applicant.
- (c) Forfeited if a successful applicant fails to pay within thirty (30) days of the offer of a plot, and the applicant shall have no further claim thereto.

Each application should be accompanied by a statement indicating—

- (a) the amount of capital it is proposed to spend on the project;
- (b) the amount of actual capital available for development with banker's letter or other evidence of financial status in support;
- (c) the manner in which it is proposed to raise the balance required for development, if any;
- (d) individual applicants to indicate numbers of their identity cards; and
- (e) in case of companies, names of directors to be included.

The successful allottee of a plot shall pay to the Commissioner of Lands, within thirty (30) days of notification that his/her/their application has been successful, the stand premium and proportion of the annual rent together with conveyancing, stamp duty, registration fees, contribution in lieu of rates, road and drains charges and survey fees. In default of payment within the specified time, the Commissioner of Lands may cancel the allocation and the applicant shall have no claim to the plot.

General conditions

The grant shall be made under the provisions of the Government Lands Act, and the title will be issued under the Registration of Titles Act (Cap. 281), or the Registered Land Act (Cap. 300).

The grant will be issued in the name of the allottee as given in the letter of application and will be subject to the special conditions set out below.

Special conditions

1. No buildings shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specifications previously approved in writing by the Commissioner of Lands and the local authority. The commissioner shall not give his approval unless he is satisfied that proposals are such as to develop the land adequately and satisfactorily.

2. The grantee shall, within six calendar months of the actual registration of the grant, submit in triplicate to the local authority and the Commissioner of Lands plans (including block plans showing the positions of the buildings and system of drainage for disposing of sewage, surface and sullage water) drawings, elevations and specifications of the buildings the grantee proposes to erect on the land and shall, within twenty-four (24) months of the said actual registration of the grant, complete the erection of such buildings and the construction of the drainage system in conformity with plans, drawings, elevations and specifications as amended (if such be the case) by the commissioner:

Provided that notwithstanding anything to the contrary contained in or implied by the Government Lands Act, if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful for the Commissioner of Lands or any person authorized by him on behalf of the President to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term created shall cease but without prejudice to any right of action or remedy of the President or the Commissioner of Lands in respect of any antecedent breach of any condition herein contained.

3. The grantee shall maintain in good and substantial repair and condition all buildings at any time erected on the land.

4. Should the grantee give notice in writing to the Commissioner of Lands that he is unable to complete the buildings within the period aforesaid the Commissioner of Lands shall (at the grantee's expense) accept a surrender of the land comprised herein:

Provided further that if such notice as aforesaid shall be given—

(1) within twelve (12) months of the commencement of the term the Commissioner of Lands shall refund to the grantee 50 per cent of the stand premium paid in respect of the land;

(2) at any subsequent time prior to the expiration of the said building period the Commissioner of Lands shall refund to the grantee 25 per cent of the said stand premium; or

(3) in the event of notice being given after the expiration of the said building period no refund shall be made.

5. (a) The land and buildings shall only be used for shops, offices and flats.

11. The grantee shall from time to time pay to the Commissioner of Lands on demand such proportion of the cost of maintaining all roads and drains serving or adjoining the land as the commissioner may assess.

12. Should the Commissioner of Lands at any time require the said roads to be constructed to a higher standard the grantee shall pay to the commissioner on demand such proportion of the cost of such construction.

13. The grantee shall pay such rates, charges, duties, assessments or outgoings of whatever description as may be imposed, charged or assessed by any government or local authority upon the land or the buildings erected thereon, including any contribution or other sum paid by the President in lieu thereof.

14. The President or such person or authority as may be appointed for the purpose shall have right to enter upon the land and lay and have access to water mains, serving pipes and drains, telephone wires and electric mains of all descriptions, whether overhead or underground, and the grantee shall not erect any building in such a way as to cover or interfere with any existing alignments of main or service pipes or telephone or telegraph wires and electric mains.

15. The Commissioner of Lands reserves the right to revise the annual ground rental payable after the expiration of the 33rd and 66th year of the term granted. Such rental will be at rate of 4 per cent of the unimproved freehold value of the land as assessed by the Commissioner of Lands.

2. The parties were heard in Nairobi, on 27th January, 18th February, 14th May, 27th August and 12th November, 1982, and 18th April, 5th and 16th May, 4th and 5th August and 19th October, 1983, and relied on their written and verbal submissions. The claimants also called the following witnesses:

D. T. Muhia.

W. Nthama.

M. Okutoi.

A. A. Mulang'o.

P. Mbinda.

AWARD

3. The Minister for Labour referred this dispute to the Industrial Court on 23rd October, 1981, in accordance with section 8 of the Trade Disputes Act, which dispute was received by the court, on 27th October, 1981.

The claimants were registered as a trade union about eleven years ago. It goes without saying that their registration must have come about after the Registrar of Trade Unions was satisfied in every respect with regard to the provisions of section 16 of the Trade Unions Act, Cap. 233.

The claimants having been registered as a trade union it is natural that they would pursue the same objectives as any other trade union in the country consistent with their registered constitution. Article 3 (a) of their constitution reads:

"Membership of the association shall be open to all persons over the age of 16 years employed by any organization, institution or corporation which is registered, incorporated or practising in Kenya, who perform managerial, professional, executive, administrative or disciplinary, stenographers/secretary, supervisory or inspectorial, representational duties and foremen no longer qualified for membership of any of the existing employees' trade unions as they are precluded from joining the existing trade unions either by existing recognition and/or collective agreements or otherwise by their terms of service; provided that nothing herein contained shall qualify the directors of any such business concerns and the employees of central and local governments for membership of the Association."

The claimants applied to the respondents for recognition on 17th July, 1974, to enable them to represent the interests of workers in the respondents' employment including representatives, supervisory, secretary/stenographer professional managerial staff but not directors.

The respondents rejected the claimants' demand and the matter eventually ended up in the High Court of Kenya, under Miscellaneous Application No. 275/77, under which the claimants had sought a writ against the respondents requiring them to recognize the claimants so that they may begin negotiations with the respondents for the betterment of the terms and conditions of service of the management staff working for the respondents. The high court rejected the claimants' demand.

The high court decision was before the amendment of the Trade Dispute Act, in 1979, when the Act was amended and under section 5 (2) the Minister for Labour was given powers to order an employer to recognize a trade union after being satisfied that a trade union has in its membership a simple majority eligible by virtue of union constitution to join that particular union in a particular undertaking or a group of undertakings and that there is no rival trade union claiming to represent such employees. The court would also like to point out that the expanded definition of a trade dispute includes disputes connected with the recognition agreement. The 1979 amendments further gave the Minister for Labour powers to refer a trade dispute to the Industrial Court where it has

not been settled under sections 5, 6 and 7 of the Trade Disputes Act, on the representation of any trade union, employer or a group of employers and it was stipulated that provisions of part 4 of the Trade Disputes Act should apply to any such reference.

In view of these new developments since the high court decision, the Industrial Court will have to come to a decision in this dispute on the facts, evidence and the submissions put forward by the parties during the hearing.

At one stage during the hearing the court caused an investigation to be carried out regarding the total number of staff who were part of the respondents' management and also to determine how many of them were claimants' members. The Deputy Chief Industrial Relations Officer, Ministry of Labour, carried out the investigation and established that the respondents' management had 267 persons in the following categories:

Junior management	205
Middle management	37
Confidential secretaries	4
Top and senior management	21

The investigation further confirmed that the claimants had 147 members although in terms of the check off in respect of union dues it appears that they had 177 members. The investigator stated that even taking the figure of 147 members in relation to the management staff being either 226 as claimed by the claimants or 267 as claimed by the respondents the fact remained that the claimants had more than a simple majority of the management staff as their members.

The court has no reason to doubt the claimants' statement that out of the several disputes which they had reported to the Minister for Labour on the question of recognition this particular dispute had been referred to the Industrial Court by the Minister for Labour as a test case. The respondents have very vigorously opposed the claimants' demand going as far as to say that any award against them in this dispute would destroy the great system of industrial relations that has been developed in Kenya over the last twenty years. They added that this dispute shall determine whether Kenya shall respect its tripartite system or whether it shall adopt a bipartite system where not only managers but even working directors shall be unionized.

The principal grounds on which the respondents are resisting recognition by the claimants are that in Kenya the principle of industrial trade unionism had been accepted and adopted. The only union to represent unionizable employees in the transport industry is the Transport and Allied Workers' Union (hereinafter referred to as the Transport Union). The respondents pointed out that the collective agreement between the Transport Union and themselves covered inspectors' terms and conditions of employment and the inspectors were free to join the Transport Union therefore the claimants' own constitution barred them from recruiting inspectors into their membership. In these circumstances if the claimants are granted recognition then this will conflict not only with the established industrial relations policy in Kenya but also the recognition agreement existing between the Transport Union and the respondents especially in respect of inspectors.

The respondents also made reference to the principles enunciated in the Industrial Relations Charter which was first signed in 1962, and has since been revised in 1980. They drew the court's attention to the fact that the F.K.E. and the Kenya Federation of Labour had agreed to exclude from union representation employees who perform confidential, directive, administrative and managerial functions. The revised charter also clearly states that the following employees shall be excluded from union representation:

- "1. Persons who are formulating, administering, co-ordinating and/or controlling any aspects of the organization's policy.
2. Staff who perform work of a confidential nature as shall be defined by a tripartite committee.
3. Any other category of staff who may in the case of any particular undertaking be excluded from union representation by mutual agreement."

The respondents referred the court to the definition of "employer" in the Employment Act, in support of their argument that an employer includes the agent, foreman, manager or factor of such person, public body, firm, corporation or

company. The respondents proceeded to refer the court to countries like Japan, U.S.A., Sierra Leone, Sweden and Tanzania, where managerial personnel are excluded from union representation.

The respondents pleaded with the court to reject the claimants' demand because it would lead to confusion and chaos in the industrial relations system in the country.

The claimants were equally vigorous in their demand and stated that they had waited for nearly ten years before the matter could be referred to the Industrial Court for a final decision on the matter. They submitted that the respondents themselves had in writing asked their employees when they were being promoted to the rank of inspector that they would have to resign from the Transport Union and were further required to sign a declaration in the following terms:

"In accepting promotion to conductor instructor I fully understand that the appointment is outside those covered by the current agreement with TAW and that my check off dues will be cancelled with effect from 1st February, 1970. In addition I agree to renounce all affiliation or dealings with TAWU which I may have had in the past."

The claimants argued that this meant that the inspectors were denied union representation and bitterly attacked the respondents for having employed underhand methods in collaboration with the Transport Union to include inspectors in the collective agreement as far as their terms and conditions of employment were concerned. They added that the inspectors had at no time been informed either by Transport Union or the respondents that they were going to be part of the collective agreement between the Transport Union and the respondents.

The claimants stated that the fact that there will be more than one trade union dealing with an employer would not necessarily destroy the system in Kenya as there were already examples where several employers recognized more than one trade union like Brooke Bond Leibig which recognized four unions, National Printers Ltd. which recognized three unions, Pan African Insurance Co. two unions, Kenya Canners Ltd. three unions.

The claimants produced a letter dated 18th November, 1975, which had been written to the F.K.E., COTU and themselves by the then Permanent Secretary, Ministry of Labour, J. H. Othieno, where in paragraph 9 it was stated:

"I hope that the question of recognition of the Management Staff Association will not again be a problem and I would like to urge the F.K.E. to recommend strongly to its members the need to deal with the Association in matters within the Association's competence without putting undue difficulties in the way."

The claimants also produced a letter written by the then executive director of F.K.E. who had told Mr. Othieno that his letter had correctly summarized the results of the meeting with the exception of paragraph 8 only. The Acting Secretary General of COTU at the time responded to Mr. Richmond's letter by writing to him on 1st December, 1975, that the only question on which the F.K.E. had any reservations was that they preferred a meeting of the National Joint Consultative Council of F.K.E. and COTU to meet and decide on a level of representation before F.K.E.'s board of management could recommend to employers to recognize the claimants. Mr. Karebe had also stated that this was no reason to delay the recommendation from F.K.E. for employers to recognize the claimants.

The claimants pointed out that since 1975 up to date eight years had gone and the matter of the level of union representation had not yet been finalized. Finally they submitted that the respondents had issued the inspectors who were the claimants' members with revised terms and conditions of service on 24th June, 1983, to which document Transport Union was not a party.

The court is very much aware and conscious of the main principles at stake in this dispute both from the employer's point of view and that of the claimants. The word "employer" is advisably used as the respondents feel that the decision in this case will have far reaching effect on all the employers. The fear is that once recognition is granted to the claimants by any one employer then a precedent will be set whereby a craft trade union as opposed to industrial trade union will have received official blessing. They further feel that the managers in its broad interpretation of the word should not be unionizable in any case. As far as the claimants are concerned they equally feel very strongly on this matter and are very bitter that having been registered by the government as a trade union way back in 1972 employers through the F.K.E. have thwarted all their

efforts for them to be recognized by the employers in the country. They are confident that they have a definite and positive role to play in industrial relations system in Kenya as the foremen, supervisors going up to the managers have no trade union protection. With these very important and fundamental points at stake the court has given very anxious thought to this dispute.

The court would now like to deal with certain points which have been established during the hearing as a result of evidence given by various witnesses and through documents. The court finds it proved that the respondents barred their employees when promoted to inspector grade from joining or from continuing the membership of Transport Union. This was proved by the witnesses called by the claimants and the documents they produced. One of these documents is signed by J. C. Ballantyne Evans who is still in the respondents' employment and who was present during the hearing of this dispute. The court also accepts the evidence of Paul Mbinda when he said that prior to 1969 the inspectors used to be members of Transport Union. He is an old official of the trade union having been associated with Transport Union from 1964 until 1979 by which time he had become its secretary general. So his evidence is first hand. He stated that in 1969 management started asking the inspectors to revoke their membership of Transport Union who resisted this move but in 1970 one J. C. Harrold became the general manager. He came from London and Mr. Mbinda said apparently he had instructions that all inspectors should leave Transport Union and Mr. Harrold started issuing letters himself telling the inspectors that they will not join the trade union which led to a very heated confrontation between the late Mr. Chege and Mr. Harrold.

The respondents, however, continued with their campaign and cancelled all the inspectors from the Transport Union check off. Mr. Mbinda also added that the Nairobi section of the respondents tried to convince their Mombasa counterparts on the same lines but since the Mombasa management was different they did not accept the Nairobi pattern and in Mombasa the inspectors continued to be members of the Transport Union. Mr. Mbinda stated that in 1974 and 1975 they tried if they could get letters which the respondents had issued to their inspectors in Nairobi barring them from the union membership to be withdrawn because the terms and conditions of employment regarding inspectors appeared in the collective agreement since the management had refused to delete it but they did not succeed. By 1975 and 1976 Transport Union could not negotiate for the Nairobi inspectors' terms and conditions of employment because they had no shop stewards but the clause covering them still continued. Mr. Mbinda added that in 1977 he insisted that inspectors should be removed from the collective agreement because they are not allowed to be members of the Transport Union but the management refused and he had no option but to sign the collective agreement for the benefit of his members. He admitted that he was committing the inspectors in the collective agreement although they were not members of his trade union, i.e. Transport Union. He stated that he was also aware that the inspectors had joined the claimants in 1973.

The court is satisfied on the evidence that Nairobi inspectors were not allowed to join the Transport Union by the respondents although the Mombasa inspectors did not face any such restrictions. So it is obvious that the inspectors who form the bulk of the claimants' membership were not allowed to join the Transport Union in Nairobi. It must have been for this reason that in 1973 they joined the claimants. The court rejects the respondents' submissions on this point and finds that although the inspectors clause continues in the collective agreement that applies to Mombasa inspectors only and the respondents cannot use that to claim that inspectors in Nairobi are part of the collective agreement. They had issued clear instructions in writing to these inspectors to sever their links with the Transport Union and if they had had any change of heart then they should have issued them letters telling them that they were now free to join the Transport Union. The fact that they put the collective agreement on the notice board does not mean that the inspectors were free to join the Transport Union. Moreover, the respondents have issued individual letters of increments to the various inspectors which shows that they have individual contracts.

The court now moves on to the Industrial Relations Charter on which the respondents have relied. This charter was revised in 1980 but unfortunately there are extremely important areas on which there is no final decision as yet by the government, COTU and F.K.E. In the revised charter it is stated that persons who are formulating, administering, carrying on and control-

ling any aspects of the organization's policy will be excluded from union representation. The inspectors obviously do not fall under this category. The next category of staff who will be excluded from union representation are those who perform work of a confidential nature but such staff is to be defined by a tripartite committee. There is no evidence before the court of any development in this regard. It appears that the tripartite committee has not even been set up till now. At least there was no evidence before the court to the contrary. Finally other category of staff may be excluded in the case of any particular undertaking by mutual agreement.

In appendix B to the revised charter there is a proposed re-organization of trade unions along industrial lines and towards the end of it there are six trade unions which are mentioned as being left out to be deregistered. On top of this list is the claimants' name. Here again despite the importance of the subject no decision had been taken and it is nearly four years when the charter was revised.

The claimants are a very active trade union indeed as they have appeared on behalf of dozens of middle level managers before the Ministry of Labour and the Industrial Court and in many cases their disputes have been referred to the court by the Minister for Labour himself and in others the employers have voluntarily signed the Notification of Dispute Form "A".

The interesting point is that whereas the government, COTU and F.K.E. have failed to resolve this very sensitive issue of the representation of the managers by a trade union the respondents are asking the Industrial Court to resolve this matter for them and rule that the managers are not entitled to trade union representation in Kenya. This is a most unfair demand on the court. It is not the court's function to rule on matters of policy which is the prerogative of the government in consultation with COTU and F.K.E. or with their agreement. It is obvious that there is no consensus of opinion on this matter because the revised Industrial Relations Charter has still not been finalized in these very sensitive areas the claimants have not been deregistered and COTU is certainly not in agreement with F.K.E. on this matter as the parties are deadlocked on the question of the level of union representation. The court has carefully considered the respondents' request on this point but must refrain from making any ruling or award which will create a precedent and might adversely affect the policy being formulated on this particular point. The court has decided to make its award on the facts as they exist at present which are that the claimants are very much in business as a trade union, the inspectors in Nairobi were barred by the respondents from joining the Transport Union and that most of these inspectors have been claimants' members since 1973. There is no gainsaying that if a trade union is registered then it is expected to function and discharge its responsibilities towards its aims and objectives and that is precisely what the claimants are doing. The question that arises is—was the government in the wrong in registering the claimants as a trade union or did the government at that time feel that this particular trade union will serve a very useful purpose in the country? The respondents are asking the court to rule indirectly that the government's decision was wrong. The court is not prepared to make any such ruling. It is up to the respondents and the F.K.E. to make representations to the government on this particular point which is a matter of national importance. It is up to the government, COTU and F.K.E. to take appropriate decision in the matter and not for the court to say anything on it.

After a careful consideration of all the submissions, the court awards that the respondents should recognize the claimants as far as their Nairobi inspectors and other middle management are concerned. The claimants conceded that they had no members from top and senior managers and as far as the confidential secretaries are concerned that matter is to be decided by the tripartite committee which the court hopes will be set up in due course. Whether the claimants will be allowed to represent them will depend on the deliberations of that committee. The court directs that the parties should enter into a formal recognition agreement as soon as it is possible but not later than three months from the date of the court award.

**IMPORTANT NOTICE TO SUBSCRIBERS
TO THE KENYA GAZETTE**

THE following notes are for the guidance of persons submitting "copy" for inclusion in the *Kenya Gazette, Supplements, etc.*:

- (1) The *Kenya Gazette* contains notices of a general nature which do not affect legislation. They are therefore submitted to the Government Printer directly.
- (2) *Legislative Supplement* contains Rules and Regulations which are issued by the Central Government. Because of this they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) *Bill Supplement* contains Bills which are for introduction in the National Assembly.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain a minimum of alterations.

Particular attention should be paid to the following points:

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—**Kenya Gazette**

"D.14.(1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."
