## Issue in dispute:

Dismissal of William Ogato.

THE Kenya Building, Construction, Civil Engineering and Allied Trades Workers' Union shall hereinafter be referred to as the claimants and Diamond Concrete Co. Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 17th January, 1984, and relied on their written and verbal submissions.

## AWARD

3. The Notification of Dispute Form "A" dated 13th February, 1982, duly signed by the parties was received by the court on 3rd June, 1983, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievant worked for the respondents from 23rd January, to 5th August, 1978, a period of six months only. He was employed as a chairman at a monthly salary of KSh. 550. The claimants had submitted that he was employed as a foreman but the court does not accept that.

The circumstances that led to his dismissal started on 5th August, 1978, when Mr. Ogato's supervisor decided to serve a letter on him in which it was pointed out that on 25th the grievant was making disturbance on the job and that he made the work progress at a very slow speed all the time and he did not want to obey the instructions given by his supervisor. In the end the supervisor wrote that he was fed up with him in this section as of 5th August. The respondents called it a warning letter which they alleged Mr. Ogato refused to sign, and was thus guilty of not obeying a lawful order. The claimants' branch secretary took up the matter and the District Labour Officer, Kisii, held a joint meeting in his office on 21st August, 1978, at which meeting it was decided that the respondents owed Mr. Ogato KSh. 1,016.90. The respondents deposited a sum of KSh. 542.10 at the Kisii Labour office and on 5th February, 1979, they further informed the ministry that Mr. Ogato was also entitled to certain arrears of payment totalling KSh. 615.90.

The matter, however, did not end there and the claimants decided to report a trade dispute to the Minister for Labour. The dispute was investigated and the investigation was considerably delayed because of the change of the investigators. Eventually the ministry released its finding to the parties that Mr. Ogato had suffered a wrongful dismissal and recommended that he should be paid KSh. 2,799.30 plus KSh. 140 for five days worked in August, 1978, and he should also be paid five months' wages as compensation for the wrongful termination.

It is most unfortunate that the respondents' memo to the first investigator on 5th February, 1979, was not handed over to the second investigator who took over from him. Moreover a meeting with the first investigator arranged did not materialize, although the respondents had called at the ministry headquarters, because the investigator was absent after having called the meeting. It is obvious that the claimants' allegations of an unco-operative attitude levelled against the respondents arose from this confusion.

The respondents submitted that the refusal to sign the aforesaid "Warning letter" to Mr. Ogato was a refusal to obey a lawful order. The court has carefully studied this letter and finds that it is not really a warning letter as such. It appears that it was really informing Mr. Ogato that the supervisor did not want him in his section any more as he was fed up with him and he was probably going to be transferred to another section. However, in view of only six months' service that he had rendered to the respondents and the fact that the matter was resolved at a joint meeting convened by the District Labour Officer, Kisii, at which the claimants' branch secretary was present the court finds that the respondents should pay him a sum of KSh. 1,016.90 as agreed at that meeting plus one month's wages being KSh. 550 in lieu of notice as the court finds that the respondents were entitled to terminate Mr. Ogato's services rather than summarily dismiss him. The court would like to stress that the parties should take seriously the efforts made by the Ministry of Labour officials to settle dispute at the earliest opportunity at local level rather than try to be too technical and stretch such disputes all the way to the Industrial Court. Mere technicalities cannot be allowed to defeat ends of justice.

Particular attention should be paid to the following points:

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

**EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—  
Kenya Gazette**

"D.14.(1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."
