Applicants must have satisfactorily served at the level of superintending engineer (Job Group "L") for a minimum period of three (3) years and have been registered by the Engineers Registration Board of Kenya, and be a corporate member of the

Institution of Engineers of Kenya, or corporate member of a professional engineering body recognized by this institution. They must have wide experience in design, construction and/or maintenance of civil engineering works including control and supervision of projects. They must also have demonstrated competence and ability to assess future workloads and resources required thereof and to control finance for large projects and must have wide experience in the administration of contracts and capability for running a general engineering design office.

Duties and responsibilities.—Provincial engineers are administratively responsible to the engineer-in-chief for the supervision and control of the Ministry of Transport and Communications functions and operations in the provinces in close liaison with departmental heads for the proper supervision and control of their professional functions. These will include:

- (a) Overall planning and control of construction projects.
- (b) Maintenance of all classified roads and airfields and structures and ferries within provincial boundaries.
- (c) Co-ordinating the deployment and maintenance of Ministry of Transport and Communications plant and equipment including management of mechanical workshops and other related facilities for their maximum utilization by district set-ups.
- (d) Providing the necessary service related to the functions of the office as well as looking after the welfare of all staff assigned to him by departmental heads.

Senior Superintending Engineer (Roads) (Four Posts)
(No. 280/84)

Salary scale.—K£3,408 to 4,428 p.a. PENSIONABLE or AGREEMENT.

Applicants must have satisfactorily served at the level of superintending engineer (Job Group "L") for a minimum period of three (3) years and have been registered by the Engineers Registration Board of Kenya, and be a corporate member of the institution of engineering body recognized by this institution. They must have wide experience in design, construction and for maintenance of civil engineering works including control and supervision of projects. They must also have demonstrated competence and ability to assess future workloads and resources required thereof and to control finance for large projects and must have wide experience in administration of contracts and capability for running a general engineering design office.

Duties and responsibilities:

- (a) The senior superintending engineer will head and co-ordinate the activities of the gravelling, bridging and culverting section of the roads department's construction branch.
- (b) He will be responsible for programming, assessing present and future workload and resources required and to control finance and other resources for the G.B.C. project.
- (c) Preparing detailed briefs in the progress and needs of the G.B.C. projects.
- (d) He will also be responsible for preparation of procurement/contract documents including bills of quantities and specification of project plant and equipment and materials from both local and overseas sources for the programme.
- (e) He will from time to time co-ordinate the activities of the G.B.C. programme with the relevant government departments and other organizations.

Superintendent (Mechanical) (Five Posts) (No. 281/84)

Salary scale.—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants should have served a recognized apprenticeship in mechanical engineering followed by at least six (6) years' experience on maintenance of heavy plant and vehicles, two (2) years of which must have been in a grade of senior inspector mechanical. They should have experience of maintenance and operation of heavy earth-moving machinery such as bulldozers and graders and have wide knowledge of vehicles maintenance. Preference will be given to applicants with school certificate, but long experience in vehicle/plant maintenance will be given special consideration.

Assistant Chief Security Officer (One Post) (Aerodromes)
(No. 282/84)

Salary scale.—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants should have satisfactorily served as security officers on Job Group "H" for at least two (2) years and are confirmed in their present appointments. They must be versed in all aspects of civil aviation security, Civil Aviation Act, aerodromes regulations and rules and other relevant laws related to the operation of airports and in addition must have a satisfactory knowledge and application of the Service Commission Act, and the civil service code of regulations.

Duties and responsibilities.—The selected candidate may be assigned to head one of the units within the aerodromes security section, or be in-charge of security at any of our international airports.

Work in this cadre involves among others:

- (a) Enforcement of aerodromes regulations and rules.
- (b) Application of civil aviation security programmes.
- (c) Training of security personnel.
- (d) Security and facilitation of VIPs.
- (e) General security and safety of airports in close liaison with police and other relevant departments.
- (f) Administration of the security section at station or unit level advising the airport manager on lapses and appropriate corrective measures.
- (g) Maintaining sound discipline among security staff in the cadre of security officer and below.

Vacancies in the Ministry of Lands and Settlement:

Senior Land Officer (Seven Posts) (No. 283/84)

Salary scale.—K£2,154 to 2,928 p.a. PENSIONABLE or AGREEMENT.

Applicants must have minimum academic qualification of East African Certificate of Education or its equivalent. They must have worked as land officers grade I, who must have undergone land administration training and be fully conversant with all land laws as applied in Kenya. They must have working knowledge and experience in land administration for at least four (4) years (training period included).

This is a responsible post and the successful candidates must be capable of assuming responsibility and taking important decisions on land matters. He must be a diligent and mature person capable of controlling and supervising the junior staff under him.







Particular attention should be paid to the following points:

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

"D.14.(1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*."
