# THE INDUSTRIAL COURT CAUSE NO. 35 OF 1984

Parties:

Railways and Harbours Union (Kenya)

and

Kenya Railways Corporation

Issue in dispute:

Failure, refusal and/or delay by the Kenya Railways to implement a voluntarily negotiated agreement entered on 24th November, 1983, revising the wages and salaries of all railway employees upwards.

THE Railways and Harbours Union (Kenya) shall hereinafter be referred to as the claimants and Kenya Railways shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 22nd August, and on 19th, 20th September and on 3rd, 4th and 5th October, 1984 and relied on their written and verbal submissions.

#### AWARD

3. The Notification of Dispute Form "A" dated 29th March, 1984, duly signed by the parties was received by the court on 2nd April, 1984, together with the statutory certificate signed by the Labour Commissioner.

The respondents were established six years ago under the Kenya Railways Corporation Act, which came into force on 20th January, 1978, after the collapse of the community. The court appreciates the fact that the respondents had a difficult start financially mainly due to economic circumstances prevailing at the time. Recently, the Arusha accord on the mediation in respect of distribution of assets and liabilities of the defunct East African Community was concluded and the respondents have been called upon to pay to Uganda over KSh. 1 billion which definitely has placed an extra heavy financial burden on them.

Respondents in this dispute have powers under section 10, subsection (d) of the Kenya Railways Corporation Act to approve within certain limits, any alteration in salaries, wages or other items and conditions of service of employees of the corporation. Under paragraph (b) of section 11 the Minister for Transport and Communications may direct the board to approve any minor alterations in salaries/wages or other terms and conditions of service of the corporation. The Minister, however, is required by law to approve major alterations in salaries, wages and terms and conditions of service of employees in accordance with section 12 (c) of the Act.

However, the court would now like to point out that on 19th December, 1979, His Excellency the President established and appointed the parastatal advisory committee. Paragraph (3) of their terms of reference which is relevant to this dispute reads:

"To advise my office from time to time on terms and conditions of service for employees of parastatal bearing in mind the findings and recommendations of the Civil Service Review Committee (1979)."

It is not disputed that all changes in salaries/wages and conditions of service of employees have to be referred to the PAC for ratification before implementation. This meant that the negotiated salaries and wages were to be sent to the PAC a proposals only to allow the committee to ratify them or otherwise.

The claimants and the respondents are nevertheless still bound by their industrial relations machinery which was signed on 9th March, 1978. In accordance with this machinery the parties signed an agreement which was reached at the central joint council meeting held on 24th November, 1983, and signatories to the agreement were:

Mr. Muthee.—Chief Personnel Manager for the respondents.

R. Okanga.-Secretary-General for the union.

J. M. Muchura.—Chairman, Central Joint Council, and it reads:

"The Council discussed in detail wage demand by the staff side and the counter proposals by the management side and agreed to a revision of salary upwards ranging between 30.1 per cent at the lower scales and tapering off to 4.7 per cent at the highest point on the scales of the salary structure. The effective date is to be 1st September, 1983."

The council further agreed that the agreement be forwarded to the parastatals advisory committee through the Ministry of

Transport and Communications for ratification. It was also agreed that other terms and conditions of service including the housing element regarding rental increase be discussed at a meeting of the central joint council to be held on 14th February, 1984.

The courts attention has been drawn by the claimants to section 11 (a) and (c) of the Industrial Relations Machinery 1978 which reads:

- "(a) It is recognized and declared that all matters provided for in this agreement shall be subject t othe provisions of any law from time to time in force in Kenya.
- (b) It is recognized that agreement(s) reached in the Central Joint Council shall be binding and where necessary it shall be the responsibility of the Railways to ensure earliest implementation of such agreement(s) by immediate reference of the agreement(s) to the appropriate bodies.
- (c) In the event of unjustifiable and/or unfair delay in the implementation by the Railways of an agreement reached in the Central Council the Union may resort to the use of the provisions of the Trade Dispute Act."

The respondents in compliance with (a) and (b) above sent the agreement to PAC within a week from the date of signing it. The claimants, however, blamed the delay in implementing the agreement on the respondents. The court however notes that although there was a delay in receiving decision from the PAC this could not have been blamed on the respondents as there is evidence to prove that all efforts were made to get a decision from the PAC. This decision finally was conveyed to the parties at a conciliation meeting held on 28th March, 1984, that the PAC was reluctant to ratify the salary and wage increases in their present form as the increases were high and could not be sustained by the respondent's present financial position. The meeting ended in a deadlock and the dispute is now before this court.

The claimants felt that they were kept in the dark and suspense with the result that their members suffered a great financial hardship. The claimants submitted that respondents are their employers and they have an established industrial relations machinery with them stipulating a collective bargaining system among other things. They challenged the PAC's role in this matter.

They strongly felt that it was entirely up to the respondents to ensure the necessary approval to their signed agreement.

At this stage the court would like to state that if proper collective bargaining procedures were followed, ratification or otherwise by the PAC was crucial as in clause 11 of the industrial relations machinery it is clearly stated that all matters provided for in the machinery shall be subject to the provisions of any law from time to time in force in Kenya.

The court finds that the instrument setting up the PAC made it mandatory for the PAC to ratify or otherwise the agreement before implementation. This provise in the signed agreement was well known to all parties who appended their signatures to the said agreement later sent to the PAC. The claimants, however, have all along maintained that nothing was raised by the respondents at the negotiating table about their inability to pay. Therefore they went further to assume that all was well as long as they negotiated within the wages guidelines and as long as the increases agreed upon did not compel the respondents to make a further financial request to the government. They further feel that workers are entitled to salary/wage increases and stressed that increases agreed for were not full compensation under the guidelines.

The respondents on the other hand have very vigorously pleaded their inability to meet new salaries/wages demand agreed to at the central joint council meeting held on 24th November, 1983, for the following reasons which arose after the signing of the agreement namely:

- (a) That the respondents are under legal obligation to have agreements ratified or otherwise by the PAC before implementation.
- (b) That the salaries/wages agreement as forwarded to the PAC are too high and cannot be met by the respondents from their existing financial resources.
- (c) That the Uganda debt of about KSh. 1 billion passed on to the respondents after the Arusha accord has placed them in a huge deficit.
- (d) That the respondents have further to pay:
  - (i) Municipal rates amounting to KSh. 83.5 million.
  - (ii) Police charges KSh. 36.9 million.
  - (iii) Loans on locomotive and spares KSh. 40 million.

(iv) Other loans KSh. 40 million.

(e) Some of the foregoing points were not known to the parties before signing the agreement the subject matter of this dispute.

In view of the foregoing reasons, they asked the court to find that, they have not failed, refused or delayed the implementation of the agreement and pleaded with the court to allow them to renegotiate with the claimants and then forward the proposals to the PAC for ratification.

The most important question in this dispute is: can the respondents go ahead and implement the agreed salaries/wages signed at the C.J.C. without the approval and consent first from the PAC? The court finds that the answer to this question is "No." His Excellency the President has set up the PAC to monitor the activities of all parastatals and it requires the PAC to advise the President's office on the terms and conditions of service for all parastatal employees.

The court, however, must emphasize that the claimants are entitled to a fair compensation arising from a free and voluntarily negotiated agreement. But, must at the same time consider the recently established government supervisory machinery with powers to streamline and regulate parastatals finances. The respondents are not exempted from this set up.

Turning to the finances of the respondents, the court observes that the respondents have a heavy financial liability arising, particularly from Arusha accord which calls on the respondents to pay Uganda some KSh. I billion. The court agrees with this point, that the respondents are legitimately responsible to pay the Uganda debt. It is noted that at the time of negotiations available surplus was in the region of KSh. 180 million. The postion has since changed considerably.

The court having studied the unaudited balance sheet ending August, 1984, notes that the corporation has a surplus of some KSh. 114 million only. This amount is a drop in the ocean when the respondents liabilities are taken into account. However, for the other debts, the court agrees with the claimants that an organization of the size of the respondents must make provision in its budget for the outgoings such as police and municipal charges. The same goes for the various loans raised by the respondents.

The court finds that the agreement having not been ratified by the parastatals advisory committee as required and the respondents claiming inability to pay due to the huge debt placed on them from the winding-up of the community, it cannot order the respondents at this state to implement the aforesaid agreement. It is the court's function to see that collective agreements are strictly within the wages guidelines as issued by the government. The court notes that although the wage/salary increases agreed are somewhat below the guidelines the fact remains that the guidelines require such increases to be given in two instalments in two years. The agreement contravenes the guidelines to that extent because the negotiated wage increases are stipulated to be awarded in one instalment from the agreed effective date.

Taking all the circumstances into account the court has decided to make an interim award regarding implementation of the parties agreement in respect of respondents unionizable employees only of 15 per cent wage increase on the lowest scale tapering off to 5 per cent the highest scale, with effect from the agreed effective date.

The court would like to warn the respondents that in future they should fully consult the PAC on wage/salary increases before signing any collective agreement. The present dispute has arisen because the respondents failed to follow the procedure.

The court further directs that the parties should embark on fresh negotiations after three months from the date of this award and the court hopes that the respondents will follow the proper procedure as far as the PAC and its role re-parastatals is concerned.

THE INDUSTRIAL COURT

Issue in dispute:

Recognition agreement.

THE Kenya Chemical Workers' Union shall hereinafter be referred to as the claimants and Kensara Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 21st May, 1984, 14th September, 1984, and 1st October, 1984, and relied on their written and verbal submissions.

#### AWARD

3. The Minister for Labour referred this dispute to the Industrial Court in accordance with section 8 of the Trade Disputes Act, which dispute was received by the court on 10th June, 1983, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

This dispute concerns the refusal by the respondents to recognize the claimants as the representative of their unionizable employees since 1980.

In 1982 the Minister of Labour carried out an investigation. During this period the Kenya Union of Commercial Food and Allied Workers actively represented the respondents' employees. In fact they had negotiated three collective agreements with the respondents since 1976.

After investigation the permanent secretary's finding was that the respondents business was that of pharmaceutical manufacturers and by its constitution, the Kenya Chemical Workers' Union is the appropriate union and recommended that the respondents accord recognition to claimants. The respondents rejected this and the dispute is now before the court.

During the hearing the claimants argued strongly that they are constitutionally the proper union to represent the workers of the respondents and that the Kenya Union of Commercial Food and Allied Workers (the interested party) and the respondents interfered with the workers' wishes to be represented by the claimants.

On 21st May, 1984, the respondents representative in court (the Federation of Kenya Employers) argued that the interested party was the proper union to respresent the respondents workers and they should be allowed to continue representing them. But on 14th September, 1984, this same representative, after having gone through both the union's constitutions decided not to make any submissions and left the matter in the hands of the court.

After careful evaluation of the evidence the court is satisfied that the claimants are the proper trade union to represent the workers of the respondents.

The court accordingly awards that the claimants should be awarded recognition by the respondents and the court directs that the parties should enter into a formal recognition agreement forthwith.

#### AWARD

By consent of the parties the court awards that the respondents should pay Rachael A. Odhialo nine months' salary, as compensation for the wrongful dismissal she had suffered. She will also be entitled to her provident fund benefits including the employers contribution.

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and Wigglesworth Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 26th September, 1984, and relied on their written and verbal submission. There hearing of this dispute was delayed at the request of the claimants on three occasions on 19th December, 1983, 15th January, 1984 and 14th May, 1984.

#### AWARD

3. The Notification of Dispute Form "A" dated 30th April, 1983, duly signed by the parties was received by the court on 16th September, 1983, together with statutory certificate signed by the Labour Commissioner.

The claimants have brought this dispute against the respondents for underpayment to Nelson Kamau.

The claimants stated that Nelson Kamau was employed on 31st December, 1976, as an unqualified artisan at a basic salary of KSh. 672 and at the time of his employment with the respondents had passed the trade test grade III.

After he had completed his probationary period, he raised the question of his up-grading with the respondents but did not get a satisfactory answer from the workshop manager. Mr. Kamau got frustrated and continued to raise the matter with the personnel manager. The personnel manager did not take note of the fact that Mr. Kamau was a qualified artisan who should be placed in the next grade. Despite several reminders and promises the personnel manager did nothing to alleviate Mr. Kamau's problem. The claimants after failing to convince the respondents that Mr. Kamau was doing the work of a higher grade than his own declared a trade dispute on 2?. March, 1982, at which a Labour Officer was appointed to conciliate. However, the discussions ended in a deadlock and both parties agreed to sign Form "A" and forwarded it to the Ministry of Labour.

The claimants now demand that Mr. Kamau be paid all the underpayment, with effect from the time he passed his trade test grade II. The respondents should promote Mr. Kamau from his present position to that of grade II.

The respondents stated that Nelson Kamau, who had been a casual worker with them, approached the management in late 1976 to be offered permanent employment but he was advised that there was no vacancy for a welder grade III which he had applied for. However, he was told that if he was interested he could be offered a position of welder unqualified.

Mr. Kamau accepted the situation and despite his qualification he was employed as an unqualified artisan, with effect from 1st January, 1977, at a salary of KSh. 672 per month and was placed on probation for three months.

Later in 1977 Mr. Kamau sought to be promoted to the position of artisan grade III, but he was advised that production of a trade test certificate was not a sufficient ground to get promoted.

In June, 1978 as a result of a change in the staff establishment a vacancy for a welder grade III became available and Mr. Kamau was promoted to that position.

In November, 1978 Mr. Kamau wrote to the respondents informing them that he had just obtained the National Trade Certificate Grade II and he sought to be promoted to that position. He was advised that there was no vacancy available in that position in the establishment.

The respondents further advised Mr. Kamau that although he professed to have a grade II certificate his performance could not measure to the standard expected of him. This was followed by letters of warning which clearly stated his inability to perform his duties well.

This matter was later brought to the attention of the Ministry of Labour by both parties. The Ministry of Labour official handling the matter advised the claimants that he was not in a position to order the respondents to up-grade Mr. Kamau if a higher position did not exist and if his performance is below the standrd required for the job.

The respondents referred the labour officer and the claimants to the collective bargaining agreement which makes the position clear as regarding appointment and ability to show appropriate skills and competence. The respondents further submitted that being a trading organization they cannot be expected to create positions in its staff establishment when there is no requirement for one.

The demand by the claimants that Mr. Kamau be promoted from grade LH to H is itself contrary to clause 7 of the recognition agreement to which both parties are signatories.

The respondents submitted that Mr. Kamau was not performing the job of artisan grade II to be entitled to wages attached to that grade and further maintained he would only be entitled to the wages for that post if he had the ability to demonstrate possession of the appropriate skills and competence. Unfortunately Mr. Kamau had failed to demonstrate such an ability even in the lower post of artisan grade III.

The court has considered the parties submissions and has come to the conclusion that the case be dismissed on the grounds that the respondents could not be expected to create a position in their establishment when there is no requirement for it. Furthermore Mr. Kamau has not satisfied the respondents with his performance to warrant such promotion.

Particular attention should be paid to the following points:

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.

  (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-Kenya Gazette

"D.14.(1) Communications for the Kenya Gazette should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer when ready.
