3. The grantee shall maintain in good substantial repair and condition all buildings at any time erected on the land.

4. Should the grantee give notice in writing to the county that she/he/they is/are unable to complete the buildings within the period aforesaid, the county council shall (as the grantee's expense) accept a surrender of the land comprised herein:

THE INDUSTRIAL COURT

CAUSE No. 66 OF 1984

Parties:

Kenya Union of Domestic, Hotels, Educational Institutions
Hospitals and Allied Workers
and
NAS Airport Services Ltd.

Issues in dispute:

- Grading of drivers.
- Grading of barmen.
- Handling charge.

THE Kenya Union of Domestic, Hotels, Educational Institutions, Hospitals and Allied Workers shall hereinafter be referred to as the claimants and NAS Airport Services Ltd. shall hereinafter be referred to as respondents.

2. The parties were heard in Nairobi on 7th and 8th February, 1985, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 11th April, 1984, duly signed by the parties was received by the court on 14th August, 1984, together with the statutory certificate signed by the Labour Commissioner.

The respondents are a member of the Kenya Association of Hotel-Keepers and Caterers, which has had collective agreements with the claimants since 1978. They engage in providing services to the two major Kenyan airports, Jomo Kenyatta and Moi International airports in Nairobi and Mombasa, respectively, and employ 850 employees out of whom 800 are unionizable.

Grading of drivers:

The claimants are demanding up-grading of drivers of vehicles of 12 tons and above to grade 3 in the previous collective agreement or to grade 7 in the current collective agreement. This demand goes as far back as 1978 when the claimants first demanded rectification by the respondents. The claimants also claim that the respondents own several trucks of over 12 tons which are driven by their members.

The respondents argued that they did not own vehicles of 12 tons as claimed by the claimants and stated that the heaviest vehicles they own are special loading trucks whose weight is 10.9 tons each and are restricted by the manufacturers not to carry more than 3.5 tons of goods. These vehicles are never out of the airports and are driven between NAS base and the aircraft loading bay which is only about $\frac{1}{4}$ km. away. They also pointed out that the weight of the vehicle should be based on "tare-weight" and not on "gross-weight".

The court notes that the weight of a vehicle is determined by the "tare-weight" as defined in the Traffic Act (Cap. 403), section 2.

The court has carefully considered the issue in dispute and finds that the claimants did not know the classification of

vehicles as stipulated in the Traffic Act. The court therefore rejects the claimants demand.

Grading of barmen:

The claimants demanded that one barman in every shift and in each one of the 8 bars and restaurants operated by the respondents in Nairobi and Mombasa airports be upgraded to head barman grade 2. They pointed out that in all these bars two employees run each of them in every shift and that one employee is the head of the other one. This demand is backdated to 1978 as well and the arrears in demand are KSh. 86,689.70.

The respondents argued that of the two employees at every bar in every shift, one is a barman and the other is a waiter and they are correctly placed in grades 4 and 3, respectively. They pointed out the duties of barman and head barman as set out in their collective agreement are as follows:

"Barman: Responsible for bar stock, service of drinks, preparation and settlement of bills, should have some training and qualification in the knowledge of alcoholic beverages.

Head barman: Barman specifically in charge of a particular bar in one establishment. Will be responsible for stock, cash float, presentation and settlement of bills and will supervise other bar staff. Must have full knowledge of alcoholic beverages and with experience in and qualifications for the preparation and service of cocktails."

The respondents stated that they have six employees in grade 2 who also work in three shifts and each one of them supervises three bars at a time. Although these six employees in grade 2 are officially known as "Controller/Cashiers", they are in fact the head barmen.

After examining the difference between barman and head barman as per the parties collective agreement, the court finds that the respondents have graded the barmen correctly. In fact if the claimants' demand is accepted, there will be one redundant grade, grade 4 as one employee in every bar is a waiter. The court rejects the claimants' demand.

Handling charges:

In the opening submission the claimants demanded that the "Handling charges" for the life of both collective agreements to be treated as "Service charge" and be paid to the respondents' unionizable employees. They claimed that handling charges are levied by the respondents in connection with loading of catering supplies, bar stocks, meals and other goods on the aircrafts in Kenya, according to the size of aircrafts being supplied.

The respondents argued that handling charges are not service charges. Their contention is that handling charge is a fee just like storage charge which assist to meet costs involved in the provision of catering services to aircrafts in all international airports in the world. The respondents are not excluded from these standing charges.

In considering this issue the court has to examine the relevant clause of the collective agreement between the parties which is clause 19:

"The employer will operate a service charge and the money collected through the service charge be distributed to all employees with exception of management staff on terms to be advised by the works committee after consultation with the employees of the individual establishment. A deduction of 15 per cent will be retained by employer in accordance with ILO agreement for administrative purposes. The union may (at their own expense) appoint a qualified accountant/auditor to check the accounts maintained by the company for the service charge at a time suitable and agreed between such accountant/auditor and the management. Should such check reveal malpractice on the part of the employer then the cost of such check shall be shared equally, provided always that where the local works committee after consultation with the union expresses a preference to the management that no service charge should be introduced then a local arrangement within the organization would be satisfactory."

In normal circumstances service charge is a tipping system charged to a client for service rendered and the money so collected is distributed to unionizable employees. In this case, handling charge is not a service charge but an operational fee.

Interestingly, the claimants in their final written submissions on this issue, came out with the following:

"In the previous parties' agreement the issue of service charge to be operated on handling charge was not there. However the parties had jointly agreed to conduct separate negotiations on the issue of handling charge with a view of finding settlement. But to-date the management of NAS have all along refused to operate service charge on handling charge hence the matter is now before your lordship."

This is an admission that the parties did not meet over this issue. Probably the claimants are trying to use the courts powers to force the respondents to instigate negotiations. The court rejects the claimants' demand on handling charges.

The court notes with regret that this dispute involving some KSh. 1,049,660.20 (according to the claimants submission) was totally misconceived and the court has had no hesitation in rejecting all the demands made by the claimants.

Issue in dispute:

Redundancy of 42 employees.

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and Ken Wheat Industries Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 27th November, 1984, and 31st January, 1985, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 16th June, 1982, duly signed by the parties was received by the court on 22nd December, 1983, together with the statutory certificate signed by the Labour Commissioner.

The claimants have brought this dispute against the respondents for refusal to pay redundancy compensation to 42 employees who the respondents claimed were casual workers and did not qualify to be paid at the time their services were terminated when their wheat mill closed down in February, 1982.

The claimants maintain that the respondents closed the wheat mill in Industrial Area, Nairobi, under the pretext that they had less wheat for processing although from the investigations there are other reasons that probably compelled them to take such an action.

The claimants stated that they had entered into a two-year collective agreement with the respondents regarding wages and terms of employment which was to be effective from 1st August, 1981. This agreement covered all unionizable employees including these 42 employees. However, the collective agreement entered into was not implemented as it was not sent to the Industrial Court for formal registration.

The claimants went on to say that the 42 employees were employed in various categories of skilled and unskilled labour but continued to work on regular basis as permanent employees but paid weekly at the convenience of the employer.

The claimants pointed out that some of the employees had worked for the respondents continuously for the period 1976 to 1982 without any break of service and yet the respondents con-

sidered them as casuals. Furthermore, the respondents never observed the regulations governing employment of casual employees.

The collective agreement which was not registered provided for a normal working week of 45 hours spread over six days or shifts and provided for annual leave and other benefits such as redundancy. The claimants therefore considered that the action taken by the respondents to dispense with the services of the 42 employees without paying them redundancy compensation was unfair and denied them what they are entitled to under such circumstances.

The respondents told the court that they were established in 1975 by Hasham Lalji Group of companies and started operating in 1976 as a wheat milling company with a capital of KSh. 3,000,000. Its main raw material when it was operating was wheat supplied from the National Cereals and Produce Board through Kenya Farmers Association (Co-operative) Ltd. The company started with 17 permanent staff and the number continued to fluctuate over the years as follows:

1976	1978	1979	1980	1981	1982	1983
17	19	29	28	40	32	17

At the time of closing down its operations, the number of the respondents' permanent employees was 13. These 13 employees have been offered regular employment by one of the directors of the respondents following the indefinite closure of the respondents' factory. The respondents further pointed out that in 1982 they had obtained permission to declare 8 employees redundant. They further stated that their business required the engagement from time to time of a number of casual workers who worked on daily basis but were paid at the end of the week. All the employees involved in this dispute were employed on casual basis and worked at their own pleasure subject to there being any work for them.

The respondents produced in court work sheets showing the various casual employment contracts covering the employees in dispute.

The respondents argued that as casual workers, the question of their having been declared redundant does not arise. This type of contract is provided for in section 14 of the Employment Act (Cap. 226) and there is no evidence that the claimants ever challenged their application for the entire period the respondents were in operation including the time they signed an agreement to effect redundancy.

The division of manpower planning and development made investigations in this dispute at the request of the court. Their findings established the following facts:

The first and foremost feature is that Ken-Wheat Industries Ltd. appear to be permanently closed at least in the immediate future and hence the question of the employees reinstatement is not so much the concern of the parties, but there are indications that this may be possible if the company is revitalized and put into full production again.

On the basis of all the interviews taken, it has come to light that all the 42 employees appear to have voluntarily agreed to sign casual employment forms (cards) starting as far back as 1978. This was done apparently as a form of guarantee for them to stay in their jobs longer, however, despite the fact that they have been paid on weekly basis and signed the above-mentioned casual employment "guarantee forms" on weekly basis, there is evidence to confirm that majority (80 per cent of the 42 employees) have actually worked continuously for a number of years without a break of service as has been supported by a number of employees who were interviewed. This is also confirmed by the attached record of weekly payment schedule which shows continuity of service for the period 1981-82 for some of the affected workers.

The respondents in their final submission reiterated their earlier point that all the 42 employees in question signed weekly casual labour cards which they presented to the court. It is therefore the respondents' submission that the signed casual cards constituted fixed weekly term contracts and essentially confirmed the contracts between the respondents and the 42 persons.

The court has carefully studied various issues raised by both parties and has no reason to doubt that the claimants had recognition and collective agreements with the respondents although not registered with the court.

The court further finds that in an endeavour to keep the same people in guaranteed employment for a very long period, the respondents engaged themselves in an unfair labour practice thereby avoiding to recognize and treat the 42 ex-employees as their regular labour force.

Furthermore, the court was not convinced with the respondents arguments that these employees were casuals as they did not comply with the regulations governing such employment.

The court finds that all these 42 employees were on weekly contracts for at least three years they were in the respondents' employment and as such they are entitled to redundancy benefits as prescribed by law. The court therefore awards that the respondents should pay all of them their redundancy dues which will be worked out by the parties with the assistance of the Chief Industrial Relations Officer, Ministry of Labour.

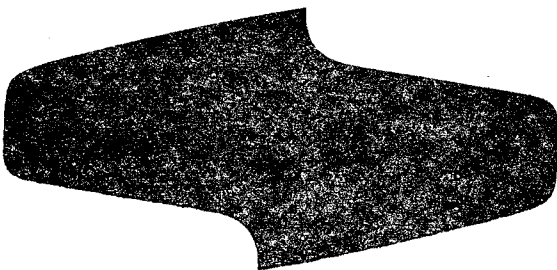

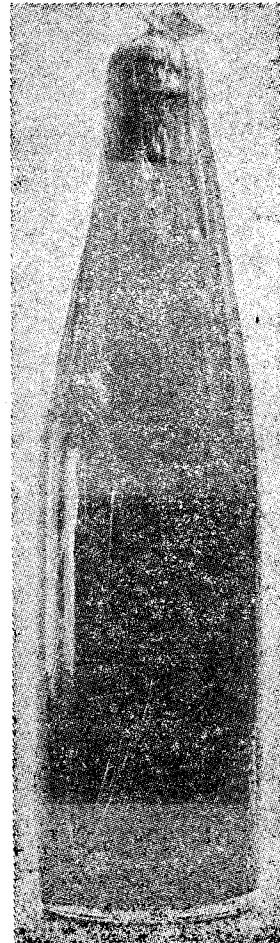

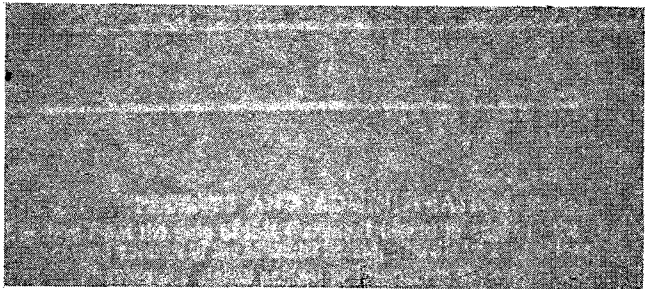
