*Vacancies in the Office of the President (G.T.I., Mombasa):***Senior Lecturer (Two Posts) (Re-advertisement) (No. 140/85)**

Applicants should be in possession of at least a master's degree in either business, administrative or management studies, or other related fields, obtained from a recognized university. Consideration will also be given to those with CPA/CPS III. In either case, applicants should have at least four years' working experience in their relevant fields.

The successful candidates will be expected to plan and to give lectures to trainees preparing for various stages of KASNEB examinations. They will be expected to plan, organize and lecture to middle level management courses/seminars. They will assist department heads in the general administration of their respective departments, and to perform other duties as may be assigned by the principal.

**Lecturer Grade I (Eight Posts) (Re-advertisement) (No. 141/85)**

Those who majored in either accounting, statistics, auditing or management mathematics will have an added advantage. Successful candidates will be expected to plan and give lectures to trainees preparing for various stages of KASNEB examinations and or Kenya National Examinations Council, business education. They will additionally plan and give lectures to middle level management courses. They will be expected to do research with a view to developing teaching materials and to perform other duties as may be assigned by the principal.

**Senior Registrar (Two Posts) (National Registration Bureau) (No. 142/85)**

**Salary scale.**—K£2,154 to 2,928 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers who must have served for at least (3) years at Job Group "J". They should have experience in government procedure and well versed in financial and stores accounting. They should be able to conduct official correspondence and prepare estimates and all types of returns. Experience in a law enforcement agency including the police or Immigration Department will be an advantage.

The duties include the interpretation of the Registration Act (Cap. 107) and assisting the principal registrar in the implementation of the Act. Applicants are expected to be responsible officers of high integrity who can work without supervision.

The successful candidates will be stationed at the bureau headquarters.

**Senior Fingerprint Officer (One Post) (National Registration Bureau) (No. 143/85)**

**Salary scale.**—K£2,154 to 2,928 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers who must have served at Job Group "J" for at least (3) years. He must have wide experience in all aspects of fingerprint work and have the ability to organize and direct work in a large bureau. He must be conversant with the relevant Acts governing the operation of the bureau and other departmental regulations and instructions. A senior fingerprint officer is required to assist the chief fingerprint officer in the operation of the bureau and/or administering the relevant Acts as appropriate. He is responsible to him for control, co-ordination and supervision of all the sections within the bureau including handling of normal correspondence on all matters affecting the work of the bureau.

He is also directly responsible to him for staff development including preparation of fingerprint examinations.

The successful candidates will be stationed at the bureau headquarters.

**Lecturer Grade II (Four Posts) (Kenya Government Secretarial College) (Re-advertisement) (No. 144/85)**

**Salary scale.**—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants should have a bachelor's degree in business education with ability to teach business english, commerce and office practice. They should have at least three years' teaching experience as graduate teachers or assistant lecturer II in business education subjects. Non-graduates who have recognized teaching diplomas and have a minimum of five years' teaching experience as assistant lecturer II at post-secondary level will also be considered.

The successful candidates will be expected to give lectures in all of the above subjects and other secretarial subjects. They will also be expected to use a variety of teaching methods, set and mark assignments, prepare tests and marking schemes and supervise students.

**Registrar Grade I (Six Posts) (National Registration Bureau) (No. 145/85)**

**Salary scale.**—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers who should have been at Job Group "H" for at least three (3) years. They should have experience in government procedure and should be familiar with financial and stores accounting. They should be able to conduct official correspondence and prepare estimates and all kinds of returns.

The duties include the interpretation of the Registration Act (Cap. 107) and assisting the principal registrar in the implementation of the Act. Applicants are expected to be responsible officers of high integrity who can work with little or no supervision. The successful candidates will be deployed in the bureau headquarters and in the provinces.

**Fingerprint Officer I (Four Posts) (National Registration Bureau) (No. 146/85)**

**Salary scale.**—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers of E.A.C.E. standard of education or its equivalent with at least three (3) years satisfactory experience as fingerprint officer I at Job Group "H". A wide knowledge of the Registration Act pertaining to fingerprint at court procedure will be an advantage.

Work at this level mainly involves supervision of the operation of a large section of the bureau; preparation of exhibits or court documents and court attendance; verification and certification of illegal registration or of certificate of previous conviction and verification of exhibits/court documents prepared by officers under him. He may also be required to attend a court of law to give evidence.

**Registrar II (Six Posts) (National Registration Bureau) (No. 147/85)**

**Salary scale.**—K£1,494 to 2,010 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers of E.A.C.E. standard or its equivalent, with a minimum of three (3) years satisfactory experience as assistant registrar at Job Group "G".

They should be familiar with financial and stores accounting and be able to conduct official correspondence independently. The duties include the interpretation of the Registration Act (Cap. 107) and assisting the principal registrar in the administration. He will also be expected to prepare estimates and all kinds of returns.

The successful candidates will be stationed in various districts in Kenya.

**Fingerprint Officer II (Twelve Posts) (National Registration Bureau) (No. 148/85)**

**Salary scale.**—K£1,494 to 2,010 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers of E.A.C.E. standard or its equivalent with three (3) years' satisfactory experience as a senior fingerprint assistant at Job Group "G". A pass in the fingerprint examinations A, B and C is a must.

The duties involve supervision of a medium-sized section of the fingerprint bureau, searching and comparison of finger marks found at scenes of crime and/or identification of bodies using fingerprint; verification and certification of illegal registration or of certificates of previous convictions. The officer may, in addition, be required to give evidence in a court of law.

**Senior Fingerprint Assistant (Fifteen Posts) (National Registration Bureau) (No. 149/85)**

**Salary scale.**—K£1,128 to 1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers preferably of East African School Certificate standard of education or its equivalent, with a minimum of two years satisfactory service as fingerprint assistant I at Job Group "F".

The duties involve testing, classifying, giving extensions and alternatives to the fingerprint formulae. They may also be required to undertake training of juniors and supervise their work.

The successful candidates will be posted to various districts in Kenya.

**Assistant Registrar (Thirty Posts) (National Registration Bureau) (No. 150/85)**

**Salary scale.**—K£1,128 to 1,554 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers preferably of East African School Certificate of Education or its equivalent with a minimum of six years' satisfactory clerical experience in various aspects of general clerical functions two (2) of which should be in the grade of senior clerical officer at Job Group "F". They should be able to conduct official correspondence independently and prepare all kinds of returns. A pass in the proficiency examination for clerical officers is mandatory.

The assistant registrar's duties include, the interpretation of the Registration Act (Cap. 107) and assisting the principal registrar in the implementation of the Act. Successful candidates will be posted to various districts in Kenya.

**Vacancies in the Ministry of Labour:****Senior Labour Officer (Three Posts) (No. 151/85)**

**Salary scale.**—K£2,712 to 3,540 p.a. PENSIONABLE or AGREEMENT.

Applicants must be civil servants with a minimum educational qualification of East African Certificate of Education or its equivalent with considerable experience in labour administration and industrial relations. They must have shown ability and merit over a period of at least three years in the grade of labour officer I. They must have thorough knowledge of government regulations, and should have administrative experience and knowledge of educating procedures.

The successful candidates will be expected to work as either provincial labour officers in charge of labour administration in the provinces or assistant to the labour commissioner at the headquarters, Nairobi. The duties will include assisting the labour commissioner in the administration of the field operations and advising the field officers on their day-to-day operations, labour inspections and preparation of monthly reports to be submitted to the headquarters.

**Vacancies in the Ministry of Works, Housing and Physical Planning:****Quantity Survey Assistant II (Two Posts) (Quantities and Contracts) (No. 152/85)**

Applicants must be in possession of the national ordinary technical diploma in building from the Kenya Polytechnic or its approved equivalent with at least three (3) years in the grade of quantity survey assistant III and must have been confirmed in appointment. Duties include preparation of bills of quantities, specifications for small projects, payment certificates and final accounts for small projects; compilation of tender and contract documentation.

Applicants should be of mature age with at least eight years' experience in road maintenance and construction of which three must have been spent in supervisory capacity. They should have considerable experience in work planning and programming, preparing and controlling expenditures and also have considerable experience in the use of heavy earth-moving equipment, bitumen surface dressing and paving equipment and also full knowledge of maintenance of bitumen and gravel roads.

They should be able to direct, control and supervise a large labour force.

**Vacancies in the Ministry of Transport and Communications:****Fire Officer I (One Post) (Aerodromes) (No. 154/85)**

**Salary scale.**—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving fire officer grade II with sound knowledge in both technical and administrative matters of aerodromes fire service organization with at least (10) years of fire fighting experience, four of which must have been spent as an officer in charge of a major fire station.

They must be capable of carrying out training at station levels and conduct fire prevention surveys affecting airport buildings and operational areas. The candidate should be capable of compiling comprehensive reports after aircraft and or fire incidents and knowledge of stores accounting procedure would be an added advantage.

**Fire Officer II (One Post) (Aerodromes) (No. 155/85)**

**Salary scale.**—K£1,494 to 2,010 p.a. PENSIONABLE or AGREEMENT.

Applicants are required to have a sound technical and administrative knowledge of aerodromes fire service matters, with at least six (6) years of fire fighting experience three (3) of which should have been spent as an officer in charge of a major fire station.

They must be capable of carrying out training at station levels and conduct fire prevention surveys affecting airport buildings and operational areas. The candidate should be capable of compiling comprehensive reports after aircraft and or fire incidents and knowledge of stores accounting procedure would be an added advantage.

**Vacancies in the Ministry of Information and Broadcasting:****Lecturer Grade II (Six Posts) (Engineering) (No. 156/85)**

**Salary scale.**—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants should preferably be graduates of electrical/electronic engineering from a recognized university or holders of higher national diploma in electrical/electronic engineering with a thorough knowledge of electronics and telecommunications.

Consideration will however be given to applicants who possess either the ordinary diploma in electronics or telecommunications technician certificate part III with at least three (3) years' experience in radio and TV engineering or qualified instructions in electronics and telecommunications techniques.

Duties will include training of technicians, technical operators and teaching other subjects related to basic telecommunications and broadcasting engineering.

**Lecturer Grade II (Three Posts) (Production) (No. 157/85)**

**Salary scale.**—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants should be graduates in mass communication or social science who have specialized in both theoretical and practical production of TV programme production techniques. Holders of a recognized diploma in TV programme production for a period of at least three years as television producers at the level of Job Group "H". Courses in training techniques will be arranged if necessary.

The successful candidates will be assigned training duties in both theory and practical aspects of production of TV programmes and will be required to teach TV news writing to information trainees in the institute including the field of drama, music production, sports and special events.

**Principal Studio Technical Operator (One Post) (Engineering) (No. 158/85)**

**Salary scale.**—K£1,794 to 2,424 p.a. PENSIONABLE or AGREEMENT.

Applicants must have at least six (6) years' experience in studio operations, three (3) of which must have been served at Job Group "H" level. In addition, they must have shown merit and ability required for efficient organization and supervision of work including good knowledge of safety regulations.

Work at this level involves taking charge of operations equipment in main radio and television studios or lighting facilities in a television studio in liaison with engineers who maintain the facilities and producers who use them. Responsibility also entails allocation of duties, preparation of shift rosters, supervision and training of staff on the job.

**Vacancies in the Ministry of Local Government:****Deputy City Engineer (One Post) (City Engineer's Department) (Nairobi City Commission) (No. 159/85)**

**Salary scale.**—K£4,446 to 5,151 p.a. PENSIONABLE or AGREEMENT.

Applicants must be professionally qualified civil engineers registered by the Engineers Registration Board of Kenya. They must have wide knowledge in civil and municipal engineering work with at least five years in a senior capacity. The deputy city engineer will be responsible to the city engineer to co-ordinate, design, implementation and maintenance of engineering works including roads, drains, bridges and buildings. The department has over 3,000 employees. He will be responsible for programming and co-ordinating the work of engineers and technical staff below him.

**Chief Mechanical Engineer (One Post) (City Engineer's Department) (Nairobi City Commission) (No. 160/85)**

**Salary scale.**—K£3,240 to 3,930 p.a. PENSIONABLE or AGREEMENT.

Applicants must be professionally qualified mechanical engineers registered by the Engineers Registration Board of Kenya or be corporate member of a professional engineering body recognized by this institution. They must have shown merit and professional competence to undertake planning and direction of maintenance work for a large fleet of motor vehicles and plants.

The chief mechanical engineer will be responsible to the city engineer for the efficient management of the transport depot which has about 800 employees and fleet of vehicles and specialized equipment totalling about 500.

**Chief Fire Officer (One Post) (City Engineer's Department) (Nairobi City Commission) (No. 161/85)**

**Salary scale.**—K£2,925 to 3,450 p.a. PENSIONABLE or AGREEMENT.

Applicants should preferably possess not less than E.A.C.E. standard of education. He must have had at least (10) years' administrative and fire fighting experience as a senior officer in a recognized fire brigade. He should have held responsible posts involving both operations and organizations and appropriate qualifications such as a diploma of the institute of fire engineers or any other course related to fire engineering.

He will be responsible to the city engineer in the day-to-day operation of fire services in the city, liaison with government departments, inspection of fire installation.

He must be resourceful and capable of formulating internal training programmes for staff under him and external agencies.

The job calls for special aptitude in the operational efficiency of the fire and ambulance service and genuine interest in this work is essential as it involves organization and supervision of welfare and recreational facilities.

**Senior Assistant Engineer (Eight Posts) (City Engineer's Department) (Nairobi City Commission) (No. 162/85)**

**Salary scale.**—K£2,925 to 3,450 p.a. PENSIONABLE or AGREEMENT.

Applicants must be in possession of B.Sc. degree in civil engineering from the University of Nairobi or any recognized university and be registered by the Engineers Registration Board of Kenya. They must have served for a minimum of three (3) years since qualifying and shown competence and ability in design and supervision of civil engineering. Duties will involve plan, design and supervise civil engineering works, general supervision of projects and preparation of contract documents and costing of various projects.

**Senior Assistant Engineer (Structural) (Two Posts) (City Engineer's Department) (Nairobi City Commission) (Re-advertisement) (No. 163/85)**

**Salary scale.**—K£2,925 to 3,450 p.a. PENSIONABLE or AGREEMENT.

Applicants must be in possession of a degree in civil/structural engineering from the University of Nairobi or any other recognized university. They must have served for at least five (5) years since qualifying and be registered by the Engineers Registration Board of Kenya.

They must have shown knowledge and ability in design and supervision of structural engineering works with emphasis on reinforced concrete.

Duties will include planning, structural design, preparation of contract documents and costing of civil and structural works, and general administration of the projects.

**Assistant Engineer (Three posts) (City Engineer's Department) (Nairobi City Commission) (No. 164/85)**

**Salary scale.**—K£2,565 to 3,135 p.a. PENSIONABLE or AGREEMENT.

Applicants should be in possession of a degree in civil engineering from the University of Nairobi or any recognized university with at least three (3) years' experience since graduating in design and supervision of civil engineering works. Candidates should be registerable by the Engineers Registration Board of Kenya.

**County Treasurer (One Post) (Kitui County Council) (No. 165/85)**

Issue in dispute:

Dismissal of Karoli Wasaba.

THE Kenya Union of Domestic, Hotels, Educational Institutions, Hospitals and Allied Workers shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 1st April and 3rd May, 1985, and relied on their written and verbal submissions.

In addition they called the following witnesses:

Claimants.—Karoli Wasaba.

Respondents.—John Mbuthia.

AWARD

3. The Notification of Dispute Form "A" dated 24th January, 1984, signed by the parties was received by the court together with the statutory certificates signed by the Minister for Labour, on 14th August, 1984, and the Labour Commissioner, on 8th August, 1984.

The grievant Karoli Wasaba was employed by the respondents as an assistant chief security officer, on 16th March, 1981, and he was dismissed on 25th June, 1982, after a service of 14 months. The circumstances that led to his dismissal took place on 19th June, 1982, when Mr. Wasaba was taken by police to his house for a search. The claimants told the court that their member was charged before a criminal court for stealing goods which were alleged to have been stolen from the respondents undertaking but he was acquitted. The claimants contended that as a result of the acquittal their member was not guilty of any offence and that the respondents should not have dismissed him. The claimants further argued that the respondents did not respect the parties collective agreement which allows suspension in a case like this one, pending criminal courts' decision. The claimants prayed the court to find this dismissal wrongful and give maximum compensation to their member.

The respondents told the court that on the day in question when Mr. Wasaba's house was searched by the police in their chief security officers' presence, the police took several goods which were similar to those at the respondents hotel and that there were two bedsheets which bore Serena logo which no doubt were stolen from the hotel. The respondents further told the court that Mr. Wasaba was not confirmed in his appointment because he had committed several offences at his place of work within that short period of service. The respondents bitterly argued about the acquittal of Mr. Wasaba by the criminal court pointing out that if the police had charged Mr. Wasaba with possessing stolen property the outcome of the case would have been different. The respondents further told the court that their trust in Mr. Wasaba ended immediately after learning that some goods from their undertaking were found and identified in Mr. Wasaba's house so they justifiably dismissed him.

The court is not really concerned with the scathing criticism made by the respondents against the police regarding the way in which the prosecution was handled in the criminal case.

After careful consideration of the submissions the court finds that the respondents had reasonable grounds for terminating Mr. Wasaba's services but not dismissing him. Further, the respondents should have taken into account the parties collective agreement which provides for fourteen (14) days suspension with pay. The court awards that Mr. Wasaba's dismissal be reduced to normal termination and he be paid one month's salary by way of compensation and a further fourteen (14) days' salary which he would have got if he had been suspended.

Provided that notwithstanding anything to the contrary contained in or implied by the Government Lands Act, if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful for the Commissioner of Lands or any person authorized by him on behalf of the President to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term created shall cease but without prejudice to any right of action or remedy of the President or the commissioner in respect of any antecedent breach of any condition herein contained.

3. The lessee shall maintain in good and substantial repair and condition all buildings at any time erected on the land.

4. Should the lessee give notice in writing to the Commissioner of Lands that she/he/they is/are unable to complete the buildings within the period aforesaid, the Commissioner of Lands shall (at the lessee's expense) accept a surrender of land comprised herein:

Provided further that if such notice as aforesaid shall be given (1) within twelve (12) months of the actual registration of the lease, the Commissioner of Lands shall refund to the lessee 50 per cent of the stand premium paid in respect of the land or (2) at any subsequent time prior to the expiration of the said building period the Commissioner of Lands shall refund the lessee 25 per cent of the said stand premium. In the event of notice being given after the expiration of the building period no refund shall be made.

5. The land buildings shall only be used for residential and commercial purposes.

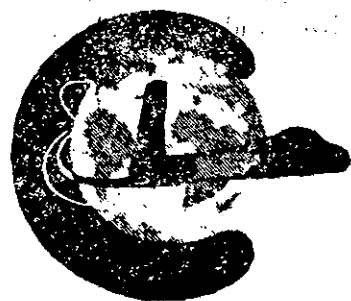
