## THE ANTIQUITIES AND MONUMENTS ACT

## DECLARATION OF MONUMENTS

IN EXERCISE of the powers conferred by section 4 (1) of the Antiquities and Monuments Act, the Vice-President and Minister for Home Affairs declares the areas of land specified in the schedule to be monuments within the meaning of the Act.

2. Completed applications should be submitted to the Commissioner of Lands, Nairobi, through the Town Clerk, Kitale Municipal Council, P.O. Box 260, Kitale, on the prescribed forms which are available from the District Lands office, Kitale, and the office of the Town Clerk, P.O. Box 260, Kitale.

3. Applications must be sent so as to reach the town clerk not later than 12 noon, on 19th July, 1985, and the applicants must enclose with their applications either a bank's cheque, money order, postal order for KSh. 1,000 made payable to the Commissioner of Lands deposit which will be dealt with as follows:

- (a) Credited to a successful applicant.
  - (b) Refund to an unsuccessful applicant.
  - (c) Forfeited if a successful applicant fails to pay within thirty (30) days of the offer of a plot, and the applicant shall have no further claim thereto.
4. Each application should be accompanied by a statement indicating:
- (a) The amount of capital it is proposed to spend on the project.
  - (b) The amount of actual capital available for development with banker's letter or other evidence of financial status in support.
  - (c) The manner in which it is proposed to raise the balance required for development, if any.
  - (d) Full details of both residential and/or commercial properties owned by the applicant in the municipality.
  - (e) Individual applicants to indicate their identity card numbers.
  - (f) In case of companies, names of directors to be included.

5. The successful allottee of a plot shall pay to the Commissioner of Lands within thirty (30) days of notification that his/her application has been successful, the stand premium and proportion of the annual rent together with conveyancing, stamp duty, registration fees, contributions in lieu of rates, roads and drains charges and survey fees. In default of payment within the specified time, the Commissioner of Lands may cancel the allocations and the applicant shall have no claim to the plot.

## General Conditions

1. The grant will be made under the provision of the Government Lands Act/Trust Lands Act, and title will be issued under the Registration of Titles Act (Cap. 281) or the Registered Land Act (Cap. 300) as the case may be.

2. The grant will be issued in the name of the allottee as given in letter of application and will be subject to the special conditions set out below.

3. The term of the grant will be for ninety-nine (99) years from the first day of the month following the issue of the letter of allotment.

## Special Conditions

1. No buildings shall be erected on the land nor shall additions or external alterations be made to any buildings otherwise than in conformity with plans and specifications previously approved in writing by the Commissioner of Lands and the local authority. The Commissioner of Lands shall not give his approval unless he is satisfied that the proposals are such as to develop the land adequately and satisfactorily.

2. The lessee shall within six (6) calendar months of the actual registration of the lease submit in triplicate to the local authority and the Commissioner of Lands plans (including block plans showing the positions of the buildings and a system of drainage for the disposal of sewage surface and sullage water) drawings elevations and specifications of the buildings the lessee proposes to erect on the land and shall within twenty-four (24) months of the actual registration of the lease complete the erection of such buildings and the construction of the drainage system in conformity with such plans, drawings elevations and specifications as amended (if such be the case) by the commissioner:

Provided that notwithstanding anything to the contrary contained in or implied by the Government Lands Act, if default shall be made in the performance or observance of any of the requirements of this condition it shall be lawful for the Commissioner of Lands or any person authorized by him on behalf of the President to re-enter into and upon the land or any part thereof in the name of the whole and thereupon the term created shall cease but without prejudice to any right of action or remedy of the President or the commissioner in respect of any antecedent breach of any condition herein contained.

3. The lessee shall maintain in good and substantial repair and condition all buildings at any time erected on the land.

4. Should the lessee give notice in writing to the Commissioner of Lands that she/he/they is/are unable to complete the buildings within the period aforesaid, the Commissioner of Lands shall (at the lessee's expense) accept a surrender of land comprised herein:

Provided further that if such notice as aforesaid shall be given (1) within twelve (12) months of the actual registration of the lease, the Commissioner of Lands shall refund to the lessee 50 per cent of the stand premium paid in respect of the land or (2) at any subsequent time prior to the expiration of the said building period the Commissioner of Lands shall refund the lessee 25 per cent of the said stand premium. In the event of notice being given after the expiration of the building period no refund shall be made.

5. The land buildings shall only be used for residential and commercial purposes.

6. The building shall not cover more than 50 per cent of the area of the land if used for residential purposes and 75 per cent of the area of the land if used for shops, offices and flats or such lesser area than may be laid down by the local authority in its by-laws.

7. The lessee shall not subdivide the land without prior written consent of the Commissioner of Lands.

8. The lessee shall not sell, transfer, sublet, charge or part with the possession of the land or any part thereof or any building thereon except with prior consent in writing of the Commissioner of Lands. No application for such consent (except in respect of a loan required for building purposes) will be considered until special condition No. 2 has been performed.

9. The lessee shall pay to the Commissioner of Lands on demand such sum as the commissioner may estimate to be the proportionate cost of constructing all roads and drains and sewers serving or adjoining the land and shall on completion of such construction and the ascertainment of the actual proportionate cost either pay (within seven (7) days of demand) or be refunded the amount by which the actual proportionate cost exceeds or falls short of the amount paid as aforesaid.

10. The lessee shall from time to time pay to the Commissioner of Lands on demand such proportion of the cost of maintaining all roads and drains serving or adjoining the land as the Commissioner of Lands may assess.

11. Should the Commissioner of Lands at any time require the said roads to be constructed to higher standard the lessee shall pay to the commissioner on demand such proportion of the cost of such construction as the commissioner may assess.

12. The lessee shall pay such rates, taxes, charges, duties, assessments or outgoings of whatever description as may be imposed, charged or assessed by any government of local authority upon the land or the buildings erected thereon, including any contribution or other sum paid by the President of the Republic of Kenya, in lieu thereof.

13. The President of Kenya or such person or authority as may be appointed for the purpose shall have the right to enter upon the land and lay and have access to water mains, service pipes and drains telephone or telegraph wires and electric mains of all descriptions whether overhead or underground and the lessee shall not erect any buildings in such a way as to cover or interfere with any existing alignments of main or service pipes or telephone or telegraph wires and electric mains.

14. The Commissioner of Lands reserves the right to revise the annual ground rental payable hereunder after the expiration of the thirty-third (33rd) and sixty-sixth (66th) years of the term granted. Such rental will be at a rate of 4 per cent of unimproved freehold value of the land as assessed by the Commissioner of Lands.

## THE INDUSTRIAL COURT

CAUSE No. 62 OF 1984

*Parties:*

Kenya Engineering Workers' Union  
and  
Stainless Steel Products Ltd.

*Issue in dispute:*

Unlawful deduction of wage increments to five employees.

THE Kenya Engineering Workers' Union shall hereinafter be referred to as the claimants and Stainless Steel Products Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 18th April, 1985, and relied on their written and verbal submissions.

## AWARD

3. The notification of dispute form "A" dated 11th December, 1982, duly signed by the parties was received by the court together with the statutory certificate signed by the Labour Commissioner.

This dispute concerns five employees of the respondents who were given wage increments ranging between Sh. 20 and Sh. 110 p.m. by the respondents, in November 79 and March and May 1980. In August 1980 the respondents withdrew these increments on the ground that they had been given irregularly. The claimants disagreed with the respondents story that these increments were given by the then personnel officer of the respondents without managements' authority. The claimants argued that the personnel officer is part of the management and his acts whether good or bad, are deemed to be the respondents' action. The claimants prayed the court to award the five employees the increments from the date the respondents had withdrawn them.

The respondents on the other hand did not agree with the claimants that the increments so illegally given by a personnel officer should be upheld by them on grounds that the personnel officer was not empowered to do so and also that he was not given authority to give these increments. The respondents told the court that four out of the five employees involved in this dispute had left the employment of the respondents. One left before the implementation of the said agreement, two left in 1981 and 1982 and had collected their dues through the Ministry of Labour in full and final settlement of their claim and the other one had deserted the employment in 1984. There is however one Susan Okare who is still in the employment of the respondents. The respondents further told the court that this personnel officer who was involved in giving these illegal increments had deserted his work immediately he knew that this irregular deal had been discovered.

The court notes that the claimants are demanding increments for all the five employees for the last 54 months from the date such increments were withdrawn by the respondents. The court also finds it strange that it took the respondents 10 months to discover the so called irregular increments which, to the employees concerned had become their regular income. After careful consideration of the submissions by both parties the court finds that the four of the five employees who have left the employment of the respondents are not entitled to any award. The remaining employee, Susan Okare, is entitled to be paid her Sh. 100 increment from the date it was withdrawn to date and she should continue receiving it as the respondents

are bound by the actions of their personnel officer. The court accordingly awards that the respondents should pay Miss Okare all her dues as stated above.

*Issue in dispute:*

Dismissal of 34 employees.

THE Kenya Building, Construction and Civil Engineering and Allied Trades Workers' Union shall hereinafter be referred to as the claimants and Victory Construction Company Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 20th and 21st March, 1985, and relied on their written and verbal submissions. The respondents also called Mr. Avtar Singh Suri to give evidence on oath.

## AWARD

3. The Minister for Labour, referred the dispute to the court on 19th October, 1983, in accordance with section 8 of the Trade Disputes Act together with the statutory certificate signed by the Labour Commissioner.

This dispute concerns 34 employees of the respondents who lost their jobs on or about 5th August, 1980, with the claimants claiming that they were dismissed and the respondents maintaining they abandoned their jobs.

The respondents are a limited liability company involved in building and civil engineering work throughout Kenya. They were until 1979 members of Kenya Association of Building and Civil Engineering Contractors. The claimants on the other hand maintain that they ceased their membership in 1982 and, so, were, in fact, bound by the associations' agreements governing wages and other terms and condition of employment.

The court would now like to deal with the incident that led to the alleged dismissal of these 34 employees. The claimants submitted that their members were paid wages below the statutory minimum. This matter was then referred to the officials of the Ministry of Labour who agreed with the parties to convene a joint meeting at the respondents' premises to establish whether or not these allegations were well founded. The claimants further sought the advice of Mr. Jaffer an advocate, who was also invited to attend the said meeting.

When the meeting was first convened in April 1980, following a complaint made by seven employees the labour officer investigated the complaint and was satisfied that the respondents had complied with the statutory wages requirements and that there were no irregularities detected.

After some months again the claimants raised a similar complaint on 5th August, 1980, involving 34 employees, an official of the ministry was again invited and attended the meeting. The claimants were this time represented by their Mr. Murugu and Mr. Gakunju and Mr. Jaffer. The respondents were represented by their managing director and the manager. The meeting took place at the respondents' offices. When the meeting had checked the records of wages paid to about seven or eight employees and it was found that there were no irregularities, it was alleged that Mr. Murugu (the Claimants' Secretary-General) left the meeting and went out. On his return after a short time the rest of the meeting heard a big noise outside and the crowd of some 30 to 35 workers were pushing the door to gain entrance to the meeting by force. They finally forced the door open while the respondents and ministry official pleaded with the claimants to contain their members. This plea failed, and the crowd pulled Mr. Avtar Singh, the managing director, and the manager and beat them and caused considerable damage to property and documents in the meeting room. The labour official was also pushed around when he tried to stop them. The commotion continued outside the offices where the manager was beaten down to the ground and Mr. Avtar Singh while being beaten was forced to walk to Makadara Court and was only saved by a police patrol car. He was later taken to the hospital and the 34 workers were subsequently arrested, charged and convicted. They were however discharged by the magistrate under section 35 (1) of the Penal Code. The workers never returned to their place of work after that.

The court is shocked with behaviour of the workers when they were the ones who sought help from the ministry officials, and while the meeting was in progress they chose to terminate the meeting through violence. The court observed that respondents had fully co-operated with the claimants and the ministry official and had tabled all the relevant documents before the meeting called specifically to solve the claimants' accusations against management.

The court is satisfied that the workers knew that their claims were baseless hence their unjustified behaviour. This did not help their case at all. In fact the court agrees with the respondents' submission that the workers' behaviour on that material day was not only disgraceful but totally unjustified.

The claimants have in their submission raised a number of issues concerning past labour unrest in the respondents' company but the court cannot go into these as they are irrelevant and do not form part of the dispute. They have further raised the question of underpayment of wages but, that again, the court has been advised by the respondents that the issue is already before the high court for adjudication and is therefore subjudice. In any case the claimants' grievances, if any, against the respondents should have been processed through the normal laid down machinery especially the question of whether or not the respondents were bound by the collective agreement between the claimants and the association.

The attention of the court was further drawn to the fact that this dispute was a subject of a parliamentary debate and was widely published in the local press when Hon. Laban Kitele the then Assistant Minister for Labour in his official reply in Parliament stated that "the 34 workers dismissed themselves from work." The Assistant Minister's reply to the National Assembly has been supported by overwhelming submission from the respondents and their witness which the claimants have totally failed to demolish. The claimants called no witnesses during the hearing. Under the circumstances the court finds no reason to differ with the minister's statement.

In view of the assistant minister's reply in parliament the court is astonished at the same ministry's investigation report which the court has no hesitation in rejecting.

The court views the deplorable behaviour of such workers with grave concern and cannot allow them to take the law into their own hands and later turn to the court expecting sympathy. The court would like to warn that there is no room for mob justice in industrial relations in Kenya. Any such tendency should be nipped in the bud. The court in consideration of submissions placed before it finds that the 34 employees abandoned their work. Even if they had reported back to work the respondents would have been perfectly justified in dismissing them summarily on grounds of gross misconduct.

The court finally finds that the 34 claimants have no cause of action in this dispute and their claims are accordingly rejected. They are entitled to their dues up to the day they worked.


