Issue in dispute:

Termination of Mary Mugure Kibuu.

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and Phoenix of East Africa Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi, on 3rd July, 1985, and relied on their written and verbal submissions. The claimants called the grievant Mary Kibuu, who gave evidence and the respondents called David Mutie and Christopher Kittakah as witnesses.

AWARD

3. The notification of Dispute Form "A" dated 7th August, 1984, duly signed by the parties was received by the court on 7th January, 1985, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievant was employed by the respondent in July, 1970, as a cleaner at a salary of KSh. 180 per month. Her services were terminated on 30th July, 1982, after 12 years' service with the respondents. Her salary at the time of termination was KSh. 1,112 per month.

The circumstances that led to her dismissal started on 20th July, 1982, when two bottles of whisky were stolen from the general manager's office. It is alleged that on the day in question Mary Kibuu was cleaning the boardroom which is adjacent to general manager's office with one, Margaret Njeri and David Mutie at about 1 p.m. In this office there is a cupboard with whisky bottles. The keys to this cupboard are kept in a key safe on the wall and which is not locked. At 2 p.m. when general manager returned from lunch he discovered that 2 bottles of whisky were missing. He directed that investigations be conducted. As a result Mary Kibuu was implicated in the offence and subsequently dismissed.

The claimants argument is that Mary Kibuu was made to make a statement on the same day. In this statement she said she was given a carton by David Mutie to take to a florist outside the building for safekeeping until Mr. Mutie collected it. The claimants held that Mary Kibuu did not know the contents of the carton. Giving evidence in court Mary Kibuu stated that she knew the contents were 2 bottles of whisky when she was called in the general manager's office in the afternoon, when she was being questioned. She told the court that she was given these bottles by Mr. Mutie. She denied the allegations that are contained in her first statement that Mr. Mutie, Margaret and herself had agreed to sell the whisky and share the money. She alleged that Mr. Kittakah who recorded her statement did not read back the statement to her so he might have written a wrong story. She also told the court that at the time Mr. Kittakah was recording the statement they were two of them only. On being cross-examined she denied that there was a witness when the statement was being recorded. Mary Kibuu recalled that she made another statement to another person which she says again was not read back to her. She claimed she did not know this other person at all. The claimants submitted that the respondents were wrong in dismissing their member and retaining Mr. Mutie who was implicated in this theft.

The respondents told the court that on the day in question the general manager discovered the theft of 2 bottles of whisky immediately he came back from lunch and straight away directed investigations be conducted into the matter.

David Mutie and one Asian manager carried out the investigations. On questioning a watchman who was guarding the premises, the watchman reported to have seen Mary Kibuu carrying a wrapped object from the building which she took across the street to a florist's shop. On visiting this shop, the Asian manager and David Mutie found the two bottles of whisky in a large envelope. They questioned the florist who told them that he did not know the contents of the large envelope but it was brought there by Mary Kibuu. After returning to the office with the exhibits, Mary Kibuu was called before the general manager. On being questioned she agreed to have taken the bottles to the florist but said she was

given the envelope by David Mutie. The general manager instructed Mr. Kittakah the respondents claims manager to record her statement. Mr. Kittakah told the court that at the time of recording the statement one, Nancy Njeri was used as an interpreter and a witness. Mary Kibuu admitted having taken the envelope with 2 bottles of whisky to the florist. She stated that David Mutie, Margaret Njeri and herself had agreed to take the whiskies which they were to sell and then share the proceeds. David Mutie gave evidence on oath and told the court that he had served the respondents for 29 years and that he keeps the keys to the offices of the respondents. He denied having agreed with Mary Kibuu and Margaret Njeri to steal the whisky in question. He added that if he had wanted to steal he would have done so alone as he had the keys to the general manager's office.

The respondents employed an independent investigator who carried out detailed investigations and concluded that Mary Kibuu stole the whisky bottles alone. An investigator from the Ministry of Labour also carried out another investigation and arrived at the same decision. The respondents told the court that they did not refer the matter to the police because Mary Kibuu was a mother of 8 children then.

The court has no doubt that Mary Kibuu stole the whisky. Although she denied having admitted the stealing of the whisky to Mr. Kittakah and the private investigator, she admitted before the general manager that she took the envelope with the bottles to the florist. The court finds evidence by David Mutie to be truthful as he keeps the keys to the general manager's office, so the question of having agreed with Mary Kibuu to steal the whisky does not arise as he could have done it quietly alone.

The court upholds both the decisions by the Ministry of Labour's investigator and the private investigator who was employed by the respondents that termination of Mary Kibuu was proper. The court accordingly rejects the claimants' demand.

Termination of Abdul Mwinyi, Mohamed Mwinyi and Juma Mohamed.

THE Kenya Quarry and Mine Workers' Union shall hereinafter be referred to as the claimants and Messrs. Kenya Calcium Products Ltd., shall hereinafter be referred to as the respondents.

The parties were heard in Nairobi on 25th June, 1985, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 4th September, 1984, duly signed by both parties was received by the court on 7th January, 1985, along with the statutory certificates signed by the Labour Commissioner and the Minister for Labour.

The claimants informed the court that the respondents had employed Messrs. Abdul Mwinyi, Mohamed Mwinyi and Juma Mohamed and the duration of their employment with them ranged between two to three years at the time of their dismissals. The claimants told the court that the problem affecting their members which led to their dismissal arose as a result of protective clothing issued to all employees of the respondents.

The claimants stated that their members were issued with protective clothing which could not fit them. The protective clothing was issued to them on 10th June, 1983, by their Kiln Supervisor, James Mayodi. The claimants went further to say that on 11th June, 1983, the grievants reported on duty without the said protective clothing, because it did not fit them.

They went further to say that the respondents did not like the idea and could not even listen to the explanation, and that when they returned the following day with the ill-fitting clothing the respondents with the convenience of the senior shopsteward decided to dismiss them. The claimants argued further that the said employees should have been given warning letters and on top of that the local committee was not utilized on this issue. They felt very strongly that their members were wronged by the management and therefore requested the court to order the reinstatement of the three employees.

The claimants demands were hotly contested by the respondents. The respondents brought three witnesses to back their submission. Their witnesses were Juma Kembe, factory manager, James Mayodi, Kiln supervisor and Ronald Mkala, senior shopsteward. The respondents told the court that they had to issue the protective clothing as per the recommendation by the factory inspector, and also the design and the type of clothing was recommended by the factory inspector. The respondents went further to tell the court that on 10th June, 1983, the three employees in question refused to accept the protective clothing issued to them through their kiln supervisor, James Mayodi. The matter was reported to Jacob Oloo, the kiln manager, and also the senior shopsteward. The respondents went further to tell the court that still the three employees refused to accept the protective clothing and all they did was actually to use abusive language towards the shop steward, and the matter was reported to the factory manager, Juma Kembe. After some arguments and persuasion they accepted the protective clothing. The respondents further told the court as far as the factory manager was concerned the matter was resolved and settled at that stage.

The respondents informed the court that the same employees reported on duty on 11th June, 1983, without the protective clothing and they were sent back home to go and come with it. They went and did not come back that or the next day.

The respondents told the court that the three employees returned again on 13th June one hour later and when asked by the factory manager why they had not reported back on 12th June, 1983, they answered that they had been settling their own private affairs at home and further that they had actually not come to work but to return their protective clothing as they did not wish to work for the respondents any more. The respondents further told the court that the factory manager, Juma Kembo summoned the kiln manager, Jacob Oloo, kiln supervisor, James Mayodi and senior shop steward to come and witness what they were saying. When the three senior members of the management were present, the three employees repeated the same statements before them that they have returned the protective clothing and that they do not wish to continue working for the respondents. The respondents told the court that they had no alternative but to meet their wishes and therefore they were issued with letters of termination and were paid their dues. The respondents requested the court to uphold their decision.

The court has taken into account both verbal and written submissions by both parties and the evidence of the witness. The court notes that the claimants had not bothered to call the grievants to back up their claim, unlike the respondents who had three witnesses at their disposal to strengthen their submission. The court also notes that the argument advanced by the claimants that the respondents should have used the warning letters instead of instant dismissal. The court is of the view that the matter of abusive language used against the senior shopsteward had been settled personally by the factory manager when he personally issued the protective clothing to the recalcitrant employees and who accepted them. They had been forgiven by the factory manager and the matter was resolved. As regards the use of the local committee as advanced by the claimants, the court finds that this would not be resorted to because the court is convinced that the three employees went and told the factory manager on 13th June, 1983, that they had come to hand over the protective clothing and that they did not wish to continue working for the respondents. The respondents had no alternative but to meet their wishes therefore, terminated as they had demanded, and were paid their dues which they accepted. The court rejects the claimants demand and up-holds the respondents' decision.

Issue in dispute:

Termination of Oburu Abwao.

THE Kenya Chemical Workers' Union shall hereinafter be referred to as the claimants and Elephant Soap Industries Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi, on 11th July, 1985, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 15th September, 1984, duly signed by the parties was received by the court on 7th January, 1985, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Oburu Abwao was employed by the respondents from 3rd June, 1960, as a general labourer and served in this capacity for 21 years.

On 22nd September, 1981, he was terminated from service due to an alleged misunderstanding between him and a Mr. Satish who was then the factory manager. He was paid one month's salary in lieu of notice. Efforts by the shopsteward to discuss Mr. Oburu's case with the respondents met with firm refusal. The matter was then referred to the claimants who reported a trade dispute to the Minister for Labour, and an investigation was carried out and the minister's findings and recommendations as conveyed to the parties dated 15th July, 1983, were that Oburu Abwao suffered a grave wrongful termination and should therefore be paid eight months' salary by way of compensation for wrongful termination of service. The respondents rejected the findings and the claimants also rejected them. The dispute is now before the court.

The claimants main argument was that Oburu Abwao rendered a loyal service to the respondents for 21 years without any warning and felt that the reasons advanced by the respondents that Oburu Abwao was unproductive, argumentative and insubordinate were baseless and could not be substantiated. They argued that the respondents had totally refused to discuss the issue fully with them and said that they were not bound to give reasons for terminating him. They further pointed out that in their collective agreement clause 16 provides for warning procedures while clause 17 provides for termination but none of these clauses were properly followed by the respondents. They reiterated that since the respondents could not follow the laid down industrial relations machinery, it was abundantly clear that the respondents were bent upon getting rid of Oburu Abwao without regard to his long service to them. At the time of his termination he was about 50 years old and was about to retire.

The claimants have demanded twelve months' salary by way of compensation to be paid to him for wrongful termination that he had suffered plus any terminal benefits that he was entitled to.

The respondents have argued that although Oburu Abwao had no written warning as required under the collective agreement they were not in a position to give written warnings for every wrong done by a worker, instead they had verbally cautioned him. They contended that Oburu Abwao had formed a habit of disappearing from work, usually hiding in some safe corners within the premises. When found, he would be so argumentative to the point of even refusing to obey lawful orders from his supervisors. They gave an example of Oburu Abwao refusing to tidy up his work place, and, despite all this they never found it necessary to issue him with a written warning letter.

After a careful evaluation of the evidence the court is satisfied with the testimony from the respondents' witness that they never gave any written warning to Mr. Abwao during his years of service and that they only found him difficult and insubordinate during the time of Mr. Satish that led to his termination. The court notes from the evidence of the respondents' witness, who is also the company personnel director, that they feel they were not bound to issue warning letters nor give reasons for dismissing their employees.

This piece of evidence really surprised the court especially coming from a person of a personnel director's standing. The

respondents evidence given before the court went a long way to corroborate the investigator's views, held after interviewing parties that Oburu Abwao suffered a grave wrongful termination for no reason whatsoever. Whereas it is the employer's prerogative to hire and fire, it is a fair labour practice to give reasons for any termination otherwise it is against rules of natural justice.

The court must point out to the parties that collective agreements are meant to protect both parties and should be properly observed so that industrial harmony is maintained.

The court must once again stress that in many past awards it has emphasized to the employers that it is not enough to terminate workers' services without giving reasons, and it is because of this requirement that our government has set up an elaborate industrial relations machinery so that those aggrieved should see that justice is done to them and, that employees are fully protected by law and the collective agreements.

The court was never told by the respondents reasons for Mr. Abwao's sudden unusual behaviour during the short period with Mr. Satish, the then factory manager, which resulted in his abrupt termination of service.

The court was told that Oburu Abwao illegally occupied staff quarters after his termination despite demands from the respondents for him to vacate the house. However, no specific amount of money was demanded by the respondents during the hearing. In any case the rent claim is a matter for a civil action.

The court in consideration of the fact that Mr. Oburu Abwao had put in 21 years of blameless service to the respondents finds that he did not deserve the harsh punishment handed down to him instead he should have received a warning. The court has been advised by the claimants that Oburu Abwao is already above fifty years old and is an ailing person. The court rejects reasons for termination advanced by the respondents as they are an afterthought to justify an action by an employer who wants to frustrate the industrial relations machinery.

In these circumstances, and, in considering all the submissions made by the parties, the court finds that Oburu Abwao suffered a wrongful termination from the respondents and awards him ten months' salary by way of compensation plus his rightful terminal dues.

Wrongful dismissal of Nthenge Mbiti.

THE Amalgamated Union of Kenya Metal Workers shall hereinafter be referred to as the claimants and Leyland (Kenya) Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi, on 10th July, 1985, and relied on their written and verbal submissions. The claimants called Nthenge Mbiti as a witness and the respondents called Hussein Mohamed and Benson Wabule to give evidence.

AWARD

3. The Notification of Dispute Form "A" dated 22nd October, 1984, duly signed by the parties was received by the court on 7th January, 1985, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievant in this dispute, Nthenge Mbiti was employed by the respondents in January, 1974, as a motor vehicle assembler. He was dismissed on 13th October, 1982, after about 9

years' service. It is alleged that Nthenge Mbiti was instructed by the line supervisor to tighten some bolts on a Land-Rover but refused to do so. He was again instructed several times by the supervisor and the production manager but still refused to carry out the instructions so he was dismissed.

The claimants told the court that their member had served the respondents for 9 years with only one warning which was not valid at the time of dismissal. The claimants argued that their member was dismissed when he refused to carry out wrong instructions given by the line supervisor. Giving evidence, Nthenge Mbiti told the court that according to his long experience the bolts he was told to tighten were the last to be tightened. He said he worked as he used to work in the past and finished his job in time. He denied having seen the production manager that day.

The respondents maintained that Nthenge Mbiti refused to carry out lawful and proper instructions by the line supervisor and the production manager. Hussein Mohamed the line supervisor giving evidence in court said that on the day in question, he found Nthenge Mbiti working on a roof of a Land-Rover. All bolts had been placed in position and Nthenge Mbiti was tightening the bolts on the front side when he should have tightened the rear part first. He then instructed Nthenge Mbiti to tighten the rear roof bolts but he refused saying that he, Mr. Mohamed was not there to teach him his work. Mr. Mohamed then left for other jobs but came back to Mr. Mbiti after sometime and found his instructions had not been carried out. On instructing Nthenge Mbiti again to tighten the rear bolts first, Mr. Mbiti told the line supervisor to sack him if he so wished. At that time the production manager arrived and Mr. Mohamed reported the matter to him. The production manager instructed Mr. Mohamed to instruct Nthenge Mbiti in his presence to tighten the rear bolts. On being instructed, Nthenge Mbiti again refused and repeated his words that he was ready to be sacked, if they so wish. The production manager then reported the matter to the administration manager Benson Wabule.

Mr. Wabule then called Messrs. Mohamed and Nthenge Mbiti to his office and after listening to stories from both sides, he summoned the operations director, the production manager and quality manager to his office to discuss whether Nthenge Mbiti was correct in tightening the front bolts first or it was Mr. Mohamed who was correct. It was in this meeting that Mr. Mohamed's instructions were as per the assembly procedures. After this confirmation, the administration manager found Nthenge Mbiti to be guilty of unlawfully refusing instructions and he dismissed him.

The court notes that this dispute was investigated by the Ministry of Labour and the investigator's findings were that Nthenge Mbiti disobeyed a lawful command and the management action should stay. After careful considerations, of both submissions, the court finds no reason to differ with the ministry's findings. The court finds the respondent's action to have been justified and rejects the claimant's demand.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain a minimum of alterations.

Particular attention should be paid to the following points:

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—**Kenya Gazette**

"D.14.(1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
