The Technical Assistance Group (TAG) constitutes the in-house consultancy arm of the Commonwealth Fund for Technical Co-operation (C.F.T.C.). It consists of lawyers and economists as well as a statistician. The economic work of the group consists principally of advice on natural resources and other investment issues as well as on macro-economic and financial policy. It is now necessary to replace a senior economist in the group; the new appointee will work chiefly in the natural resources area. The lessee shall pay to the Commissioner of Lands on demand such sum as the commissioner may estimate to be the proportionate cost of constructing all roads and drains and sewers serving or adjoining the land and shall on completion of such construction and the ascertainment of the actual proportionate cost either pay (within seven (7) days of demand) or be refunded the amount by which the actual proportionate cost exceeds or falls short of the amount paid as aforesaid.

10. The lessee shall from time to time pay to the Commissioner of Lands on demand such proportion of the cost of maintaining all roads and drains serving or adjoining the land as the Commissioner of Lands may assess.

11. Should the Commissioner of Lands at any time require the said roads to be constructed to higher standard the lessee shall pay to the commissioner on demand such proportion of the cost of such construction as the commissioner may assess.

12. The lessee shall pay such rates, taxes, charges, duties, assessments or outgoings of whatever description as may be imposed, charged or assessed by any government or local authority upon the land or the buildings erected thereon, including any contribution or other sum paid by the President of the Republic of Kenya in lieu thereof.

13. The President of Kenya or such person or authority as may be appointed for the purpose shall have the right to enter upon the land and lay and have access to water mains service pipes and drains, telephone or telegraph wires and electric mains of all descriptions whether overhead or underground and the lessee shall not erect any buildings in such a way as to cover or interfere with any existing alignment of mains or service pipes or telephone or telegraph wires and electric mains.

14. The Commissioner of Lands reserves the right to revise the annual ground rental payable hereunder after the expiration of the thirty-third (33rd) and sixty-sixth (66th) years of the term granted. Such rental will be at a rate of 4 per cent of unimproved freehold value of the land as assessed by the Commissioner of Lands.

#### THE INDUSTRIAL COURT

CAUSE No. 79 OF 1983

Parties:

Railways and Harbours Union (K)

and

Kenya Railways Corporation

Issue in dispute:

Wrongful and/or unjustifiable dismissal of Alfred Obiya by the Kenya Railways Corporation.

THE Railways and Harbours Union (K) shall hereinafter be referred to as the claimants and Kenya Railways Corporation shall hereinafter be referred to as the respondents.

2. This dispute was mentioned on 29th September, 24th October, 1983, and 13th February, 1984. On 14th February, 1984, the hearing was fixed for 16th June, 1984, but the claimants requested that the dispute be adjourned. The court ordered that the dispute be stood over generally. This dispute was again mentioned on 30th July, 8th October, 1984, and 11th January, 1985. Finally the parties were heard in Nairobi, on 21st May, 1985, and relied on their written and verbal submissions.

#### AWARD

3. The Notification of dispute Form "A" dated 14th May, 1983, duly signed by the parties was received by the court on 29th August, 1983, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Alfred Obiya served the respondents from June, 1962, to 6th April, 1979, when he was dismissed with loss of all benefits. His dismissal came about after he had embezzled the respondents funds amounting to KSh. 6,855.40 and after he was found guilty by the criminal court and convicted on all the charges raised against him.

The learned magistrate before sentencing him stated as follows:

"I take into account the fact that the accused is a first offender and that he has had a clean record of service with the Kenya Railways for a period of 16 years. I also bear in mind all those stated on his behalf by the learned counsel and more particularly as he is likely to lose his job as a result of this conviction. In my view in the circumstances I consider this to be a fit case for probation if report is favourable."

Subsequently he was placed on probation for two years.

The claimants have raised this dispute on his behalf and are asking the court to order the respondents to revoke his dismissal and instead to terminate his services on the grounds of public interest so that he can get all his terminal benefits and that his pension be reduced by 10 per cent.

The reasons and arguments put forward by the claimants in support of their prayer are the provisions of the Probation of Offenders Act, particularly section 9 (1) and the fact that in the past the respondents had in the case of two of their female employees Sarah Ajuang and Marceline Munala, terminated their services on the grounds of public interest after they had been placed on probation by a court of law. The claimants want the respondents to be consistent in their actions and decisions.

The respondents have very strongly opposed this demand on the ground that if accepted it would be tantamount to rewarding a dishonest employee by awarding him a lifetime pension.

The respondents observed that they had about twenty-two thousand employees and honesty and integrity are of paramount importance especially among those employees whose duties are to collect revenue for them.

The respondents submitted that Mr. Obiya had been convicted by the trial magistrate before being placed on probation while the two ladies whose cases had been cited by the claimants were not convicted and as such their cases were different from Mr. Obiya's.

The court will now proceed to examine the relevant provisions of the Probation of Offenders Act, and the Kenya Railways Staff Regulations and a letter from the Attorney-General's Chambers dated 11th July, 1979, addressed to the respondents' managing director regarding the case of the two ladies.

Section 9 (1) of the Probation of Offenders Act, reads as follows:

"Where a person is convicted of an offence and is released under a probation order, his conviction for that offence shall be disregarded for the purpose of any enactment by or under which any disqualification or disability is imposed upon a convicted person or by or under which provision is made for a different penalty in respect of a second or subsequent offences, or in respect of an offence committed after a previous conviction. Provided that if a probationer is subsequently sentenced for the original offence this section shall cease to apply in respect of that offence, and he shall be deemed, for the purposes of any such enactment imposing a disqualification or disability to have been convicted on the date of sentence."

On the other hand the respondents have a set of elaborate staff regulations which apply to all the respondents employees as part of the their employment contract.

Staff regulation G (9) (g) provides that:

"If an employee is adjudged guilty in any court of a criminal offence which in the opinion of the managing director, in the case of employees to whom regulation G. 3 would apply, or head of department, in the case of an employee to whom regulation G. 5 would apply, warrants disciplinary proceedings, the managing director or the head of department, as the case may be, should forward a copy of the charge and of the judgement and of any judgement or order made on appeal or revision to the board for consideration, and the employee may be dismissed or subjected to some lesser punishment on account of the conviction of the offence of which he has been adjudged guilty."

The court has to determine if the Kenya Railways Staff Regulations are as enactment as envisaged in section 9 (1) of the Probation of Offenders Act, and further if the court finds that they are an enactment then does the respondents action under staff regulation G (9) (g) impose any disqualification or disability upon Mr. Obiya, who is a convicted person but placed on probation.

The claimants have pleaded that the staff regulations are deemed to have been made under the Kenya Railways Corporation Act, the dismissal was thus imposed upon him by or under an enactment.

The respondents submitted that the staff regulation at the material time were never issued as a legal notice and only form the contractual obligation between the respondents and their employees. The respondents do not accept that the staff regulations are deemed to be made under section 94 (1) of the Kenya Railways Corporation Act. They state that these regulations were not so made and are not among those saved by the section.

Leaving this point for the time being the court will now consider whether dismissal under staff regulations has imposed any disqualification or disability upon Mr. Obiya.

The claimants have strongly submitted that Mr. Obiya has as a result of dismissal suffered a disqualification as he is incapacitated or rendered ineligible from enjoying his pension and other terminal benefits. Further he is placed under a disability in so far as he is thereby deprived of his already acquired and vested rights (pension, etc.) and he cannot enforce those rights by legal action. His dismissal drives him away from the court, at the same time as it takes away his already acquired rights.

The respondents on this point have pleaded that to impose a disqualification or disability means to make it mandatory for a certain action to be taken which disqualifies or disables the subject from carrying out a particular action or actions as the case may be. For these provisions to come into play the provision complained of must impose a disqualification or disability,

i.e. it must be compulsory. However, under staff regulation G (9) (g) no disqualification or disability is imposed on a person. It only states that the offence must be considered and only when in the opinion of the officer concerned it warrants disciplinary action then he may act. The action to be taken is merely discretionary. The person could have been awarded lesser punishment such as down grading or stopping of increment, depending on the gravity of the offence.

The court notes that the case of the two ladies and that of Mr. Obiya was dealt with by the respondents in accordance with a directive issued by their general manager on the advice of their legal adviser which was issued on 1st September, 1965, which reads in part as follows:

- "(a) An employee who has been dealt with by a court under section 4 (1) (a) of the Probation of Offenders' Act, i.e. convicted and placed on probation, may be proceeded against under the provisions of public service regulation 56 or under the terms of staff regulation G 9 (g).
- (b) An employee who has been dealt with by the court under section 4 (1) (a) of the Probation of Offenders Act, i.e. placed on probation without being convicted, may not be proceeded against under the provisions set out at (a) but may be charged with misconduct and punished under the provisions of public service commission regulations 46 to 47 (or staff regulation G. 4 and G. 5) P.S.C. regulations 47 to 50 (or staff regulations G. 6, G. 7 and G. 8) according to the officer's status."

In any case the court is of the view that it is at the discretion of an employer to treat his employees leniently if he deems it fit to do so under certain circumstances. So the case of the two ladies is not really all that relevant to this dispute.

The court has carefully considered the other submissions and finds that the railways staff regulations are not an enactment as it is clearly stated in the preamble to the regulations that "these staff regulations issued in 1962 replace the staff regulations of 1951 as amended from time to time. With the difference that whereas the latter constituted a legal notice under provisions of the East African Railways and Harbours Act, the present regulations do not." These regulations form the contractual obligation between the railways and their employees.

The court further finds that regulation G (9) (g) is discretionary and it does not require a certain mandatory punishment to be awarded. The degree of punishment to be awarded is at the discretion of the board. There is no automatic disability or disqualification imposed.

The court has also considered the opinion given in 1979 from the Attorney-General's Chambers that it is wrong for an employer to be less merciful than a court exercising criminal jurisdiction. The court appreciates this opinion and the Industrial Court has always protected workers whenever the need arises and in fact it is common knowledge that workers feel secure in their employment through the Industrial Court decisions. The court, however, does not protect dishonest workers. In some cases it is desirable that an employer should be more merciful than the criminal court but in others he need not. Each case has to be examined on its merits.

In the present case the learned magistrate clearly stated that Mr. Obiya was likely to lose his job as a result of his conviction and the court has no doubt that that was the reason why Mr. Obiya was placed on probation and not because Mr. Obiya was to be given a chance to continue his employment or enjoy his terminal benefits which in this case would be a lifetime pension.

The court has considered every aspect of this dispute most carefully and finds that there is absolutely no justification to grant a convicted thief who has even failed to refund the money he stole, a lifetime pension from public funds. To make any award in favour of the grievant would be to encourage dishonesty. This, the court is not prepared to do.

The court accordingly rejects the claimants' demand.

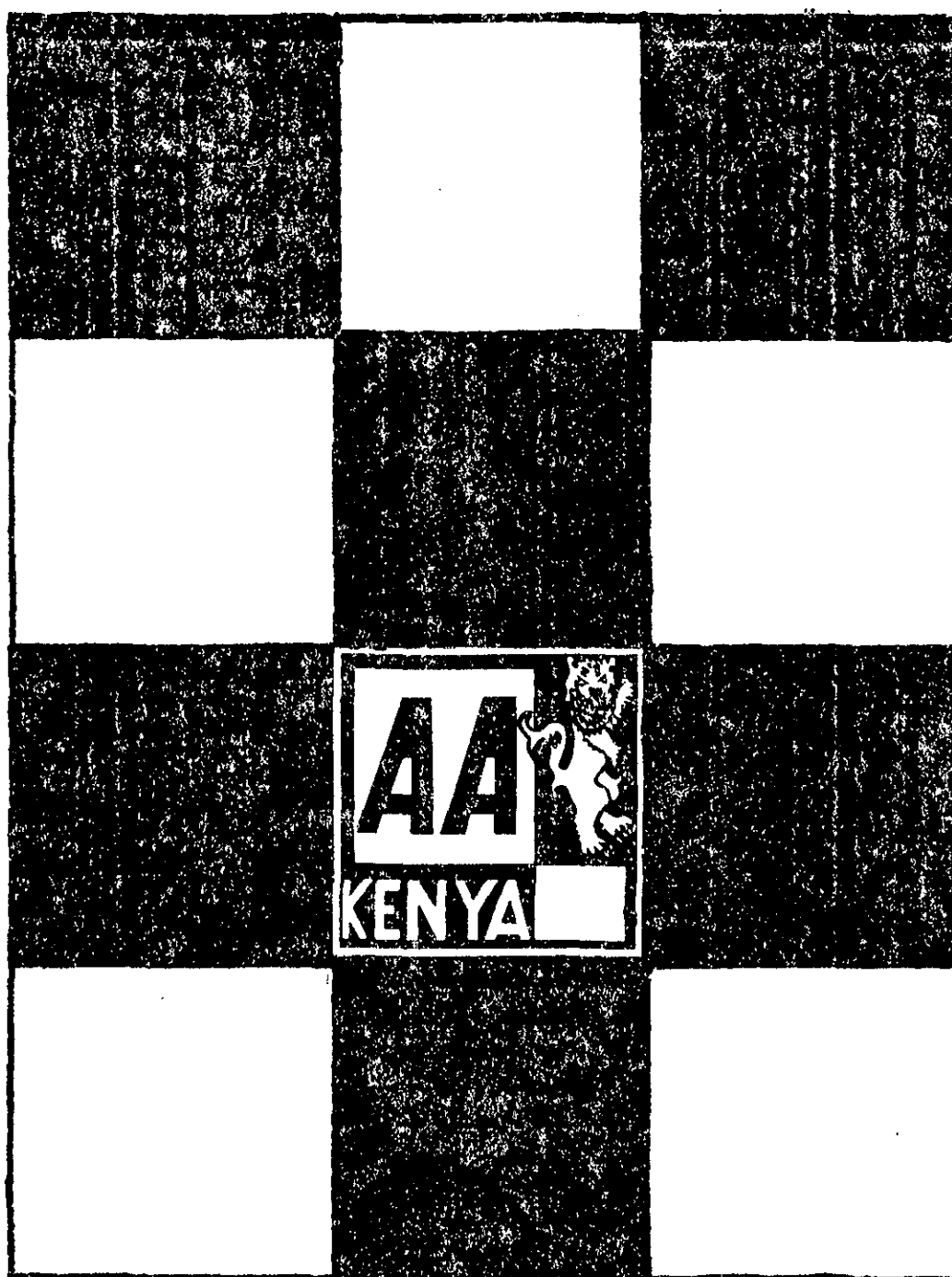
