The Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the Claimants and the Kenya Bankers (Employers) Association shall hereinafter be referred to as the Respondents.

AWARD

2. The parties were heard in Nairobi on 23rd and 24th October, 12th and 13rd November 1985 and relied on their written and verbal submissions.

3. The Notification of Dispute Form "A" dated 25th June 1985, duly signed by the parties was received by the court on 23rd July, 1985 together with the statutory certificate signed by the Labour Commissioner.

This dispute concerns about 8,185 unionizable bank employees out of a total of 9,801, the balance are the management team spread among 20 banks. The unionizable employees are placed in the following categories:

- (a) Section heads.
- (b) Check clerks (Standard Bank PLC Ltd.).
- (c) Clerical staff.
- (d) Technical.
- (e) Subordinate.

The parties last collective agreement expired on 28th February 1985 after two years duration. The agreement had a wage re-opener clause after one year. Similar arrangement prevailed in all previous collective agreements stipulating that salaries will be reviewed yearly.

During the very bitterly contested submissions made by the parties during the hearing the court was told by the Claimants that the Respondents management earned vast salaries in relation to theirs which continued to widen the gap between the two groups instead of narrowing it. This, they said, was contrary to the objectives of the wages guidelines which were to adequately compensate the workers rising cost of living and to enable the Respondents to create more employment opportunities. They submitted that wages guidelines were completely out of touch with the economic realities and were only applicable to the Claimants but never applied when considering management staff salary increases. They demanded that they be exempted from its applicability. They maintained that the Respondents were making huge profits which should be shared equitably between them as they substantially contributed to the earning of such profits in the banking industry. They pointed out that vast

profits are repatriated abroad instead of using part of it for improving living standards of their staff. Further, the little employment openings shown in the Respondents industry have been due to new banks coming into operation and new branches opened by some bigger commercial banks. However, the Respondents role in this field of employment creation was insignificant and should be ignored by the Court.

The Respondents on the other hand submitted that the Claimants are the best paid compared to their counterparts in the other industries. They considered the offers made to the claimants reasonable and in line with the wages guidelines, which, according to the D.M.P.D. report amounts to an over compensation under the permissible wages guidelines. The respondents stressed that during the years 1982/83 and 1983/84, employment level grew at about 3.0 per cent and 5.0 per cent respectively. Besides, majority of individual member banks had reflected an annual employment growth ranging between 0.7 and 3.7 per cent during the same period. They pointed out that, in the recent report by the Presidential Committee on Unemployment it was confirmed that the guidelines should continue in their present form taking into consideration various economic forces. The court in consideration of the strong views advanced against the application of the guidelines, would like to point out that, whereas in the recent years the court has registered some agreements in excess of the wage guidelines, the court must continue to be broadly guided by the guidelines but without prejudice to the courts powers under Guide (V). The court would like to place on record that during 1984 analysis of a random sample survey of 87 firms revealed that employers had granted wage increase in excess of the guidelines ranging between 4.2 per cent and 10 per cent. These agreements were registered on the recommendation of the Ministry for Labour. The court has also noted that Barclays Bank had granted the managerial staff an 11 per cent wage increase. The respondents made it clear that their resolution of granting salary increases to the managerial staff in accordance with the guidelines was not binding on their members.

1. Duration of agreement

The claimants under this item have submitted that the present agreement required either party to give, by 30th November, three months notice in writing of their intention for this agreement to continue in force for a further period to be agreed upon, or, of its intention to terminate the agreement or alter any clause therein. They maintain that, generally, they have been the ones to give such notices calling upon the respondents to alter clause (5) or putting up demands for improvement on terms and conditions of employment. They consider the three months' notice to be too long and would like this period to be reduced to one month in order to bring to an end accusations and counter accusations from either party. They maintain that very rarely do the respondents give such notices.

The respondents on the other hand saw no justification for changing this clause as it allowed both parties ample time to study the expiring agreement without haste. It provided parties with ample time to send in and receive any contemplated changes in the agreement. The parties also expected to receive economic data by this time, but this never happened due to the delay in getting this information published. The claimants have generally sent in their intentions to amend the agreement in November but have thereafter delayed for months before sending in the actual proposals. The court has considered the reasons advanced by the claimants and finds that this clause should be amended only to the extent that the party wanting a change or changes must also submit their proposals within four (4) months having given the notice as already provided for the other party should make its counter proposal within four (4) weeks of the receipt of the proposals.

3. Promotions of check clerks, clerical, technical and subordinate staff

The court in its award in cause No. 61 of 1979 ruled that:

"After careful consideration of all the submissions the court awards that when an employee is promoted he or she should be placed on a notch which would give the employee an increase of not less than the difference in the scale of that particular category."

Following this ruling the claimants have submitted that they have experienced a problem in interpreting this award as they found that the difference between the salary earned by the person acting which includes his acting allowance is a lot more than what he earned when he was confirmed. A case in point is where a clerk earning Sh. 5,195 per month on the 15th year notch is promoted to section head, the agreement provides that he should be placed on the 5th year notch of the section head's scale i.e. Sh. 5,197 which gives him Sh. 2 only per month on promotion. This, they argue, gives this person no incentive

at all. So, it really benefits those who earn their promotion earlier and not later in their scale. They, therefore, demand that wages payable during the acting period should not be withdrawn on confirmation.

The respondents have submitted that an employee can be promoted and placed on probation not exceeding six (6) months and at the end of that period he can revert to his substantive grade, he, therefore, cannot expect to continue earning the total amount he was earning during his acting period. The claimants in this case seem to link promotion from one grade to another with the acting appointment. Acting allowance is for a short period whereas a promotion is of a permanent nature earned after a long service in a given scale.

The court in consideration of this issue finds that an employee on an acting assignment is rewarded by way of a fixed acting allowance as provided for under clause AB 26, and, once his acting period ceases he reverts to his substantive post. The court finds that the person promoted enters in a completely new scale which is normally longer and carries with it all the benefits that, that scale enjoys. The court finds the two issues to be totally unrelated. There is no way that money earned during acting period can be translated to form part of permanent monthly earning. If this was allowed, the scales would be totally interfered with, and, a few individuals in acting position would have undesirable advantage over the rest. The court finds no merit in this demand and accordingly rejects it.

3. *Termination of employment.*—Withdrawn by the claimants.

4. *Gardeners employed by the banks*

The agreement stipulates that "gardeners employed by banks shall not interchange duties with office messengers" but the claimants state that there has been violation of this clause by the respondents.

The respondents submit that this clause is quite clear and where there is violation of this clause the claimants should report a trade dispute over such a breach, but see no valid reason calling for an amendment to this clause.

The court was advised by the respondents that there are cases of flexibility in outlying areas where, because of the size of the business transacted, the total staff establishment has been kept small and in such cases there have been cases of interchangeability. This, the respondents conceded was more of an exception than the rule.

The court finds no justification for amending this clause but the respondents are directed to observe the agreement properly. But where the claimants feel that the respondents member is persistently violating this clause then they should take remedial measure and declare a trade dispute. The court was, however, not given specific cases to enable the respondents to caution their member concerned.

Under the circumstances the court rules that the dispute be referred back to the joint industrial council for discussion and solution, and on failure, it should come as a dispute through the laid down machinery. The court finds the clause quite clear without any ambiguity to warrant a further clarification by way of an amendment to it.

Terms and conditions of service

(i) Salary and wages

The last revision of wages by the parties was 1st March, 1984 running for twelve (12) months from that date.

The claimants' demand 45 per cent increase on wages effective from 1st March, 1985 for all unionisable grades.

Section heads	45 per cent
Check clerks and clerks	45 per cent
Subordinate staff	45 per cent
Technical staff	45 per cent

They have based their demand on a 45 per cent overall compensation covering two (2) years' period of the collective agreement. They claim that this demand was based on 25 per cent sacrifice they made under the wages guidelines in the previous agreements which was intended to expand employment opportunities which, they claim, never achieved the intended goal. Coupled with the huge profits the respondents accumulate, they feel entitled to a fair share of this profit.

The respondents on the other hand have made the following counter offer:

Section heads	6½ per cent
Check clerks	8 per cent
Clerical staff	8 per cent
Technical staff	9 per cent
Subordinate staff	9 per cent

In addition to these offers the employees would be entitled to an automatic yearly increment. The respondents have further argued that any wage increase must be based on the current wage guidelines. To ignore this principle would mean breaching the Trade Disputes Act (Cap. 234, section 14 (10)).

The above offer is for first year but as has been the case in the past, salary review for the second year of this agreement will be negotiated between the parties as per clause 2 (duration of the agreement and effective date) of the existing agreement.

A study of the report from the D.M.P.D. reveals that the respondents have argued that account should be taken of their offer given during the first year (i.e. 1st March, 1983 to 29th February, 1984) of the agreement in which case the claimants entitlement would be as follows:

This table shows that, the middle income who include the technical and subordinate staff employee categories are entitled to 8.3 per cent whereas section heads, check clerks and clerical are entitled to 5.6 per cent being the maximum compensation under the wages guidelines. However, the claimants have demanded full compensation under the guidelines for both the lowest and highest paid workers which would entitle them to 11.1 per cent and 7.4 per cent respectively for the first year. This ultimately gives the claimants an overall average wage compensation of 9.4 per cent for all income groups (i.e. middle and upper covered by the one year agreement). Nevertheless, strict application of the wages guidelines grants the claimants lowest and highest paid workers a wage boost of 8.3 per cent and 5.6 per cent respectively or an average of 7.1 per cent for same period under review.

The claimants on the other hand argued that account should be taken of the cost of living increases during the period between March, 1983 to February, 1985 minus what the respondents had given after the first year than the compensation would be as shown in table II below:

A comparison between the two tables definitely show that the claimants would gain more if calculation is made on annual basis instead of two (2) years. The latter table give the middle and upper income groups a compensation entitlement of 7.2 per cent and 5.1 per cent respectively or average of 6.8 per cent.

After careful consideration of the parties submissions on this issue the court has decided to go along with the parties mutual agreement to revise the wages of the claimants annually so the award on this particular item will be for one year only effective from 1st March, 1985. In making this award the court has taken into consideration the views expressed in the D.M.P.D. report.

The court awards the following wage increases:

Subordinate and technical staff	14 per cent
Clerical staff	11.5 per cent
Check clerks (Standard Bank)	11.5 per cent
Section heads	8 per cent

As stated earlier this award will be reviewed at the end of the first year of the agreement. The court further points out that, whereas no further negotiations on these terms are permissible under the revised wages guidelines, voluntary revisions after one year are, however, allowed if ample proof is advanced

by the claimants showing that current wage increases fail to compensate for price increases to the extent permitted under guideline (iv).

(ii) *Housing allowance*.—For section heads, check clerks, clerical, technical and subordinate staff.

The current position with the claimants' demands and the respondents' offer is reflected below:

The claimants made vigorous submissions on this issue and stated that the monthly rent in various estates in Nairobi ranged between KSh. 800 for single rooms to KSh. 1,800 for two bedrooms and Sh. 2,000 for three bedrooms. They produced receipts in respect of the rents which the bank employees are paying currently.

The respondents opposed the claimants' demand very strongly saying that it ranged between 112.1 per cent and 275.0 per cent. They in turn offered an increase on the current rates between 9 and 11 per cent according to occupational category which in shillings would be between Sh. 36 to Sh. 63 p.m. They relied on wages guideline 4 (b) (i) under which the workers would be entitled to 10.1 per cent and 7.6 per cent for the middle and upper income groups respectively.

The respondents stated that the court had in its last award determined the current rents by relying on guideline (v). They submitted that the court should now award the increase in house allowance strictly in line with the guidelines.

The court has very carefully considered the parties' submissions on this burning issue of house allowance and would like to make it clear that in relying on guidelines (v) in the last award the court did not intend to bring the bank employees as far as house allowance was concerned to the standard of living which the court expects them to enjoy at one go. The court having formulated the basic minimum standard of living which it feels bank employees enjoy intends to take them up to that standard gradually. For this reason the court must reject the respondent's argument and the court while relying on guideline (v) makes the following award on this issue:

AB 4, Granting and withholding increments

The claimants stated that there was no dispute on this issue except that they wanted the scales lengthened. The respondents saw no merit in this demand and asked the court to dismiss the same. The court notes that in the recent past cases regarding lengthening of scales have been brought forward for consideration, and were given favourable consideration. This issue is not properly before the court and as such cannot be dealt with in this dispute.

AB 5, Merit increases

The claimants submitted that merit increases tend to place the bank employees in the middle of the notches and wanted such increases to tally with the incremental notches. They have further argued that under this clause (ii) the respondents merit increases have been inadequate.

It is the court's view that merit increases are given purely at the respondents discretion and as such it should be left to the respondents to exercise their discretion in awarding such increases. The court therefore rejects the demand.

AB 15, Local leave allowance

The current leave allowances are as under:

The claimants have demanded that they be paid a month's salary instead of the current rates by way of local leave allowance. They argued that this allowance had not risen at the rate of the salary increases.

The respondents on the other hand have argued that since the last review was made there has not been any marked increase in transport charges to justify higher increases equivalent to a month's salary. They maintain that they have adequately compensated the claimants for the rising cost of living under the item of salary.

The court has carefully considered the reasons advanced by the parties in particular the labour cost involved should the court award leave allowance equivalent to a month's salary, the additional cost based on the current wage bill would be something in the region of Sh. 22 million. This would be an excessive expenditure which the court cannot justify. The court is of the view that there has been a rise in transport cost and workers are entitled to get some compensation to meet them. under the circumstances the court awards as follows:

AB 21, Allowance for mobile staff

The claimants demand an increase of Sh. 15 on the current lunch allowance of Sh. 35 stating that food price has gone up since 1983 dispute. The claimants stated that in addition to the above reason, the employees working in the countryside work under difficult conditions and they require good food to replenish lost energy. The claimants under this item included a demand that an amendment to the parties agreement clause dealing with this item be made to allow this allowance to be paid to all the bank staff who are required to work over the lunch time or who are away from their offices on duty during lunch time.

The respondents resisted this demand by saying that in the first place there is no justification for this allowance since whether an employee works on a mobile bank or not, he would still take lunch. On the question of amending the agreement to allow this allowance to be paid to other staff who work during lunch time, the respondents felt that this demand is improperly before the court as it is not included in the list of disputed items. The respondents requested the court to give a nil award on this item.

The court has carefully considered this item and finds that the price of food has gone up steadily so the court awards the claimants members an increment of Sh. 5 on lunch allowance under review. The court rejects the request to amend the clause related to this item to allow this allowance to be payable to other bank staff because this demand was not reported as required under the Trade Disputes Act.

AB 22, Supper allowance

The claimants demand Sh. 60 instead of Sh. 45 currently paid as supper allowance and gave the same grounds for justification as on mobile staff meal allowance. The claimants again included another demand for amendment of the agreement to pave way for this allowance to be payable to staff who work later than 8 p.m.

The respondents objected to this demand giving the same reasons as contained in the mobile staff meal allowance and added that if this demand of paying staff who work later than 8 p.m. is allowed this will only encourage malingerers to be fed with supper.

On this item the court finds there is justification for this allowance to be paid during peak periods only and not otherwise. As in the other items on meal allowances, the court awards an increment of Sh. 5 on the current allowance due to increased prices of meals. The court rejects to rule on the demand for payment of this allowance to staff who work later than 8 p.m. because this demand is not properly before the court as stated above.

AB 23, Computer inconvenience allowance

Withdrawn by the claimants.

AB 23, Computer meal allowance

The claimants contested very strongly for this allowance to be improved stating that this item should be equalized with

other meal allowances since this is intended for the same purpose. The claimants prayed the court not to allow this allowance to be discriminatory as all concerned are employees of the same employer.

The respondents resisted this item and gave the same grounds as in other meal allowances. The respondents further pointed out that there was differential in every item in the parties agreement and that this differential should be maintained.

The court finds there is differential in all items agreed by the parties and for this reason the court is unwilling to compromise with the claimants demand, but the court finds the current allowance paid to this section of employees to be low, so the court awards this section meal allowance as follows:

Breakfast	Sh. 20
Lunch	Sh. 25
Supper	Sh. 35

AB 24, Airport agencies

Each of the meal allowances under this item will all go up by Sh. 5.

Lengthening of scales and efficiency bars

The claimants demand lengthening of scales to as follows:

- Subordinate staff.*—From one year to 25 years.
- Clerks and technical staff.*—From one year to 25 years with introduction of efficiency bars of 20th, 23rd and 25th notches.
- Check clerks.*—From 18 to 25 years with introduction of efficiency bars at 15th and 18th notches.
- Section heads.*—From 15 to 25 years with introduction of efficiency bars at the 12th and 15th notches.

The respondents submitted that this item should have been included in Form "A" as an item for the court to rule on instead of its introduction under another item. The respondents prayed the court not to consider it as it was improperly before the court.

The court finds that the claimants introduction of this item in this dispute is not proper. The claimants should have reported this item as an issue in dispute and it should have appeared as a separate item on Form "A". The court, therefore, cannot consider this demand.

Technical staff

The claimants are demanding that technical employees such as printing machine operators, painters, carpenters, electricians, etc., be placed on the same wage scale as the clerical staff. The reason regarding this demand is that technical staff are specialized employees who have undergone technical education after their formal education which in many cases is equal to that of the clerical staff.

The respondents argued that these employees basically do odd jobs as the respondents members do not have permanent jobs for technicians except once in a while when the need arises.

The court has carefully considered this item and finds that the claimants did not report this issue in accordance with the Trade Disputes Act. Although it is included in the submissions, the court rejects to consider it as it is not properly before the court.

AB 30, Transport

The claimants demand is that employees should be provided with transport if they are required to work late. The claimants informed the court that some towns have no public transportation system, while some have transport up to 7 p.m. The claimants would like their members to be provided with transport by the respondents members if required to work after the normal working hours.

The respondents resisted this demand by stating that currently there is a system of night transportation in the industry which the claimants would like to be applied to even day workers. The respondents provide transport to workers who work late even if there is public transport.

After considering this item the court rejects the claimants demands.

**IMPORTANT NOTICE TO SUBSCRIBERS

- (2) *Legislative Supplement* contains Rules and Regulations which are issued by the Central Government. Because of this they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) *Bill Supplement* contains Bills which are for introduction in the National Assembly.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain a minimum of alterations.

Particular attention should be paid to the following points:

- (i) Signatures must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

"D.14.(1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 12 noon, on Tuesday of the week that publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
