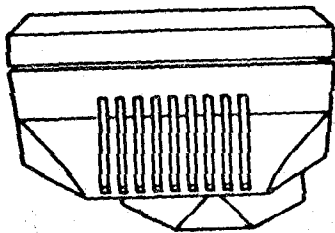

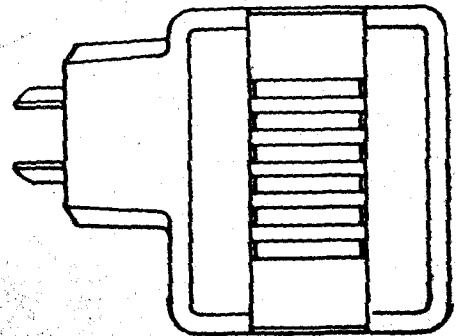

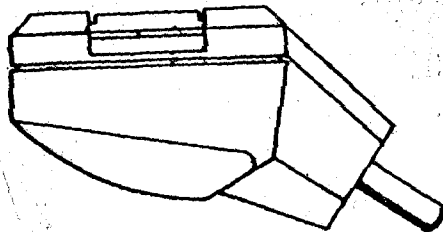
FRONT VIEW



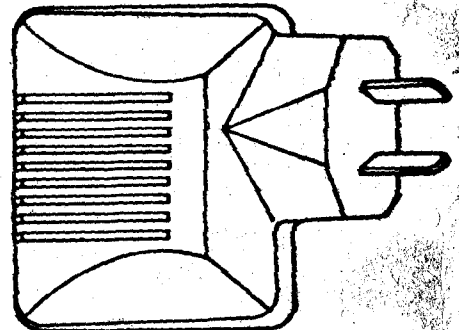
REAR VIEW



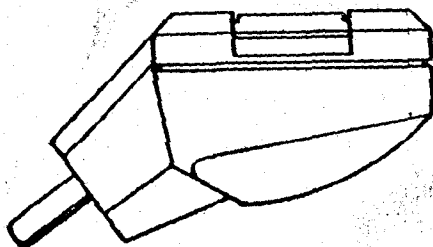
PLAN VIEW



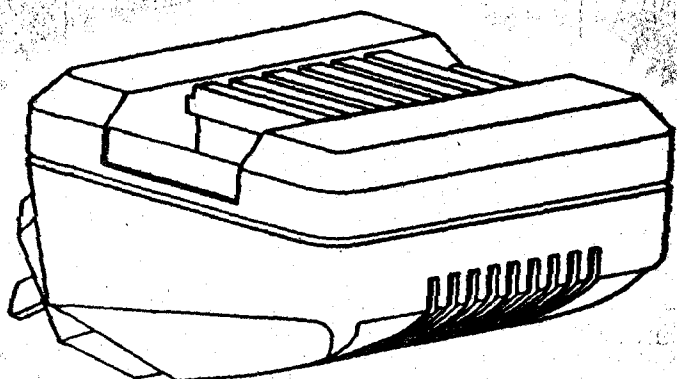
SIDE VIEW
