THE WEIGHTS AND MEASURES ACT (Cap. 513)

NOTICE TO TRADERS

AN Inspector of Weights and Measures will open a stamping station at the places mentioned hereunder for the purpose of assizing and stamping traders' weighing and measuring apparatus on the dates indicated.

All traders within a radius of twenty kilometres of the places mentioned are required under the provisions of the Weights and Measures Act, to produce to the Inspector of Weights and Measures all weights, measures of length and capacity, and weighing instruments which have been in use for trade for verification and stamping.

Only weighing instruments, the weighing capacity of which exceeds 500 kg, or which are of a permanently fixed nature or delicate construction will be assized in situ. Traders in possession of such instruments may comply with this notice by notifying the Inspector of Weights and Measures in writing as to the type, maximum weighing capacity and location of the said instrument not later than one week preceding the date notified in the column hereunder:

INTENDED DISTRUCTION OF COURT RECORDS

THE Transport and Allied Workers Union shall hereinafter be referred to as the claimants and the Kenya Airways Limited shall hereinafter be referred to as the respondents.

2. The parties were heard on 3rd November, 1988, and relied on their written and verbal submissions.

Award

3. The Notification of Dispute Form "A" dated 4th November, 1987, duly signed by the parties was received by the court on 3rd May, 1988, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The dispute was investigated by the Ministry of Labour and the Ministry's finding was that the grievant had suffered a wrongful dismissal. It was recommended that the dismissal should be reduced to normal termination of service that would entitle him to all his terminal dues under the collective agreement in force at that time. In addition, he was to be paid twelve (12) months' salary as compensation for the wrongful dismissal he had suffered.

This recommendation was turned down by the respondents and the matter is now before the court for consideration.

In this case also the grievant's acquittal by the Court of Appeal gives it a different complexion and he is entitled to benefit under the relevant clause of the collective agreement. So the grievant must win this case on technical grounds. Under these circumstances, the court while upholding the Ministry of Labour's finding that the grievant suffered wrongful dismissal, does not support the Ministry's recommendation that he should be paid twelve (12) months' salary by way of compensation.

The court awards that Mr. Njuguna should be given the benefits of a normal termination in terms of the collective agreement and three (3) months' salary by way of compensation.

AWARD

3. The Notification of Dispute Form "A" dated 4th November, 1987, duly signed by the parties was received by the court, on 3rd May, 1988, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The court has carefully considered the parties' submissions and finds that the possibility of the video cassette having disappeared within the airport building cannot be ruled out. In fact on balance of probabilities, that is, from where it disappeared because there is no evidence to show positively that the baggage containing the video cassette was ever loaded on the trolley which was being driven by the grievant. The role of the porter and others in the building handling the baggage at the time would not appear to have been properly considered by the respondents in the disappearance of the video cassette. Obviously it was not a one-man job.

The court notes that the grievant was dismissed while on leave and he does not appear to have been afforded an opportunity to defend hemself. He also had a clean record. For the foregoing reasons, the court agrees with the finding of the Ministry of Labour that the grievant has suffered a wrongful dismissal. The court, therefore, awards that the grievant's dismissal should be reduced to normal termination and in addition, he should be given six (6) months' salary by way of compensation.
