"Dismissal of B. K. Galogalo"

THE Kenya Local Government Workers Union shall hereinafter be referred to as the claimants and the Tana River County Council shall hereinafter be referred to as the respondents.

2. This dispute was fixed for hearing in Nairobi on 7th April, 1988, and when it came up for hearing the claimants raised a preliminary objection to a full hearing based on technical grounds. The respondents reply to the claimants' objection was heard on 13th May, 1988. Thereafter the dispute was heard on 17th October and 9th and 10th November, 1988, respectively. The parties relied on their written and verbal submissions. In

addition the parties called the following witnesses to give evidence on oath.

#### AWARD

3. The Notification of Dispute Form "A" dated 11th June, 1986, duly signed by the parties was received by the court on 30th July, 1987, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The court has carefully analysed all aspects of this dispute and finds that the parties are in agreement that Mr. Galogalo had actually issued cash receipts of Sh. 20,000 to Messrs. P & C Bura. The court however cannot rule out the role of the clerk and the treasurer in this irregular transaction. The court further notes that the grievant was not afforded an opportunity to defend himself and that he had been acquitted by the criminal court albeit through default of the prosecution.

In view of the foregoing reasons the court agrees with the finding of the Ministry of Labour that the grievant has suffered a wrongful dismissal but the court must add purely on technical grounds. The court considering all the circumstances awards that the grievant's dismissal should be reduced to normal termination and in addition he should be given two months salary only by way of compensation. The grievant does not deserve anything more than that.

The court further directs that the respondents should recover Sh. 20,000 they lost from the grievant's dues because the respondents lost his money through an irregular financial deal initiated by the grievant.

The court accordingly awards that the dismissal should be reduced to normal termination that would entitle the grievant

to all his terminal dues. In addition he should be paid three months salary by way of compensation for the wrongful dismissal he has suffered.

The court notes that the parties signed a recognition agreement in January 1986, and the claimants did press for negotiations for the terms and conditions of employment for the respondents' unionizable employees. The court further notes that the respondents commenced operation of their business late in 1984 and are operating at a loss since then arising from business competition and inelastic demand for their product. The P.R.D. investigator confirmed this and also that the cumulated loss as at November 1988, was over 1.6 million shillings.

The court has carefully considered the respondents' financial position and the court feels that it would not be in the interest of the parties to make an award that would increase the financial burden of the respondents to a point where payment of wages of their employees may be jeopardized. The court cannot make an award which may quite easily put the respondents in liquidation and cause a loss of about 36 jobs.

Keeping all these points in view and the wages guidelines the court awards as follows:

#### Basic minimum wages.

The court has carefully considered the arguments advanced by both parties on this issue and finds that the current basic minimum should not be revised.

The court accordingly rejects the claimants' demands on this item.

#### General wage increase.

The court has decided to award a 4.0 per cent increase for the first year and a further 5.0 per cent increase for the second year respectively.

#### Housing allowance.

The court awards that the present amount of Sh. 150 and 175 per month should be increased to Sh. 175 and Sh. 200 per month respectively.

#### Leave travelling allowance.

The court has carefully considered the two proposals put forward by the parties on this issue and finds both proposals unreasonable.

The court therefore awards a leave travelling allowance of Sh. 230 per employee per year.

#### Effective date.

The court notes that this is the first collective agreement to be negotiated and that the parties have divergent views on the effective date.

The court keeping in view the respondents' financial position awards that the parties collective agreement should become effective from 1st December, 1988.
