## Ruling

In the above-mentioned three disputes the Bakery, Confectionery, Manufacturing and Allied Workers' Union (K) hereinafter referred to as the Bakery Union is seeking recognition from the aforesaid 3 employers who all belong to one group.

The Kenya Union of Commercial Food & Allied Workers hereinafter referred to as the Commercial Union has applied to be joined as an interested party in these disputes. This application has been very strongly opposed by the Bakery Union.

The parties made very detailed and comprehensive submissions during the hearing of this application which the court has considered in depth. It must be pointed out that the submissions of the Bakery Union in fact have covered a lot of substantive ground which they would have if the Commercial Union had been allowed as an interested party to join in the disputes. In view of this the court does not intend to go into the pros and cons of those submissions and the court will confine itself purely to the merits of the Commercial Union's application to be joined as an interested party.

The three respondents have had dealings with the Commercial Union in one form or the other for over 20 years and claim that they have a valid recognition agreement with the Commercial Union with whom they have entered into several collective agreements covering terms and conditions of their employees. The Commercial Union confirms this.

It is also on record that the Commercial Union was involved in these disputes up to the pre-Industrial Court proceedings.

The Industrial Court has always adopted the stance in view of the delicate and sensitive nature of industrial relations that all parties involved in such problems should be accorded an opportunity to fully make their views known on them. It is important that it should be so as otherwise chaos in labour relations would ensue. In view of the past relationship between the Commercial Union and the three respondents based on a recognition agreement, valid or not, dating back many years it would be most unfair to deny the Commercial Union an opportunity to have a say in these disputes which after all seek an order that the respondents should recognize the Bakery Union and sever their relationship with the Commercial Union.

To say the least the Commercial Union is indeed a very much interested party in these disputes and to deny them the right to be joined in these proceedings would not serve the interests of justice.

The court has therefore decided to allow the Commercial Union to be joined in all these three disputes as an interested party without prejudice to the arguments submitted by the Bakery Union in this application.

The court having decided to allow the Commercial Union to be joined in as an interested party directs that these disputes be mentioned on 17th February, 1989, for further directions.
