2. The parties were heard in Nairobi, on 24th January and 2nd February, 1989, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 17th June, 1988, duly signed by the parties was received by the court on 26th August, 1988, together with the statutory certificate signed by the Labour Commissioner.

#### Wages

The court requested the Division of Research and Planning (D.R.P.) to carry out investigations because, most of the issues were affected by the wage guidelines. A detailed analysis was carried out by the D.R.P. and this analysis revealed that the average maximum compensation ceiling for the price increase under the then applicable Wages Guidelines of 1932, that is three quarters ( $\frac{1}{4}$ ) of the rise in the consumer price index from July 1984 to June 1986, would be 16 per cent. However, if the claimants' demand of full compensation is considered the figure would be an average of 20.1 per cent.

After cereful consideration of all the submissions made the court awards salary increases of 5 per cent for the first year and 9 per cent for the second year of the collective agreement.

This award is made keeping in mind that the court is also to make an award on the housing allowance on a deconsolidated basis.

#### Leave Travelling Allowance

The court has given due consideration to all the submissions made in respect to this issue and awards that the present leave travelling allowance of Sh. 300 should be increased to Sh. 350 to be paid to the workers once a year when proceeding on annual leave.

Funeral Expenses for the Employees of the Company The claimants' demand on this item is rejected.

#### Tools Allowance

The court notes that the respondents have been providing long-term loans to the workers to buy tool-kits and thereafter at their own discretion give tools allowance which at present is Sh. 120. The court has no desire to change the loan arrangement but it has to decide on the issue of tools allowance. The court accordingly awards that the present rate of Sh. 120 should be increased to Sh. 160 per employee per month. This award is effective from 1st July, 1987.

#### House Allowance

The court notes that the Wage Guideline IV b (ii) reads: "Where deconsolidation of consolidated wage is deemed necessary the housing element shall be deemed to be no more than 15 per cent of the prevailing minimum wage for a particular group covered."

The court has also noted that the parties both at their own and conciliation levels had voluntarily agreed in principle to have a separate house allowance in addition to the current salaries.

Having given due consideration to all the submissions made on this issue and keeping in mind its award on wages, the court awards a separate housing allowance of Sh. 150 effective from 1st July, 1986.

#### Safari/Meal Allowance

After careful consideration of the demands and offers made on this item the court has decided to award the following:

Lunch	Sh.	35.00
Dinner	Sh.	35.00
Overnight	Sh. 20	05.00

#### Grading / Job Descriptions

The court rules that no party to a collective agreement can unilaterally amend any of its provisions. So there should be no amendment to Appendix "A" of the collective agreement.

As far as the application of the Revised Industrial Relations Charter dated 14th April, 1984, to the collective agreement is concerned the parties will have to determine on the basis of the job contents of each post in question wheather or not it can fall within the trade union representation. It should however be borne in mind that the respondents have the prerogative to creat additional posts but whether or not they are unionizable is a different matter.

The court would like to advise the parties that any dispute on this issue that may arise should be reported to the Minister for Labour as a separate dispute to warrant a detailed and comprehensive investigations so that a proper assessment can be made on each contested post.

#### Disturbance Allowance

In view of the submissions made by the parties, there appear to be some factors to warrant an additional increase of disturbance allowance. The court therefore awards that the present Sh. 1,000 disturbance allowance should be increased to Sh. 1,500.
