VACANCIES

Civil servant applicants and local authority officers should complete (revised) form PSC. 2A in triplicate (submitting the original through their heads of department). Other applicants should complete forms PSC. 2 in triplicate.

The documents are obtainable from either the Secretary or other Government offices and are issued free of charge.

Originals of certificates and similar documents should not be submitted unless specifically asked for. All applicants should state their postal addresses.

NOTE

Incremental credits will be granted to successful candidates who are not civil servants for approved previous experience provided the maximum salary is not exceeded. They will also be eligible for benefits and privileges enjoyed by civil servants in accordance with existing Government regulations.

Vacancies in the Office of the President:

Assistant Principal Registrar (Four Posts) (National Registration Bureau) (No. 163/89)

Salary scale.—K£4,272 to 5,946 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers with outstanding administrative ability, whose work performance and achievement of results at the level of senior registrar of persons have been consistently exemplary and deserving. In addition, they must have served at the level of senior registrar of persons, job group "L", for at least three (3) years.

At this level, work is of the same nature as that of senior registrar of persons but generally more diversified and somewhat more complex. The duties may include being in charge of a large section at the National Registration of Persons headquarters, where work involve interpreting the Registration of Persons Act, and developing procedures for its implementation; authorization of alterations of registration records; staff and establishment matters, etc.

Senior Registrar (Ten Posts) (National Registration Bureau) (No. 164/89)

Salary scale.—K£3,408 to 4,770 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers who have demonstrated capability of consistent and effective leadership and organization ability for at least three (3) years at the level of registrar of persons I, job group "K", and be fully conversant with the Registration of Persons Act, its subsidiary legislation, related Acts, registration procedures and Government regulations.

Duties involve documentation of registration records, receiving and scrutinizing all registration records from districts; inspection and maintenance of registration records; and dealing with complaints from the public. In addition, the officer is expected to supervise, train and develop staff working under him.

An officer at this level may also be deployed as a provincial registrar with responsibility for the co-ordination of activities of the district registrars.

Registrar of Persons I (Eighteen Posts) (National Registration Bureau) (No. 165/89)

Salary scale.—K£2,820 to 4,116 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers who have shown merit and ability in work performance for at least three (3) years in the grade of registrar of persons II, job group "J". They should have a good knowledge of the Registration of Persons Act, registration procedures and Government regulations; and have shown administrative ability in exercising supervision and control of junior staff.

Duties will include deployment as a general line assistant to a senior registrar of persons or may be in charge of a busy district. At this level, the officer must be capable of carrying out a variety of duties involving the administration and enforcement of the Registration of Persons Act, and supervision of the processing and issue of identity cards.

Registrar II (Twenty-two Posts) (National Registration Bureau) (No. 166/89)

Salary scale.—K£2,334 to 3,408 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving officers, who must have been confirmed in appointment and completed a minimum of three (3) years satisfactory service in the grade of registrar of persons III.

Duties include deputizing for a district registrar of persons or being in charge of a district. As a district registrar of persons, he will administer and enforce the Registration of Persons Act, and supervise the processing and issue of identity cards.

Registrar III (Fifteen Posts) (National Registration Bureau) (No. 167/89)

Salary scale.—K£1,938 to 2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants should be assistant registrar of persons, who have served in the grade for at least three (3) years. They must have a good knowledge of the Registration of Persons Act, and have shown merit and ability in administering and enforcing the Act.

For direct appointment, candidates must be in possession of a university degree in social sciences from a recognized university or other approved equivalent qualification.

Duties will include a wide-range of registration in an administrative division or at district headquarters, co-ordination of registration activities and supervision of junior staff.

Assistant Registrar (Thirty-eight Posts) (National Registration Bureau) (No. 168/89)

Salary scale.—K£1,554 to 2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants should be serving senior clerical officers, who must have a good knowledge of the Registration of Persons Act (Cap. 107); have shown merit and ability in administering the Registration of Persons Act, for at least three (3) years, and have been confirmed in appointment.

Duties will include a limited range of registration in an administrative division and supervision of junior staff.

Assistant Lecturer (One Post) (Health Education) (Embu D.D.I.) (No. 169/89)

Salary scale.—K£1,938 to 2,820 p.a. PENSIONABLE or AGREEMENT.

Applicants must be Kenya Registered Nurses, or its equivalent, with at least three (3) years' full time nursing experience. Preference will be given to the applicants with experience in teaching, and/or co-ordination of health training programmes.

Work involves teaching, preparation of teaching materials and and co-ordination of courses, seminars and workshops for the public and extension staff undergoing in-service training. The successful candidate will also be required to run a mini-dispensary at the institute and to undertake welfare services for sick students—including making arrangements for their treatment in hospitals.

Vacancies in the Ministry of Home Affairs and National Heritage:

Archivist I (One Post) (Archives Department) (No. 170/89)

Salary scale.—K£2,820 to 4,116 p.a. PENSIONABLE or AGREEMENT.

Applicants must be graduates from a recognized university. They must have served in the grade of archivist II, job group "J", or in similar position in an information management institution for at least three years. They should have acquired wide experience in records and archives management, and information science. A post-graduate qualification in records and archives management, and information science will be an added advantage.

The successful candidate will plan and guide records' surveys and appraisal, production of inventories, guides and indexes. He/she will advise on accessibility to public records, management and retrieval of information, preparation of records disposal schedules, and conservation of archives. He/she will also assist senior archivists in the preparation and implementation of programmes related to specific divisions. Successful candidates may be posted to any of the records centres in Mombasa, Nakuru and Kakamega.

VACANCIES—PUBLIC SERVICE COMMISSION—(Contd.)

Archivist II (Four Posts) (Archives Department) (No. 171/89)

Salary scale.—K£2,334 to 3,408 p.a. PENSIONABLE or AGREEMENT.

Applicants must be graduates from a recognized university. They must have completed three (3) years in the grade of archivist III, job group "H". In addition, they must have displayed talent and industry in records' surveys and appraisal, editing, and the preparation of finding aids, or cataloguing classification of library books. Applicants who, in addition to the above requirements, have also post-graduate qualification in records and archives management of library science will be given preference.

Successful candidates will be in charge of the operations of the sub-sections of the archives administration, records management, or the national documentation and information retrieval services divisions such as records surveys and appraisal, repository, or search and information retrieval services. He/she will also assist and guide archivist III trainees to acquire necessary skills and experience. Successful candidates may be posted to any of the records centres in Mombasa, Nakuru and Kakamega.

Social Welfare Officer I (One Post) (Prisons Department) (No. 172/89)

Salary scale.—K£2,334 to 3,408 p.a. PENSIONABLE or AGREEMENT.

Applicants must be social welfare officers grade II, who have served in job group "H" for a minimum period of three (3) years and in addition be in possession of the requisite professional qualifications. They should also have shown merit and ability to run efficiently social welfare services at the provincial level or at any other comparable position.

Duties will include investigation and solution design to social problems of staff and prisoners at a provincial penal institution. He/she will liaise with relevant authorities such as Prisoners' Aid Association on behalf of the prisoners.

*Vacancies in the Ministries of Transport and Communications:**Air Transport Officer I (One Post) (No. 173/89)*

Salary scale.—K£2,334 to 3,408 p.a. PENSIONABLE or AGREEMENT.

Applicants must be serving air transport officers II, job group "H", who have demonstrated competence and ability in discharging air transport duties as promulgated under the Civil Aviation Act (Ca. 394)—Licensing of Air Services—for at least three (3) years.

Duties and responsibilities involve enforcing civil aviation licensing regulations and procedures and monitoring the activities of scheduled and non-scheduled airlines operating into, within and out of Kenya. The successful candidate will also be expected to monitor the activities of the travel agents and tour operators. He/she will be stationed at any of the main airports in Kenya or at the Civil Aviation Board headquarters.

Link Trainer Instructor (Two Posts) (Civil Aviation) (No. 174/89)

Salary scale.—K£2,334 to 3,408 p.a. PENSIONABLE or AGREEMENT.

Applicants must be air traffic control officer II, in possession of air traffic control licence with aerodromes and approach control ratings or operations officer II, all of whom, should have served satisfactorily for a minimum period of three (3) years. Consideration will be given to other persons who should be trained to commercial pilot licence standard or possess current/lapsed professional flight navigator's licence.

Successful applicants will be trained to link trainer instructor level for one (1) year, through a link trainer course, which involves handling and navigating the equipment and executing instrument approach procedures. The trainees will be exposed to both theoretical and on-the-job training for a further period of two (2) years after which they will be considered for appointment as senior link trainer instructor, job group "K".

*Vacancies in the Ministry of Information and Broadcasting:**Librarian I (One Post) (No. 175/89)*

Salary scale.—K£2,820 to 4,116 p.a. PENSIONABLE or AGREEMENT.

Applicants must have a wide experience in library management and administration which must include at least three (3) years service at the level of librarian grade II, job group "J". They

must have demonstrated satisfactory administrative ability in organizing and running large libraries.

The successful candidate will be responsible for management of library services including implementation of library work programmes. Work involves mainly direction, control and co-ordination of the library branches. The librarian I, will be required to estimate, control the vote for library service and write reports on library services.

Senior Library Assistant (Five Posts) (No. 176/89)

Salary scale.—K£1,554 to 2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants must be in possession of a certificate in library studies from the Kenya Polytechnic or any other approved institution. They must have served as library assistant, job group "F", for a period of not less than three (3) years, and have shown competence and ability in the performance of library duties. The successful candidates will carry out the day-to-day library duties, that is cataloguing and classification, shelving, serving users, and so on. One will be expected to head some library units and supervise junior staff including messengers.

Applicants must be qualified in all respects in accordance with the scheme of service for library assistants and librarians.

Executive Assistant (Sales) (Eight Posts) (No. 177/89)

Salary scale.—K£1,554 to 2,334 p.a. PENSIONABLE or AGREEMENT.

Applicants must have a minimum of eight (8) years satisfactory and appropriate clerical experience within the cadre of which at least three (3) years must be in the grade of senior clerical officer and must have passed the proficiency examination for clerical officers.

Duties assigned to this post include, collection of primary data on revenue collected; sale of rural newspapers and other Government publications in a given area; sale of advertising space in rural newspapers and other Government publications; collection of sales and advertising revenue and accounting for the same; maintenance of sales and advertising records; liaison with space sellers and advertisers; setting sales targets per publication and monitoring the performance closely; initiating appropriate sales competition between vendors; forecasting sales trends and taking appropriate measures and finally promoting of rural newspaper circulations.

*Vacancies in the Ministry of Public Works:**Chief Superintending Architect (Three Posts) (Architectural Department) (No. 178/89)*

Salary scale.—K£5,730 to 7,038 p.a. PENSIONABLE or AGREEMENT.

Candidates must possess the full professional qualifications, including registration by the Board of Registration of Architects and Quantity Surveyors of Kenya, and have a minimum of (9) years' total experience as an architect, two (2) of which must have been served in the grade of senior superintending architect.

They should also have a wide experience in monitoring of expenditure on building contracts and projects behind schedule, preparation of forward budget, draft and revised development estimates in the architectural department on the Ministry of Public Works or an architectural organization of comparable scope and status. They must also have experience and ability for direction and control of personnel at all levels in a professional office dealing with the administration of large building contracts.

Senior Inspector (Buildings) (Five Posts) (Architectural Department) (No. 179/89)

Salary scale.—K£1,938 to 2,820 p.a. PENSIONABLE or AGREEMENT.

IMPORTANT NOTICE TO SUBSCRIBERS TO THE KENYA GAZETTE

THE following notes are for the guidance of persons submitting "copy" for inclusion in the *Kenya Gazette, Supplement*, etc.:

- (1) The *Kenya Gazette* contains notices of a general nature which do not affect legislation. They are, therefore, submitted to the Government Printer directly.
- (2) *Legislative Supplement* contains Rules and Regulations which are issued by the central Government. Because of this they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) *Bill Supplement* contains Bills which are for introduction in the National Assembly.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain a minimum of alterations.

Particular attention should be paid to the following points:

- (i) Signature must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

"D 41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
