By consent of the parties, the court awards that the respondents should pay the above-named grievants in accordance with the following terms:

- (a) The grievants be paid salary for the days worked.
- (b) The grievants be paid for leave accrued.
- (c) The grievants, who have served the respondents for five years and above, be paid two months' salary in lieu of notice.
- (d) Those grievants, who have served the respondents below five years, if any, be paid one month's salary in lieu of notice.
- (e) The grievants be paid pro rata housing allowance.
- (f) The grievants be paid leave travelling allowance, if any.
- (g) The grievants be paid two months' salary each as ex-gratia final settlement.
- (h) The total sum due and payable by the respondents to the grievants be paid in three equal monthly instalments with effect from 30th June, 1989.
- (i) The instalments be paid by the respondents to Mombasa Labour Office.

Housing allowance to employees of the company.

Leave travelling allowance.

Working condition or condition allowance.

Baggage Allowance.

Long Service increment.

Job grading.

THE Kenya Chemical and Allied Workers Union shall hereinafter be referred to as the claimants and the Dawa Pharmaceuticals Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 7th December, 1988 and 13th February and 28th March, 1989, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 31st May, 1988, duly signed by the parties was received by the court on 14th July, 1988, together with the statutory certificate signed by the Labour Commissioner.

The respondents are a local pharmaceutical manufacturing company incorporated in 1974 and commenced business in 1976. They engage in the manufacture of drugs and are owned by the Industrial and Commercial Deelopment Corporation (I.C.D.C.), Krka Pharmaceuticals of Yugoslavia and some local share-holders.

The respondents currently employ 132 unionizable and 73 managerial staff, that is, a total of 205 workforce. Among the respondents' local competitors are Sterling Winthrop Ltd., Nicholas Kiwi Ltd., Wellcome Kenya Ltd., Boots Products Ltd., Macs Pharmaceuticals Ltd., Glaxo (E.A.) Ltd., Laboratories and Allied Industries Ltd. and Elly Pharmaceuticals Ltd.

The parties have voluntarily negotiated and concluded many collective agreements, but this dispute arose when parties were negotiating for the renewal of the latest of their collective agreement which expired on 30th June, 1987.

The parties held several meetings at their own level during which they agreed on certain issues. The Ministry of Labour appointed a concilliator to assist the parties reach an agreement on the remaining issues but they recorded a deadlock on the issues now before the court.

Minimum rates of pay and general wages increases to all unionizable employees of the company.

The court notes that the claimants have demanded a wage hike of 12.5 per cent for the first year and a similar 12.5 per cent for the second year; but the respondents have pleaded their nability to pay because of severe liquidity problems, resulting in insolvency in 1987. The respondents have however offered the claimants 9.0 per cent for the first year and a similar 9.0 per cent for the second year. These increases total up to 18.0 per cent as opposed to the claimants demand of 25.0 per cent. The court requested the Planning and Research Division (P.R.D.) of the Ministry to carry out investigations due to the fact that some of the issues in dispute were affected by the wages guidelines. A comprehensive analysis was carried out by the P.R.D. and its findings are that the claimants would be entitled to an average wage hike of about 14.0 per cent for the two year period.

After taking into considertaion all the parties written and verbal submissions, and the P.R.D. report on this issue, the respondents lowest minimum wage of Sh. 831 and the current average minimum wage of about Sh. 1,284 in the pharmaceutical industry, and the financial predicaments faced by the respondents, the court has decided to improve on the respondents offer of 9.0 per cent, which is well above the wage guidelines, by 1.0 per cent each year for the two year period.

that is, 10.0 per cent each year, and awards the same increases based on their present salaries, effective from 1st July, 1987.

The court makes no award on the present basic minimum wages.

Housing or Housing Allowance

Under this issue, the claimants have demanded house allowance increase of Sh. 50 per month per year against the repondents offer of Sh. 30 per month per year. At present, the respondents are paying an average house allowance of Sh. 271 or between Sh. 211 and Sh. 430.

Having given due and serious consideration to all the submissions by the parties on this issue and keeping in mind wage guidelines stipulation (IV) and its award on wages, the court awards housing allowance increases of Sh. 40 per month per year with effect from 1st July, 1987.

Leave Travelling Allowance

The court has given anxious consideration to all the submissions made by the parties in respect of this issue and awards that the present leave travelling allowance of Sh. 300 be increased to Sh. 350, payable to the workers once a year when proceeding on annual leave.

Working Candition or Condition Allowance

The court notes that the workers in these departments/sections, particularly in anti-biotics and tabletting sections, are exposed to occupational hazards which may have adverse long-term health effects. However, after careful consideration the court rejects the claimants' demand for payment of working condition allowance in respect of the other departments/sections and upholds the respondents offer and the experts recommendation that effective and suitable provision be made for extra ventilation, mask equipment, foot-wear or shoes and protective clothing and gloves as may be necessary.

Baggage Allowance

The court considers that the respondents increment of Sh. 40 on the present allowance of Sh. 400 is inadequate; and after careful consideration, awards Sh. 500 on this item.

Long Service Increment

The court feels that the present arragement under this heading should not be disturbed. However, the court advises the parties to review this matter during their next round of negotiations.

Job Grading

In view of the recent job evaluation and the parties' submissions, the claimants' demand is rejected on this item.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain a minimum of alterations.

Particular attention should be paid to the following points:

- (i) Signature must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-Kenva Gazette

"D 41. (1) Communications for the Kenya Gazette should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer when ready.

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
