THE Kenya Chemical and Allied Workers Union shall hereinafter be referred to as the claimants and the Haco Industries Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 29th March, 1989, and relied on their written and verbal submissions, in addition the respondents called S. S. Sagoo, their Mombasa Factory Manager, to give evidence on oath. The claimants did not call any witness.

AWARD

3. The Notification of Dispute Form "A" dated 11th July, 1988, duly signed by the parties was received by the court on 10th October, 1988, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Mr. E. Okoth was employed by the respondents on 1st January, 1977, as a machine operator. He was deployed at the respondents' factory in Nairobi. He stayed on this job in Nairobi until he was transferred to Mombasa on 27th May, 1985.

Mr. Okoth was dismissed on 26th June, 1986, after having served the respondents for nearly nine (9) years. He was dismissed on allegations of carelessness in his work and negligence on duty. The respondents requested the court to find that their action in giving Mr. Okoth normal termination of service as fair and so to reject the claimants' demand for reinstatement.

After careful consideration of all the submissions the court finds that both parties were at fault to some extent and the court feels that a normal termination of service with two months compensation would be adequate in this dispute as recommended by the Minister for Labour and so award.

2. The parties were heard in Nairobi on 10th, 13th and 17th April, 1989, and relied on their written and verbal submissions. In addition, the respondents called the following seven witnesses to give evidence on oath:

The claimants did not call any witness.

AWARD

3. The Notification of Dispute Form "A" dated 13th September, 1988, duly signed by the parties was received by the court on 17th October, 1988, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

This issue concerns nine (9) employees who were dismissed on 16th December, 1987, after serving the respondents for a number of years ranging from 8 to 16 years as approximately shown below:

They were dismissed for allegedly taking part in beating up their departmental manager causing him grievous bodily harm on 15th December, 1987.

The court notes with concern that there was lawlessness in the respondents' factory at Limuru where a departmental manager was badly assaulted by workers under him on 15th December, 1987. The court is surprised at this because there was no evidence of provocation on the part of the manager on the day in question or previously having had problems with his workers. It is evident that not only Patrick Mwangi who assaulted him, but all those dismissed, took part in assaulting their manager using fists, lasts and hammers to an extent that he received head injuries which had to be stitched at the Nairobi Hospital where he was admitted for ten days.

The court finds the witnesses who gave evidence before it to have been truthful and reliable as they told of what they saw at the time of the fight. They identified each grievant and the part he played during the fracas and immediately thereafter.

The court also finds that the claimants' submission that the nine grievants were selected on tribal basis, hatred and victimization was not proved at all. There is not a shred of evidence to prove that. On the contrary it goes to the credit of the personnel manager of the respondents, who was a target of this accusation, for not having practised tribalism during his 14 years of service with the respondents. If anything, there were only eight (8) employees from his tribe compared to 33 from the alleged victimized tribe as the claimants would like it believed. The court finds this accusation to be baseless and unwarranted.

This dispute was first investigated by the District Labour Officer, Kiambu, who surprisingly enough found the case in favour of the claimants and recommended dismissal of Patrick Mwangi only exonerating the rest of the assailants whereas in his findings he stated that he could not wholly condemn the nine (9) workers nor exonerate either of them.

In the light of the evidence that was produced before the court during the hearing, which evidence the court was told was also given before the official investigator, the court cannot accept the findings or recommendation of the Ministry of Labour.

The court finds this to be a shocking case where a departmental head who had the reputation of being the most loved expatriate manager was brutally assisted just because he was instructing a worker under him on how to do his work better. There is no evidence that the manager abused any worker on that day or any other day or that he used to misbehave in any way towards the workers.

Under the aforesaid circumstances the court cannot help the grievants in any way and they must suffer the consequences of their serious gross misconduct to say the least.

The court therefore rejects all the claimants' demands in this dispute and the respondents' decision to dismiss the grievants in this dispute stands.







- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

Kenya Gazette

"D 41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.
