# THE INDUSTRIAL COURT CAUSE No. 42 of 1988

Parties:

Kenya Chemical and Allied Workers Union and Magadi Soda Company Limited

Issue in Dispute:

Termination of the services of Richard Kirunja M'Rimberia.

THE Kenya Chemical and Allied Workers Union shall hereinafter be referred to as the claimants and the Magadi Soda Company Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 10th May, 1989, and relied on their written and verbal submissions.

# AWARD

3. The Notification of Dispute Form "A" dated 30th January, 1988, duly signed by the parties, was received by the court on 3rd June, 1988, together with the statutory certificates, both signed by the Minister for Labour and the Labour Commissioner.

Richard K. M'Rimberia was first employed by the respondents as a casual employee between September 1974, and July 1977, at a salary of Sh. 460 to 621 per month. He was subsequently confirmed into permanent terms of service as a general labourer and in May 1979, the grievant was promoted to the position of a tractor driver on payroll 6 at a salary of Sh. 1,076 per month. In July 1980, he was transferred from production department to engineering department on payroll 7, where he worked as a driver of mechanical shovels at a salary of Sh. 1,139 per month. He was eventually placed on payroll 8, and at the time of termination of his services, on 17th February, 1983, he was earning a salary of Sh. 1,558 per month. The grievant has served the respondents for nearly nine (9) years. The incidents that led to the termination of the grievant's services took place on various dates between 18th May, 1982, and 15th February, 1983.

The court notes that this dispute was reported to the Minister for Labour by the claimants in August 1986, a period of 3½ yars after the termination of the grievant's services. An investigator was appointed, and as a result the chief industrial relations officer forwarded his "findings and recommendations" to the parties. These were, inter alia, as follows:

## Finding:

From 1982 his record deteriorated and began to get warnings at short intervals. The final incident which caused his termination was failure to report for duty on 1 th February, 1983, during the day shift. In the discussions, the union and Mr. M'Rimberia accepted the offer of resignation and the final payment of KSh. 22,501.00 given by the management. In his letter of 18th February, 1983, Mr. M'Rimberia claims that he was forced to resign by the company, no evidence has been produced to show any form of force or presure on him to do so . . . Mr. M'Rimberia resigned from his employment willingly, as a compromise solution, arising out of the discussion on his termination. The matter was then satisfactorily settled . . . Even if the resignation was in doubt . . . the offer by the management . . . would have been reasonable in terms of termination.

# Recommendation:

That being the case Mr. M'Rimberia should take his final dues of KSh.  $22,501\ldots$ 

The circumstances leading to this dispute quite clearly show that Mr. M'Rimberia absented himself from duty on 1st, 2nd and 16th February, 1983; and the court has no hesitation in finding that Mr. M'Rimberia did indeed commit a serious misconduct as the court cannot disregard the obvious inference from the aforesaid set of circumstances. The court has also considered Mr. M'Rimberia's long service with the respondents and finds that this was not a case of victimization.

For the foregoing reasons the court concurs with the Ministry of Labour's findings and recommendations in this dispute and finds that the grievant has indeed resigned his employment. The court has therefore decided to uphold the respondents' offer to the grievant of Sh. 22,501 and awards that the same be paid to him accordingly. In conclusion and for the sake of industrial harmony in this country, the court, while making this award, must caution the claimants to desit from reviving a matter on behalf of their member which has long been settled satisfactorily. The court hopes that such conduct will not be repeated in future.

## THE INDUSTRIAL COURT

Cause No. 92 of 1988

Bakery, Confectionery, Manufacturing and Allied Workers Union (K)

and

# Pwani Bakery

Issue in Dispute:

Refusal by the company to recognize the union for the representation of the industrial interests of its employees.

THE Bakery, Confectionery, Manufacturing and Allied Workers Union (Kenya) shall hereinafter be referred to as the claimants and the Pwani Bakery shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 24th April, 1989, and relied on their written and verbal submissions and documentary evidence.

#### AWARD

3. The Notification of Dispute Form "A" dated 1st September, 1987, duly signed by the parties was received by the court on 11th November, 1988, together with the statutory certificate signed by the Labour Commissioner.

The respondents are based in Mombasa and engage in bakery business since May 1985. They have a permanent labour force of 11 employees. They further engage temporary employees with the number varying between 30 to 40 employees depending on the availability of work.

The court has carefully considered the submissions and the arguments advanced by the parties and finds that there have certainly been undercurrents in this dispute to the detriment of the claimants' demand for recognition. The respondents have tried to dodge recognizing them.

On balance, the court feels that the respondents should recognize the claimants and so award. This is the only way to establish sound industrial relations and to prevent dismissals of workers when they join their trade union.

The court further directs the parties to enter into and sign a recognition agreement within three months of the date of the court award and rules that the recognition agreement will be effective from the date it is signed.

2. The parties were heard in Nairobi on 3rd, 4th and 25th April, 1989, and relied on their written and verbal submissions.

# AWARD

3. The Notification of Dispute Form "A" dated 9th November, 1988, duly signed by the parties was received by the court

on 16th December, 1988, together with the statutory certificate signed by the Labour Commissioner.

The respondents are an employers association comprising of 40 member companies. The members of the association employ a total of 8,064 employees, out of whom 6,053 are unionizable staff and 2,011 are managerial staff. This dispute concerns 6,053 unionizable staff.

The dispute arose when the parties were negotiating for the renewal of their two year collective agreement which expired on 30th June, 1988. Interestingly the respondents initiated correspondence directed to the claimants to start negotiations for revising their C.B.A. as early as 25th February, 1988. The claimants then forwarded their proposals and received counter proposed from the respondents.

The parties held several meetings and later the Ministry of Labour appointed a conciliator to assist them reach an agreemeent. The parties agreed on most of the issues leaving only the seven items now before the court.

# Non-unionizable staff:

The demand made by the claimants under this issue is not so simple as they have tried to make it.

A major exercise and review by the parties at their own level at first is a must. The parties should examine most carefully what actual functions are performed by the foremen, supervisors and other categories which the claimants are desirous of enrolling as their members and representing them. This is necessary to ascertain whether or not they fit in with the letter and spirit of the revised industrial relations charter specifying the non-unionizable employees in an organization.

The court must however point out that the industrial relations charter was revised when the Kenya Management Staff Association ceased to exist with a clear view to raising the level of unionizable employees.

With the aforesaid remarks the court directs the parties to apply their minds seriously to this problem first at their own level and then seek the assistance of the Ministry of Labour failing which the matter should come to industrial court as a fresh and separate dispute.

# Retirement Benefits:

After careful consideration of all the submissions the court has decided to award the workers additional retirement benefits to those in clause 20.

The additional award is that the workers' service with the respondents' members with effect from 1st January, 1988, will also be counted towards payment of their retirement benefits in addition to their dues under the N.S.S.F.

# Under-payment of Housing Allowance:

There is no merit in the claimants' demand under this issue and it is accordingly rejected.

# Members Benefits:

The court has decided to reject this demand.

# Long-service Increment:

The court has decided to reject this demand for the time being and the parties are advised to examine it carefully during the next round of negotiations.

# Wage Increments:

After careful consideration of all the admissions, the court awards a wage increase of 8 per cent for the first year and 10 per cent increase for the second year on the workers existing wages.

# House Allowance:

The court awards that the current house allowance entitlement of workers should go up by Sh. 88 per month for the first year and Sh. 50 per month for the second year.

# Effective Date:

The court awards the effective date to be 1st July, 1988, with a duration period of two years from that date.

Particular attention should be paid to the following points:

- Signature must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya

EXTRACT PROM THE CODE OF REGULATIONS, SECTION D-Kenya Gazette

- "D 41. (1) Communications for the Kenya Gazetic should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.
- (2) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer when ready."
