THE Kenya Union Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and the Kenya Bankers (Employers) Association shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 20th March and 31st May, 1989, respectively. The parties relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 16th October, 1987, duly signed by the parties was received by the court on 1st December, 1988, together with the statutory certificate signed by the Labour Commissioner.

The respondents consist of 24 member banks and have a collective agreement with the claimants. The agreement applies to all member banks.

This dispute concerns the following banks:

Middle East Bank of Kenya.
Algemene Bank Nederland.
Pan African Bank Ltd.
Citi Bank,
Co-operative Bank of Kenya.
Union Bank of Kenya.
Bank of Oman.

Habib Bank AG. Zurich.
Grindlays Bank International.
Commercial Bank of Africa.

The historical background to this dispute is that prior to 1975, the respondents' unionizable employees used to work a six-day week. The claimants submitted that the parties had a joint consultative meeting in 1975. As a result of the meeting, the following nine (9) banks agreed to adopt five-day working week and maintained it between April 1975 and April 1986.

A.B.N. Bank N.V.
Commercial Bank of Africa.
Citi Bank N.A.
Grindlays Bank International (K) Ltd.
Habib Bank A.G. Zurich.
Pan African Bank Ltd.
Union Bank of Kenya.
Middle East Bank Ltd.
Co-operative Bank of Kenya.
Bank of Oman.

The court has carefully considered the parties submissions and finds that this is not the first time this issue has come before it. In fact the issue has come before the court several times except that now it is in a different form. On each occasion the court rejected the claimants' demand for five-day working week. The court pointed out that an issue like this which has far reaching implications in the banking industry is a matter within the definition of management methods which in the parties recognition agreement is listed as a non-negotiable item.

The court further notice that 85 per cent of the respondents' work is done on six-day working week arising from the convenience and needs of the community served.

In the present dispute the claimants' demand is that the banks affected by this dispute should be ordered to add all the Saturdays from 1975 to date to the workers' annual leave which were denied to them notwithstanding that Saturdays were rest days. They should either get additional leave to compensate them for this or they should be paid cash in lieu thereof. It is obvious the demand entails a colossal financial burden on the banks if granted.

Unfortunately for the claimants the relevant provision in the collective agreement goes against their demand in that Saturday is not specified as a non-working day. Further, in the overtime clause it is provided that double time is to be paid for Sundays and public holidays, not on Saturdays. So Saturday is not a rest day.

The fact, however, still remains that the workers are rather puzzled and confused working hour arrangements in various banks and about work on Saturdays. The court understands their predicament which is also linked with the workers' perennial demand for a five-day working week in the banking industry.

The answer to all this is not an award against the banking industry as demanded by the claimants which would cause a heavy financial burden on the banks but to tackle this whole problem in a realistic manner after going through all the pros and cons of the various issues at stake. In any case appropriate amendments are necessary to the collective agreement.

Under these circumstances the claimants are advised to formulate their demands on the relevant matters and forward them to the respondents for processing it through normal channels of discussions, negotiations and then final arbitration by the industrial court.

The court dare not make an award which would be tantamount to amending the parties collective agreement when the issue of amending the collective agreement is not before the court. The court, however, will be prepared to consider the matter when it comes before it on the issue of amending the collective agreement after it has gone through all the pre-industrial court procedures.

The respondents are advised not to hedge this matter when proposals are made by the claimants but to approach the problem in a practical manner.

With the aforesaid remarks the court has no alternative but to reject the claimants' demand as it is misconceived.

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and the Nakuru Flour Mills Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 27th April and 8th June, 1989, respectively. The parties relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 9th September, 1988, duly signed by the parties was received by the court on 6th January, 1989, together with the statutory certificate signed by the Labour Commissioner.

The respondents are a flour milling company situated in Nakuru town. They employ a total labour force of 72 employees out of whom 68 are unionizable employees. This dispute concerns the 68 unionizable employees.

The parties signed a recognition agreement on 26th February, 1987, and the claimants submitted their proposals for negotiation of the first ever collective agreement on 29th April, 1987. In a series of joint industrial council meetings that followed, the parties settled several items and recorded a deadlock on twelve (12) items now before the court for adjudication.

After careful consideration of the parties' submissions and the report by the Planning and Research Division (P.R.D.), the court awards as follows on each item:

Annual leave
Long-service increment
Suspension

The court has carefully considered the arguments advanced by both parties on these items and finds that these items should not be revised for the time being.

The court accordingly rejects the claimants' demands on these items.

Minimum wages

The court has carefully considered the submissions made by the parties on this item and finds that the respondents offer is reasonable. The court accordingly awards that the respondents' offer on this item should be the new minimum wages subject to revision by the statutory orders.

General wage increase

The court awards the workers a wage increase of 10 per cent for the first year and a further increase of 10 per cent for the second year respectively.

House allowance

After careful consideration of the submissions the court awards that the workers are entitled to a separate house allowance and that the consolidated wages should continue in force as at present. The court therefore awards a separate housing allowance of Sh. 50 per month in addition to the consolidated wage.

Leave travelling allowance

The court awards an increase of Sh. 80 on the current leave allowance.

Dismissal

The parties agreed on this item.

Transport for night shift workers

The court has carefully considered the claimants' demand on the night shift transport and finds that their demand has some merits.

The court has decided to award either of the following to be chosen by the respondents:

- (a) The court directs that those employees who report for duty at 10.30 p.m. and those reporting from the second shift at 11.00 p.m. be provided with company transport. There are only 12 employees per shift and they should be picked and dropped at one central point convenient to both parties within the Runda estate.
- (b) The respondents start operating two shifts instead of the current three shifts. If the two shift arrangement is adopted the respondents should pay the over-time for the extra hours worked within the two shift arrangements.

Night shift allowance

The court awards a night shift allowance of 70 cents per hour. This allowance should be paid to employees who work on night duty only and is effective from 1st July, 1989.

Death of an employee

During the hearing the claimants informed the court that the respondents have never contributed either in kind or cash towards the burial of deceased employees.

The court after considering the submissions put forward by the respondents' is inclined to accept that this issue is purely a welfare matter. However, the court feels that both parties should be in a position to join hands in a matter like this one in one way or the other. The court accordingly awards that the respondents should contribute a sum of Sh. 1,000 towards funeral expenses of a dead employee since they made no contribution in the past when two (2) employees died.

Effective date

The court awards that the effective date should be 1st May, 1988.

THE Kenya Engineering Workers Union shall hereinafter be referred to as claimants and the Wire Products Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 5th June, 1987, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 19th September, 1988, and duly signed by the parties was received by the court on 19th December, 1988, together with the statutory certificates signed by the Labour Commissioner.

The seven employees who are affected by the dispute are:

John Macharia.
Joseph Kiema Kiarie.
Wilson Gichuki.
John Muiruri.
Abdulla Muindi.
Altima Kanguha (Mrs.).
Agnes Waithira Mwaura (Miss).

The parties to this dispute have since concluded five collective agreements, three of which are relevant in this matter.

These are:

1st May, 1983 to 30th April, 1985.
1st May, 1985 to 30th April, 1987.
1st May, 1987, to 30th April, 1989.

The monthly housing allowances applicable thereto were Sh. 160, Sh. 190 and Sh. 225 respectively.

The grievants were formerly classified as managerial staff, but pursuant to the amendment to Appendix C of the Industrial Relations Charter in 1984, which raised the level of union representation, they became unionizable, and accordingly their salaries were governed by the parties' collective agreement. The claimants requested the respondents to implement the housing allowance entitlements to the grievants, but their request was turned down on the ground that consequent upon the aforesaid amendment the grievants salaries were subject to deconsolidation. The matter was discussed between the parties but a deadlock was reached and the same was therefore reported to the Minister for Labour as a trade dispute.

The court has carefully analysed the submissions and arguments put forward by the parties in this dispute and finds that the parties are in complete agreement that, pursuant to the amendment of Appendix C of the Industrial Relations Charter, the grievants became unionizable employees and their salaries were inevitable subject to deconsolidation. The only bone of contention between the parties in this matter is the appropriate method of deconsolidation. The claimants have maintained that the grievants' already consolidated salaries should not be interfered with but instead a house allowance be added thereon. On the other hand the respondents have pointed out that the right approach in this matter is to deconsolidate the grievants' already consolidated salaries so as to get the basic wage and the housing element.

The court notes that if the claimants' approach is adopted the grievants would be entitled to double house allowance. Such a situation would amount to unfair and unjust treatment of the other employees, and the court would not allow it. The court has therefore no hesitation in coming to the conclusion that the respondents approach is the correct one, and accordingly the claimants' approach and demand are rejected.

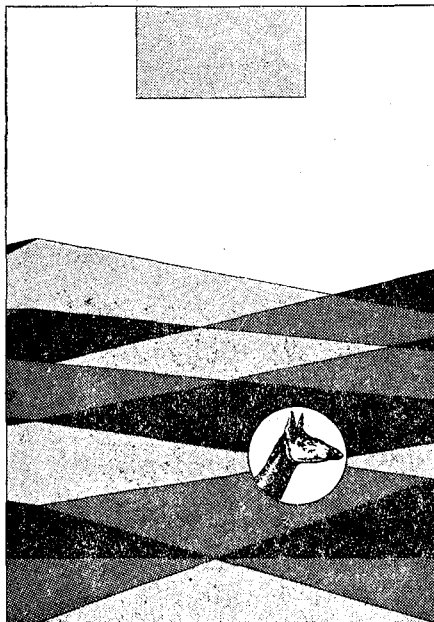

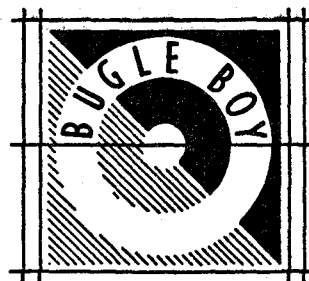

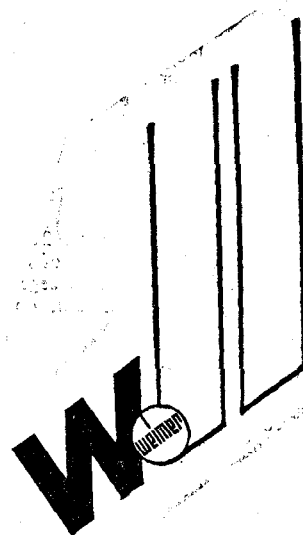
