CAUSE No. 82 OF 1984

Parties:

Kenya Engineering Workers' Union.
and
East African Metal Works Limited.

Issue in dispute:

Dismissal of Messrs. Bondo Odum and Osewe Monye.

THE Kenya Engineering Workers' Union shall hereinafter be referred to as the claimants and the East African Metal Works Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 5th July, 1989, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A", dated 16th May, 1984, and duly signed by the parties was received by the court on 20th August, 1984, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The respondents are a member of Minor Engineering Group of the Federation of Kenya Employers and at the time of the grievants' dismissal the parties had a valid collective agreement for the period 1st August, 1982 to 31st July, 1984.

The grievants were employed by the respondents on 10th March, 1964, and 1st February, 1978, respectively. They were both dismissed for negligence on 11th July, 1983. At the time of their dismissal, the grievants were earning KSh. 1,000 and KSh. 600 and they had worked for the respondents for 19 years and nearly 5 years respectively.

The events leading to the dismissal of the grievants occurred on 11th July, 1983. It is alleged that the grievants damaged the respondents' machinery negligently and willingly by inserting one foot square of high carbon steel into the blade of the machine which, in normal use, cuts light sheets, and as a result all shearing blades cracked and the main driving and crank shaft bushes were damaged.

In this dispute the court notes that the grievants served the respondents for 19 and nearly 5 years respectively without valid warning letters against them. The court further notes that as a result of the grievants' action in inserting the square into the blade machine the respondents incurred a great loss of production.

Under the above circumstances the court is to determine whether the grievants were careless and negligent while performing their duty; and if so, whether their dismissal was justified.

In common law, an employer is entitled to dismiss a servant for a single act of misconduct or serious negligence. In determining the seriousness of an act of negligence, regard must be had, not to the consequences of the act, but to its nature. The act complained of has to go beyond a mere error of judgement and into the realms of gross negligence.

The court has carefully analysed all aspects of this dispute and the parties submissions, and has no hesitation in coming to the conclusion that the grievants' action amounted to gross misconduct. In the circumstances, the court therefore finds that the grievants deserved summary dismissal and their services were properly terminated by the respondents.

However, because of their length of service to the respondents and purely on compassionate grounds, the court feels that the respondents, in addition to the amount already deposited with the labour officer, should pay the grievants three (3) months and one (1) month salary respectively, and the court so directs.

The claimants' demand for fringe benefits or payment under redundancy clause and full compensation to the grievants are accordingly rejected.

*Issue in dispute:**Claimants wording:*

Surcharge made from salaries of employees in leaf bases (Githongo and Imenti) on loss of weight of green leaf, in 1980, 1981, 1982 and 1983.

Respondents wording:

Refund of wrongful surcharges effected on salaries of employees in leaf bases (Githongo and Imenti) during the year 1981.

Amendment in court:

Refund of wrongful surcharges made from salaries of employees in leaf bases (Githongo and Imenti) during the months of March, April, and May 1981.

THE Plantation and Agricultural Workers Union shall hereinafter be referred to as the claimants and the Kenya Tea Development Authority shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 15th May and 4th July, 1989, and they relied on their written and verbal submissions. At the conclusion of the parties' main submissions on 15th May, 1989, and in the light of certain matters which were not properly gone into or cleared by the parties, the court requested the Planning and Research Division (P.R.D.) to carry out an analysis and submit a report thereof for the court's guidance. In the circumstances, the award could not be ready earlier as the said report was not available to the court until the 29th June, 1987.

AWARD

3. This dispute was referred to the court by the Minister for Labour in accordance with section 8 of the Trade Disputes Act. The court received the Minister's reference dated 16th December, 1988, on 19th December, 1988, together with the statutory certificate from the Labour Commissioner.

The respondents are a parastatal organization established by a statutory legislation under section 190 of the Agricultural Act, Cap. 318, for the purposes of farming and processing of tea in the country. They also manage thirty-nine factories and a similar number of leaf bases. Githongo and Imenti leaf bases in Meru District of Eastern Province are the subject matter of this dispute.

The parties have a recognition agreement between them and two kinds of collective agreements. The first collective agreement covers employees in the thirty-nine factories, and the second covers employees in the respondents' head office and the thirty-nine leaf bases. The present dispute relates to 1981/82 collective agreement between the parties which covered the leaf bases only.

The court has scrupulously perused the Planning and Research Division's (P.R.Ds.) report on this matter and notes that losses of green leaf occurred at two stages. First at the buying centre, and secondly when the leaf is on transit to the leaf base for factory. Various reasons were cited by the claimants which allegedly contributed to these heavy losses of leaf—for example, faulty scales, poor road conditions and torn bags. The respondents advanced some counter reasons and maintained that the surcharges imposed upon the grievants were in respect of losses which occurred at the buying centres only.

The court notes that the surcharges were introduced by the respondents throughout the country in 1977, through circular No. 136/77 dated 8th November, 1977, addressed to all factory managers and leaf officers, and copied to all heads of departments, factory superintendent and assistant factory superintendent (L.C.), by then General Manager, Mr. C. K. Karanja.

From the foregoing the court is satisfied that the short falls for which the leaf collection clerks were surcharged occurred at their respective buying centres, that is the difference between A and B, and the leaf collection clerks, on accepting employment from the respondents, knew precisely what their position was as regards losses of green leaf at the buying centres. The grievants were employed to render satisfactory and careful service to the respondents; and, as they had failed or neglected to do so, they were therefore bound to compensate the respondents for the losses which had resulted through want of care.

The court is further satisfied that the grievants were aware that the respondents had power to deduct a reasonable amount from their wages for bad or negligent performance of their duties. They also knew what acts and omissions carried deductions because they had taken their jobs on the contractual terms which permitted such deductions and they accepted their appointments from the respondents on the same terms as to deductions for any shortfalls of green leaf in their possession or custody.

The court has scrutinized the relevant collective agreement that existed between the parties during the period under consideration and finds that surcharge is not a condition of service which is negotiable; and, in the circumstances, the respondents were clearly within their right to improve efficiency of their enterprise by introducing such a deterrent method to curb the possibility of abuse by unscrupulous leaf collection clerks.

Although the claimants have put forward very interesting arguments during the hearing, the court finds that they have failed to convince it on excessive losses incurred by the leaf collection clerks at the buying centres after the 1 per cent allowable loss has been taken into account. Furthermore, a $\frac{1}{4}$ kg. of leaf weight which is not normally recorded in the growers' receipts should at the end of the day, add to the total weight of the leaf recorded for that particular day.

Taking all the aforesaid points into consideration, the court rules that the surcharges were proper and justified and rejects the claimants' demand.

THE Transport and Allied Workers Union (K) shall hereinafter be referred to as the claimants and the Express Mombasa Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 17th July, 1989 and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 31st August, 1988, duly signed by the parties was received by the court on 19th December, 1988, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievant worked for the respondents from 1st July, 1970 as a messenger and was dismissed on 3rd July, 1986, after 15 years of service. The circumstances which led to his dismissal started on 2nd July, 1986, when the respondents' personnel and administrative manager wrote a letter to the grievant, instructing him to flush toilets twice a day and ensure that there was a bucket of water in each toilet which he, the grievant, was to draw. The following morning, 3rd July, 1986, the general manager brought some jerrycans of water from his house as there was water shortage at the respondents premises. It is alleged that he instructed the grievant to remove the jerrycans from his vehicle and place them in different toilets, but the grievant refused to do so, and as a result of his refusal he was instantly dismissed.

The court has thoroughly analysed the parties' submissions in this dispute and notes that the instructions given to the grievant by the personnel officer on the one hand, and the general manager on the other, were at variance. The former instructed the grievant to flush toilets, whereas the latter instructed him to remove some jerrycans of water from his vehicle and place them in the toilets.

Although the respondents stated that the grievant was dismissed because he disobeyed "the top official of the company", the court cannot positively find that the grievant refused to obey the instructions. He might have been an unsatisfactory employee, but in the court's mind he certainly was not disobedient, and the court is therefore convinced that his behaviour on that fateful day amounted very much to a reluctance rather than an outright refusal to obey an order.

In view of the foregoing reasons the court finds that the grievant was wrongfully dismissed by the respondents, and accordingly awards that, in addition to the respondents' offer herein, he be paid nine (9) months salary by way of compensation for wrongful dismissal.

The court has seriously considered the question of the grievant's reinstatement, but taking into account the circumstances of this dispute, the court has decided that it will not be in the best interests of the parties to reinstate him.

THE Kenya Chemical and Allied Workers Union shall hereinafter be referred to as the claimants and the Central Glass Industries Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 6th July, 1989, and relied on their written and verbal submissions, and in addition the respondents called Major Samuel Kibutu to give evidence on oath. The claimants did not call any witness.

AWARD

3. The Notification of Dispute Form "A" dated 9th November, 1988, and duly signed by the parties was received by the court on 6th January, 1989, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Mr. Odhiambo was employed by the respondents as a plant mechanic on 21st April, 1987 at a monthly salary of KSh. 2,770, plus a house allowance of KSh. 250 per month, and his services were terminated on 16th September, 1987.

Mr. Peter Kuria was employed by the respondents on temporary basis on 2nd May, 1987, as process minder at a monthly wages of KSh. 1,080. On 1st July, 1987, his temporary engagement was extended for a further period of two months and his services were eventually terminated on 15th September, 1987.

The circumstances leading to Mr. Odhiambo's termination of services occurred on 9th September, 1987. The respondents have alleged that Mr. Odhiambo was instructed by his supervisor to work overtime in order to complete some urgent work on/decorating lehr. He refused to work overtime unless it was stated in writing, and his refusal or failure to perform the job caused considerable loss of production to the respondents.

The court notes that Mr. Odhiambo worked for the respondents for nearly five months when his services were terminated for allegedly disobeying lawful order to work overtime. He was paid his terminal dues in full and final settlement thereof.

The primary obligation of a servant is to serve; he must therefore obey orders and observe the rules which are within the scope of the work he agreed to do. The law sees the legal power to give orders as vested in the legal employer simply because it defines the employer/employee relationship in terms of the subjection of one to the will of the other. It recognizes that the power to give orders may be delegated and sub-delegated down a line of authority to the ultimate point of production.

In this dispute the court is satisfied that the grievant disobeyed a lawful order to work overtime, for which he was suspended. However, after the claimants' intervention, the grievant tendered his apology in writing to the respondents for such insubordination, and on receipt of the same the respondents' Personnel Officer/Senior Security Officer, Mr. Kibutu, verbally asked him whether he was actually apologetic for the offence he had committed. The grievant took exception to this further questioning and started some argument with Mr. Kibutu which led to termination of his services.

In the circumstances the court feels that it was improper and unnecessary for Mr. Kibutu to subject the grievant to further questioning after he had written the letter of apology and accordingly the court finds that the respondents have wrongfully terminated the grievant's services.

On the other hand, a very important point is at stake in this dispute, which is that should the grievant be allowed to back out of a settlement which he had arrived at with the respondents. It is not disputed that the grievant acknowledged receipt of his terminal dues of KSh. 3,277.85 in full and final settlement of all his claims; and as far as the respondents were concerned the matter was settled.

In Cause No. 78 of 1987, Cockar J., had this to say:

The court must point out that if a trade union member, on whose behalf the trade union is fighting a case, goes and settles the dispute with the employer he is entitled to do so and the trade union cannot turn round and say that the employer should not have settled the matter with him.

The claimants are now trying to back out of this settlement but the court cannot accept it because the grievant had settled the matter with the respondents.

As regards the second grievant, Mr. Kuria, the court notes that he was engaged on temporary basis and his services were terminable by either side giving one week's notice in writing. The fact that he remained longer on the job for a further period of 30 days did not affect the nature of his temporary appointment.

After due consideration of the parties' submissions hereof, the court rules that the respondents' action in terminating the grievants' services under the aforesaid circumstances was justified.

The claimants' demands in respect of the grievants are accordingly rejected.

The respondents acquired the property from Fox Theatre (E.A.) Limited and signed a recognition agreement with the interested party on 3rd April, 1987. The parties also signed a two year collective agreement which was registered by this court on 19th October, 1987, under RCA No. 257 of 1987.

The court has carefully examined and evaluated the submissions by the parties in this dispute and finds no grounds for disturbing the recognition agreement existing between the respondents and the interested party. In order to maintain industrial peace and avoid conflicts between unions, the court advises the unions to desist from interfering with employers who have recognized the other union and let matters be as they are.

The claimants demand is accordingly rejected.






