Issue in dispute:

Overtime payment prior to five-day working week effective

THE Kenya Union of Commercial Food and Allied Workers thall hereinafter be referred to as the claimants and the C.P.C. Industrial Products (K) Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 21st July, 1989, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 16th June, 1987, duly signed by the parties was received by the court on 23rd July, 1987, together with the statutory certificate signed by the Labour Commissioner.

The claimants informed the court in their opening submission that there was only one issue before the court as the second issue had been amicably resolved by the parties.

The parties entered into a recognition agreement in 1982 and have since concluded several collective agreements.

This dispute only arose after the five-day working week was introduced in May 1986, and it hinges on hours of work and how they affect the calculation of overtime payment.

In this dispute the battle was hard fought but neither side pulled punches. The claimants seem to have misunderstood the mechanism of the four-week cycle because they have failed to take into account the extra days in each month, except February, which has either 28 or 29 days. They have ignored the fact that "offs" are staggered during the four-week cycle in order to accord the employees equal treatment. The court finds that an employee who works more hours in a given week is compensated by being assigned to work less hours in other

shifts, as the case may be. When the claimants argue that the employees work for seven days in a stretch, they ignore the fact that the same employees are allowed seven-day off-duty in 28 days. Perhaps what has caused the misunderstanding is the fact that, prior to 1980, the respondents did not have enough work to support three shifts; hence the claimants became used to the two shifts arrangement, which is no longer applicable.

During the hearing the respondents produced some charts and demonstrated to the court the present working arrangements; and it would appear the implications of these arrangements and the two additional shifts have not been understood by the claimants.

As far as the clocking system is concerned, the court notes that the cards produced by the claimants reflected 48 hours and they have conveniently left out some cards showing 40 hours, from which information is compiled in order to arrive at the monthly averages of hours worked.

Under the circumstances and after careful consideration, the court is unable to find any unfair labour practice, or any attempt by the respondents to deprive the employees of their financial gains arising from the current system. The court is also satisfied with the respondents' method of averaging the hours of work at the end of each cycle, otherwise the system would not have achieve its desired results.

Accordingly, the court, having studied the computation of the clocking system and the mode of payment of overtime under current working arrangement, upholds the existing system. The claimants' demands are therefore rejected as misconceived and baseless.
