## Issue in dispute:

Wrongful termination of services of Mr. Raphael Oduol Odera.

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and the Kenya Commercial Bank Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 10th July, 1989, and relied on their written and verbal submissions.

## AWARD

3. The Notification of Dispute Form "A", dated 1st June, 1988, and duly signed by the parties, was received by the court on 19th December, 1988, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievant was employed by the then National Bank of India on 1st October, 1961, as a warehouseman in the printing department at a salary of E.A. Sh. 139, plus a collar allowance of E.A. Sh. 90 per month. The name was eventually changed to National Grindlays Bank and in 1970, the respondents took over the functions of the aforementioned bank and assumed its present name. The grievant continued to render his unbroken service to the respondents and at the time he quit employment in January, 1983, he was earning a monthly salary of KSh. 1,560, plus house allowance of KSh. 230 per month.

The court notes that the grievant rendered continuous service to the respondents for twenty-one (21) years and on 31st December, 1982, he gave, on his own volition, one month's notice to respondents of his intention to retire. However, since he was only 40 years old and had not reached the retirement age of 50 years as stipulated under the terms and conditions of service, the respondents treated the notice as resignation.

In subsequent correspondence between the grievant and the respondents, it is quite clear that the grievant became aware that he could not retire at the age of 40 years; and he accepted the arrangements made by the respondents under resignation and accordingly he collected his terminal dues as stated hereinabove.

The court, in conjunction with the Planning and Research Division (P.R.D.), has called for and thoroughly perused the whole pension booklet of the respondents and also computed the grievant's entitlements therein and it is satisfied that, under the existing pension scheme, the grievant was adequately compensated; and, in the circumstances, the court finds that no case has been made out to warrant its interference in the respondents' decision to terminate the services of the grievant as stated hereinabove.

Accordingly, the claimants' demand for the grievant to be placed on pension scheme and/or payment of compensation for his long service with the respondents are rejected.

Particular attention should be paid to the following points:

- (i) Signature must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

### EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

#### *Kenya Gazette*

"D 41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) It will facilitate work at the Press if Permanent Secretaries will forward Gazette notices to the Government Printer when ready."
