THE Kenya Chemical & Allied Workers Union shall hereinafter be referred to as the claimants and the Twiga Chemicals Industries Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 27th July, 1989, and they relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A", dated 26th April, 1988, and duly signed by the parties, was received by the court on 4th November, 1988, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievant was employed by the respondents on 1st July, 1981, as a raw materials clerk at a salary of Sh. 1,500 per month. His responsibilities and duties were to receive and issue materials from the stores and also to keep proper records and accounts thereof on the cards.

The grievant stayed on this job for five years and four months when his services were terminated on allegations of negligence on duty and dishonesty in his work. At the time of the termination of his services the grievant was receiving a salary of Sh. 2,685 per month.

The circumstances which led to the termination of the grievant's services happened between July and October, 1986. It is alleged that on 11th July, 1986, the respondents lost 2.4 metric tons of sumithion technical, valued at Sh. 200,000. On 30th October, 1986, the grievant attempted to reconcile stocks of 9th October, 1986, which led to the loss of material of unascertained value.

The grievant was requested to explain the discrepancy between the figures on the cards and the materials received and issued; but he was unable to give a satisfactory answer, and as a result his services were therefore terminated by the respondents.

The court has analysed the parties' submissions and notes that for a period of five years, the grievant satisfactorily performed his duties without any warning letter against him. It was only during the last four months of his employment with the respondents when his work performance fell below expectation, resulting in a loss to the respondents of 2.4 metric tons of raw materials worth Sh. 200,000. This loss prompted the respondents to issue him with a warning letter on 11th July, 1986. The grievant was again warned on 26th August, 1986, when it was discovered that he had neglected to post two entries on the cards and yet the demand sheets had passed through him since the beginning of the year. On 30th October, 1986, the grievant's inability to reconcile some stocks revealed a further loss of material to the respondents of uncertain value; and, on being asked to explain the difference between the figures on the cards and the materials received and issued, he could not give a satisfactory answer. In the circumstances, the respondents served him with the hereinabove letter of termination of his services.

After careful consideration and taking into account all the circumstances of this matter and the loss which the respondents have suffered, the court is satisfied that the grievant was responsible, through his poor performance of work, for the mess in which the respondents found themselves. The respondents were therefore entitled to termination of his services in the aforesaid manner because his continued employment could totally ruin and destroy the reputation and hence the business of the respondents.

In view of the foregoing reasons, the court takes exception to the Ministry's findings and recommendations, and in consequence rules that the claimants' demands are lacking in merit and are accordingly rejected.

The court, having carefully considered the respondents' offer of terminal benefits to the grievant as stipulated in their afore-

said letter of termination of service, finds them adequate compensation and the court so awards.

The question of union membership and underpayment of salary are irrelevant in this dispute, and the court has decided not to go into their merits.

Ruling on Preliminary Objection

When this dispute came up for hearing on 14th September, 1989, the respondents raised a preliminary objection on the ground that the dispute was premature and/or improperly before the court.

The respondents submitted, through their learned advocate, Mr. Namai, that the parties have neither a valid recognition agreement nor a collective agreement between them. They added that they were not a party to any agreement entered into by the claimants and the employees.

The respondents submitted further that their employees were earning better wages, and there was no complaint from the claimants that the employees were not receiving adequate wages or salaries. They stated that the employees were not members of the claimants at the material time when this dispute arose.

The respondents prayed the court to dismiss the claimants' demand.

In their brief submission, the claimants stated that lack of recognition and collective agreements was not a bar to this court hearing the dispute. They stated further that the dispute was properly before the court because the matter was processed and the Minister for Labour accepted the dispute between the parties and gave his certificate thereto for the court to hear and determine the same.

The claimants requested the court to proceed with the hearing of the dispute.

In this dispute, the parties reported a trade dispute to the Minister for Labour who referred the matter to the court under powers conferred upon him by section 14 (9) (e) which states as follows:—

"14 (9) The court shall not take cognizance of any trade dispute or deal with any matter connected therewith—

(e) unless the court has received a certificate signed by the Labour Commissioner stating that the Minister has accepted the report of the trade dispute and that all available machinery for the voluntary settlement of disputes prior to reference to the court has been exhausted."

The court has carefully gone into the respondents' arguments that have been put forward by their learned advocate, and has come to the conclusion that their objection must fail because, as this court has stated before, it would be wrong for it, when all the statutory formalities have been complied with, to reject the dispute. In Cause No. 66 of 1988—*Kenya Engineering Workers Union and Unibilt (K) Limited*—Cockar, J. said:—

"The court has no power to go behind the Minister's or the Labour Commissioner's certificates. To accept the respondents' submission would be tantamount to challenging these certificates from the Minister and the Labour Commissioner and the court has no intention of doing that."

This court echoed the same observations in Cause No. 106 of 1988—*Kenya Union of Commercial Food & Allied Workers and Kenya Stationers Limited*.

In the circumstances, the court rules that the dispute is properly before it, and the court must proceed to hear and determine it on its merits.

THE Kenya Petroleum Oil Workers Union shall hereinafter be referred to as the claimants and the Kenya Pipeline Company Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 7th June and 18th July, 1989, and they relied on their written and verbal submissions. In addition they called the following witnesses to give evidence on oath:

Claimants:

Mr. S. N. Nyakako and Mr. H. G. Musasia.

Respondents:

Mr. B. Kahura, Mr. J. Begisen and Mr. P. Ng'ang'a.

AWARD

3. The Notification of Dispute Form "A", dated 23rd June, 1988, and duly signed by the parties was received by the court on 19th December, 1988, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Mr. Nyakako was employed by the respondents as a driver on 11th May, 1981; and prior to his summary dismissal he was earning a salary of KSh. 1,880, and a house allowance of Sh. 600 per month. Similarly, Mr. Musasia was also employed by the respondents as a driver on 26th July, 1978; and at the time of his summary dismissal, he was earning a salary of Sh. 1,620, and a house allowance of Sh. 600 per month. Both grievants were stationed at the respondents' depot (terminal) in Industrial Area, Nairobi; but their duties required them to make trips to other installations or stations operated by the respondents along the pipeline route up to Mombasa.

The incidents which led to the grievants' dismissal occurred in November 1985. The respondents alleged that between 6th and 23rd November, 1985, their crane, Reg. No. KSW 917, which was carrying out maintenance work at pumping station No. 1, in Mombasa, had used excessive quantity of diesel, without any proper authority. They alleged that their investigations revealed that the grievants, who were attached to mechanical and electrical sections at Mombasa in November 1985, and Mr. Kibe, who was their crane driver, were suspected of fraudulently obtaining 800 litres of diesel and 2 litres of oil, from Changanwe Service Station. In consequence the grievants were interdicted from duty on 18th January, and on 17th February, 1986, they were suspended. On 11th April, 1986, the grievants were eventually summarily dismissed.

In this dispute the grievants admitted that they collected, on diverse dates, the diesel and the oil from Changanwe Petrol Station on the request of Mr. Kibe, the crane driver. But, in their evidence-in-chief and cross-examination, the grievants maintained that they delivered the products to Mr. Kibe. The grievants vigorously denied that they indulged in a dishonest deed whereby they defrauded their employer of three drums of diesel of 200 litres each and two tins of oil of 1 litre each.

It is also on record that the grievants were not issued with any gate passes by the sentries when they went about their errands because, as they alleged, the sentries or askaris "knew what was happening". When the grievants were pressed during cross-examination to explain why they did not obtain the gate

passes to cover their errands as required by the existing regulations of the respondents, they were very evasive and vague. In the circumstances the court finds that the grievants were not telling the truth on this very important point in the whole dispute.

The claimants contended that the grievants' summary dismissal was unfair because the respondents did not wait for the outcome of the police investigations and the criminal proceedings, if any. On this score, the court would once again like to clarify the position regarding the employer's right of taking disciplinary action against an employee where the employee is alleged to have committed a criminal offence. Criminal proceedings are quite distinct from civil proceedings; and, unless an employer has decided to wait for the outcome of criminal prosecution, there is no reason for him not to take appropriate disciplinary action against his employee on the employer and employee relationship. In the present dispute the respondents promptly dismissed the grievants on finding that they had colluded to defraud them of diesel and oil against forged documents.

On the whole, the court was impressed by the respondents' witnesses' demeanour during their evidence-in-chief and cross-examination, and the court finds that their evidence is enough to satisfy it that the allegations which the respondents have levelled against the grievants have been proved by them on the balance of probabilities.

The court has carefully considered Mr. Kibe's involvement in this matter and finds that he was the main character in this nefarious scheme, and the grievants were his principal accomplices. He purported to resign during the cause of investigations but he was instead summarily dismissed. During the hearing the respondents admitted that there were shortcomings in their control system and Mr. Kibe and the grievants took advantage of it.

After careful consideration of all the submissions and the evidence adduced by the parties in this dispute the court has no hesitation in coming to the conclusion that the grievants were involved in dishonest acts through which they fraudulently obtained some diesel and oil on the account of the respondents.

Under the circumstances, the court is satisfied that the grievants forfeited their right of continued employment with the respondents, and accordingly their services have been terminated by the respondents with full justification. The claimants' demands are therefore rejected in respect of each of them.

However, the court has evaluated the respondents' offer and the Ministry's recommendation and has decided that, in the interest of harmonious industrial relations, the grievants' dismissal be reduced to normal termination of their services, and awards that they be paid their full terminal benefits in accordance with the parties collective agreement.

The grievants are not entitled to anything more.

Particular attention should be paid to the following points:

- (i) Signature must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

"D 41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."
