- (a) examine the legal framework of the industry with particular reference to the Tea Board of Kenya and the Kenya Tea Development Authority and recommend amendments as necessary for the better management of the industry:
- (b) examine the headquarters and field operations of the Kenya Tea Development Authority and recommend possible improvements for the efficient operation of the small-scale tea industry;
- (c) examine the current memoranda and articles of association of the Kenya Tea Development Authority, tea factory companies with a view to recommending how best to enhance farmer participation and efficiency in the running of the factories;
- (d) study the financing, financial structures and the accounting systems employed by the Kenya Tea Development Authority and make recommendations for further improve-
- (e) investigate any mismanagement and irregularities in the operations of Kenya Tea Development Authority and recommend appropriate remedial measures;
- (f) examine the existing procurement, disposal of assets and tendering procedures and make the necessary recommendations thereon:
- (g) examine the organization, management and staffing structure of the Authority and make recommendations for efficient management bearing in mind the scope and nature of Kenya Tea Development Authority operations;
- (h) examine the organization and strategies employed in the making of smallholder teas in relation to Kenya's system of tea marketing and make recommendations for the improvement of the system to cater for local market, export and possible development of value-added tea
- (i) deal with any other matters pertinent for the efficient operations of the tea industry in Kenya.

The committee is to submit its report in one (1) month.

### THE INDUSTRIAL COURT CAUSE NO. 69 OF 1988

Parties:

Kenya Union of Employees of Voluntary Associations, Trade Unions and Allied Organizations

and

Eastleigh Community Centre

Ruling on Preliminary Objection.

THIS dispute was fixed for hearing on 19th September, 1989, but the respondents raised a preliminary objection to a full hearing. They submitted that the claimants lacked locus stand to move the court because they have no recognition agreement with them.

The respondents stated that the claimants have no capacity to represent the grievants because there was neither a recognition agreement nor collective agreement between them and the claimants. They told the court that they belong to the Presbyterian Church of East Africa (P.C.E.A.), which was associated with the National Christian Council of Kenya (N.C.C.K.). In the circumstances, they pointed out, they have both recognition and collective agreements with the Kenya Union of Domestic, Hotels, Educational Institutions, Hospitals and Allied Workers (KUDHEIHA), which was the relevant union in this matter.

The respondents outlined their work—for example, they assisted the needy and poor secondary and primary schools children by paying their school fees. They also provided food, clothes, shelter and housing to old men and women. Furthermore, the respondents trained and assisted destitutes in making napkins and/or school uniforms.

The respondents submitted further that the claimants were not the proper union to represent employees of this type of organization. They maintained that the claimants have never been recognized by either the Presbyterian Church of East Africa (P.C.E.A.), to whom they belonged, or the National

Christian Council of Kenya (N.C.C.K.); and it was therefore improper for the claimants to purport to represent the grievants when they could not participate in any matters pertaining to their terms and conditions of employment.

The respondents prayed the court not to accord the claimants the mandate to represent the grievants and to reject their demands accordingly.

The claimants submitted that lack of recognition of their union by the respondents was not a subject of the dispute. They stated that during the investigation of this matter, they became aware that the respondents, through Presbyterian Church of East Africa (P.C.E.A.) and Kenya Union of Domestic Hotels, Educational Institutions, Hospitals and Allied Workers (KUDHEIHA) had both recognition and collective agreements between them. However, the claimants contended that they were entitled to recognition by the respondents because they have recruited 119 out of 37 employees of the respondents, thus constituting a simple majority under section 5 (2) of the Trade Disputes Act, Cap. 234.

The claimants accused the respondents of violating the provisions of section 4 (5)) of the Act by declaring the grievants redundant without first reporting the matter to the Minister for Labour. They referred the court to section 23 of the Trade Disputes Act, and argued that although they have no recognition agreement with the respondents, they were not barred from reporting the dispute and the grievants should not be denied representation.

The claimants prayed the court to disregard the recognition agreement and proceed with the hearing of the dispute.

The court would like to state that the question of lack of recognition agreement or collective agreement in any dispute is of great importance because it seriously concerns the power of this court to settle industrial disputes efficaciously, completely and justly.

This dispute was referred to the court by the Minister for Labour under powers conferred upon him by section 8 of the Trade Disputes Act, Cap. 234, which clearly states as follows:

"8. Where a trade dispute has not been settled under sections 5, 6 and 7 the Minister may, in a case where an appeal to the Industrial Court does not already lie, on the

representation of any trade union, employer or group of employers, refer the dispute to the Industrial Court and the provisions of part IV shall apply to any such reference."

The reference was accompanied by the usual statutory certificates signed by the Labour Commissioner and the Minister for Labour under section 14 (9) (e) and (f) of the Act, which reads:

- "(9) The court shall not take cognizance of any trade dispute or deal with any matter connected therewith—
  - (e) unless the court has received a certificate signed by the Labour Commissioner stating that the Minister has accepted the report of the trade dispute and that all available machinery (including statutory machinery) for the voluntary settlement of disputes prior to reference to the court has been exhausted;
  - (f) where the trade dispute solely concerns the dismissal of any employee, unless the court has received, in addition to the certificate required by paragraph (e) of this subsection, the written authority of the Minister for that purpose."

The court took cognizance of the dispute and registered it in the court register after the Minister had taken the necessary steps in exercise of his powers under the Act as aforesaid.

The respondents have now raised a preliminary objection that, since there was neither a recognition agreement nor a collective agreement between the parties to the dispute, the issue could not be adjudicated by the court. They asked the court to reject the dispute.

The claimants replied to the preliminary objection by submitting that the question of a recognition agreement or collective agreement did not arise because reporting of a trade dispute was optional. They urged the court to hear and determine the dispute.

The court has carefully considered the respondents' preliminary objection and has come to the conclusion that it must fail. Section 4 (1) of the Trade Disputes Act, clearly states as hereunder:

"4 (1) . . . any trade dispute, whether existing or apprehended may be reported to the Minister by or on behalf of any party to the dispute."

The court is satisfied that any party may report a trade dispute, and that the existence of either a recognition agreement or collective agreement between the parties to the dispute is not a prerequisite to the dispute being reported to the Minister and subsequently heard by the court.

Accordingly, the court rules that the dispute is properly before it, and the court must proceed to hear and determine the same on its own merits.

THE INDUSTRIAL COURT CAUSE NO. 78 OF 1988

Parties :

Kenya Union of Commercial Food and Allied Workers and

African Retail Traders (Industries) Ltd.

Issue in dispute:

"Recognition Agreement."

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and the African Retail Traders (Industries) Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 15th August, 1989, and they relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 18th July, 1988, duly signed by the parties was received by the court on 23rd September, 1989, together with the statutory certificate signed by the Labour Commissioner.

The respondents are a limited liability company and were incorporated on 31st August, 1983, and registered under certificate of incorporation No. C 26151. They engage in the making of furniture and employ a labour force of 62 employees, 56 of whom are unionizable.

The respondents are members of the Furniture Manufacturers Group of F.K.E. They negotiated and signed a recognition agreement with the defunct Kenya Timber and Furniture Workers Union and they have had several collective agreements between them.

The respondents told the court that the members of the Kenya Timber and Furniture Workers Union have since joined the Kenya Building, Construction, Civil Engineering and Allied Trades Workers Union and they are paying their union dues to the said union as ordered by the Minister for Labour in Kenya Gazette Notice No. 3676 of 11th August, 1989. The respondents have since signed a recognition agreement with them.

On the other hand, the claimants have both recognition and collective agreements with the African Retail Traders (Kenya) Ltd., which is also a limited liability company and a member of the Distributive and Allied Trades Association (D.A.T.A.). This company was incorporated on 16th Ootober, 1968, and registered under Certificate of Incorporation No. 7936.

The court has thoroughly analysed the submissions by the parties and finds that the claimants have both recognition and collective agreements with the African Retail Traders (Kenya) Ltd., who are engaged in hire-purchase business. On the other hand, the respondents are a furniture making company and the claimants have neither recognition nor collective agreement with them. These two companies are in law distinct and separate legal entities. Furthermore, the former is a member of the Distributive and Allied Trades Association (D.A.T.A.), while the latter is a member of the Furniture Manufacturers Group of F.K.E.

The claimants argued that the undertaking being carried on by the respondents fell under their union, and some of the respondents' employees are their members. They produced a list of the alleged members and some receipts to support their contention.

The respondents, on the other hand, strongly resisted the demand on the ground that they were not part or subsidiary of the African Retail Traders (Kenya) Limited with whom the claimants have both recognition and collective agreements. They contested that they have both recognition and collective agreements with the defunct Kenya Timber and Furniture Workers Union whose members have since joined the Kenya Building, Construction, Civil Engineering and Allied Trades Workers

The court would like to point out that an employer is within his rights to state that he will establish a relationship with a particular trade union which is appropriate for his industry, and this is what the respondents are doing in this matter. On the other hand, trade unions have acquired a more important status in this country. They are not only agents of their members with powers to negotiate for favourable terms and conditions of employment for their members, but they are also bodies whose concern is the industrial condition of the whole trade or industries which are covered by their respective constitutions.

The most important point to remember in this kind of dispute, or any dispute for that matter, is that when it comes to an industrial court award which creates a precedent, the court has to come to its decisions, taking into account the existing industrial relations system and practice in the country and the evidence that is adduced before it during the hearing.

The court has given serious thought to the whole dispute and finds that the only point in favour of the claimants is that they have recruited some of the respondents' employees as their members, but that point alone cannot persuade the court to come to a decision which would be patently wrong.

The court has previously stated that it has to be extremely cautious in cases of this nature concerning recognition, otherwise it will create a lot of mix-up and confusion in the trade union movement in this country and their relationship with the employers.

After careful consideration of all the submissions by the parties, the court has come to the conclusion that to give an

ward as demanded by the claimants would be creating an undesirable precedent because it would be quite contrary to the industrial relations set-up which has developed over the years in this country.

In the circumstances, the claimants demand for recognition against the respondents is accordingly rejected.

Finally, the issue of underpayment of the employees is not within the scope of this dispute and the court must refrain from addressing its mind to it and making any findings thereto.

#### THE INDUSTRIAL COURT

Cause No. 108 of 1988

Parties:

Kenya Union of Commercial Food and Allied Workers and

C.P.C. Kenya Limited

Issue in dispute:

"Termination of services of Messrs, William Njoroge and Wycliffe Sifuma and dismissal of Mr. Destimore Kilali."

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and the C.P.C. Kenya Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 19th July, 1989, and relied on their written and verbal submissions.

#### Award

3. The Notification of Dispute Form "A", dated 23rd August, 1988, and duly signed by the parties was received by the court on 19th December, 1988, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The respondents are a limited liability company incorporated in Kenya. They are a food processing firm, with a consumer branch in Nairobi and an industrial branch in Eldoret.

The parties have a valid recognition agreement and have since concluded several collective agreements which accorded the claimants the right to represent all the respondents unionizable employees on matters relating to terms and conditions of employment.

Mr. Njoroge was initially engaged as a freelance salesman on 1st August, 1977, earning 5 per cent gross commission on net sales value. On 1st March, 1982, he was employed on permanent terms as a van salesman at a monthly salary of Sh. 1,250. The grievant's services were terminated on 11th October, 1985. At the time of the termination, Mr. Njoroge was earning a monthly salary of Sh. 1,434, and had served the respondents for eight (8) years. He was paid three months' salary in lieu of notice.

The events which led to termination of Mr. Njoroge's services took place between October 1982 and July 1985. The respondents alleged that Mr. Njoroge had habitually and invariably absented himself from work before or after weekends, public holidays and month ends, and as a result he neglected his duties. They alleged further that Mr. Njoroge purported to produce notes and sick sheets from some doctors to support his explanation that he had been sick; and all these notes and sick sheets originated from doctors in Nakuru, which was the grievant's home town.

Mr. Sifuma was employed by the respondents as a casual worker in the production department of the respondents in December 1977. He was confirmed on permanent terms of employment on 17th April, 1979, at a salary of Sh. 420 per month.

The grievant was promoted in March 1980 to a position of production supervisor. In May 1985, he was suspended from

duty and subsequently sent on compulsory leave to facilitate investigations for alleged cheating in production reports. His services were terminated on 17th July, 1985. At the time of his termination, he was earning a monthly salary of Sh. 1,949, and house allowance of Sh. 380 per month. The grievant had served the respondents for a period of eight (8) years. He was paid two months' salary in lieu of notice, and other terminal benefitits, but he refused to collect the same.

The circumstances that led to Mr. Sifuma's termination of service were that on 14th May, 1985, he booked 120 kgs. of Aromat bulk for use in production against requisition No. 10799, and obtained the signature of the production manager thereon before presenting it to the store. It is alleged that he used 96 kgs. only, and was required to return the balance of 24 kgs. back to the store. He returned to the store only 19.7 kgs. on requisition No. 10804, leaving a balance of 4.3 kgs. unaccounted for.

The error was uncovered by the production manager after the packing material requisitioned was found to be less than the raw material. On being asked about the anomally, the grievant said that the Aromat bulk had been booked in excess. The respondents alleged further that this dispute was reported to the Minister for Labour, and after the usual investigations and findings, the Ministry's recommendations in respect of Mr. Njoroge and Mr. Sifuma were that, in addition to all other terminal benefits, the grievants be paid two (2) months and four (4) months salary respectively as compensation for loss of employment.

The Ministry recommended that Mr. Kilali's case be reduced to normal termination of service that would entitle him to full terminal benefits in accordance with the parties collective agreement.

The Ministry's decision was accepted by the claimants but rejected by the respondents for the reasons given in their written submission and the matter is now before the court for adjudication.

In their submission, the respondents stated that Mr. Sifuma's duties included getting materials out of the store through requisition forms for use in the production process. They stated further that the usual procedure was that the production manager would sign the requisitions before the grievant took them to the store for issuance of the materials, and any alterations thereon required the initials of the production manager.

The court has thoroughly analysed the circumstances leading to the termination of services of Messrs. Noroge and Sifuma and notes that their services with the respondents were terminated because of persistent absentiesism and falsification of production records respectively. The first grievant was a van salesman and it is clear from his attendance record that his work performance was unsatisfactory. The second grievant, who was a production supervisor, was certainly a dishonest employee and the respondents were bound to lose faith and confidence in him.

Considering all the circumstances of the grievants' work performance, the court finds that the respondents' action in terminating their services was justified and did not amount to an unfair labour practice.

However, taking into account the grievants' length of service to the respondents, the court feels that, in addition to their terminal benefits as per the parties collective agreement, the grievants should be paid three (3) months' salary each on exgrafia basis, and the court so awards. The grievants do not deserve anything more than that.

The court has carefully considered and evaluated all the submissions put forward by the parties in respect of Mr. Kilali, and is satisfied that the respondents had scrupulously complied with the provisions of the warning procedure under the parties collective agreement. The grievant's work performance did not measure up to the standard required of him, and this led to some financial losses to the respondents.

Accordingly, the court finds that the grievant's summary dismissal was justified and the claimants' demands for reinstatement and/or compensation are rejected.

Issue in dispute:

"Dismissal of Mr. Nyafuanga Owuoh."

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and the Kenya Canners Ltd. (Delmonte (K) Ltd.) shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 24th July and 30th August, 1989, and relied on their written and verbal submissions. In addition, the respondents called the following witnesses to give evidence on oath:

R. K. Munyili.

C. Githinii.

J. P. Kemor.

The claimants did not call any witness.

#### AWARD

3. The Notification of Dispute Form "A" dated 20th July, 1988, dully signed by the parties was received by the court on 6th January, 1989, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievant in this dispute was employed by the respondents as a mechanic on 7th February, 1980, at a salary of Sh. 880 per month, plus house allowance of Sh. 150. The grievant was put on three (3) months probation; and, after successful completion of this period, he was confirmed to the position of mechanic grade 5.

The respondents stated that the events which led to the grievant's dismissal took place on 27th November, 1986. At about 10.30 a.m. on the aforementioned date, the supervisor assigned the grievant to fit a hydraulic pipe underneath a Big Bud, but he told the supervisor that he required a helper as he was unable to perform the job on his own. A driver, Mr. Kemor, was asked to assist him, but the grievant sent him away saying that he did not need him there. He was therefore left to perform the job alone. At about 12.30 p.m. the supervisor went to check on the grievant's work, but he found that he had done nothing. The hydraulic pipe was still lying on the ground. The supervisor then called the grievant, and, in the presence of a shopsteward, he (the supervisor) asked him to explain why he had not fitted the pipe, but the grievant gave no explanation at all. In the circumstances, the supervisor charged him by filling the "employee discipline or discharge form", and when the grievant was asked to fill his part he refused.

The supervisor reported the matter to the foreman who called the grievant and the shopsteward to his office. They discussed the matter but no settlement was reached. Later in the afternoon, the supervisor went round again in order to check on the progress of the work before he handed over to the night shift. He found the grievant with two other mechanics thatting, and when he asked the grievant whether he was being paid for standing or working, the grievant abused him by calling him "sturpid". The supervisor again reported the matter to the foreman, and the following morning, that is 28th November, 1986, the grievant was served with the following letter of mised as stated below:

"Following two acts of insubordination in the workshop during business hours on 27th November, 1986, you are hereby suspended from your job pending investigation."

On 2nd December, 1986, the grievant was summarily dismised as stated below:

"Dismissal:

This is to inform you formally that you have been dismissed from employment of this company effective 27th November, 1986, vide section 15 (d) of the union contract.

You will be paid all days worked including 27th November, 1986, plus any pro rata leave due."

The aforementioned section 15 (d) of the union contract is clearly worded as hereunder:

#### "15. Dismissal:

An employee shall be liable to instant dismissal for a serious offence. Serious offences shall be deemed to be:

(d) Insubordination and conduct which violates common decency or morality."

The respondents alleged that the grievant was summarily dismissed because he disobeyed a lawful order when he was asked to perform some work, and secondly for insulting his supervisor.

The claimants took up the matter with the respondents, but their request for settlement was not successful. Consequently, they reported a trade dispute to the Minister for Labour, and, after the usual pre-industrial court investigation, the Ministry's findings and recommendation were as follows:

#### "Findings:

.... Mr. Owuoh was a qualified mechanic and was in a position to determine what would be unsafe working environment regarding his line of work. His explanation as to the reason he was not able to carry out the work immediately should have been seriously considered by the management. He (Mr. Owuoh) was ready to carry out the same work at 4.00 p.m. after he (Mr. Owuoh) was sure of the safety measure. The supervisor did not allow him to do so.

. . . . the supervisor had already made up his mind not to give Mr. Owuoh a fair hearing.

No witness appears to have heard Mr. Owuoh utter insulting words against the supervisor.

Discipline must be enforced at all levels. Equally so, workers have to be given a chance to make suggestions as far as the safety in work and other conditions are concerned.

.... Mr. Owuch had good reason to defer the assignment until the afternoon to ensure safety at the work he was provided. Mr. Owuch had a clean record since his employment

#### Recommendation:

I recommend that Mr. Ownoh's dismissal be converted into a normal termination with all benefits. In addition, he should be compensated for the loss of his job by receiving four (4) months' salary."

The decision was accepted by the claimants but the respondents rejected it and the matter is now before the court for adjudication.

The respondents vigorously contended that the grievant's behaviour amounted to gross misconduct for which he was summarily dismissed.

The respondents called three witnesses to give evidence on oath, and all of whom corroborated the written and verbal submissions of the respondents.

In this dispute it is evidently clear that the grievant had served the respondents for six years without any warning letter against him on record; and his services were terminated by the respondents on a single act of disobeying lawful orders.

The claimants have vigorously submitted that the respondents had deliberately violated the provisions of the warning procedure as stipulated in the parties collective agreement because no warning or proper warning had been issued to the grievant prior to his summary dismissal. On the other hand, the respondents strongly argued that the grievant's behaviour in refusing to perform the job which was assigned to him and calling the supervisor stupid amounted to gross misconduct for which he was summarily dismissed as aforestated.

This court would be going too far if it finds that every act of disobedience of a lawful order by an employee must entitle the employer to dismiss him. In the court's view, in order to justify a summary dismissal it has to be shown that the conduct complained of is such as to show the employee to have discregarded the essential conditions of the contract of service. In other words, one act of disobedience or misconduct can justify summary dismissal only if it is of a nature which goes to show in effect that the employee is repudiating the contract, or one of its essential conditions. It must connote a deliberate flouting of the essential contractual conditions. It is just not enough for an employer to say that he has complied with his legal obligation

as far as the termination of employment of an employee is concerned. An employer should have a justifiable cause.

The court has carefully analysed and weighed all aspects of this dispute, and also perused the authority which was cited by the respondents, and it is satisfied that the facts of this case do not constitute sufficient justification for the grievant's termination of employment by way of summary dismissal. The court is satisfied that the employer was unduly harsh, and a warning letter would have sufficed in the circumstances.

The court has also seriously considered the alleged insult by the grievent against the supervisor, and finds that this particular incident was not proved by the respondents on the balance of probabilities, and the court has decided to give the grievant the benefit of doubt.

Having come to the foregoing conclusions, the court accepts the Ministry's recommendation that the grievant's summary dismissal be reduced to normal termination. However, the court feels that, in addition to his terminal benefits in accordance with the parties collective agreement, the grievant should be paid three (3) months' salary by way of compensation for wrongful dismissal, and the court so awards. This will meet the ends of justice.

The court has considered the question of the grievant's reinstatement, but has decided not to award his reinstatement and/or any other benefits.

Issue in dispute:

"Dismissal of Miss Margaret Anyango"

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and the Sofiona Hair Dressing Saloon shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 17th August, 1989, and relied on their written and verbal submissions.

#### Award

3. The dispute was referred to the court by the Minister for Labour under powers conferred upon him by section 8 of the Trade Disputes Act. The court received the Minister's reference dated 5th January, 1989, on 10th January, 1989, together with the statutory certificates from himself and the Labour Commissioner.

Miss Anyango was allegedly employed on 2nd March, 1984, by the respondents on 50 per cent commission basis. It is alleged that on 29th July, 1984, the grievant asked for and was granted four days leave to enable her take the body of her aunt home, who had died in Nairobi and also to attend her funeral. The grievant was required to report on duty on 2nd August, 1984, but she overstayed her leave, and consequently she was summarily dismissed on 15th August, 1984. The claimants approached the respondents with a view to amicably settling the matter, but the respondents declined any settlement with them.

The claimants then reported a trade dispute to the Minister for Labour; and, having gone through the usual pre-industrial court machinery, the Ministry's findings and recommendation were as follows:

#### "Findings:

. . . Miss Anyango was employed on 2nd March, 1984, on commission basis. Miss Anyango asked for permission to be away from duty for four (4) days on 29th July, 1984, and on resuming duty she was dismissed on the grounds that she had absconded from duty . . . .

Miss Anyango had never been issued with a warning letter and that she used to work on Sundays and public holidays.

#### Recommendation

.... It is recommended that Miss Anyango's dismissal be reduced to normal termination. She should further be paid overtime for the Sundays and public holidays she had worked ....."

This decisions was accepted by the claimants, but it was turned down by the respondents and the matter is now before the court for consideration.

The claimants urged the court to find that the grievant was wrongfully dismissed and award the following entitlements to her:

- (a) One month's pay in lieu of notice.
- (b) Overtime pay for 24 days.
- (c) Pro rata leave.
- (d) Adequate compensation for wrongful dismissal.

In their submission, the respondents denied that Miss Anyango was a member of the claimants' union, and challenged the claimants to produce her membership card for the year 1984. They pointed out that there was neither a recognition agreement nor a collective agreement between them and the claimants; and as such they could not accept to sign form "A" and come to the count with strangers.

The court has carefully considered the submissions of the parties and perused the muster roll for the period March to August 1984, when the grievant was employed by the respondents, and finds that the grievant had an appalling record of absenteeism, especially during the months of April, June, July and August 1984. Her pay in the muster roll for the five months of her employment was Sh. 450 per month; and, in the circumstances, the court is satisfied that the grievant was not employed on commission basis as alleged by the respondents, but was a regular employee. The court is further satisfied that between 29th July and 4th August, 1984, the grievant was given permission by the respondents to attend the funeral of her aunt. However, the court is convinced that between 5th and 15th August, 1984, the grievanit either deserted her duties or was absent without permission, thus overstaying her leave by ten days, for which she was liable for summary dismissal.

Taking all the foregoing into consideration, and the respondents' financial inability, the court endorses the Ministry's recommendation that the grievant's dismissal be reduced to normal termination; and awards that, in addition to Sh. 130 which the respondents deposited with the Ministry of Labour, Miss Anyango be paid:

- (i) One month's salary in lieu of notice; and
- (ii) Pro rata leave due.

The court has also considered the claimants' overtime demand but, in view of the grievant's poor work record, the court feels that she is not entitled to any payment on this item, or any other compensation.




