THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and the Gatundu Coffee Growers Co-operative Society Limited, shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 24th August, 1989, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 16th October, 1986, duly signed by the parties was received by the court in April 1989, together with the statutory certificate signed by the Labour Commissioner.

The dispute was reported to the Ministry of Labour, and its findings and recommendation were as hereunder:

"Findings

.... Due to prolonged dry spell that hit the agricultural industry in 1984, coffee production dropped to such a low level that the society ... has no alternative but to reduce their labour force by terminating the services of the twenty-five (25) seasonal workers.

Recommendation:

.... It is recommended that the affected employees should be paid their terminal benefits for services rendered continuously up to 30th June, 1984."

The ministry's findings and recommendation were acceptable to the claimants, but the respondents rejected them and the matter is now before the court for consideration.

The court has carefully considered the submissions by the parties and also scrutinized the documents produced in court and finds that the grievants were sometimes working as casual and regular employees. The court finds further that both parties were at fault to some extent in this dispute because the respondents' employment records confused the claimants, and as a result they were unable to follow the procedure being used by the respondents in implementing the terms and conditions of service as per the parties collective agreement.

Under section 2 of the Employment Act, Cap. 226, casual employee is clearly defined as follows:

"Casual employee" means any individual the terms of whose engagement provide for his/her payment at the end of each day and who is not engaged for a longer period than 24 hours at a time."

In view of the foregoing definition, the court notes from the muster roll that the respondents were not paying the grievants in accordance with the above-mentioned provision, but after 27 or 30 days of a calendar month.

After considering all aspects of this dispute, the court awards that, in addition to their benefits under the parties' collective agreement, the grievants be paid as follows—

- (a) those grievants who have worked for less than two months must receive one week's pay;
- (b) those who have worked between two months and one year should receive one month's pay; and
- (c) those who have worked for more than one year must receive two (2) months' pay.

Finally the court directs that the total amount of this award must be deposited with the Labour Officer, Thika, who will pay the grievants in the presence of a witness from the claimants' union.

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and the Reckitt and Colman (Industries) Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 22nd August, 1989, and relied on their written and verbal submissions.

AWARD

3. The Notification of Dispute Form "A" dated 4th November, and duly signed by the parties, was received by the court on 2nd June, 1989, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The respondents are a limited liability company which manufacture toiletry, pharmaceutical, household and food products.

The grievant was employed by the respondents on 1st July, 1985 as a merchandiser at an initial monthly salary of Sh. 1,600, plus house allowance of Sh. 200 per month; and, at the time her services were finally terminated on 8th December, 1987, she was earning a consolidated salary of Sh. 2,200 per month.

The court has thoroughly considered the submissions by the parties and appreciates the difficulties which some employers encounter when they are faced with the prospect of declaring some of their employees redundant. It is also appreciated by everyone in this country that the loss of employment suffered by an employee is a very serious matter, and as such the necessary statutory provisions have been enacted on the subject to ensure that when an employee's services are to be terminated due to redundancy, then the employer has to satisfy the union concerned and finally the Industrial Court before it can be effected.

In the present dispute the court finds that the respondents did not have any other areas within the organization where the grievant's services could be better deployed. On the other hand, the court is satisfied that the respondents have committed a breach of statutory provisions laid down for cases of redundancy because they declared the grievant redundant without first reporting the matter to the Minister for Labour and receiving the approval of the Industrial Court.

Once again, the court would like to state and emphasize for the benefit of all the employers generally in Kenya that they should strictly comply with the procedure laid down in cases of redundancy prior to seeking the approval of the Industrial Court to such cases.

The court has taken note of the fact that the grievant has been out of employment for two (2) years; and, although she is still unemployed for all that period, the question of reinstatement does not arise.

Since the grievant has suffered wrongful termination as she was declared redundant without the approval of the Industrial Court, the court endorses the ministry's recommendation and awards that she be paid three months' salary by way of compensation. This compensation would be in addition to all the other terminal benefits to which she is entitled under the agreed clause on redundancy.
