- (a) Keeping abreast with development in telecommunications, especially changes by the world meteorological organization and the internal telecommunications union, and advising on methods and alternatives of implementation considering available resources.
- (b) Reviewing the use of various telecommunications programmes and networks such as satellite, microwave, high frequency, etc., data collection and dissemination techniques and in liaison with the engineering section, advising on future requirements for telecommunications equipment.
- (c) Keeping abreast with the development of new protocols that enable computer to computer interaction in the automatic mode and advising on their implementation requirements.
- (d) Identifying present and future telecommunications manpower and equipment requirements and also organizing training for telecommunications personnel.

**Senior Aeronautical Information Services Officer (Two Posts) (No. 412/89)**

**Salary scale.**—K£2,820 to 4,116 p.a. PENSIONABLE or AGREEMENT.

Candidates must be Kenya citizens of at least K.C.E. division II, who are serving aeronautical information service officers I, job group "J", with a minimum of three (3) years' satisfactory service at that grade. THE Kenya Shoe and Leather Workers Union shall hereinafter be referred to as the claimants and Orbitsports Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 24th August, 1989, and relied on their written and verbal submissions.

## AWARD

3. The Notification of Dispute Form "A" dated 14th January, 1989, and duly signed by the parties was received by the court on 7th June, 1989, together with the statutory certificate signed by the Labour Commissioner.

The respondents are a manufacturing firm, engaged in making of sports goods. They have a total workforce of 320 employees. The parties signed a recognition agreement in 1969 and have since had several collective agreements between them.

The issues in dispute arose on diverse dates, and in a series of joint industrial council meetings that followed, the parties recorded a deadlock on the items which are now before the court for consideration.

After thorough analysis of the parties' submissions and of the various documents presented to the court, the court awards as follows on each item.

*Failure to implement clause 24 of our C.B.A.*

It is clear from the records produced to the court that the six grievants were placed on the respondents permanent employment record on 15th June, 1978, and by 1st June, 1984, the grievants had served the respondents for 5½ years only and not six (6) years. Accordingly the grievants had not qualified to be up-graded to category IV. This system of promotion has since been abolished, and the claimants' demand under this item is accordingly rejected.

*Wrongful deduction of wages of four (4) employees*

The court is satisfied that the grievants' wages were wrongfully deducted by the respondents and the court awards that the grievants be refunded the amounts so deducted from their salaries in respect of their compassionate leave.

*Wrongful termination of 29 employees*

The court notes from the casuals pay sheet between 28th January and 2nd February, 1987, both dates inclusive, that the grievants were paid in accordance with the number of balls made. In the circumstances, the court is therefore satisfied that the employees were piece rate workers, but not on permanent terms of employment. The court has therefore decided to reject the claimants' demand on this item.

*Hours of work*

Although the deployment of staff within an organization is the prerogative of management, such a decision must reflect good faith and fairness.

In this dispute, the respondents altered the hours of work for some employees without consulting the claimants, thus creating discrimination among the employees—some working longer hours and others shorter hours.

After careful consideration, the court awards that the existing arrangement in the parties collective agreement be adhered to, but advises the parties to review this item during their next round of negotiations.

THE Transport and Allied Workers Union shall hereinafter be referred to as the claimants and United Touring Company Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 6th September, 1989, and relied on their written and verbal submissions.

## AWARD

3. The Notification of Dispute Form "A", dated 23rd May, 1987, and duly signed by the parties, was received by the court on 11th July, 1989, together with the statutory certificate signed by the Labour Commissioner.

The respondents are a firm of tour operators with a labour force of 518 employees.

The parties signed a recognition agreement on 16th December, 1963, and have since had several collective agreements between them. In their 1987/88 and 1989/90 collective agreements there is a clause, which is the subject matter of this dispute, on overtime that reads:

"7 Overtime—

7.1 Driver Guides

Driver guides will be paid a fixed overtime at a percentage rate of their basic wage and will not be entitled to any additional overtime payments. The fixed overtime payments shall not be paid during any period of absence, sickness or leave. The percentage rate shall be 37 per cent.

7.2 Clause 7.1 will remain in force until such a time as the present dispute on this issue is resolved, and a supplementary agreement signed."



The claimants have alleged that the dispute was initially reported to the Ministry of Labour on 20th May, 1987, and a conciliator was appointed who advised them that overtime was a point of law and as such a non-negotiable matter. They were advised further that the 37 per cent of the basic pay should have been in addition to the minimum pay.

The claimants went on to allege that they subsequently reported the dispute afresh and the ministry informed them that the problem was not refusal by the respondents to pay overtime, but wrong method of calculation of overtime payment.

Another conciliator was appointed and on 23rd May, 1989, the parties recorded a deadlock and they then decided to refer the matter to the court for consideration.

The parties' main bone of contention in this dispute relates to the aforementioned sub-clause in their two collective agreements for the period 1987/88 and 1989/90. In their previous collective agreements to 1986, the parties adopted this mode of payment and no dispute arose regarding suitability of this sub-clause until now. The claimants now want the respondents to discard this sub-clause and instead pay the driver guides as aforesaid in their submissions.

The respondents of course have rejected this demand and have on their part, asserted that it was impossible to compute the overtime performed by the driver guides, particularly when they went on safaris and they have offered to improve the rate from 37 per cent to 40 per cent of driver guides basic salary.

The court has very carefully considered the parties submissions and finds that the parties have really made no serious effort at their own level to resolve this issue. In the circumstances, the court would like to warn the parties that they should not expect the industrial court to negotiate for them their collective agreement or any part thereof. The parties should come to the industrial court only as a last resort after they have exhausted all possibilities of a settlement through voluntary negotiations.

Tourism industry is a very important sector of our economy, and this country can ill-afford to stand any disruption in the smooth running of its various components, and for this reason the court feels that the existing system of paying driver guides should not be changed for the time being. However, after serious consideration of the respondents' offer of 40 per cent overtime for the driver guides, and after perusing some previous relevant rulings and also keeping in view the tourist industry as a whole, the court has decided to award that all the respondents' driver guides be paid 41 per cent overtime of their basic salary.

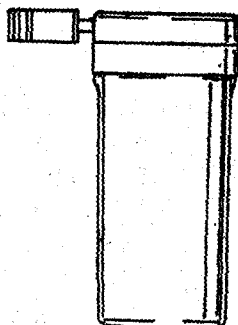
