APPOINTMENT OF A JUDICIAL COMMISSION OF INQUIRY

ilN EXERCISE of the powers conferred by section 3 of the Commissions of Inquiry Act, il, Daniel Toroitich arap Moi, President and Commander-in-Chief of the Armed Forces of the Republic of Kenya, being of the opinion that it is in the public interest, do hereby appoint a commission of inquiry to inquire into the circumstances surrounding and leading to the disappearance and subsequent death of Dr. Robert John Ouko, former Minister for Foreign Affairs and International Cooperation, to be headed by Hon, Mr. Justice Johnson Evans Gicheru as the chairman and—

Hon. Mr. Justice Richard Otieno Kwach,

Hon, Mr. Justice Akilano Molade Akiwumi,

to be the commissioners, and

Ezekiel Omwombo Abang',

to be the secretary to the commission.

THE COMMISSIONS OF INQUIRY ACT (Cap. 102)

JUDICIAL COMMISSION OF INQUIRY

Citation

A JUDICIAL COMMISSION to inquire into the circumstances surrounding and leading to the disappearance and subsequent death of Dr. Robert John Ouko, former Minister for Foreign Affairs and International Co-operation, and generally or in particular to matters appertaining thereto.

Now, therefore, in exercise of the powers conferred upon the President by section 3 of the Commissions of Inquiry Act, I, Daniel Toroitich arap Moi, President and Commander-in-Chief of the Armed Forces of the Republic of Kenya, do hereby direct the commissioners to hold an inquiry at Kisumu Law Courts with immediate effect. The terms of reference shall be—

 (a) to inquire into the circumstances surrounding and leading to the disappearance and subsequent death of Dr. Robert John Ouko; and (b) to inquire generally or in particular into any other matter pertaining to the above; and in accordance with the provisions of section 7 (1) of the said Act, to report thereon.

And I do hereby direct that-

Justice Johnson Evans Gicheru, a judge of the Court Appeal of the Republic of Kenya,

Justice Richard Otieno Kwach, a judge of the Court of Appeal of the Republic of Kenya; and

Justice Akilano Molade Akiwumi, a judge of the High Court of the Republic of Kenya,

shall be the commissioners and that Justice Johnson Evans Gicheru shall be the Chairman of the said Commission.

And I do hereby appoint-

Ezekiel Omwombo Abang'.

Dan Ameyo,

to be joint secretaries to the said commission, and

Bernerd Chunga,

Dancan Mwanyumba,

to be counsel to assist the said Commission.

And I do hereby direct that in accordance with the provisions of section 10 (1) of the said Act, the commissioners shall summon any person or persons concerned to testify on oath and to produce any books, plans and documents that the commissioners may require.

And I do hereby direct that after its commencement, the said inquiry may be held at such times and in such places as the said commissioners may from time to time determine and shall be held in public or in private or partly in public and partly in private as the said commissioners may from time to time determine.

And I do hereby direct that the said commissioners shall execute the said inquiry with all the diligence and speed and make their report without undue delay.

And I do hereby command all other persons whom it may concern to take due notice hereof and to give their obedience accordingly.
