THE Transport and Allied Workers Union shall hereinafter be referred to as the claimants and Messrs. United Touring Company Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 30th, 31st August, and 27th November, 1990, respectively. The parties relied on their written and verbal submissions. In addition the respondents called the following witnesses:

B. Morgan.

D. L. Haworth.

The claimants did not call any witness.

## AWARD

3. The Notification of Dispute Form "A" dated 14th December, 1989, duly signed by the parties was received by the court on 17th May, 1990, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

The grievants, W. Buyakane and C. Kinuthia, were employed by the respondents on 11th September, 1970, and 1st April, 1976, respectively. Mr. Buyakane was engaged as an electrician mechanical grade I at a salary scale of Sh. 1,020 per month, while Mr. Kinuthia was employed as a tour driver at a monthly salary of KSh. 450.

The grievants were dismissed on 25th February, 1988. Mr. Buyakane at this time was earning a monthly salary of Sh. 7,028, plus a housing allowance of Sh. 360 per month, while Mr. Kinuthia was earning a basic salary of Sh. 2,253 per month and housing allowance of Sh. 360 per month. They were dismissed after having served the respondents for nearly (Mr. Buyakane) 18 and (Mr. Kinuthia) 13 years, respectively.

The circumstances which led to the grievants dismissal took place between 1985 and 1987. It is alleged that during this period the grievants were responsible for loss of spare-parts from respondents' workshop. The said spare parts were later sold in town. It was further alleged that the cost of spare-parts used by the respondents vehicles had increased over 50 per cent from Sh. 3.9 million to KSh. 4.8 million and KSh. 5.9 million in the years 1985, 1986 and 1987, respectively. The spare-parts costs increased despite the fact that there was no increase in the fleet.

The dispute was reported to the Minister for Labour on 12th September, 1988. The dispute was investigated by the Ministry of Labour and on 6th November, 1989, the findings and recommendations were released to the parties.

The Ministry's findings were that the respondents had carried out their investigation into the theft allegations against the grievants in a way that it was not sufficient to pin down the grievants, consequently the grievants were victims of circumstances. Finally it was established that the grievants were wrongful dismissed.

It was recommended that the grievants be paid all their terminal benefits in accordance with the parties' C.B.A. They were also to be paid compensation of six months salary to Mr. Kinuthia and ten months salary to Mr. Buyakane for the wrongful dismissal they had suffered.

The decision was turned down by the respondents and now the matter is before the court for consideration.

The claimants urged the court to uphold the Ministry of Labour's findings and recommendations. In addition the grievants be awarded their salaries for the period between the date of their dismissal and 6th November, 1989, the date Ministry's findings and recommendations were released to the parties.

The respondents concluded their submissions by saying that the grievants were summarily dismissed under section 17 (g) of

the Employment Act. They prayed the court to uphold the action taken against the grievants.

This is rather an unfortunate case when two long-serving employees (Mr. Buyakane 18 years service and Mr. Kinuthia 13 years service) lost their jobs on a summary dismissal handed out to them on 25th February, 1988.

The court has carefully evaluated the evidence given by the respondents' two witnesses—the late Mr. B. Morgan and Mr. D. L. Haworth—and finds them to be truthful in what they told the court.

From Mr. Morgan's evidence it is clear that there were sufficient grounds for the respondents to terminate the employment of the two grievants. The workshop manager and the fleet manager also lost their jobs because of the loss of spare parts. The court, however, notes that despite the case regarding the two grievants having been handed to the police no criminal charges were preferred against them.

After careful consideration of all the submissions the court finds that the respondents were justified in dispensing with the services of the two grievants but they did not deserve a summary dismissal. The respondents should have given them a normal termination in accordance with the parties' collective agreement and the court so awards.

THE Kenya Shoe and Leather Workers Union shall hereinafter be referred to as the claimants and Adibas Kenya Limited shall hereinafter be referred to as the respondents.

2. This dispute was heard in Nairobi on 11th December, 1990. When the dispute came up for the hearing the respondent's representative sought an adjournment and requested the court to fix a fresh hearing date on 29th January, 1991, or thereafter. However, the adjournment application was rejected and the court proceeded to hear the dispute *ex parte* as the hearing date had been fixed by consent of the respondents' advocate and as the dispute had started way back in 1987 and had dragged on because of the respondents' negative attitude to the whole process.

The court relied on the parties' written submissions in addition to the claimants' verbal submissions.

## AWARD

3. The Minister for Labour signed the reference of this dispute to the Industrial Court on 8th August, 1990, in accordance with section 8 of the Trade Dispute Act, Cap. 234, which reference was received by the court on 10th August, 1990, together with the statutory certificate signed by the Labour Commissioner.

The respondents engage in the manufacture of footballs and employ a total labour force of 20 workers. This dispute arose in November 1987 when the claimants approached the respondents seeking to be accorded recognition. The claimants' demand was apparently rejected by the respondents and subsequently on 25th February, 1988, the dispute was reported to the Minister for Labour. The dispute was thereafter investigated by the Ministry of Labour and on 29th August, 1989, the Ministry's findings and recommendation were conveyed to the parties. The Ministry's findings were that the respondents'

industrial activities fell under the leather industry and the claimants were the appropriate trade union to represent their unionizable employees. It was recommended that the respondents should accord the claimants recognition.

The decision was turned down by the respondents and now the matter is before the court.

The claimants submitted that 13 unionizable employees out of a total of 20 employees in the respondents employment are their members since 16th November, 1987. The claimants further stressed that there is no other trade union fighting to represent the respondents' employees and the workers have indicated their wish to remain in the claimants' union.

The claimants summed up their submissions by telling the court that the findings and recommendations by the Ministry of Labour were in their favour and the court should endorse the same.

The respondents had submitted in their written reply that union membership had been done secretly and were surprised at the allegation that some of their employees were claimants' members. The respondents further stated that workers are entitled as of right to decide of their own free will whether to join or not join a trade union. The respondents felt that their employees were being coerced to join the claimants' union. Consequently, the respondents did not support enrolment of their employees into the claimants' union.

The respondents went on to state that the workers have not expressed to them their desire to join any union. As a result, it is not known whether there is any rival trade union claiming membership in their organization. The respondents urged the court to reject the claimants' demand.

The court has carefully considered the parties submissions and has come to the conclusion that the nature of the respondents' business is such that the claimants are the proper trade union for the respondents' employees and they have a simple majority of respondents' employees as their members. The court awards that the respondents should recognize the claimants forthwith and sign the recognition agreement with them within three (3) months of the date of award.

2. The parties were heard in Nairobi on 29th November, 1990 and they relied on their written and verbal submissions.

The respondents called the following witnesses:

1. Rose Osodo.
2. Rebecca Nzuri.

#### AWARD

3. The Notification of Dispute Form "A" dated 17th April, 1990, duly signed by the parties was received by the court on 24th August, 1990, together with statutory certificates signed by the Labour Commissioner and the Minister for Labour.

Both ladies, Caroline Muthoni and Philomena Mueni, were taken on as the employees of the respondents on 1st October, 1987, as line packers or general workers at a salary of Sh. 750 per month plus Sh. 250 as house allowance. They served their respective probationary periods and were eventually confirmed. At the time they were dismissed on 27th April, 1989, their respective salaries stood at Sh. 838 with a housing allowance of Sh. 335.

The claimants told the court that the circumstances leading to the dismissal of the two grievants by the respondents was because of an incident which took place on 25th April, 1989, within the factory premises.

The claimants continued to tell the court that in the afternoon during the tea break, both the grievants had a joke in which they pulled each other in a jovial mood but at the juncture, the respondents' foreman was passing by and misunderstood the whole incident and thought that they were fighting in their place of work. The claimants further added that their members were suspended immediately and were told to report on 26th April, 1989, to record the statements.

The claimants continued to tell the court that the management took a rather hasty decision to dismiss the two employees without following the parties' collective bargaining agreement, and they also added that the shop-steward was not informed of the unfortunate incident as required and neither was the union involved in the matter.

The claimants ended their submissions by telling the court that they were prepared to accept Ministry of Labour's recommendation but since the respondents had rejected it they were now asking the court for the reinstatement of the two ladies and to be paid adequate compensation for the wrongful dismissal they had suffered.

On the other hand the respondents told the court that on 25th April, 1989, at 3 p.m. Mueni went to packing section to pick up a container for use at her place of work and in the cause of trying to borrow the said container she picked up a quarrel with Njeru which resulted into a physical fight between the two ladies.

The respondents further told the court that the claimants were not telling the truth to the court by saying that the two ladies were jokingly pushing each other while in actual fact they were fighting. The respondents also added that the two ladies were accorded a chance to defend themselves, but instead they both declared that they had nothing to say.

Rose Osodo, as the respondents witness, confirmed what Nzuri had told the court that the two grievants fought physically in the factory.

The respondents ended their submissions by asking the court to uphold their decision to dismiss the two grievants and to reject the claimants' demands totally.

The court took into account the submissions presented to court by the parties written and verbal. The court was convinced beyond reasonable doubt that the fight took place between the two grievants as confirmed by two witnesses called by the respondents namely Rebecca Nzuri and Rose Osodo so was the Ministry of Labour investigations. The only area where the respondents went wrong was that they took a rather hasty decision to dismiss the two grievants without making proper investigations. It was also evident to the court that the shop-steward was not involved nor the Union. It is the option of the court that the two ladies deserved stern warning for their misbehaviour as there was no damage to the company property and taking into account their previous clean record. The court is more sympathetic to Mueni simply because she was going about her duty and had gone to borrow a container from Rebecca Nzuri only to be accosted by Muthoni Njeru for reasons best known to herself and in any case Njeru had nothing to do with the container in question.

The court awards that the dismissal of the two grievants be reduced to normal termination and they be paid their dues as per parties' collective agreement. But since the court sympathizes with Mueni because she was provoked by Njeru, she should be paid one months extra salary by way of compensation.

- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

**Kenya Gazette**

"D 41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."
