2. The parties were heard in Nairobi on 13th, 17th and 21st December, 1990, respectively. That parties relied on their written and verbal submissions.

## AWARD

3. The Notification of Dispute form "A" dated 8th August, 1990, duly signed by the parties was received by the court on 11th September, 1990, together with the statutory certificate signed by the Labour Commissioner.

The respondents are a limited liability company that engage in the manufacture of all kinds of footballs and other leather products like boxing gloves, shin guards and boxing head guards.

The respondents and claimants entered into a recognition agreement in May 1969. Since then the parties have negotiated and concluded several collective agreements.

The dispute arose when the parties were negotiating for the renewal of their collective agreement which expired on 31st May, 1990. The parties held several meetings and later the Ministry of Labour appointed a conciliator to assist the parties reach an agreement. The parties agreed on several items concerning terms and conditions of service for the respondents' unionizable employees except the ten issues now before the court.

The respondents have a total labour force of 319 employees out of whom 288 are unionizable employees and who are subject of this dispute.

After careful consideration of all the submissions and taking into account the report prepared by the Planning and Research Division of the Ministry of Labour and the Wages Guidelines the court makes the following award on each item.

## House allowance

The court has carefully considered the two proposals put forward by the parties and has found some merit in the claimants' demand. The court taking into account the workers' entitlement under the wages guidelines has decided to award the rates of house allowance.

First year 340 per month.

Second year 360 per month.

## Leave travelling allowance

The court has considered the points for payment of increased travel allowance and makes the following award:

A flat rate of KSh. 370 per employee per year.

## General wage increase

The court awards a general wage increase of 10.0 per cent each year based on individual existing salaries as at 31st May, 1990.

## Job groupings

The court having considered the submissions by the parties, finds that the parties had carried out a job classification exercise in 1988 and a settlement was reached. The court feels that

no case has been made to necessitate just now a further job evaluation exercise and accordingly the claimants' demand on this item is rejected.

## Annual leave

After careful consideration the court rejects the claimants' demand.

## Termination of employment

The court notes that the parties agreed on the clause on termination of employment as far back as 1979 and the said clause has operated since then. The respondents have sought an amendment to make this clause less favourable while the claimants have resisted it very strongly. The court finds no merit in the respondents' demand and accordingly their demand is rejected.

## Protective clothing

The court finds that the present clause in the parties' collective agreement is adequate. The court fails to understand why clerks and typists should be provided with protective clothing, and so rejects the claimants' demand.

## Hours of work

## Overtime

After careful considering the respondents' demands on this issue and the various alternatives proposed by them, the court awards that a status quo should be maintained.

However, the court rules that working hours for employees in the stores and administration sections only should be changed as under:

Mondays—Fridays 8.30 a.m.—1.00 p.m.  
1.45 p.m.—5.15 p.m.

Hours of work a week remains unchanged.

## Long service award

## Transportation

The court has carefully considered submissions by the parties on the above three items and finds no merit in the claimants' demands, so the court rejects them.

For instance, in the next four (4) years, the industry is committed to a development programme estimated to cost at least KSh. 9 billion on the following capital projects: 60 mega-watts geothermal power project, 75 mega-watts standby generating plant, Sondu Miriu hydro-power project, Kiambere-Nairobi and Nairobi-Mombasa 220 kilo-volt transmission lines, reinforcement of major transmission and distribution substations and rural electrification. During the same period, K.P.L.C. has a debt service obligation of at least KSh. 6 billion in respect of the following existing national investments: Kindaruma, Kamburu, Gitaru, Masinga, Kiambere, Kipevu and Olkaria power stations, Kiambere-Rabai

220 kilo-volt line, Embakasi 220 kilo-volt Substation and system control facilities.

The escalation of debt service burden is attributable mainly to the appreciation of the hard currencies, in which the industry has borrowed, against the Kenya shilling. The cost of the projects also continue to be influenced upwards by the appreciation of the hard currencies as well as both domestic and imported inflation. This financial burden is further compounded by the rising operational and maintenance costs of the system for the same reasons, as well as the rising fuel prices.

In consultation with the Government, the applicant is exploring ways and means of diversifying sources of development capital with a view to moderating price increases in future.

The object of and reasons for the application are, therefore, to achieve an overall increase in revenue which is necessary to enable the power industry to implement the expansion programme, service its debts and operate and maintain the system.
