## THE INDUSTRIAL COURT

CAUSE No. 33 OF 1990

## Parties:

Kenya Shoe and Leather Workers' Union  
and  
Slapper Shoe Industries Ltd.

## Issue in dispute:

Wrongful dismissal of Kennedy Orwa.

THE Kenya Shoe and Leather Workers' Union shall herein after be referred to as the claimants and the Slapper Shoe Industries Ltd., shall hereinafter be referred to as the respondents.

2. A preliminary ruling on this matter was delivered in favour of the claimants on 4th September, 1990, and the parties were eventually heard in Nairobi on 29th and 30th September and 22nd November, 1990. In addition, the respondents called the following witnesses to give evidence on their behalf:

1. Edward Kariuki.
2. Peter Kilonzi.

The claimants did not call any witness.

## AWARD

3. The Notification of Dispute Form "A" dated 31st October, 1989, and duly signed by the parties was received by the court on 26th February, 1990, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Mr. Orwa was engaged by the respondents as an artisan (welder), on 1st August, 1985, at a monthly salary of KSh. 695 and a house allowance of KSh. 105. At the time of his summary dismissal on 30th August, 1988, his salary stood at KSh. 1,045 per month with a house allowance of KSh. 200. Mr. Orwa's employment record indicates that on 20th August, 1987, he was served with a warning for his absence from duty, and on 30th January, 1988, he was suspended for disobeying his supervisor. On 20th May, 1988, he was again warned for negligence in the performance of his duties.

The alleged grounds leading to Mr. Orwa's summary dismissal were that he falsely signed the attendance record book to show that he was on duty for 5 hours from 12.00 noon to 5.00 p.m. on Saturdays 6th, 20th and 27th August, 1988. Further, Mr. Orwa, is alleged to have dishonestly recorded in the same attendance book that his workmate, Caleb Ogolla, was on duty from 15th to 19th August, 1988 while the latter was absent. Consequently, Mr. Orwa was summarily dismissed for gross misconduct because he wilfully supplied the respondents with false records of his attendance on duty for the said three days and also for wilfully recording that his above-named workmate attended to his normal duties as aforesaid. Again he failed to inform the respondents of such falsifications until the matter was unearthed by them.

The claimants took up the matter on his behalf with the respondents but the parties were unable to reach an amicable settlement; and on 14th February, 1990, the claimants formally declared a trade dispute with the respondents.

The Ministry of Labour appointed Mr. J. M. Kiraguri, of Mombasa Labour Office, to act as an investigator, and on 19th October, 1989, the chief industrial relations officer forwarded the following findings and recommendation to the parties:

## Findings:

The investigations noted that Mr. Kennedy Orwa, was engaged by Messrs. Slapper Shoe Company Limited as a welder on 1st

August, 1985 until 30th August, 1988, when he was summarily dismissed.

It was established that Mr. Orwa knew that his workmate, Caleb Ogolla, was absent from duty, and wilfully signed his (Ogolla's) name in the daily attendance register to indicate that Mr. Ogolla was actually present when he was not. The union's allegation that this arrangement had the blessing of the supervisor was not substantiated. Also noted is the fact that Mr. Orwa, had also falsified records of hours between 4th August, 1988 and 29th August, 1988. Besides, he had been served with two warning letters before for other disciplinary offences.

It is, therefore, the findings of the investigations that Mr. Orwa was correctly charged by the management with forgery which was sufficiently proved. Hence, his dismissal was in the circumstances well deserved.

## Recommendation:

.....the management's action was justified and should be upheld."

The claimants rejected the ministry's report and the matter is now before the court for consideration.

The claimants prayed the court to re-instate Mr. Orwa to his job with full rights and benefits, or alternatively award him the following entitlements:

- (a) Pay in lieu of notice in accordance with the parties' collective agreement.
- (b) Leave travelling allowance.
- (c) 12 months' compensation for loss of employment.

On careful consideration of this matter, the court notes that Mr. Orwa was summarily dismissed for dishonest falsification of attendance records in respect of himself and his workmate, Mr. Ogolla, as is clearly evident from the facts of this case and the evidence on record. In his letter dated 31st August, 1988, to the respondents, Mr. Orwa apologized for having worked for Mr. Ogolla, between 15th and 19th August, 1988, but made no mention of the days when he was alleged to have dishonestly and falsely recorded and signed the attendance book that he was on duty and yet he was absent; that is, on Saturday 6th, 20th and 27th August, 1988. It is also most strange and regrettable that the claimants did not make any written submission on this point. They did not even bother to call Mr. Orwa, who was present in court during the hearing of this dispute, to come and give evidence surrounding his involvement in respect of the three days under consideration. In the circumstances, the evidence of the respondents' witnesses remains unchallenged.

The respondents' witnesses, particularly the Personnel Officer, Mr. Kilonzi, testified that when Mr. Orwa was questioned over this matter, he admitted that he was actually not on duty on the aforementioned three days; and in the absence of Mr. Orwa's evidence, the court has no reason to doubt their testimony.

For these reasons, the court, therefore, upholds the ministry's findings and recommendation, and accordingly rejects all the demands made by the claimants on the grievant's behalf.

- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.
