Wrongful dismissal of Johnson Lukalo.

THE Kenya Union of Commercial Food and Allied Workers shall hereinafter be referred to as the claimants and Standard Chartered Bank of Kenya Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 28th August, 23rd, 24th, 25th October, 1990, and 23rd January, 1991, respectively. The parties relied on their written and verbal submissions and in addition the following witnesses were called to testify on oath:

Claimants: Johnson Lukalo.*Respondents:* Lynn Kanjiru Kiraithe and Anne Mary Kinyanjui.

AWARD

3. The Notification of Dispute Form "A" dated 16th November, 1989, duly signed by the parties was received by the court on 26th February, 1990, together with the statutory certificates signed by the Minister for Labour and the Labour Commissioner.

Johnson Lukalo, was employed by the respondents on 24th June, 1974, as a clerk earning KSh. 829 per month. He subsequently rose through the ranks to the post of check clerk in 1979, and section head in 1980, respectively. He was dismissed on 28th October, 1986, after having served the respondents for 12½ years. At the time of his dismissal he was earning KSh. 6,349 plus a housing allowance of KSh. 900 per month.

The circumstances which led to Johnson Lukalo's suspension and subsequent dismissal were the allegations that on several occasions in the period between January and 23rd September, 1986, he had breached the parties collective agreement clause 5 (a) (ii) i.e. he had contravened the laid-down regulations and procedures. He was further allegedly found to have been a security risk to the respondents business.

The parties tried to settle the matter amicably at their own level but failed. Subsequently on 19th December, 1988, the dispute was reported to the Minister for Labour. Thereafter, the dispute was investigated by the ministry and the findings and recommendations were released to the parties, on 27th September, 1989.

The ministry's findings were that Mr. Lukalo had actually contravened the bank's regulations for reasons known only to himself. The respondents were found to have acted justifiably in taking the disciplinary action against Mr. Lukalo.

However, on the grounds that he had not committed a serious disciplinary offence between 1974 and 1st September, 1986, the dismissal action was found to be rather too harsh.

The ministry recommended that Mr. Lukalo's dismissal be reduced to normal termination of service to entitle him to terminal dues accruing from the parties collective agreement. The decision was turned down by the claimants on the grounds that the findings were not only inconsistent but also irrelevant to the issue in dispute. Consequently the matter was referred to the court for consideration. The claimants felt that any other form of compensation would not be justifiable in this case and Mr. Lukalo has suffered irreparable damage as a result of criminal charge preferred against him and his confinement in police custody. They urged the court to award reinstatement of Mr. Lukalo without loss of seniority and benefits.

The respondents prayed the court to reject the claimants case in total as it is ill-founded.

The grievant in this dispute worked for the respondents from 24th June, 1974, until 29th October, 1986, when he was dismissed. At the time of his dismissal he was a section head in the foreign exchange department earning a salary of KSh. 6,349 per month in addition to a housing allowance of KSh. 900 per month.

The grievant was taken into police custody on 16th September, 1986, on a matter involving a criminal offence and he was suspended on 23rd September, 1986, pending the outcome of the investigations by the police and court proceedings against him. He was to be paid half salary with effect from 16th September, 1986.

On 28th October, 1986, he was dismissed on the allegation that he had been grossly careless and negligent in the performance of his duties in connection with two bank drafts No. 238517 and 238523 for K£2,069.08 each.

The grievant was charged in the criminal court with 12 counts of conspiracy to export bills of exchange without permission of the minister as provided for under the Exchange Control Act. After the hearing of the criminal case the grievant was acquitted on all counts.

The two bank drafts in connection with which he had been dismissed figured prominently in the criminal case and as stated earlier the grievant was acquitted on all counts.

The grievant, since his acquittal, has been fighting to get his job back and the claimants reported a trade dispute on his behalf to the Minister for Labour.

The ministry's finding and recommendation were as follows:

"The investigations carried out established that Johnson Lukalo processed the two cheques in question. It has not been debated that Mr. Lukalo initiated the two entries both as a worker and a checker contrary to the bank's regulations.

It was noted further that Mr. Lukalo admitted having prepared the two entries pertaining to the two drafts. As a section head in foreign exchange department of the bank, Mr. Lukalo no doubt knew the bank's standing instructions relating to security.

It is evident that Mr. Lukalo contravened bank's regulations for reasons known only to himself. The fact that the relevant documents concerning the matter at issue were misplaced obviously raised grave doubts about Mr. Lukalo's integrity on 2nd September, 1986. Hence, the management were justified in taking the disciplinary action against Mr. Lukalo.

It was observed that the joint negotiating council held the view that Mr. Lukalo should be reinstated on the ground of his acquittal. Nevertheless, it has been found out that Mr. Lukalo wilfully committed a breach of fidelity which he owed to his employer. But considering that Mr. Lukalo had not committed a serious disciplinary offence since 1974 up to 1st September, 1986, I find that his dismissal was a rather harsh action.

Recommendation:

All points carefully considered, I am inclined to recommend that Mr. Lukalo's dismissal be reduced to normal termination of services to entitle him to terminal dues to be calculated in accordance with the parties' C.B.A."

The claimants rejected the ministry's finding and recommendation.

There are two aspects to this dispute, one is the criminal charge and the other is the grievant's alleged gross negligence during the performance of his duties as a section head in the foreign exchange department.

The fact that the grievant was acquitted on all extremely serious counts in the criminal case involving conspiracy to export bills of exchange without permission of the minister as specified in the Exchange Control Act disposes of the criminal aspect of this dispute and the grievant must get the full benefit of this acquittal as far as his dismissal is concerned.

This then leaves the aspect of negligence in his work performance. The court is satisfied that the respondents books balanced at the end of the day when the material transactions took place.

The bank drafts in question had to be countersigned by the grievant's immediate superior Mrs. Kinyanjui. It is a laid down requirement in the bank that important documents have to be signed by two authorized signatories one of whom in this case was Mrs. Kinyanjui. The court was told that she trusted the grievant and therefore did not carry out the necessary double check. The court, finds it difficult to believe that she did not check the documents before she signed them. Were this not to be so then the whole purpose of requiring a second signature on all important documents would be of no use and the purpose for which the second signature is needed would be defeated.

The court, therefore, finds that when the bank drafts in question left the bank they were in order.

The only point which the respondents have been able to prove during the hearing is that the relevant entries were made by the grievant by passing the clerks who had to make those entries in the first place. In other words he performed the task of the clerk and the checker himself. For this default, however, taken in conjunction with the court's earlier findings the grievant with his twelve-and-half (12½) years' service did not deserve a dismissal.

After careful consideration of all the submissions the court finds that he has suffered a wrongful dismissal.

The court has decided to give him his job back but not as section head. The court feels that for the default he committed he should be demoted to the position of a checker and his salary should be adjusted accordingly.

The court accordingly awards that the grievant should be reinstated to the position of a checker with effect from 1st June, 1991, and the respondents will be at liberty to post him to any of their branches in Kenya in that position. His services will be deemed to have continued without a break.

The grievant has been out of employment from 29th October, 1986, and lost his monthly salary of KSh. 6,349 and house allowance of KSh. 900 per month since that date.

The court finds that the grievant deserves compensation for this in addition to his reinstatement and the court awards that the respondents should pay him KSh. 100,000 by way of compensation.

The grievant will not be entitled to any other payment by way of salary and house allowance for the period he was out of employment.

THE Kenya Shoe and Leather Workers Union shall hereinafter be referred to as the claimants and Bata Shoe Company Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 26th and 28th February, 1991, and relied on both their written and verbal submissions.

The respondents called the following witnesses:

1. J. Njenga.
2. S. N. Njoroge.

AWARD

3. The Notification of Dispute Form "A" dated 18th May, 1990, duly signed by the parties was received by the court on 2nd October, 1990, together with the statutory certificates signed by both the Labour Commissioner and the Minister for Labour.

The grievant, Pecos Mutua, was engaged by the respondents as a supplier on 5th January, 1976, at a salary of KSh. 240 per fortnight.

His services were terminated on 7th April, 1987, for alleged gross misconduct after serving the respondents for eleven (11) years. At the time of his dismissal, his salary was KSh. 1,022 per fortnight plus KSh. 148 house allowance per month.

Upon his dismissal, the claimants and the respondents held a joint meeting on 22nd December, 1988, to try and solve the matter amicably but no agreement was reached and the matter was then reported to the Minister for Labour in accordance with section 4 of the Trade Disputes Act.

The Minister for Labour, then appointed an investigator to try and resolve the matter. The investigator held joint meetings with parties but still no agreement was reached and the matter is now before this court for determination.

In their submissions, the claimants informed the court that Mr. Mutua's responsibility at the time of his dismissal was to receive shoes from the Bata Factory in Voi, which are always transferred to Limuru depot where the grievant was stationed before they are sold to customers, both retail and wholesale.

Before the shoes are packed into lorries, which are privately owned, there is an employee of the respondents who checks whether the packing is in accordance with the list given to him.

After the shoes have been packed, there is a checker who goes around to confirm the figures given before releasing shoes in cartons to the turn-boys and drivers of the privately owned lorries, who again pass through the final checking at the gate.

The claimants further informed the court that at around 10.00 a.m. on 7th April, 1987, Ndungu Njoroge, the final checker was going through the cartons which were already on the trolley in the process of being packed in the waiting lorry when he discovered that there were more pairs packed contrary to the figures shown on the list given to him. He referred the discrepancy to the head of department who immediately called in the security who arrived in 10 minutes time.

The two turn-boys and the driver who were pushing the trolley and David Karanja, who works in the same department were taken to the personnel manager's office for questioning. All of them were later taken to Tigon Police Station for further action.

The following day (8th April, 1987), the grievant together with Phillip Waita and Mr. Mathu, who were working in the depot were picked up by police. The grievant and his colleagues were told at the time of arrest that their names had been mentioned by the three who were already at the police station as having been involved in the deal.

The grievant together with all those arrested were charged in court for theft. However, the grievant was acquitted but on reporting for duty after the acquittal he was informed that he had been dismissed on the 7th April, 1987 the day the alleged theft is said to have been committed.

The claimants submitted that the grievant was entitled to reinstatement with full rights and benefits or alternatively to:

- (a) Two months' notice.
- (b) Days worked.
- (c) Leave/pro rata.
- (d) Leave travelling allowance.
- (e) Full compensation (12 months) for loss of employment.

They prayed the court to award as per their submissions.

On their part the respondents submitted that on 7th April, 1987, a shocking discovery was made by a checker at the company's warehouses whereby forty-eight (48) pairs of shoes were discovered hidden inside gumboots that had already been packed and ready for dispatch. During investigations, the grievant was implicated in the plot and together with his colleagues were handed over to the police for further investigations, after which the grievant and his colleagues appeared before Limuru Magistrate's Court charged with the offence of theft.

The respondents, prayed the court to uphold the findings of the Ministry of Labour. The findings were that the grievant either took part or condoned what was taking place (during the alleged theft) or was totally negligent in the whole affair and that this negligence was enough to render the grievant liable to summary dismissal. The management thus acted lawfully when they discharged the grievant under section 17 of the Employment Act.

The respondents urged the court to uphold the respondents' action and reject the claimants case in total. They also urged the court to disregard the ministry's recommendations which were that the grievant's dismissal be turned to normal termination and he be paid terminal benefits as per parties collective bargaining agreement.

After careful consideration of all the circumstances of this case the court is of the view that had the grievant been alert while on duty it would not have been possible for any other employees from other sections to come and stuff pairs of shoes in the gumboots which were stacked in the grievant's section.

The fact that the grievant was acquitted by the criminal court goes in his favour and also the fact that the respondents during the hearing have shifted their reasons for dismissing him from those contained in the letter of dismissal.

The court, however, finds that the respondents were justified in losing trust and confidence in the grievant but instead of handing him a summary dismissal they should have dispensed with his services by giving him a normal termination as laid down in the parties collective agreement and the court so awards.

Particular attention should be paid to the following points:

- (i) Signature must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—

Kenya Gazette

"D 41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."
