- (b) at any subsequent time prior to the expiration of the said building period, the local authority shall refund the lessee twenty-five (25) per cent of the said stand premium; or
- (c) in the event of notice being given after the expiration of the said building period, no refund shall be made.

5. The land and buildings shall only be used for the purposes indicated in the schedules.

6. The buildings shall not cover more or lesser area as may be laid down by the local authority in its by-laws.

7. The lessee shall not subdivide the land without the prior written consent of the local authority and of the Commissioner of Lands.

8. The land and buildings shall not be used for any trade or business which the local authority considers to be dangerous or offensive.
