"Termination of services of Mr. Raphael Njenga."

THE Kenya Union of Commercial, Food and Allied Workers shall hereinafter be referred to as the claimants and Eveready Security Guards Company Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 19th February, 1991, and relied on their written and verbal submissions. In addition, the court caused the Ministry of Labour to carry out further investigation in this dispute. The court received the Ministry of Labour's report on 3rd July, 1991.

AWARD

3. The Minister for Labour signed the reference of this dispute to the Industrial Court on 28th September, 1990 in accordance with section 8 of the Trade Disputes Act (Cap. 234), which reference was received by the court on 2nd October, 1990, together with the statutory certificate signed by the Labour Commissioner.

The grievant Raphael Njenga was employed by the respondents on 26th February, 1984 as a security guard earning a consolidated monthly salary of KSh. 800. On 1st February, 1986 Njenga was promoted to the post of a corporal and held that position until 9th May, 1986, when his services were terminated by the respondents. At the time of his termination he was earning KSh. 840 and had served the respondents for 2 years and 2 months.

The respondents alleged that the grievant in the period between 27th January and 8th May, 1986 had numerous shortcomings. The respondents cited the grievant's shortcomings as absenteeism from duty, sleeping while on duty and refusal to perform assigned night duties. The respondents further alleged that the grievant was not dismissed from work but on 9th May, 1986, absconded from duty only to go and work for their clients privately.

The claimants told the court that, they took up the matter with the respondents but no settlement was reached. The claimants then reported a trade dispute to the Minister for Labour. Thereafter, an investigator was appointed and the dispute having gone through the usual machinery the ministry's findings and recommendation were released to the parties on 19th May, 1988.

The ministry's findings were that the grievant had deserted his employment and started working with a former client of the company which Njenga was previously assigned to guard. It was also found that Njenga did not in any way suffer wrongful dismissal.

The ministry recommended that the grievant be paid the following dues—

- 9 days worked in May, 1986;
- leave *pro-rata*;
- uniform refund;
- one way leave travelling allowance.

The recommendation was turned down by the claimants and the matter is now before the court for consideration.

The claimants concluded their submissions by stating that the Ministry of Labour findings were biased and one sided. They requested the court to set aside the Ministry of Labour's findings and recommendation and award the grievant full terminal benefits as follows:

- One month's pay in lieu of notice—KSh. 840.
- Pay for 9 days worked in May, 1986—KSh. 290.75.
- Overtime entitlement worked over and above 52 hours a week. Mr. Njenga worked for 12 hours daily totalling 72 hours a week. $12 \text{ hours} \times 6 \text{ days} = 72 \text{ hours} - 52 \text{ hours} = 20 \text{ hours}$
 $20 \text{ hours} \times 1\frac{1}{2} = 30 \text{ hours per week}$
 $\text{One (1) month (4 weeks)} \times 30 \text{ hours} = 120 \text{ hours}$
 $= \text{KSh. } 840 \times 120 = \text{KSh. } 448$
 $\text{225 hrs. } 1$

Total overtime = 26 months \times 448 = KSh. 11,648.

- Off-duty entitlement as Mr. Njenga never had off-duties for rest.

One (1) month = 4 days \times 26 months = 104 days.
KSh. 840 over 30 \times 104 days = KSh. 2,912. Total off duty = KSh. 12,912.

- Uniform refund at KSh. 20 each month for 26 months = KSh. 520.

- Leave travelling allowance for two years as Mr. Njenga never got it while proceeding on leave = KSh. 150×2 Total KSh. 300.

- Compensation for wrongful termination as the court may decide.

The respondents stressed that the grievant is the one to pay the company one (1) month's salary in lieu of notice because he left employment without serving the mandatory notice. The respondents went on to say that they were willing to pay Mr. Njenga his legal dues tabulated as follows:

- Pay for 9 days worked in May, 1986, KSh. 290.
- Uniform refund KSh. 520.00.
- Pay for leave due KSh. 168.00.

Total KSh. 940.00.

However, his total dues of KSh. 940.00 should be subject to a deduction of one month's salary in lieu of notice. The respondents argued that the remaining payable amount to the grievant is only KSh. 100. They told the court that KSh. 100 was paid to the Provincial Labour Officer, Nairobi on 15th January, 1987, for onward transmission to the grievant. They prayed the court to dismiss the claimants' pleas and uphold their action.

Notwithstanding the fact that the respondents failed to appear in court and the court heard the dispute *ex parte* this court found it expedient in the interests of justice that further inquiries should be made and accordingly directed the Chief Industrial Relations Officer to make the necessary inquiries as directed by the court.

The Chief Industrial Relations Officer reported to the court on 2nd July, 1991 that the respondents had been quite evasive about this matter and that in the absence of the necessary records his officers could take the information available on its face value only.

The court has carefully considered the parties' written submissions and the claimants' further verbal submissions and the Chief Industrial Relations Officer's report and has decided to make the following award.

The court awards that the respondents should pay the grievant the following amounts:

- One month's pay in lieu of notice—KSh. 840.
- Pay for 9 days worked in May, 1986—KSh. 290.75.
- Overtime worked for the period 8th May, 1985 up to 9th May, 1986 (one year)—KSh. 5,276.
- Uniform refund—KSh. 520.
- Leave travelling allowance—KSh. 168.
- Two month's salary by way of compensation for wrongful termination—KSh. 1,680.

THE Commissioner of Lands invites applications for the allocation of plots in the above township as described in the schedule hereto. A plan showing the plots may be obtained from the Public Map Office, P.O. Box 30089, Nairobi, on payment of KSh. 30, post free.

2. Completed applications should be submitted to the Commissioner of Lands, Nairobi, through the County Clerk, Isiolo County Council, P.O. Box 36, Isiolo, on the prescribed forms which are available from the District Lands Office, P.O. Box 40, Meru, and the office of the County Clerk, P.O. Box 36, Isiolo.

3. Applications must be sent so as to reach the county clerk not later than noon, on 13th September, 1991, and the applicants must enclose with their applications either a banker's cheque, money order or postal order for KSh. 1,000 made payable to the Commissioner of Lands, as deposit which will be dealt with as follows:

- (a) Credited to a successful applicant.
- (b) Refunded to an unsuccessful applicant.

3. The grantee shall maintain in good and substantial repair and condition all buildings at any time erected on the land.

4. Should the grantee give notice in writing to the county council that he/she is unable to complete the buildings within the period aforesaid, the county council shall (at the grantee's expense) accept a surrender of land comprised herein:

Provided further that if such notice as aforesaid shall be given—

- (a) within twelve (12) months of the commencement of the term of lease, the county council shall refund to the grantee 50 per cent of the stand premium paid in respect of the land;
- (b) at any subsequent time prior to the expiration of the said building period, the county council shall refund the grantee 5 per cent of the said stand premium; or
- (c) in the event of notice being given after the expiration of the said building period, no refund shall be made.
