THE INDUSTRIAL COURT CAUSE No. 4 of 1991

Parties:

Kenya Union of Domestic, Hotels, Educational Institutions, Hospitals and Allied Workers

and

Aga Khan Sports Club

Issue in dispute:

Claimants' version .- "Refusal by the management to pay employees arrears of salaries, house allowance, travelling allowance and long service award for the years of 1987/88."

Respondents' version .- "Demands by the union for salaries, house allowance, travelling allowance and long service awards for the years 1987/38, in excess of that contractually between the employer and the employees, notwithstanding that at the time no formal agreement was in existence between the parties.'

Hearing: 6th June and 3rd July, 1991.

AWARD

The respondents are a self-supporting and non-profit making body. They were established in the early part of this century to cater for the sporting interests of their members from subscriptions paid by them, and are run on strictily voluntary basis by a management committee whose tenure of office is for a period of 12 months. Currently the respondents engage a total of 39 employees, out of whom 32 are unionizable a worst of 37 cmproyes, our of month of archands, along staff. In the 1930s the respondents moved to Parklands, along Limuru Road, Nairobi; and in 1987, they shifted to their present location, along Mtama Road, off 5th Parklands Avenue.

The present dispute arose after the registration of the 1987/ 88, collective agreement between the claimants and the sports clubs group of F.K.E., which was registered on 26th July, 1988, as RCA No. 211 of 1988. In November, 1988, the respondents raised their employees' salaries and other benefits in conformity with the terms and conditions of service of the sports clubs group of F.K.E.'s employees, but refused to back-date the increases to the effective date of the said agreement in force, i.e., 1st January, 1987. The parties met at their own level with a view to resolving the matter but no settlement own rever with a view to resolving the matter out his schement was reached. Consequently, the claimants reported a trade dispute to the Minister for Labour in accordance with section 4 of the Trade Disputes Act, (Cap. 234), of the Laws of Kenya. 4 of the Trade Disputes Act, (Cap. 234), of the Laws of Kenya. The Minister appointed Mrs. L. A. Orege, of Natirobi Labour Office, to act as a conciliator, but the conciliation proceedings which followed were futile, and a failure certificate was, therefore, signed by the parties and issued on 19th October, 1989. On 8th August, 1990, the Minister for Labour forwarded to the court the Notification of Dispute, Form "A", duly completed and signed by the parties in accordance with section 14 (7) of the Act, and the same, accompanied by the statutory certificate from the Labour Commissioner under section 14 certificate from the Labour Commissioner under section 14 (9) (e), thereof, was received by the court on 7th February, 1991.

The claimants, prayed the court to award the arrears as demanded.

The respondents prayed that the claimants' demand be

When management or employers and unions negotiate on various matters which constitute the terms and conditions of employment, the decisions thus arrived at are emcodied in collective agreements, the terms of which find their way into the employment relationship between the management and employees by being incorporated into employees' individual contracts of employment. Collective agreements are, therefore, the products of collective bargaining process which, under the common law, is recognized by the courts, and there are two possible ways in which this incorporation of collective agreements may be carried out. First, there may be an express clause in the contract of employment incorporating the terms of such collective agreements. Many employers do this by referring the new employee in his letter of employment to another document, generally the employee handbook, which contains the collective agreements, the terms of which may change from the collective agreements, the terms of which may change from time to time without further obligation on the employer of notifying such changes to the employee as long as the document is available and accessible to him. Secondly, where the employment contract says nothing about the collective terms, in which case there is no express incorporation, such terms can be incorporated only if they can be regarded by the court as customary practice of long standing, or implied and intended terms of the contract. Where the employer customarily applies such terms to all his employees, it will be easy for the courts to imply the terms into the employees' individual contracts of employment. It is, however, not clear how far the knowledge of the employee will regulate the implication of terms into his individual contract of employment. Much depends upon the precise circumstances of each individual case. But it is plain that after terms and conditions of a collective it is plain that after terms and conditions of a collective agreement have been acted upon by an employer for a long period, it is much easier to imply and incorporate them by practice, or even "custom", into the employees' individual contract of employment. Where that is so, the courts will normally imply that the employer and the employees had known and tacitly accepted such terms and conditions of employment and incorporated them into the employees' individual contracts of employment are as to effect their infinity and dual contracts of employment so as to affect their rights and obligations.

Although the parties in the present dispute had neither recognition nor collective agreements between them, it is evident from the documents on record, the parties' relationship to date and the P.R.D. report, that they have from time to time since 1979, except for the period under consideration, implicitly adopted the sports clubs group of F.K.E.'s terms and conditions of service by acting upon them; and the respondents have been paying their employees wages and other benefits based on the same. The employees have also since 1979, accepted and taken advantage of the better terms and conditions of service of the group's collective agreements and the respondents have not challenged the claimants' arguments on this point. In the circumstances, and taking into account the practice which has since 1979, existed between the parties, we are of the opinion that the benefits arising out of the 1987/88, agreement arrived at between the claimants and the Sports Clubs Group of F.K.E., should be extended by implication to the members of the claimants' union in the respondents' employment. Accordingly, our award on this demand is that the respondents do pay the affected employees the outstanding arrears of their salaries, house allowance, travelling allowance and long service award for the period 1987/88, based on the Sports Clubs Group of F.K.E.'s collective agreement in force at the time.

We note, however, that the total arrears in this case amounts We note, however, that the rotal arrears in this case amounts to about KSh. 120,000, and the respondents have expressed their inability to pay because of their weak financial position. For example, from 1985 to 1989, the respondents were running in deficits, except in 1987 when they realized a surplus of KSh. 1,653,407. But despite this precarious financial position, we feel that the employees demands are legitimate and have we feel that the employees' demands are legitimate and have to be catered for by the respondents irrespective of their finances. Keeping this observation in view, it is ordered that the respondents do liquidate the total arrears due to the employees in four equal instalments, commencing on 30th November, 1991, and on 30th of each and every succeeding months until payment in full.

We award as above, and finally advise the parties to formalize or regularize their relationship by signing a recognition agreement between them.

AWARD

The respondents are a group of five (5) companies engaged in laundry, drycleaning and dying activities in Nairobi. They

- 1. Pearl Drycleaners Ltd.
- 2. White Rose Drycleaners Ltd.
- 3. Mbuni Drycleaners Ltd. 4. Khushal Singh Laundry (K) Ltd.
- 5. Central Laundry Ltd.

The respondents have recognized the claimants as the legitimate and rightful union to represent their total workforce of about 900 employees, and the parties have had dealings with each other for the last 12 years without recourse to arbitration. The last time they appeared before the count was in 1976, in cause No. 3 of 1976, in which the issue in dispute was "wage increase." The present dispute, however, arose when the parties commenced their negotiations on 26th July, 1990, for a review or revision of their latest two (2) years' 1990, for a review of revision of them rates two (2) years collective agreement which was belatedly signed on 26th April, 1989, but covering the period 1st July, 1988 to 30th June, 1990. The parties met at their own level on 18th and 28th August, 3rd and 9th September, 11th October, 8th and 12th November, 1990, during which occasions they resolved all the items except four (4) issues viz., general wage increase, housing allowance, gratuity and night shift allowance.

In consequence, the claimants reported a trade dispute on these issues to the Minister for Labour, who accepted the same and, vide his letters dated 9th January, and 4th February, 1991, appointed M. M. Gitao (Mrs.), of Nairobi Labour Office, to act as a conditiator. At the conditiation meeting held on 21st March, 1991, the parties agreed on the general wage increase at the rate of 11 per cent each year, but recorded a deadlock on the three (3) issues or demands now before the court for consideration

The dispute between the parties was, therefore, referred to the court in accordance with section 14 (7) of the Trade Disputes Act (Cap. 234), of the laws of Kenya, and the Notification of Dispute Form "A", dated 7th May, 1991, was received by the court, accompanied by the statutory certificate from the Labour Commissioner under section 14 (9) (e), on 12th June, 1991. We will now proceed to consider the parties' submissions and record our decisions on each of the three (3) issues or demands set out in the notification. issues or demands set out in the notification.

1. Housing Allowance:

It cannot be denied that accommodation and its high rent are acute problems in Nairobi and other major towns in the are acute property. It is also true that the wage structure of the unionizable employees in these concerns is relatively low and there is some force in the claimants' argument on this point. But we are not inclined to ignore the fact of payment of house allowance vis-a-vis the wages guidances (ii) and (iv). The P.R.D. report on this issue shows that fight claimants' demand of KSh. 100 increase per month is allowed the current monthly bill on house allowance of about KSh. 225, KSh. 500, will bill on house almowance of about 1831. 223, RSII. 300, Will rise to KSh. 360,000, i.e., an increase of KSh. 130,500 per month. On the other hand, the respondents offer of KSh. 80 or 31.37 per cent, per month will hike it to KSh. 301,500, i.e., an increase of KSh. 72,000. In accordance with the P.R.D. computation, the claimants are entitled to an increase of 9.4 per cent compensation per year on their current house allowance. With these facts and figures in mind, we feel that the claimants' demand of KSh. 400 is quite unrealistic and un-

In our opinion the ends of justice in the particular circumstances of this case will be met if the employees of the respondents are allowed an increase of house allowance of KSh. 95 on their current rates, i.e. KSh. 350 per month with effect from 1st July, 1990.

We award accordingly.

2. Gratuity:

Under this head the demand of the claimants is that the employees should be granted a soheme of gratuity as a past service benefit because provident fund schemes and the National Social Security Fund (N.S.S.F.) benefits which the National Social Security Fund (N.S.S.F.) benefits which the employees will draw at the time of their retirement is so meagre that they can hardly meet the expenses of the employees for any length of time. They have cited the cases of Distributive and Allied Trade Association (DATA) and Kenya Breweries Ltd., in support of their demand. The respondents are not willing to accede to this demand because the matter had been adequately adjudicated upon in cause No. 35 of 1968; and furthermore, the provident fund schemes, and the National Social Security Fund (N.S.S.E.) entitlements and the National Social Security Fund (N.S.S.F.) entitlements

give a generous and prompt relief to the employees at the time of their retirement.

Gratuity is a superannuation scheme or amonity which adds a permanent burden to the finances of a company; and before granting it, it has to be seen whether the company concerned is capable of hearing the financial burden of such a long term scheme. Also before the employees can be granted the graduity they must show that the company is well established, assured. It is, therefore, absolutely unwise and dangerous burden of this kind on a company which can ill-afford it. There have been a large number of decisions of this count and other industrial tribunals in which fundamental principles governing this subject have been laid down: that gratuaty should not be refused on the ground that other companies have no scheme of gratuity; that the existence of a provident fund scheme and other retining benefits are no bar for the introduction of gratuity scheme; that a scheme for graduity can be introduced only if the financial position of the company or concern justifies it; and that if the financial position does not justify then such scheme should not be introduced.

Having regard to the fragile financial position of the res-Having regard to the tragite financial position of the respondents and the award in cause No. 35 of 1968, we are clearly of the opinion that the claimants' demand under this item has satisfactorily been met by the respondents' written and verbal submissions. In the circumstances, the parties are at liberty to go for a review or amendment of the award under cause No. 35 of 1968, which is still in force.

Meanwhile, the demand stands rejected.

3. Night Shift Allowance.

It is clear in this case that the respondents pay their employees overtime whenever they are called upon to work after the fixed working hours. It is also on record that the claimants' demand is not based on the increased production but on the employees having to work during hours which are usually employees having to work during moins which are usuary meant for rest, i.e. from 6 p.m. to 9.30 or 10 p.m. Keeping in view the foregoing salient points and since night shift work is not prevalent in this type of industry we are salisfied that there is no substances in this demand which is hereby rejected.
