Mr. D. A. Ngirimani, for the claimants. No appearance for the respondents.

Hearing: 15th October, 1991.

AWARD

This dispute was referred to the court by the Minister for Labour under powers conferred upon him by section 8 of the Trade Disputes Act (Cap. 234), of the laws of Kenya; and his reference, accompanied by the statutory certificates from himself and the Labour Commissioner under section 14 (9) (e) and (f) of the Act were received by the court on 14th June, 1991.

On 18th June, 1991, the parties were advised that the dispute would come up for mention on 15th July, 1991, at 10 a.m. On this date, the claimants' representative appeared but the respondent failed to attend. The case was then listed for a further mention on 19th August, 1991, with a view to fixing a hearing date, and the parties were ordered to file their memoranda on 31st July and 14th August, 1991, respectively. On 26th July, 1991, the claimants filed their memorandum in court, a copy of which was forwarded to the respondent on 29th July, 1991. The respondent failed to file his replying memorandum as ordered. On 19th August, 1991, the claimants' representative appeared but the respondent again failed to attend. The case was then fixed for hearing on 15th October, 1991. The parties were accordingly informed of the hearing date. Meanwhile, a copy of the claimants' memorandum, which had been correctly addressed and forwarded to the respondent as aforestated, was on 4th October, 1991, received back by the court uncollected. In the circumstances, the court requested the claimants to collect the same and effect personal service upon the respondent, which they did. On 7th October, 1991, at 2 p.m. Benson I. Maina, who is an employee of the claimants served the respondent by delivering to him the said copy of the claimants or memorandum in this matter, for which his secretary signed the delivery book and proof of service thereof is supported by the attached affidavit, duly sworn by the said Mr. Maina (exh. C. I (a) and (b). On 15th October, 1991, when the dispute came up for hearing the claimants' representative appeared, but the respondent once again failed to attend and the court proceeded to hear it ex parte or in his absence. The grievant was also present in court.

The grievant was employed as an office messenger on 17th April, 1978, by James and Joel International Ltd., of which the respondent was a senior director. The company wound up in 1984, without the knowledge of the grievant, but he continued working for the respondent until 1st December, 1986, when due to decline in business he was verbally declared redundant after serving the company and the respondent with a clean record for a total period of eight (8) years and eight (8) months. At the time of termination of his services, the grievant was earning consolidated wages of KSh. 1,100 per month.

The grievant handed over the matter to the claimants, but no amicable settlement was reached between them and the respondent. Consequently, on 23rd December, 1986, the claimants reported a trade dispute to the Minister for Labour who recommended on 26th April, 1990, after the usual ministry's investigations, that the grievant be paid—

- (a) redundancy benefits at the rate of 15 days pay for each completed year of service;
- (b) redundancy severance pay for eight (8) years of service;
- (c) two months pay as compensation for unfair loss of employment.

The claimants submitted that the grievant was illegally and unfairly declared redundant by the respondent, and for this reason prayed the court to award the following terminal entitlements to him—

- (a) one month's wages in lieu of notice;
- (b) redundancy severance pay for eight (8) years of service at the rate of 15 days for each completed year of service;
- (c) wages on pro-rata basis in lieu of leave;
- (d) compensation for loss of employment; and

(e) wages up to the time the court announces its award.

It would appear that James and Joel International Ltd., was a private enterprise under the sole management of the respondent who was at liberty to close it down for whatever reasons, economic or otherwise, which he thought inopportune to continue its operation. There is no doubt that the grievant was an employee of the respondent because the latter had in fact appeared before the investigator in this matter and agreed that "he was prepared to pay the grievant one month notice only since he used to proceed on annual leave whenever it was due." But nowhere in the investigation report is it stated that, apart from the one month's notice pay, the respondent had paid the grievant his terminal dues when he was declared redundant on 1st December, 1986. Hence the investigator's recommendation as above.

As the circumstances indicate, the grievant was retrenched because the respondent's business had become uneconomical to run or operate, and for this reason he was entitled to be paid his terminal benefits. However, we find the claimants' demand under (c) and (e) herein above not proven and, therefore, baseless and not maintainable.

In the result, it is accordingly ordered that the respondent should pay the grievant the following terminal benefits:

PRELIMINARY OBJECTION

Ruling:

The present dispute was referred to the count on 2nd July, 1991, by the Minister for Labour in accordance with section 8 of the Trade Disputes Act (Cap. 234). The minister's reference, together with the statutory centificates from himself and the Labour Commissioner under section 14 (9) (e) and (f) of the said Act, were received by the court on 4th July, 1991, and the matter was listed for mention on 5th August, 1991. On this date the parties were ordered to submit their memoranda on 20th August and 17th September, 1991, respectively, and the dispute was fixed for hearing on 24th September, 1991.

But the claimants were unable to file their memorandum as ordered hereinabove until 18th September, 1991. On 24th September, 1991, the hearing could not, therefore, proceed because the respondents had not had sufficient time to respond to the claimants' oalated memorandum; and, in the circumstances, the court allowed the respondents to file their memorandum on or before 18th October, 1991. The matter was then postponed to 25th September, 1991, when it was fixed for hearing on 22nd October, 1991. Meanwhile, the respondents submitted the memorandum on 15th October, 1991.

At the commencement of the hearing of the dispute on 22nd October, 1991, the respondents raised a preliminary objection on the ground that they were only a branch of Natirobi Homes Ltd., against whom the dispute was initially reported to the Minister for Labour on 29th December, 1987, (see claimants App. I). They pointed out that Nairobi Homes Services Ltd., are two (2) separate legal entities based in Nairobi with branches, which are not legal personalities, in Mombasa and Nakuru. But the directors and the shareholders of the two (2) companies are the same.

The respondents maintained that since they were a branch of Nairobi Homes Ltd., against whom the dispute was initially reported as aforestated and with whom the claimants did not have a recognition agreement, the dispute was, therefore, not properly before the court and urged it to uphold their objection.

In reply the claimants blamed the respondents for not revealing to them and the investigator that they were only a branch of Nairobi Homes Ltd. They stated that all along the respondents have not been honest and genuine to them in this matter. For example, the respondents refused to sign form "A" when it was forwarded to them without assigning any reasons for their refusal. In the circumstances, the claimants prayed the court to reject the respondents' preliminary objection and proceed with the hearing of the dispute.

The respondents have urged the court in their preliminary objection that the dispute before it was not maintainable because they were not the proper party against whom the dispute was initially reported to the Minister for Labour. This is a spurious argument because the substance of the dispute is to be looked into and not its form. It is also wrong to import the technicalities of civil law into industrial disputes brought under the Trade Disputes Act, which is a special statute dealing with a special subject.

In terms of the definition of a "trade dispute" under section 2 of the Act, the court is entitled to adjudicate and determine any "dispute or difference between employers and employees, or between employees and employees, or between employers and trade unions, or between trade unions and trade unions, connected with the employment or non-employment, or with the terms of employment, or with the conditions of labour. of any person and includes disputes regarding the dismissal or suspensions of an employee, the redundancy of employees, allocation of work or recognition agreement; and it also includes an apprehended trade dispute." As to who owns an undertaking cannot, therefore, be said by any stretch of imagination to be a dispute or difference within the meaning of the definition of a trade dispute.

In any case, it is not within the jurisdiction of this court to question the property of the reference by the Minister for Labour, and hold that he had no power to refer the matter to this court at all. All that this court has got to see is if the Minister has referred certain matters to the court, and if he has then it cannot go behind his reference and say that he had no power to do so. Under section 4 of the Act, any trade dispute, whether existing or apprehended, may be reported to the Minister by or on behalf of any party to the dispute; and where the trade dispute has not been settled under section 5, 6 and 7 of the Act, the minister may, under section 8 thereof, refer the dispute to the court.

In their preliminary objection, the respondents have admitted that, although they are not in fact a legal entity, they are a branch of Nairobi Homes Ltd., against whom the dispute was reported to the Minister for Labour. That being the case, the question as to whether they are a proper party or not before the court does not arise, and the preliminary objection is, therefore, rejected as irrelevant and misconceived.

Accordingly, the court will proceed to hear and determine the dispute on merits, and the same is listed for mention on 5th February, 1992, at 9.30 a.m. with a view to fixing a hearing date.
