(AWARD)

THE respondents are a limited liability company incorporated in Kenya, on 13th May, 1974, and a member of the Garment Manufacturing Mass Production Group of the Kenya Federation of Employers (F.K.E.). They are situated in Kiambu District, along Banana Hill/Limuru Road, and their main business is the manufacture of ladies' out-wear garments. The respondents employ a workforce of about 147 employees, out of whom 138 are unionizable, and the present dispute concerns 20 piece-rate workers thereof.

The respondents entered into a recognition agreement with the claimants in 1976, and have since then negotiated and signed several collective agreements between themselves, the latest of which was signed on 3rd October, 1990. The present dispute dates back to 20th August, 1985, when the parties met at their own level to discuss the following issues:

- (a) Public holidays.
- (b) Sick leave.
- (c) Overtime.

The parties resolved the first two (2) issues, but failed to reach an agreement on the third issue.

On 3rd July, 1987, the claimants reported a trade dispute on the issue under consideration to the Minister for Labour in accordance with section 4 of the Trade Disputes Act (Cap. 234). The minister accepted the dispute and appointed M. M. Gitao (Mrs.), of Nairobi Labour Office, to act as a conciliator. But at the conciliation meeting held on 18th October, 1990, the parties recorded a deadlock on the matter, and in the circumstances the conciliation officer issued to the parties a failure certificate on the same day.

Consequently, the parties referred the dispute to the court under section 14 (7) of the said Act; and the Notification of Dispute Form "A", dated 29th November, 1990, together with the statutory certificate from the Labour Commissioner under section 14 (9) (e) of the Act, were received by the court on 26th March, 1991. The parties filed their written submission on 16th and 30th May, 1991, respectively, which we will now consider and give our decision thereon.

In their submission the claimants referred the court to paragraphs 3 and 8 of the parties' 1984/86 collective agreement which read as under:

"3. Overtime:

- (i) Overtime shall be payable at the following rates—

- (a) for time worked in excess of the normal number of hours per week specified in paragraph 2 of this agreement at one-and-one-half times the normal hourly rates; and
- (b) for time worked on Sunday, of employee's public holidays—at twice the normal hourly rate.

- (ii) for the purpose of calculating payment for overtime in accordance with sub-paragraph (i) of this paragraph the normal hourly rate shall be deemed to be not less than one-two hundredth of the employee's monthly wage, exclusive of housing allowance, and in the case of employees remunerated otherwise than at a monthly rate, it shall be calculated in proportion, save that where the employee is remunerated at an hourly rate of wages such hourly rate of wages shall form the basis of calculation.

8. Piece work or task work:

An employee engaged on piece work rate or task work rate shall be entitled to wages and conditions of employment not less favourable than those specified in this agreement. However, leave pay will be calculated on average of the previous 12 consecutive months work pay."

Paragraph 3 of the parties' collective agreement for the years 1986/88, 1988/90 and 1990/92, is word for word the above-mentioned paragraph 3, except sub-paragraph (ii) regarding the calculation of the normally hourly rate of pay, which is one-hundred ninety-fifth of the employees' monthly wage.

To support their case further, the claimants also referred the court to paragraph 12 of Legal Notice No. 169 of 1972 (Rev. 1980) which states thus:

"12. Piece work or task work:

An employee engaged at piece-rates or task work shall be entitled to wages and conditions of employment not less favourable than those specified in this order."

The claimants submitted that on the basis of paragraph 8 hereinabove the piece rate workers in the respondents' employment are entitled to overtime payment as stipulated under paragraph 3 (i) (a) and (b). They stated that the overtime payment to the piece rate workers should be calculated in proportion to the hourly rate of wages. The claimants contended further that the piece rate workers should be paid overtime in the same manner as other workers who are paid on hourly basis. They saw no reason why the respondents are not paying overtime when all the other members of the Garment Manufacturing Mass Production Group of F.K.E. are paying the same.

The claimants, therefore, prayed the court to award the demand in terms of their interpretation. In reply the respondents submitted that the payment of overtime to the piece rate workers does not arise because their remuneration is based on the amount of work done and not the time spent in doing it. On this score, they referred the court to the definition of "piece work" under section 2 of the Employment Act (Cap. 226), which states:

"piece work' means any work they pay for which is estimated by the amount of work performed irrespective of the time occupied in its performance."

The respondents stated that the criterion here is the amount of work rather than the time taken in doing it. They argued, contrary to the claimants' assertion, that they have always complied with the provisions of the parties' collective agreements by paying their piece rate employees all the other benefits except overtime which does not apply to them. The respondents strongly contended that an award in favour of the claimants in this case would set a bad precedent, adversely affect productivity and destroy the whole concept of piece rate work because most employees would not bother to do any work during working hours, but would only embark on it outside the stipulated time in order to earn overtime payment.

Finally, the respondents denied that the other members of the Garment Manufacturing Mass Production Group of F.K.E. pay overtime in respect of piece rate work as alleged by the claimants. Accordingly, the respondents prayed the court to reject the claimants' demand.

Piece work rates are a method of wage payment where an employee is paid according to the amount of work he has done, and the rates can be applied only when the amount of work accomplished can easily be measured. Under this system the employee is paid for the amount of work performed rather than for the time spent on the job. A specified rate of wage may be fixed per unit of output measured, for example, in terms of pieces of garments produced. The basis of pay in this case is the output or production and the wages are paid for independent of time—i.e., the pay is directly based on productivity. In the Concise Commercial Dictionary by P. G. Osborn and S. T. Grandage "piece rate" means:

"work done and paid for by the unit of production as distinct from work paid for by the hour or at a fixed wage or salary. It is a method of payment by results."

The wages payable to an employee under this system is calculated by multiplying the number of products by the amount to be paid for each unit/or product. In other words, the wages of an employee = $N \times R$ —i.e., "N" is the number of units of a product produced and "R" is the wage rate per unit of the product. If an employee produces, say 15 units when the price rate is Sh. 30 per unit, the total wages would be $Sh. 30 \times 15 = Sh. 450$. In fact, the employee himself will realize that it will not be financially worthwhile for him to engage on piece rate work if he cannot work with some speed and produce enough to earn a wage that will meet his personal requirements.

With the above observations, we are unable to appreciate the claimants' arguments and see no justification in accepting their demand, which is accordingly rejected as baseless and untenable.

THE Bakery, Confectionery, Manufacturing and Allied Workers Union shall hereinafter be referred to as the claimants and the Wrigley Co. E.A. Ltd. shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 11th November, 10th and 11th December, 1991, and relied on their written and verbal submissions. In addition the following witnesses were called to give evidence on oath:

The claimants: J. M. Gaiitho.

The respondents: E. G. Oburrah.

AWARD

3. The Notification of Dispute Form "A" dated 7th May, 1991, duly signed by the parties was received by the court on 14th June, 1991, together with the statutory certificates signed by the Minister for Labour and Labour Commissioner.

J. M. Gaiitho was employed by the respondents on 15th January, 1972, as a filter/mechanic at a consolidated salary of Sh. 1,000 per month. Subsequently, he rose through the ranks and on 1st November, 1984, he became engineering co-ordinator earning KSh. 9,000 per month. His services were terminated on 15th January, 1988. He had served the respondents for a period of 16 years.

The incident leading to the grievant's dismissal happened on 12th January, 1988. It is alleged that at the material time he abandoned his duties without informing the night-shift supervisor. In his absence, a machine broke down and there was nobody to attend to it. As a result, there was a loss of production for two (2) hours.

The parties tried to settle the matter amicably at their own level but failed. The dispute was then reported to the Minister for Labour. Thereafter, the dispute was investigated by the ministry and the findings and recommendation were released to the parties, on 22nd January, 1991.

The ministry's findings were that the decision to terminate the grievant's services was rather too harsh and uncalled for. The ministry also found that the grievant was not accorded an opportunity to defend himself.

The ministry recommended that the grievant be paid all his terminal benefits. In addition he be paid ten (10) months salary by way of compensation for loss of employment he had suffered.

The decision was turned down by the respondents and the matter is now before the court for consideration.

They prayed the court to award Mr. Gaiitho as follows:

- (a) Unconditional reinstatement to his job and position, and all other benefits attached thereto at the time of his termination.
- (b) Be entitled to all his salary and benefits from 1st February, 1988 to date.
- (c) In the event of the company's failure to comply with (a) and (b) above, alternatively he should be paid 12 months pay as compensation for wrongful termination of his services.
- (d) In addition to (c) he should also be entitled to notice pay, leave if any, leave travelling allowance, etc., including unpaid days worked and other terminal benefits if any.

The respondents summed up their case by saying that Mr. Gaiitho was treated leniently over the years but he did not improve himself to the expected standards. He continued to show disregard for his job and authority. The respondents submitted that they had no option but inevitably to terminate

the grievant's services. They prayed the court to uphold the disciplinary action taken against the grievant.

There are two distinct aspects of this dispute. One is—was the grievant victimized so that an expatriate's work permit could be extended? The other is—were the respondents justified in terminating the services of the grievant because on one night he was absent for two hours from duty?

The court has carefully studied the educational background, the technical qualifications and the technical experience of the grievant and all the circumstances pertaining to the grant of work permit to Mr. Vizcaino and his subsequent replacement by Mr. Oburrah—a Kenyan.

The court has also taken into account the chain of command at the respondents factory and has come to the conclusion that the grievant was not in the running as far as Mr. Vizcaino's post was concerned—certainly not as far as the senior management was concerned. The grievant may have had this aspiration but it was misguided.

The court must therefore reject this part of the claimants submission and proceed to consider the dispute on the other aspect of it.

The grievant had worked for the respondents for 15 years and at the time of dismissal was the engineering co-ordinator earning Sh. 9,000 p.m.

During his 15 years service the grievant had maintained a fairly good working record and the few offences alleged to have been committed by him were minor in nature. The only serious offence was the allegation that he had taken respondents property when proceeding on leave in March, 1987. The grievant, however, was not dismissed and was given a "last" warning.

The court cannot hold any of these shortcomings against the grievant. The removal of company property was forgiven and the other warnings were of trivial nature.

Now coming to the incident on the night of 12th January, 1988, that led to the grievant's termination the court accepts the grievant's version of what happened. He was entitled to one hour off for dinner during the night shift on which he was deployed due to exigencies of service. On the night of 12th January, 1988, he overstayed his break by one extra hour and that is because one of his children had injured his forehead and as his wife was on duty he had to take the necessary action.

On the question of why he did not inform the supervisor the court believes the grievant that he informed one of the mechanics as the supervisor was asleep in the canteen.

The court cannot believe that the grievant absconded from his work from 15th to 29th January, 1988. The truth seems to be that the senior management expected the grievant to resign and he was not allowed to resume duty although he reported every day for work.

The letter written by the grievant to the relevant co-operative society is not of much importance under the circumstances of this dispute as the grievant was under the impression that his days with the respondents were numbered.

After careful consideration of all the submissions the court finds that Mr. Gaiitho has suffered a wrongful termination and the court concurs with the Ministry of Labour's finding that the decision to terminate the grievant's services was rather too harsh considering all the factors.

The court awards that the respondents should pay the grievant 12 months salary by way of compensation for wrongful termination of his services and he should also be paid notice pay, leave pay if any and other terminal benefits.

The court directs the respondents to allow the grievant to remove all his personal belongings which are still in the factory.

AWARD

THE Notification of Dispute, Form "A", dated 21st January, 1991, together with the statutory certificate from the Labour Commissioner under section 14 (9) (e) of the Trade Dispute Act (Cap. 234), were received by the court on 25th September, 1991, and the dispute was listed for mention on 16th October, 1991. On this date, the parties were ordered to file their written submissions on 31st October and 29th November, 1991, respectively, and the dispute was fixed for hearing on 28th January, 1992. The parties were heard on their opening submissions on the said date; and at the conclusion of the same, and in the light of the evidence on record, the court ordered the respondents to produce before it their muster roll on 5th February, 1992, for the months of December, 1991 and January, 1992 for verification and cross-checking against the claimants' alleged list of their current members. The matter was then postponed for final disposal to the said date—i.e. 5th February, 1992. The parties complied with the court order, and on 5th February, 1992, the verification and cross-checking established that during the month of December, 1991, the claimants had 46 members out of 79 unionizable employees and in January, 1992, their membership stood at 60 out of 102 unionizable employees. On the basis of the aforesaid membership, the case was, therefore, postponed further to today for final submissions. However, after a brief consultation between themselves this morning, the parties informed the court that they have reached an amicable settlement on the matter and prayed that an award by consent may be made.

By consent of the parties, the court awards that the respondents accord the claimants recognition forthwith as they have fulfilled the conditions laid down in section 5 (2) of the Trade Dispute Act (Cap. 234), subject to the signing of the formal recognition agreement in due course.

**IMPORTANT NOTICE TO SUBSCRIBERS
TO THE KENYA GAZETTE**

THE following notes are for the guidance of persons submitting "copy" for inclusion in the *Kenya Gazette, Supplement*, etc.:

- (1) The *Kenya Gazette* contains notices of a general nature which do not affect legislation. They are, therefore, submitted to the Government Printer directly.
- (2) *Legislative Supplement* contains Rules and Regulations which are issued by the central Government. Because of this they must be submitted to the Government Printer through the office of the Attorney-General.
- (3) *Bill Supplement* contains Bills which are for introduction in the National Assembly.
- (4) *Act Supplement* contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible and contain a minimum of alterations.

Particular attention should be paid to the following points:

- (i) Signature must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- (ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE CODE OF REGULATIONS, SECTION D—**Kenya Gazette**

"D 41. (1) Communications for the *Kenya Gazette* should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the *Gazette*.

(2) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer when ready."

It is emphasized that these notes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
