

- (4) Act Supplement contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet no matter how small the notice or Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear. legible and contain a minimum nf alterations.

- Particular attention should be paid to the following points:
- (i) Signature must be clarified by means of rubber-stamping or typing the same of the signer in capital letters.
- ii) Dates must be correct and filled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to isgislation are up to date and conform with the Revised Edition of the Laws of Kenya.
- EXTRACT FROM THE CODE OF REGULATIONS, SECTION D-Kenya Gazette

"D 40. (i) Communications for the Kenya Gazette should reach the Government Printer not later than 9 a.m., on Friday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.

(2) Ministries will be required to pay for the Kenya Gazette and to meet the cost of advertising in it.

(3) It will facilitate work at the Press if Permanent Secretaries will forward *Gazette* notices to the Government Printer in time."
