- (b) to take appropriate measures for speedy recovery of all loans and advances particularly insider loans;
- (c) in the event of liquidation, to ensure that small depositors have access to their money as early as possible;
- (d) taking into account the management and financial requirements, to determine the possibility of reconstructing, re-organizing and/or re-opening of closed banks or financial institutions;
- (e) in view of (d) above, to explore and determine ways and means of raising the necessary resources required to enable such re-opening;
- (f) to consider all legal ramifications to be dealt with as regards troubled banks and financial institutions and their assets and those of associated companies, and any other assets which might have been financed by the bank or financial institution being examined, and in particular the question of ownership interests where additional funding is to be provided from new sources;

- (g) to liaise with the various arms of government including law enforcement agencies to ensure that any evidence of wrong-doing by directors, officers and employees are brought to light for the enforcement of the law;
- (h) in view of the fact that substantial sums of parastatal money are at risk, to examine how such deposits were made, review the procedures for investment of such funds, and make appropriate recommendations;
- (i) to make appropriate recommendations for preventive measures, including legislation, to avoid future recurrences of underlying problems in order to promote steady and stable growth of Kenya's financial system.
