- (3) Bill Supplement contains Bills which are for introduction in the National Assembly.
- (4) Act Supplement contains Acts passed by the National Assembly.

All "copy" submitted for publication should be prepared on one side of an A4 sheet ao matter how small the notice of Act, each page being numbered, and should be typewritten with double spacing. Copy should be clear, legible aod contain a minimum of alterations.

Particular attention should be paid to the following points:

- (i) Signature must be clarified by means of rubber-stamping or typing the name of the signer in capital letters.
- ii) Dates must be correct and tilled in where necessary.
- (iii) Care should be taken to ensure that all headings to notices and references to legislation are up to date and conform with the Revised Edition of the Laws of Kenya.

EXTRACT FROM THE COOR OF REGULATIONS, SECTION D-Kenva Gazette

- "D 40. (1) Communications for the Kenya Gazette should reach the Government Printer not later than 9 a.m., on Priday of the week before publication is desired. The Government Printer will not publish communications received after that hour until the next subsequent issue of the Gazette.
- (2) Ministries will be required to pay for the Kenya Gazette and to meet the cost of advertising in it.
- (3) it will facilitate work at the Press if Permanent Secretaries will forward Gazette actices to the Government Printer in time."

It is emphasized that these aotes are for guidance only, but it is requested that persons submitting copy for publication first satisfy themselves that such copy is complete in every respect.
